





# Accessing Battery Compartment


To gain access to the Battery Compartment, simple remove the Protective Cover/ Stand off the rear of the GSM-12 unit to expose the Battery Compartment.



## **Battery Installation**


To gain access to the Battery, slide the cover off the back of the GSM-12. To preserve battery life, the 9v Battery of the GSM-12 is shipped with the Battery reversed. Flip the Battery 180° from its original package position and re-insert. Slide the Battery Cover back on and replace the Protective Cover/ Stand.

**NOTE:** Insure correct Polarity (+) and (-) when inserting battery.




### **Data Cable Connection**

Insert the Data Cable into the Communications Port on top of the GSM-12. Place the other end of the Data Cable in the Communications Port of the Wayne-Dalton remote radio receiver (sold separately).



### **Protective Cover/Stand**

The protective cover of the GSM-12 has a built in Stand, which provides hands-free operation. To use the built-in stand, pull the Stand out from the rear of the GSM-12.




## **Activating the GSM-12**

- 1. Press and release the ON/YES button.
- a) The Display will indicate the Model and Version numbers.

GSM-12 VX.XX PRESS MENU

NOTE: X is the version number



# Programing (Learning) Devices to the GSM-12


**1.** Press the MENU/NO button until the display indicates the Learn Device operation.

# LEARN DEVICE? NO YES

**2.** Press the ON/YES button. If the receiver is initializing, the display will indicate a wait message.

### WAIT.....

**a)** When the receiver is ready to receive device signals, the display will indicate a ready message.



# Programing (Learning) Devices to the GSM-12 (Continued)

- **3.** Press and hold the transmitter button you would like to program (learn) to the GSM-12.
- **4.** Once the GSM-12 has received the transmission, two possible messages will be displayed.
- **a)** Message 1 will be displayed if this is a new device.

### **NEW LEARN ID-XXX**

**b)** Message 2 will be displayed if this device had been previously added.


### **DUPLICATE ID-XXX**

**5.** If a transmission is not received within 30 seconds, the GSM-12 will display a time-out message.

### **LEARN TIME-OUT**

**6.** To cancel the "Listen Mode" press MENU/NO. The display will indicate this action.

# **Erasing Individual Devices From The GSM-12**

# **Erasing Individual Devices From The GSM-12:**

**1.** Press the MENU/NO button until the display indicates the Erase Device operation.

# ERASE DEVICE? NO YES

**a)** Pressing the ON/YES button will display information about an added device.

### ID-XXX YYYYYYY NO ERASE? YES


**NOTE:** X is the memory location of the device.

**NOTE:** Y is the serial number of the device.

3. Use the UP and DOWN buttons to search through the memory to find the device to erase. When the device to be erased has been found, press the ON/YES button. A confirmation message will be displayed before permanently erasing the device.

# ID-XXX ERASED NO UNDO? YES

- **a)** To permanently erase the device, press the MENU/NO button.
- **b)** To restore or undo the erase operation, press the ON/YES button.
- **c)** An UP arrow in the top left display indicates more devices to view.
- **d)** A DOWN arrow in the top left display indicates there is a previous device to view.



# **Erasing All Devices From The GSM-12**

**1.** Press the MENU/NO button until the display indicates the Erase All operation.


# ERASE ALL?

**2.** Pressing the ON/YES button will display confirmation message before erasing all devices.

# ERASE ALL? NO SURE? YES

- **a)** To permanently erase all devices, press the ON/YES button.
- **b)** To cancel the erase all operation, press the MENU/NO button.




# Retrieving Free Storage Space

**1.** Press the MENU/NO button until the display indicates the Get Free Memory operation.

### GET FREE MEMORY? NO YES

**a)** Pressing the ON/YES button will display how many devices can be added to the GSM-12.

# Transfering Controller Devices to Radio Remote Receiver

- **1.** Connect the communication cable from the GSM-12 to the Remote Radio Receiver.
- **2.** Press the MENU/NO button until the display indicates the Send To Receiver operation.

# SEND TO RECEIVER NO YES

**3.** Pressing the ON/YES button will display transfer operation activity.

### SENDING.....

**a)** When transfer operation is complete, the GSM-12 will display.


### **SENDING DONE**

**b)** If the communication cable is not connected or the connection is not correct, the GSM-12 will display.

### CHECKING COMM.....

**c)** Then after two seconds the GSM-12 will display.

### **COMM ERROR**



# Transfering Radio Remote Receiver Devices to Controller

- **1.** Connect the Data Cable from the GSM-12 to the Remote Radio Receiver.
- **2.** Press the MENU/NO button until the display indicates the Get From Receiver operation.

# GET FRM RECEIVER NO YES

**3.** Pressing the ON/YES button will display transfer operation activity.

### RECEIVING.....

**a)** When transfer operation is complete, the GSM-12 will display.


### RECEIVING DONE

**b)** If the communication cable is not connected or the connection is not correct, the GSM-12 will display.

### **CHECKING COMM....**

**c)** Then after two seconds the GSM-12 will display.

### **COMM ERROR**




# **Turning Off GSM-12**

**1.** Press the MENU/NO button until the display indicates the Turn Off operation.

# TURN UNIT OFF? NO YES

- **a)** Pressing the ON/YES button will turn off the GSM-12.
- **b)** The controller is equipped with an auto shut-off mechanism. After 5 minutes of inactivity, the GSM-12 will automatically turn off.



### **Maintenance**

While the GSM-12 is maintenance-free, periodic cleaning of the receiver case is suggested. To clean the GSM-12, use a soft cloth to remove any dirt and dust.

### **Service**

Unit contains no user serviceable parts. Contact your dealer or Wayne-Dalton customer support for additional information.

# **Battery Replacement**

Slide off battery cover. Replace battery, being careful to match positive (+) symbols on Circuit Boards with battery. Slide battery cover back into place.

**NOTE:** Dispose of dead battery properly.

# **Possible Solution**

| Displays appears DIM  | Check Battery   |

| Difficulty in programing (learning) devices.                              | Insure controller is not near any metal. Possible near-by radio interference.                                     |
| Can not transfer device information between controller and gate receiver. | Make sure cable is correct and connected securely. Possible near-by radio interference can cause slower transfer. |
