## **Regulatory Notices**

## Installation Instructions for CM9700-CC1-VID

1. Turn off all power to the CC1. Disconnect and label all attached cabling.

## **WARNINGS:**

- Failure to turn off the CC1 power could result in serious damage to the equipment.
- Electrostatic Discharge (ESD) precautions must be observed when performing the
  procedures described in this manual. Always wear a gounding strap connected to an
  approved grounding source when working on or around exposed electronic components.




Figure 1. Removing the CC1 Top Cover




Figure 2. CC1 Internal Layout

- 2. Install the VGA card in the CC1. Refer to Figures 1 and 2 and do the following:
  - a. Loosen and remove the top cover mounting screws.
  - b. From the rear, tilt the top cover up at a slight angle, and then pull backwards away from the front edge to remove it from the CC1 chassis.
  - c. Remove the retaining screw of the existing graphics card. Gently pull the card straight up. If there is no existing card, remove the retaining screw for the slot cover of any vacant PCI expansion slot. Slide the cover out.
  - d. Install the new VGA card into the selected PCI expansion slot from step c. Carefully align the gold-fingered edge connector of the VGA card with the PCI slot. Gently but firmly press the VGA card down until fully seated into the PCI slot. Reinstall the retaining screw to secure the VGA card into place.
  - e. Reinstall the top cover and secure with mounting screws.

## UTILITY DISK SOFTWARE INSTALLATION

1. If not done after installation of the VGA card, reconnect all cabling to the CC1.

**NOTE:** A keyboard and monitor must be connected to the CC1 in order to install the driver software.

- 2. Apply power to the CC1.
- 3. Insert the driver utility disk into the "A" drive of the CC1.
- 4. When "C:\9700>" appears on the screen, type the following:

## a:\install

**NOTE:** If your system is in the A directory, "A:\>" will appear. In this case, type **install** only.

- 5. Press the Enter key.
- 6. The drivers and where they will be installed will be displayed on the screen. The option of either aborting or continuing the installation will be given.
  - To abort installation, press the CTRL+C keys. The files will not be installed.
  - To continue installation, press any key on the keyboard. The files will be installed.
- 7. Upon completion, "Installation successful" will appear on the screen.
- 8. Remove the utility disk from the "A" drive and press CTRL+ALT+DEL to reboot the system.

### PRODUCT WARRANTY AND RETURN INFORMATION

#### WARRANTY

Pelco will repair or replace, without charge, any merchandise proved defective in material or workmanship for a period of one year after the date of shipment.

Exceptions to this warranty are as noted below:

- · Five years on FT/FR8000 Series fiber optic products.
- Three years on Genex® Series products (multiplexers, server, and keyboard).
- Three years on Camclosure® and fixed camera models, except the CC3701H-2, CC3701H-2X, CC3751H-2, CC3651H-2X, MC3651H-2, and CC3651H-2X camera models, which have a five-year warranty.
- Two years on standard motorized or fixed focal length lenses.
- Two years on Legacy®, CM6700/CM6800/CM9700 Series matrix, and DF5/DF8 Series fixed dome products.
- Two years on Spectra®, Esprit®, ExSite™, and PS20 Scanners, including when used in continuous motion applications.
- Two years on Esprit® and WW5700 Series window wiper (excluding wiper blades).
- Eighteen months on DX Series digital video recorders, NVR300 Series network video recorders, and Endura<sup>™</sup> Series distributed network-based video products.
- . One year (except video heads) on video cassette recorders (VCRs). Video heads will be covered for a period of six months.
- . Six months on all pan and tilts, scanners or preset lenses used in continuous motion applications (that is, preset scan, tour and auto scan modes).

Peloo will warrant all replacement parts and repairs for 90 days from the date of Peloo shipment. All goods requiring warranty repair shall be sent freight prepaid to Peloo, Clovis, California. Repairs made necessary by reason of misuse, alteration, normal wear, or accident are not covered under this warranty.

Pelco assumes no risk and shall be subject to no liability for damages or loss resulting from the specific use or application made of the Products. Pelco's liability for any claim, whether based on breach of contract, negligence, infringement of any rights of any party or product liability, relating to the Products shall not exceed the price paid by the Dealer to Pelco for such Products. In no event will Pelco be liable for any special, incidental or consequential damages (including loss of use, loss of profit and claims of third parties) however caused, whether by the negligence of Pelco or otherwise.

- 3. Details of the defect or problem

If there is a dispute regarding the warranty of a product which does not fall under the warranty conditions stated above, please include a written explanation with the product when returned.

Method of return shipment shall be the same or equal to the method by which the item was received by Pelco.

All merchandise returned for credit may be subject to a 20% restocking and refurbishing charge.
