


12VDC • 1.5A **AC-to-DC Power Adapter**

Using Your Adapter

1. Plug the correct size Adaptaplug onto the lack at the end of the adapter's cord.



- If your device's DC input lack is marked • align **TIP** on the adapter's lack with + on the Adaptaplug (shown).
- If the DC input jack is marked • align TIP on the adapter's jack with - on the Adaptaplua

!\ CAUTION: Be sure to set the correct tip polarity. Incorrect polarity can damage your device or the adapter.

- Plug the Adaptaplug into your device's DC input jack
- Plug the AC adapter into an easily accessible power outlet located near the equipment.

Cautions:

- If this adapter is not compatible with the voltage and current requirements of your portable device, it can result in PERMANENT DAMAGE to the device

- The power adapter's current (1.5A) must be equal to or more than the current needed by your portable device.
- Before charging cell phones, make sure the cell phone specifications are supported by this power adapter.
- Never operate the adapter if it has been damaged in any way. Do not disassemble it.

!\ WARNING: To prevent fire or shock hazard, do not expose the adapter to rain or other moisture.

CAUTION: The total combined current for accessories plugged into this adapter must not exceed 1.5A.
