- 1** Open the battery container on the back of the Remote Wonder™ Plus and insert two AAA batteries.
- 2** Insert the included *ATI Installation CD* into your CD-ROM drive.
- 3** Click the Remote Wonder™ icon on the ATI CD Install screen. Follow the on-screen instructions, and then allow the computer to restart.
- 4** Plug the remote receiver into any available USB port on your computer. The Remote Wonder™ Plus icon will appear on the Windows taskbar. Your Remote Wonder™ Plus is ready to use!

The Remote Wonder™ Plus operates at 433 MHz. The Remote Wonder™ Plus range depends upon the environment. For best results, the receiver should be placed as far as possible from the computer's case and monitor.



For optimum long-range performance, tilt the Remote Wonder™ Plus up approximately 30 degrees.

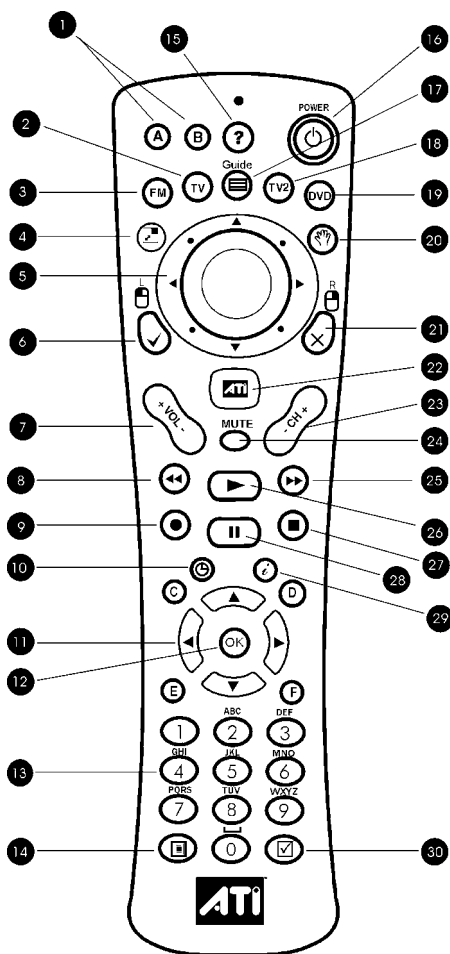
