

 Plug the correct size Adaptaplug onto the jack at the end of the adapter's cord.



- If your device's DC input jack is marked
  ● ⊕, align TIP on the adapter's jack with + on the Adaptaplug (shown).
- If the DC input jack is marked ⊕ ⊕ , align TIP on the adapter's jack with – on the Adaptaplug.

- **2.** Plug the Adaptaplug into your device's DC input jack.
- **3.** Plug the AC adapter into an easily accessible power outlet located near the equipment.
