System Requirements

Software installation requires an Internet connection.

Remote viewing requires a PC or Intel-based Mac running Flash® Player, which is a free download.

PC is not required to record video. The camera includes a 2 GB microSD $^{\text{m}}$ card. The amount of video that can be stored on a 2 GB card is subject to the amount of motion. We calculate an average one week using cameras in typical home locations. Upgrade to a larger microSD card (not included) to get months of on-camera video recording.
