

Assembly/Operation

Your Tool Chest and Roller Cabinet will require complete assembly. It is important that you read the entire manual to become familiar with the product BEFORE you assemble and use the Tool Chest and Roller Cabinet. Before assembling the Chest and Cabinet be sure that you have all parts described in the Parts List located on page 4 of this manual.

- 1. Insert each of the Caster (1B) shafts into the holes in the bottom of the Tool Chest and Roller Cabinet-see Figure 1.
- 2. Attach the Handle (9) to the side of the Roller Cabinet with two Screws (2B) and Nuts (3B)-see Figure 2.
- 3. Set each Shelf (8) down onto the lips built into the sides of the Roller Cabinet.
- 4. Set each of the Hooks (6B) in place on the Door.
- 5. Place the Tool Chest onto the top of the Roller Cabinet to have it stand as one unit.
- 6. If the Non-Slip Mats (4, 5) are not in place in the face drawers, place the Non-Slip Mats (4, 5) into each of the Drawers.


