

MAINTENANCE

GENERAL MAINTENANCE

- The mechanisms of the CD player and the cassette deck are fitted with self-lubricating bearings and therefore must not be oiled or greased.
- Fingerprints, dust and dirt on the apparatus can be removed using a soft, clean and slightly damp leather cloth. Do not use any cleaning agents which contain abrasives or solvents such as benzine thinner, alcohol, refined petrol or ammonia, since they may affect and harm the cabinet.
- Do not expose the set, batteries, CD discs or cassettes to rain or moisture, or, for any great length of time, to excessive heat from heating equipment or direct sunshine, e.g. in cars parked in the sun.
- Keep the set, the CD discs and the cassettes away from sand and do not store the cassettes too close to magnets, loudspeakers or transformers.

CD-PLAYER AND DISCS

- The lens ⊗ (fig. 6) should never be cleaned.
- The lens may steam up when the set is taken from a cold into a warm environment. Playing a disc is not possible then. Do not clean the lens, but let the set acclimatize for a while.
- Always pick up the CD disc by the edge (fig. 4) and put it back in its box immediately after use.
- To remove dirt from a disc, breath on the disc first and wipe it off in a straight line from centre to edge (fig. 7) using a soft, lint-free cloth. The use of cleaning agents may harm the disc.

CASSETTE RECORDER

Clean the parts (A)(C)(0) indicated in fig. 10 after every 50 hours of operation or, on average, once a month.

- Open the cassette holder by pressing EJECT ■.
- Use a cotton bud slightly moistened with alcohol or a special head cleaning fluid.
- Press PLAY ▶ and clean the rubber pressure roller ⊚ (fig. 10).
- Then press PAUSE II and clean erase head (A), recording/playback head (B) and capstan (c).
- After cleaning, press STOP ■.

Cleaning of the heads (a) and (a) can also be done by playing the cleaning cassette SBC 114 through once as an ordinary cassette.

SUPPLY

Batteries

- Open the battery compartment (fig. 2) and insert as indicated eight (preferably Alkaline) batteries, type R20, UM1 or D-cells.
- Remove the batteries if exhausted or if they will not be used again for a long period.

Note: The battery supply is automatically switched off when the set is connected to the mains. When changing over to battery supply, pull out the plug from the AC MAINS socket (a).

Mains

- Check if the mains voltage as shown on the type plate corresponds to your local mains supply. If it does not, consult your dealer or service organisation.
- Insert the female plug of the mains lead into AC MAINS socket (a) and the mains plug into the wall socket. The mains supply is now switched on.
- To disconnect the set from the mains completely, withdraw the mains plug from the wall socket.

Important note for users in U.K.:

When fitting a mains plug to the mains lead proceed as follows: The wires in the mains lead are coloured in accordance with the following code: Blue = Neutral, Brown = Live.

These colours may not correspond with the colour markings identifying the terminals in your plug, so proceed as follows: Connect the Brown wire to the terminal marked L or coloured Red. Connect the Blue wire to the terminal marked N or coloured Black. No connection is necessary to the earth terminal.

Note: This apparatus must be protected by a 3 Amp Fuse if a 13 Amp plugis used or, if any other type of plugis used, by a 5 Amp Fuse either in the plug or adapter or at the distribution board. If in doubt consult a qualified electrician.

CONNECTIONS - fig. 1-2

Stereo headphone socket (1) 🔐

For stereo headphones with Ø 3.5 mm plug. Inserting the plug will disconnect the loudspeakers.

CD Output sockets CD OUT (4)

Cinch-sockets for high quality Compact Disc reproduction (not radio or cassette) through an amplifier, receiver, recorder, etc.

 Connect the CD OUT sockets to the tape recorder input sockets REC IN, TAPE IN, LINE IN, AUX or CD IN of the other set.

The CD OUT output signal is not affected by the position of the controls VOLUME ③ and TONE ④.

OPERATION

SWITCHING THE POWER ON AND OFF

The set is switched on and off with MODE selector ②. The set is switched off when MODE selector ② is in position TAPE - RADIO OFF and the recorder buttons are released.

MODE SELECTOR ②

The desired sound source for reproduction or recording is selected using MODE selector ②.

- Position CD (Compact Disc) for:
- Compact Disc playback
- recording from the CD player
- Position RADIO for:
- radio reception
- a radio recording
- Position TAPE (cassette) for:
- cassette playback
- mono recording from the built-in MICROPHONE (?)

SOUND ADJUSTMENT

The sound reproduced by the loudspeakers or by stereo headphones is adjusted by means of the controls VOLUME ③ and TONE ④.

The position of these controls does not affect the cassette recording nor the CD OUT (a) output signal.

- The VOLUME control (3) enables adjustment of the sound volume.
- Using the TONE control (4), the sound timbre can be adjusted.

COMPACT DISC PLAYER

RADIO RECEPTION

- Set the MODE selector (2) to RADIO.
- · Select the wave band using BAND selector (5).
- Adjust the sound with the controls VOLUME (3) and TONE (4).
- Tune to a radio station using TUNING knob (8).
- For FM-reception, pull out the telescopic aerial. To improve FM-reception, incline and turn the aerial (fig. 3a). Reduce its length if the FM-signal is too strong (very close to a transmitter).
- For AM/MW and LW reception (Medium and Long Wave), the set is provided with a built-in ferrite aerial, so there is no need to use the telescopic aerial. The ferrite aerial can be directed by turning the whole set (fig. 3a).
- When BAND selector (is in position FM STEREO and the FM STEREO indicator (is lights up, you are receiving a FM-stereo transmitter. A disturbing noise, due to a weak FM-stereo signal, can be suppressed by setting the BAND selector (is to FM MONO. The FM STEREO indicator (is will then go out and you will hear (and record) the FM programme in mono.
- To switch off the set, place MODE selector ② to position TAPE RADIO OFF.

PLAYING A CD DISC

- Set MODE selector ② to CD (Compact Disc).
- Press CD OPEN (9) to open the disc cover.
- To play a Ø 3"/8 cm disc 'CD single', use a suitable adapter, e.g. type SBC 3580 (4822 535 60104) or equivalent.
- Insert the disc (fig. 4-5), label side facing outward, and close the cover. The CD-player starts and the WAIT indicator '--' appears on the display @ as a sign that the CD-player is scanning the contents list of the disc. After that, the number of tracks present on the disc appears on the display @ and the CD-player stops.
- If the battery voltage is not sufficient any more for playing a CD disc, the CD-player will not start.
- you inserted the disc in the wrong way (the label should face outward):
- the surface of the disc is badly scratched or dirty, see 'Maintenance':
- If you want to hear only the beginning (a few seconds) of all tracks, press the INTROSCAN button, see 'INTRO-SCAN'.
- Playback will start by pressing PLAY ▷. As soon as playback starts, the display shows the track number 1 (1st title). When reaching the 2nd title the track number 2 appears, etc.
- Adjust the sound with the controls VOLUME ③ and TONE ④.
- For brief interruptions, press PAUSE III. Then the PAUSE indicator lights up. To continue playback, press PAUSE again.
- If you want to jump to the next title or you want to repeat the previous title, see chapter 'PREVIOUS/NEXT M/N'
- \bullet To locate rapidly a certain passage within a track, see chapter 'SEARCH $\mbox{\em \varnothing}/\mbox{\em \bowtie}$ '.
- The CD player goes to position STOP:
- by pressing STOP
 or CD OPEN (9);
- when the end of the disc is reached;
- by setting the MODE selector ② to another position;
- if the batteries get exhausted or if the power supply is interrupted in another way.
- To take out the disc, open the disc cover by pressing CD OPEN (a). Press CD OPEN (a) only if the CD-player is in position STOP.
- \bullet To switch off the set, place MODE selector 2 to position TAPE RADIO OFF.

PREVIOUS/NEXT M/M

The PREVIOUS/NEXT buttons are only operative during CD playback and during INTROSCAN.

NEXT - go to the next track (title)

During playback, you can jump to the next title by pressing NEXT N, once. The next track number appears on display (6), the actual playback is interrupted and the next track is played.

If you want to skip more than one track, then press NEXT I more than once until the display (1) shows the desired track number.

M PREVIOUS - go to the previous track (title)

If you want to repeat a previous title, press PREVIOUS 14 once or more than once until the display @ shows the required track number.

SEARCH 41/₩

The SEARCH-buttons are only operative during CD playback.

By pressing SEARCH, the disc is played at high speed in the forward № or backward ⋖ direction. The sound is reproduced partly and at high speed, however, it is still recognizable. In this way you can locate rapidly a certain passage within a track.

Keep the button ▷ (search forward) or ຝ (search backward) pressed until you recognize the required passage. Then release the button: the disc will be played back in the normal way from this passage.

INTROSCAN

The INTROSCAN function can be switched on both from the STOP and the PLAY position.

By pressing the INTROSCAN button, the INTROSCAN function is switched on. The INTROSCAN indicator @ lights up.

Only the first few seconds of all tracks on the disc are played, but always from the 1st track number. After playing a few seconds of one track, the CD player jumps to the next track. The display (1) always shows the corresponding track number.

The moment that you press PLAY >, the INTROSCAN function is muted (the INTROSCAN indicator goes out) and the disc is played in the normal way from this track number.

If you press NEXT ▷ or PREVIOUS ⋈, the INTROSCAN function remains operative and the beginning of the next ▷ or previous ⋈ track is played again for a few seconds. If the INTROSCAN function is not muted by pressing PLAY ▷ or STOP □, then the CD player automatically returns to the STOP position as soon as the end of the disc is reached.

PROGRAMMING TRACK NUMBERS

Instead of playing a complete disc, you may select a number of tracks and store these in the memory in the desired sequence. When playing, you will only hear the stored titles in the selected sequence.

- Insert the CD-disc.
- Manual selecting
- Store this track by pressing the STORE-button.
- Storing during INTROSCAN
- Press the INTROSCAN-button to play the first few seconds of all tracks. The display @ will always show the corresponding track number.
- Press the STORE-button as soon as you recognize a desired title.
- Storing during PLAY
- During normal playback PLAY you may store the running title by pressing the STORE-button.
- By pressing the STORE-button the display will show the character 'P', indicating that the track has been stored.
- Store all desired titles in the required sequence. At most 24 tracks can be stored in the memory. You may store each track more than once. When the memory is full, the character 'F' (FULL) appears in the display
- When pressing the button DISPLAY, the display will show in sequence all stored track numbers.
- You can simply erase the whole memory by pressing the button CLEAR.

The contents of the memory are also erased:

- by opening the disc cover using CD OPEN (9);
- by setting the MODE selector ② to another position;
- if the batteries get exhausted or if the power supply is interrupted in another way.
- To play your selection, the CD-player should be in position STOP; then press the PLAY button ▷.
- If the display ⑩ shows the ERROR indicator 'E', you gave an illogical operating command when playing PLAY a stored selection of titles, e.g. if the last track of the selection is being played and you give the command NEXT B'go to the next track'. If such an error has been made, the player will remain in the PLAY mode.

CASSETTE RECORDER

RECORDING

• Set the MODE selector @ to position:

CD (Compact Disc) for:

recording from the Compact Disc player (synchrostart)

RADIO for:

- radio recordings

TAPE (cassette) for:

- recording from the built-in MICROPHONE (7) (set VOLUME control (3) to zero)
- In case of FM radio recordings, set BAND selector (§) to the desired position (FM MONO or FM STEREO).
- Press EJECT to open the cassette holder.
- Insert the cassette (fig. 8). For recording you must use a cassette on which the tabs on the back (fig. 9) are not broken out.

For *recording*, use only NORMAL or FERRO cassettes (ferric oxide, IEC type I).

For playback, any cassette type can be inserted.

 Now start recording by pressing RECORD ●; in doing so, PLAY ▶ is automatically pressed too.

At the very beginning of the tape, no recording will take place during the first 7 seconds when the transparent leader tape passes the recorder heads.

The automatic recording level control ensures that all sounds are recorded at the correct level.

Synchro-Start with a Compact Disc recording:

In position CD it's not necessary to start the CD-player separately: as soon as the RECORD-button • is pressed, the CD-player will start automatically:

- If the CD-player is in position STOP, recording will start from the beginning of the disc (or from the beginning of the stored selection):
- If the CD-player is in position PAUSE, recording will start from this very position;
- In position INTROSCAN the CD-player will first return to the beginning of that track and then recording will start
- When monitoring during recording, adjust the sound with the controls VOLUME ③ and TONE ④. These controls do not affect the recording.

During microphone recordings, monitoring is not possible (set VOLUME control ③ to zero).

- For brief interruptions, press PAUSE II. To restart recording, press this button once more.
- To stop recording, press STOP . On pressing again, the cassette holder will open.
- The set is switched off if MODE selector ② is in position TAPE - RADIO OFF and the recorder buttons are not pressed.

PLAYBACK

- Set MODE selector @ to TAPE.
- Press EJECT and insert a recorded cassette (fig. 8).
- Press PLAY) and playback will start.
- Adjust the sound with the controls VOLUME (3) and TONE (4).
- To stop playback, press STOP ■. The set is then switched off.

COMPACT CASSETTES

For **recording**, use only NORMAL or FERRO cassettes (ferric oxide, IEC type I).

For playback, any cassette type can be inserted.

COPYRIGHT

FAST WINDING AND REWINDING

Press fast forward wind F.FWD → or REWIND ← button. To stop fast winding, press STOP button ■.


END OF THE CASSETTE


When the end of the tape is reached during recording, playback and fast forward winding or rewinding, the pressed recorder buttons will automatically be released.


SAFEGUARD AGAINST ERASURE

To protect a recording e.g. on side 1 of the cassette, break out the tab as shown in fig. 9. Now, recording on side 1 is no longer possible.

You can render this safeguard ineffective by covering the aperture now existing with a piece of adhesive tape.
