Maintenance

- Place the unit on a level surface away from sources of direct sunlight or excessive heat.
- Protect your furniture when placing your unit on a natural wood and lacquered finish. A cloth or other protective material should be placed between it and the furniture.





Charging the iHM27

The iHM27 is powered by a rechargeable battery. When the blue power light dims, or if you start to notice sound distortion at higher volumes, it's time to recharge the battery.

- 1. Connect the micro USB plug on the included charging cable to the USB charging port on the back of the unit
- 2. Connect the larger USB plug to a powered USB port, such as that on a computer. The **Power Button** on the speaker will turn to red while charging and turn blue when fully charged.

Note: you can continue to listen to the unit while it is charging.
