Docking Station for the TPS-6X: TPS-6X-DS

Introduction

The TPS-6X-DS is the desktop docking station that is included as standard with the Isys® TPS-6X Wireless Touchpanel. Placing the touchpanel onto the TPS-6X-DS converts it to a stylish tilt touchpanel, providing wired communications and video capability while charging the touchpanel's internal battery.

Features and Functions

- A stylish desktop dock for the Isys TPS-6X
- Provides a simple battery charging solution
- Affords full-featured tilt touchpanel operation
- Supports wired Ethernet or Cresnet® communications
- Enables balanced or unbalanced video input
- Powered by Cresnet or an optional power pack
- Features a lightweight cable for easy placement
- Includes a TPS-6X-IMCW Interface Module

Versatile Docking Options

The TPS-6X-DS provides both wired Ethernet and Cresnet connectivity to the touchpanel. When the touchpanel is placed on the docking station, it will switch automatically from RF wireless to fully wired operation if either Ethernet or Cresnet is connected. Without a wired Ethernet or Cresnet connection present, the touchpanel will continue to operate wirelessly while it charges. Power can be drawn either from the Cresnet network or a 12 Volt power pack (sold separately). A composite video input is also included to enable the display of full-motion video on the touchpanel screen while docked.

Triple-Lock Tilt Mechanism

The tiltable docking port on the TPS-6X-DS allows the touchpanel to be tilted at any angle up to 45 degrees for optimal viewing and operation. The angle can be freely adjusted during use or locked down at a fixed angle. A finger-operated latch can be engaged at any time to lock the touchpanel securely to the docking station or left unlocked for easiest removal after recharging. For a fulltime tabletop touchpanel solution, the touchpanel and docking station can be semi-permanently attached together using a special locking key pin provided.

Low Profile Base

Its sleek appearance belies a surefooted design offering excellent stability on any flat surface. A single cable exits the rear of the docking station base, which can be repositioned to exit the bottom for a very clean, cordless appearance when permanently mounted.





- 1. The interface module connector fixed onto the TPS-6X-DS is to be connected to the TPS-6X-IMCW's **TO PANEL** port.
- 2. To determine which is pin 1 on the cable, hold the cable so that the end of the ten pin modular jack is facing away from you, with the clip down and copper side up. Pin 1 is on the far left.

Setup


Hardware Hookup

The only connection to the TPS-6X-DS is via the fixed cable, which is connected to the **TO PANEL** port on the (included) TPS-6X-IMCW Interface Module.

When connecting the TPS-6X-DS, consider the following:

- Use Crestron® power supplies for Crestron equipment.
- The included cable cannot be extended.

Recommended Cleaning


The TPS-6X-DS comes in a soft microfiber bag to protect it during shipping. This can be used to clean the docking station.

Operation

Mounting the Touchpanel

To mount the TPS-6X, the touchpanel must first be positioned onto the docking station at a slight angle to latch the top portion of the docking station onto the touchpanel. Magnets on the TPS-6X-DS attach to metal plates installed on the TPS-6X to secure the touchpanel in place (refer to the illustration below).


Touchpanel Mounting



Tilt Adjustment

The TPS-6X-DS head can be tilted 45 degrees from vertical. The amount of resistance on the tilt mechanism can be changed or locked to a desired tilt angle by adjusting the tilt clutch using a 7/64" hex wrench (refer to the illustration below).

Operating Modes


The TPS-6X-DS can be configured into a *lock* mode or *unlock* mode to either secure or release the TPS-6X touchpanel. The touchpanel can also be configured to permanently lock the touchpanel onto the TPS-6X-DS using a locking pin accessory.

Lock Mode

Pull the latch toward the touchpanel or the user as indicated in the illustration below.

When in *lock* mode, the touchpanel cannot be docked or undocked from the TPS-6X-DS.

TPS-6X-DS Lock Mode




Unlock Mode

Push upward on the latch as indicated in the illustration below.

When in *unlock* mode, the touchpanel can be docked or undocked from the TPS-6X-DS.

NOTE: *Lock* and *unlock* modes are mechanical states only. The docked touchpanel will operate in either mode.


Permanent Lock Mode

Ensure the touchpanel is securely placed on the docking station and placed in *lock* mode. Then slide the locking pin accessory straight through the slot of the latch of docking station until the locking pin clicks into place (refer to the illustrations below).

The locking pin can be installed from the left or right side of the docking station with the snap of the pin facing in or out of the slot on the latch.

When in *permanent lock* mode, the touchpanel is permanently secured onto the docking station. While the locking pin is removable, it is recommended that the user only use the locking pin when necessary. Refer to the **CAUTION** below.

CAUTION: Use caution if this locking pin must be removed. Using excess force while removing the locking pin once it has been installed can damage the latch of the docking station and render the locking mechanism unusable.

As of the date of manufacture, the TPS-6X-DS has been tested and found to comply with specifications for CE marking and standards per EMC and Radiocommunications Compliance Labelling.

Merchandise Returns / Repair Service

- No merchandise may be returned for credit, exchange or service without prior authorization
 from CRESTRON. To obtain warranty service for CRESTRON products, contact an
 authorized CRESTRON dealer. Only authorized CRESTRON dealers may contact the factory
 and request an RMA (Return Merchandise Authorization) number. Enclose a note specifying
 the nature of the problem, name and phone number of contact person, RMA number and
 return address.
- 2. Products may be returned for credit, exchange or service with a CRESTRON Return Merchandise Authorization (RMA) number. Authorized returns must be shipped freight prepaid to CRESTRON, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. CRESTRON reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- Return freight charges following repair of items under warranty shall be paid by CRESTRON, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

CRESTRON Limited Warranty

CRESTRON ELECTRONICS, Inc. warrants its products to be free from manufacturing defects in materials and workmanship under normal use for a period of three (3) years from the date of purchase from CRESTRON, with the following exceptions: disk drives and any other moving or rotating mechanical parts, pan/tilt heads and power supplies are covered for a period of one (1) year; touchscreen display and overlay components are covered for 90 days; batteries and incandescent lamps are not covered.

CRESTRON is not liable for any claim made by a third party or made by the purchaser for a third party.

CRESTRON shall, at its option, repair or replace any product found defective, without charge for parts or labor. Repaired or replaced equipment and parts supplied under this warranty shall be covered only by the unexpired portion of the warranty.

Except as expressly set forth in this warranty, CRESTRON makes no other warranties, expressed or implied, nor authorizes any other party to offer any warranty, including any implied warranties of merchantability or fitness for a particular purpose. Any implied warranties that may be imposed by law are limited to the terms of this limited warranty. This warranty statement supersedes all previous warranties.
