The Astoria Bay is designed to turn your inefficient open fireplace into a power house home heater (45,100 BTU/Hour). Adjust the feed rate to low and with the maximum fuel load (82 lbs.), you can expect up to 52 hours of continuous heating. Use the provided wall thermostat and stretch the burn time even longer. The computerized control panel allows you to operate the Astoria Bay manually or change to a fully automatic mode with the push of a button.

The EPA certified Astoria Bay is extremely clean to burn producing just 0.7 grams of emission per hour.
