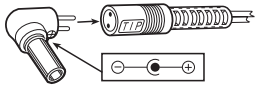




3 / 5 / 6 / 6.5 / 7 / 7.5VDC • 2A AC-to-DC Power Adapter

Using Your Adapter



1. Plug the correct size Adaptaplug onto the jack at the end of the adapter's cord.
 - If your device's DC input jack is marked $\ominus \bullet \oplus$, align **TIP** on the adapter's jack with **+** on the Adaptaplug (shown).
 - If the DC input jack is marked $\oplus \bullet \ominus$, align **TIP** on the adapter's jack with **-** on the Adaptaplug.
- ⚠ CAUTION:** Be sure to set the correct tip polarity. Incorrect polarity can damage your device or the adapter.
2. Plug the Adaptaplug into your device's DC input jack.
 3. Set the adapter's voltage switch to the correct setting.
 4. Plug the AC adapter into an easily accessible power outlet located near the equipment.

Cautions:

- If this adapter is not compatible with the voltage and current requirements of your portable device, it can result in PERMANENT DAMAGE to the device.

- The power adapter's current (2A) must be equal to or more than the current needed by your portable device.
