Gastonia, N. C.,

Tuesday, October 26, 1915.

The Synod of North Carolina met in its One Hundred and Second Annual Sessions on Tuesday, October 26, 1915, at 11:00 o'clock a.m., in the First Presbyterian church, Gastonia, N. C., and was opened with a sermon by the retiring ing Moderator, Rev. R. P. Smith, on the text: "And we know that all things work together for good to them that love God." Romans 8:28.

After the sermon, the Synod was called to order and opened with prayer by the Moderator.

The Synod then took recess until 2:30 o'clock p. m.

FIRST DAY—AFTERNOON SESSION.

Gastonia, N. C., Tuesday, Oct. 26, 1915.

The Synod met at 2:30 o'clock p. m., and was opened with prayer, by the Moderator.

The work of enrollment was completed, and the Synod proceeded to the election of a Moderator. The vote was taken by ballot, and resulted in the election of the Rev. Walter L. Lingle, D. D., of Concord Presbytery, as Moderator. The Rev. J. K. Hall, of Fayetteville Presbytery was elected Temporary Clerk by acclamation.

The following brethren were invited to sit as corresponding members, and were introduced to Synod by the Moderator, viz: Rev. H. F. Beaty, of the Presbytery of Cuba, Rev. S. L. Morris, D. D., of the Synod of Georgia, Rev. W. C. Underwood, of the Synod of Alabama, Rev. W. L. Boggs, and the Rev. A. A. McLean, of the Synod of South Carolina, Rev. J. C. Galloway, D. D., of the Associate Reformed Church, and the Rev. G. W. Belk, of the Synod of Kentucky.

The Committee on Arrangements, Rev. J. H. Henderlite, chairman, made a partial report, recommending that Rev. Dr. S. L. Morris, Assembly Secretary of Home Missions, be heard this evening at 7:30 o'clock, and that he be followed by Rev. W. D. Moss, of Chapel Hill, on the work among Students in State Institutions. The report was adopted, and the Synod took recess until 7:30 p. m., closing with prayer by the Moderator.

FIRST DAY—Evening Session.

Gastonia, N. C., Tuesday, October, 26, 1915.

The Synod met at 7:30 o'elock p. m., together with a large Congregation. The Moderator called the Synod to order and led the same in prayer. The Moderator yielded the chair to the Rev. Byron Clark, D. D., chairman, of the Assembly Home Mission Committee, who conducted the devotional exercises and introduced the Rev. Dr. S. L. Morris, the Assembly's Secretary of Home Missions. Dr. Morris, was heard in an earnest address on the great cause of Mome Missions, and the address was referred to the Permanent Committee on Home Missions.

The Rev. Melton Clark, D. D., chairman, of the Synods Committee on Religious Work among the Students in State Institutions, introduced the Rev. W. D. Moss, pastor of the Chapel Hill church, who addressed the Synod on the Religious Work and Influence among the Students at the University of North Carolina. This address was referred to the Permanent Committee of which Dr. Clark is chairman.

By special invitation, Dr. Thos. P. Harrison, of the A. & M. State College, at Raleigh, North Carolina, also addressed the Synod on the religious influence at that institution. This address was also referred to the Committee, of which Dr. Clark, is chairman.

The Committee on Arrangements made a partial report:— That following the report of the Committee on Religious Work among Students at State Institution, tomorrow morning at 10:00 o'clock, five minutes be given to Rev. G. W. Shipley, to speak in the interest of Albemarle Institute. And that after the report of the Permanent Committee on Publication and Sabbath Schools, tomorrow morning, the Synod will hear Dr. W. J. Martin, President of Davidson College, in the interest of that Institution. Also at 11:00 o'clock tomorrow morning the Rev. Drs. R. F. Campbell, and Wm. E. McIlwaine, will preside at the table and conduct the Communion Service, and the following Ruling Elders will assist in the service, viz.: Geo. W. Watts, A. M. Hoke, Dr. C. N. Strong, E. F. Reid, T. B. Bailey, S. K. Fountain, A. L. James, C. M. Brown, Walker Taylor, Frank A. Brown, Prof. McIntosh, Dr. W. J. Martin, Geo. W. Montcastle, Geo. T. Williamson, and James Choate. Adopted.

Therefore, we do not see the necessity of increasing the apportionments of the Presbyteries, but we do recommend that those Presbyteries, now in arrears, viz: Fayetteville, \$75.00; King's Mountain, \$20.00; and Mecklenburg, \$65.00, be urged to settle with Synod's Treasurer at once so that he may have funds in hands to pay all bills promptly.

The Rev. E. L. Siler, tendered his resignation of the office of Permanent Clerk, to take effect after this meeting of Synod. The resignation was referred to the Standing Committee on Nominations.

The order of the day was now taken up, and the Rev. Melton Clark, D. D., chairman of the Permanent Committee on Religious Work Among Students of State Educational Institutions, addressed the Synod in the interest of the work of the church and pastor at the University of North Carolina, Dr. Clark, also made an appeal for funds for the support of the work, and subscriptions amounting to \$1425.00 were secured.

The Rev. G. W. Shipley, addressed the Synod for five minutes in the interest of Albemarle Institute.

The Synod took recess for ten minutes.

After recess the Synodical Communion, according to Standing Rule, was observed. The Rev. Drs. R. F. Campbell, and W. E. McIlwaine, presided at the table, and conducted the Service, assisted by the Ruling Elders appointed. Following this solemn and delightful Service, the Memorials of the deceased brethren, Rev. J. E. Ballou, and Rev. B. B. Palmer, were read by the Rev. H. B. Searight, and the Rev. Dr. Neal L. Anderson, respectively.

The Memorials were adopted by a rising vote and ordered to be placed upon the Records.

They were as follows:

MEMORIAL OF REV. J. E. BALLOU.

James Eustace Ballou, was born in Winston-Salem, N. C., June 24, 1874. When but a small child the family moved to Danville, Va., where his boyhood and youth were spent. His was the blessed heritage of those who fear the Lord; and through the gracious influences of a Godly home he was led at an early age to give his heart to God, and joined the First Presbyterian church of Danville, of which his father was an honored ruling elder.

He attended Hampden-Sidney College, Virginia, taking the A. B. course, and graduating with honor. He entered Union Seminary in the Fall of 1896, finishing his course in 1899. Both at college and the seminary he was a great favorite. In fact he had a genius for friendship, and by his sweet and winsome personality drew multitudes to him, and held them in the bonds of enduring affection.

Mr. Ballou was licensed by the Presbytery of Lexington, October 19, 1899. His first work was in the Home Mission field as supply of the churches at Elkton and Basic City, Va., from June, 1899 to June 1900, when he became pastor of the fine old Bethany church at Craigsville, Va. Here he labored with fidelity and zeal for six years, greatly endearing himself to the people by his devoted pastoral attentions and

his consecrated Christian life among them. In 1906 he was called to the First Presbyterain church of Middlesboro, Ky., Presbytery of Transylvania, and entered upon his work there in September of that year. His ministry of four years in this thriving mining and manufacturing town was a happy and fruitful one, marked by the same devotion to duty which distinguished his former pastorates.

It was with reluctance that he resigned this pleasant and prospering work to accept the unanimous and urgent call from Tarboro, N. C., in the summer of 1910. He loved his people and received their affection in return to an unworted degree, so that it was always painful to him to part from them and move to a new field. In these changes he conscientiously followed the plain leadings of Providence and the Spirit of God. He entered upon his ministry as pastor of the Howard Memorial church in Tarboro in September of 1910, where he labored with untiring zeal and great success until laid low by his last illness. During his sickness of nearly four weeks' duration everything was done for him by his devoted people that love and skill could suggest. At first his condition was not considered alarming, but when pneumonia developed, grave apprehensions were felt. Under the attack of this dread disease, aggravated by complications, he gradually sank, until death ensued on Thursday night, April 1, at 10 o'clock.

The labored breathing gradually grew weaker, the weary heart refused to respond any longer even to the most powerful stimulants, and God's faithful servant fell asleep in Jesus. We confidently believe that he received an abundant entrance into the everlasting kingdom of our Lord and Saviour, Jesus Christ, for he could truly say, "For to me to live is Christ, and to die is gain."

Enstice Ballou, as his friends and schoolmates fondly called him, was in many ways a rare and remarkable man, a choice and gentle spirit greatly beloved by all who knew him. Beauty and strength, or sweetness and light, were blended in his personality in an unusual manner. He was as modest as a girl, pure as Sir Galahad, and the very incarnation of that charity which "Suffereth long, and is kind; envieth not, thinketh no evil, seeketh not her own, beareth all things, believeth all things, hopeth all things, and endureth all things." The secret of this beautiful soul was its close and constant communion with the Christ—his life was hid with Christ in God. It was this that made him a true and faithful witness of Christ, and a wise and successful winner of souls. Men took knowledge of him that he had been with Jesus, and were won by his Christian character and conversation.

As a Presbyter Brother Ballou was regular in his attendance on the courts of the church, profoundly interested in their work, and faithful to every responsibility imposed on him.

His preaching was earnest and evangelical, directed toward the conversion of sinners and the edification and comfort of believers. But it was as a pastor that he excelled. He had peculiar gifts for this tender and beautiful office and succeeded to a rare degree in gaining the confidence and affection both of his own people and of outsiders, and of turning this advantage to the good of their own souls and to the glory of God.

Our lamented and beloved brother abounded in the work of the Lord. He regularly preached three times on Sunday, besides teaching a large Bible class. In addition to his work in Tarboro he preached at numerous mission points in the adjacent country regions, and held frequent prayer meetings during the week in homes, school houses, etc., thus doing the work of an evangelist, and making full proof of his ministery. While taken away in the midst of his days, in the strange Providence of God, he had in fact finished his appointed course, and has gone to receive that crown of life which the Lord has promised to those who are faithful unto death.

The funeral services were conducted by his brethren of the Presbytery in the church which he loved so well, and were attended by a large concourse of sorrowing friends. His body was then taken to Danville and buried beside his father and mother.

Soldier of Christ! well done, Praise be thy new employ; And while eternal ages run Rest in thy Saviour's joy.

REV. BENJAMIN BOSWELL PALMER.

In the death of Rev. Benjamin Boswell Palmer, who fell asleep at his home near Milton, N. C., on May 14th, 1915, the church has lost one of her faithful servants, who represented the rapidly diminishing class of negro ministers who were reared in the heart of the old South. Brother Palmer carried with him into the new era the spirit of affection for the white people, and his genuine humility and the gentility of his manners endeared him to his brethren throughout the years of his ministry.

He was born in Sumter, S. C., in 1845, deprived of his parents at an early date they left him to the care of Miss Kate Morehead, who trained him for college and sent him to Lincoln University in Pennsylvania, where he graduated.

He began his career as a teacher near the historic Presbyterian Church at Red Honse in Caswell County, and was licensed to preach the Gospel by Orange Presbytery at New Bern, April 28th, 1878, and ordained to the Gospel ministry at Mebane, N. C., on Sept. 16th, 1892, except for a period of eight months spent in organizing and building a church at New Bern, Brother Palmer's entire ministry was spent in Caswell County. For years he was pastor of the Elim church, ministering to it in connection with his school work in which he was most successful.

The county papers speak of him as a "pioneer teacher and preacher of the colored race, a man of education and good sense, whose manner of walk and good work early commended him to the respect and confidence of the white people of the County." It adds, "the successful conduct of his school is a lasting tribute to his memory. lle was always modest and polite, and sought to impart to his race only those ideals and views which were sensible, wholesome and good, and he reared a family of children who reflect in their conduct the high character of his teachings."

The brethren of Presbytery and Synod will long remember the dignified, courteous, modest and humble brother, who was always welcomed by them at the meetings of the Church Courts, and on the few occasions in which he spoke was listened to with respectful interest. Never violating the proprieties of the situation, that another might have made delicate and embarrassing to himself and others, Brother Palmer won and maintained the confidence and affection of his brethren in the Lord.

He died in the midst of his family, who were gathered at his bedside in prayer, and his last whispered words were: "The Lord! The Lord is right, and all He does He does right, and all who serve Him are right—all is right."

closing with prayer by the Moderator, the afternoon being given by Standing Rule for the work of the Committees.

SECOND DAY—Evening Session.

Gastonia, N. C., Wednesday, Oct. 27, 1915

The Synod met at 7:30 p. m., together with a large congregation and resumed business. A popular meeting in the interest of Foregin Missions was held, with the Rev. J. M. Wells, D. D., chairman, presiding. Dr. Wells read the annual report of the Committee on Foreign Missions which was received, and pending its adoption, the Rev. Dr. Egbert W. Smith, the Assembly's Secretary of Foreign Missions, was introduced and addressed the Synod. Also, addresses were made by Rev. W. C. McLauchlin, under appointment to China, Rev. N. G. Stevens and Rev. R. D. Beddinger, of the African Mission.

The report was then adopted and is as follows:

REPORT ON FOREIGN MISSIONS.

Your Committee on Foreign Missions present the following report:

We would call your attention to the fact that the Assembly's Committee on Systematic Beneficence, after a careful examination of the work of our Committee of Foreign Missions, report the most successful year in the history of the work.

I. Blessings—There were 4,059 additions reported from our field, about, which is 542 more than the year before, and the largest number ever reported in any year.

This is an average of thirty-eight to each ordained Missionary; whereas the average to each minister at home is only ten.

The growth of our work in the past ten years has been wonderful.

The number of our Missionaries has increased 75 per cent. Our native force has increased 458 per cent: Our out-stations has increased 252 per cent. The number of communicants has increased 244 per cent. The number of adherents has increased 635 per cent. The Sunday School membership has increased 485 per cent. And our receipts has increased 157 per cent.

The doors in every field are opened wider than ever before.

II. Advance Steps—The standard of qualifications required of candidates to go to the foreign field has been distinctly raised.

The work of the Rockerfeller foundation, in planning for a great advance in Medical Educational and Hospital work, promises to be a great blessing to our Medical Mission work.

And the Panama Conference to consider all plans of work in Latin America, should be of large importance in our work in Mexico, Cuba and Brazil.

III. Financial—The total receipts for last year were \$544,162. The total deficits for the last two years amounted to \$63,286. The total amount absolutely needed for this year is \$570,000. The amount raised during the first six months of the year is \$139,000. The amount approtioned to our Synod was \$110,000. The amount raised by our Synod for the first six months was \$28,341.

In face of the depression caused by the war, and the low price of cotton we rejoice that the regular Foreign Mission gifts were more this year than last. The native Christians gave \$56,422, a gain of 35 per cent over the year previous. The work has been administered with rare economy, the cost of administering the work being only 6.6 per cent. The three weeks in February have been given to the cause of Foreign Missions, in addition to May and October no longer "Special."

- IV. Recommendations-1. We ask our Ministers to keep this great cause before our people by frequent sermons on the subject.
- 2. We advise the judicious use of literature in our congregations to teach and stimulate our people.
- 3. Our churches are urged to send representatives to the nearest convention of the National Missionary Campaign held this winter.
- 4. That we call our pastors and people to prevailing prayer for this great cause.

5. In view of the vastness of the need and opportunities, we eall our Synod to more sacrificial giving toward this work.

The Synod then adjourned with prayer by the Rev. C. E. Raynal, D. D., to meet tomorrow morning at 9:00 o'clock.

THIRD DAY—MORNING SESSION.

Gastonia, N. C., Thursday, Oct. 28, 1915.

The Synod met at 9:00 o'clock a. m., and the devotional exercises were conducted by the Rev. J. S. Sibley, D. D.

The Minutes of yesterday's sessions were read and approved.

On motion, the order of the day for 10:00 o'clock was changed to 10:30 o'clock.

Dr. W. J. Martin, President of Davidson College, was now heard with great interest in behalf of Davidson College.

Dr. Thornwell Jacobs was heard in a brief address in the interest Oglethorpe University.

The Rev. Messrs. Thornwell Jacobs, of the Synod of Georgia, and R. T. Chafer, of the Synod of South Carolina,

were invited to sit as Corresponding Members, and Revs H. H. Jordan, of the M. E. Church, South, and J. C. Deats, of the Lutheran Church, were invited to sit as visiting brethren, and all of them were formally introduced to the Synod.

The Rev. Neal L. Anderson, D. D., chairman, of the Permanent Committee, on Systematic Beneficence, submitted and read the report of the Committee, which was received, and pending its adoption the Synod was addressed by Mr. R. E. McGill, Secretary of Publication and Sabbath School Work. In view of the standing order of the day, the report went over as unfinished business.

The Rev. C. G. Vardell, D. D., by common consent, read a newspaper clipping, for the imformation of Synod, describing a gift to the Flora McDonald College from India.

The Synod now heard the report of the Regents of the Orphans' Home. The Rev. W. S. Wilson, D. D., presided and conducted the devotional exercises, after which the report was read by Dr. H. G. Hill, President of the Board of Regents, and pending action on the report, Dr. Hill addressed the Synod on the aims and results of the Home. The report was now received and referred to the Standing Committee on the Report of the Regents of the Orphans' Home.

The Permanent Committee on the Bible Cause submitted their report through the Rev. E. L. Siler, chairman of the Committee. The report was received and adopted as a whole, together with its recommendations, as follows:

REPORT OF COMMITTEE ON THE BIBLE CAUSE.

Your Committee on the Bible Cause would call attention to the fact that last year the American Bible Society distributed more Bibles than in any of its history, and while it felt very keenly the depressing influences of the war in Europe, not only in the distribution of Scriptures in some quarters, but especially as regards contributions

in the home land, still there is much in the work of the past year which calls for sincere gratitude to God and thanksgiving for His signal blessings which He has bestowed on this agency of His Kingdom.

We would also remind the Synod that the very successful World's Bible Congress was conducted in connection with the Panama-Pacific Exposition, which was epoch-making in the history of Bible distribution.

We call attention to the fact that our Synod was asked to contribute last year \$1,678. We gave \$1,389, which, however, was an increase of \$44.00 over the contribution of the previous year.

The following Presbyteries exceeded their apportionments: Asheville and Wilmington.

The following fell short of their apportionments: Albemarle, Concord, Fayetteville, King's Mountain, Mecklenburg and Orange.

We recommend:

1st. That Synod apportion the Presbyteries the same as last year, as follows:

Your Committee on Woman's Work would respectfully report as follows:

The President of the North Carolina Synodical has furnished your chairman with minutes of the meeting of that body, a program of the meeting of the Women's Council held in Memphis, and a recently adopted constitution of the Women's Auxillary, with other detailed reports, in all of which we find nothing calling for special action on the part of Synod, and nothing but that which is to be commended.

We note that the "Council" is hereafter to be called "The Woman's Advisory Committee," and that the officers for the present year are: President—Mrs. W. B. Ramsay, Hickory; Vice-Presidents—Mrs. J. M. Melver, Gulf, Mrs. E. C. Murray, Greensboro, Mrs. J. M. Baker, Tarboro, Miss Madeline Orr, Charlotte, Mrs. E. D. Brown, Loray, Mrs. G. V. Patterson, King's Mountain, Mrs. J. A. Brown, Chadbourn; Secretary—Mrs. W. T. Bannerman, Wilmington.

The Synodical is to hold its meetings at different points in the State, instead of at Montreat, as heretofore.

We recommend: That Synod express its very hearty appreciation of the loyal, devoted, and efficient co-operation of our women in the work of the Lord entrusted to us.

Rev. E. C. Murray, Treasurer for Orange Presbytery, reports Collections \$951.12, which was disbursed as follows:

An increase over last year is noted in the amounts received from Albemarle and Concord Presbytery, and a small amount from Kings Mountain Presbytery, which last year sent none. Wilmington and Fayetteville Presbyteries show a decrease, the latter doubtless because of its action at the recent spring meeting. The other Presbyteries send no funds through the Synodical Treasurer, though Mr. Murray, the Treasurer of Orange Presbytery, sends in a report which is appended to the report of Synod's Treasurer as information. Two Presbyteries have decided to act independently of the Synod's Committee and your Chairman would report that there appears to be rather a discouraging outlook in this matter. At the same time your Committee would earnestly urge the Presbyteries to secure harmonious team work in the interest of all their educational institutions.

I append to this report the minutes of the First and Second meetings of the Presbyterian Educational Association of the South. The organization of this body was completed during last July at Montreat. I would suggest that this paper, and Dr. Sweets letter be referred to a special committee for report at this meeting of Synod, and would call especial attention to the subjects of "Student Aid" and "Synodical Organization" in the paper on the Association.

Dr. W. J. Martin tendered his resignation as Chairman of the Permanent Committee on Schools and Colleges. The resignation was accepted and the vacancy referred to the Standing Committee on Nominations.

The Synod then took recess until 2:30 o'elock p. m.

THIRD DAY—AFTERNOON SESSION.

Gastonia, N. C., Thursday, Oct. 28, 1915.

The Synod met at 2:30 o'clock p. m., and resumed business.

On motion the papers of Dr. W. J. Martin, concerning the Educational Conference at Montreat this summer, were referred to the Ad-interim Committee on Schools and Colleges.

An invitation was received from the business men of Gastonia, to take the Synod in automobiles for an outing, this afternoon at 4:00 o'clock. In view of the pressing business, the Synod respectfully declined the invitation, with thanks.

The unfinished business, viz.: The report on Systematic Beneficence was taken up, and the report as a whole was discussed, amended and adopted, together with the recommendations, as follows:

SYSTEMATIC BENEFICENCE.

Your Committee on Systematic Beneficence, begs to submit the following report:

STATISTICAL

The past year has been marked by the generous gifts of our people to all the cause of Beneficences. For all causes, exclusive of gifts to the local congregation the churches gave \$352,472, this being twenty-three per cent of the amounts given for these causes by all the churches of the Assembly.

For the four Assembly causes the Synod gave \$193,626, or nearly one-fourth of all given by the whole Assembly for these causes. It may be interesting to note that the Synod's of North Carolina and Virginia, contributed forty per cent of the gifts to all causes of beneficences last year, and thirty-eight per cent of the amounts contributed to the Assembly causes.

Practically one-third of the churches are reported as having undertaken the Every-Member-Canvass during the past year, and the results as illustrated in the chart exhibited in connection with this report is conclusive proof of the importance of this canvass to the development of the spirit of giving among our people.

Considering all the four Assembly causes the churches of the Synod contributed fifty-nine per cent of their total gifts to these causes to Foreign Missions, and eight per cent to Assembly Home Missions.

Adding to Assembly causes, the other causes of Home Missions, the churches of the Synod gave forty-eight per cent to Foreign Missions, and thirty-seven per cent to Home Missions.

Amount apportioned Synod by the Assembly last year,	\$194,721
Amount apportioned churches by Presbyteries,	143,921
Amount raised by churches for Assembly causes,	193,626

It thus appears that the churches of the Synod raised \$50,000 more than the amount apportioned by Presbyteries, and practically the amount apportioned by the General Assembly. This statement, however, must be discounted by the fact that of the total gifts for Assembly causes \$50,000 was an individual gift to Ministerial Relief, and will be scarcely duplicated another year.

Deducting this amount, it appears that the total raised by the churches was approximately the amount apportioned by Presbyteries, and some \$50,000 less than amount asked for by Assembly. The churches, however, gave as stated above fifty-nine per cent to Foreign Missions and only eight per cent to Assembly Home Missions.

Taking up the relation of the gifts of the churches to the apportionments by Presbyteries we find that with reference to the Assembly Causes,

Thus in the majority of our Presbyteries the amount raised were far below the amount asked for by Presbytery, being in one Presbytery less than half. In Wilmington and Orange the large excess over apportionments must be in part attributed to large individual gifts, and in Albemarle to the exceptionally low apportionments made by Presbytery.

APPORTIONMENTS

Your Committe has secured in every Presbytery the adoption of apportionment tables for the coming year at the Fall meeting of Presbytery, and consequently it has not been possible for the Synod to make the apportionments of the Assembly Causes to the various Presbyteries. The value to the eauses of having the apportionment tables adopted at the Fall meeting of the Presbyteries, in the judg-

ment of your Committee, far outweighs any disadvantages arising from the fact that the Synod itself has no part in dividing the Assembly budget among its Presbyteries.

So long as the churches have not been brought up to the standard set by the Presbyteries themselves this is not so serious a matter.

The greatest confusion has arisen in the churches and among the different societies owing to the fact that the percentage tables sent down by Assembly include only the five causes of the Assembly itself, while the plan of the Every-Member-Canvass involves the making up of a budget including all the causes of beneficence.

Inasmuch as the Presbytery itself, in the judgment of your Committee, alone has authortly to deal with the matter of the apportionment of the individual churches we have solved this difficulty in a very simple way, which we trust will be put into effect in all of our churches: The Presbyterial Committee on Systematic Beneficence in making up the table of apportionment for the churches takes into consideration the whole benevelences of the church, as was designed from the inauguration of the new plan, in making up this budget the Assembly causes are given their proportion of the total budget in accordance with the deliverances of that body, and under the name of each cause in the Table of Apportionments is placed the percentage it bears to the whole table of apportionmnts. Thus any Session or Deacon's Committee can at once determine the distribution of any undesignated funds.

Your Committee would earnestly call attention to the importance of this method of handling the new plan, and to the confusion caused by the Executive Secretaries of the Assembly communicating with the different organizations of the congregation urging them to give amounts to the causes in proportion to the tables of the Assembly, which were designed to represent only these five out of all the causes of benevolences, while the Assembly itself has repeatedly instructed that there should be a general Beneficence Budget embracing all causes. The Assembly's instructions are that the Presbyteries "see that the apportionments made by the Assembly reach each Church Session" and that these "apportionment include also the amounts needed for the local work of those courts, in addition to the Assembly needs, and further that the Sessions of the individual churches add to these apportionments the needs of their respective local beneficences before the budget is announced to the congregation or the subscription taken---' Minutes, 1915, p. 53.

The method suggested by your committee simplifies the working out of these instructions through the Presbytery's Table of Apportionments itself.

Inasmuch as our Presbyteries are not yet securing from their churches, even the amounts they apportion, we would urge that it is of vital importance that congregations bend every energy to raising their full apportionments, and that the Sessions unify as far as possible all the organizations of the local churches in an effort to meet in full every apportionment made by Presbytery.

In our judgment there is nothing more important in the working of the new plan than to have it made as simple and easily understood by the people as possible, and that its essential features be kept prominently before the churches.

The Committee would emphasize the fact that the pastor is the key to the situation and upon his consecration, zeal and enthusiasm, depend the success of any plan of beneficences.

The Elders' and Deacons' Conventions inaugurated by your committee some years ago have in several Presbyteries been taken over by the Committee on Evangelism with excellent results to both causes. We believe such conventions ought to be part of the life of every Presbytery, as affording opportunities for the development of interest on the part of these officers.

We recommend:

- I. That the Synod re-affirm its confidence in the new Plan of Beneficences.
- II. Persistent all-the-year-round efforts on the part of Presbyterial Committees to secure full apportionment from every congregation.
- III. Renewed and persistent efforts to secure the introduction of Every-Member-Canvass into every church.
- IV. That Presbyteries be requested to designate churches making the every-member-canvass by some such symbol as "E. M. C." in the the Table of Apportionments.
- V. That churches receiving aid from the Home Missionary Treasuries be stimulated to introduce the every-member-canvass by pressing upon them their peculiar obligation of loyalty to the system adopted by Assembly, Synod and Presbytery.

VI. That Sessions be directed to call to the attention of the Diaconate the fact that the essential function of their office under their vows of ordination is for the care and distribution of the beneficences of the congregation.

VII. That the Sessions be urged to unify the work of their churches so far as possible by having all benevolent funds pass through the hands of the Treasurer of Beneficences.

VIII. That for the information of its Presbyteries, Synod define an every-member-canvass church as one in which there is a canvass made of every member of the church for the causes of beneficence as distinguished from the needs of the local church, and the funds raised for beneficences are kept entirely separate from funds raised for local causes.

NEAL L. ANDERSON, Chairman.

The report of the Permanent Committee on Assembly Home Missions was submitted by the chairman, Rev. Byron Clark, D. D. The report was received and adopted with its recommendations. The report is as follows:

Your Committee on Assembly's Home Missions, offers the following report:

We have heard with marked interest the helpful and heart-stirring address of our Secretary of Assembly's Home Missions, Dr. S. L. Morris, and wish to express our deep appreciation for the services he is rendering to the church in this great work.

The immensity of this work is seen when we consider the enormous territory covered, the scarcity of ministers and money, the inadquate equipment of many of our fields, the disintegration of many rural churches, the educational needs of backwood sections, the increased immigration of recent years, and the problems arising from two races living in the entire South, the opportunities of work among the mountaineers of several States, the increased cost of living, and a number of other questions confronting the work.

Last year, \$180,000 were expended, and nearly 500 missionaries were employed by the Committee.

It is a matter of serious concern that we have not fewer than 250 organized churches having no house of worship, and it is of thrilling interest to know that at least 275 churches could be organized

immediatly, if needed financial assistance could be given. In addition to the great number of silent pulpits in our Assembly, at least 500 more churches would be without pastors, if the Assembly's aid should be withdrawn.

We cannot afford to organize churches which we are not able to sustain, and for every dollar spent in evangelistic efforts looking towards organization, at least ten dollars are necessary for the maintenance looking to self-support. Weak, but promising, churches are conserved, and some of the strongest churches now on the Assembly's roster once received the Assembly's aid.

Consider, too, the rich possibilties of our work among the three million mountaineers within our bounds, and that as yet we have done only an infinitesimal part of the work. There are forty-five Missions and day schools dependent on the Assembly's funds and these are community centers. \$85,000 are needed to equip our schools alone. These mission churches and schools are splendid investments which declare rich dividends in conversions and workers in Christ's kingdom.

Let us also remember Lazarus at our door. There are 9,000,000 negroes within our bounds, and we are compelled to confess that there is very little apparent interest in their spiritual welfare. There is ample opportunity here for doing the Lord's work among those who are precious in His sight. Fireside Bible Classes, Sabbath Schools, Churches and other work among these wards of our South should receive our careful though belated attention.

We can only mention the hundreds of thousands of Mexicans who have flocked to our borders since the Mexican Revolution began. Nor can we do more than mention the fact that on an average about 250,000 foreigners return to their native lands every year. If won for Christ they could be an immense power in the evangelization of the nations. Many of this class are being reached and thus we are doing a foreign missionary work.

We recommend:

- I. That the Synod of North Carolina repeat the appeal of the Newport News Assembly to emphasize the distinctive place of Assembly's Home Mission, and accord to the Executive Committee a large place in the thinking, praying and giving of the Church.
- II. That Presbyteries, pastors and churches be urged to recognize the twenty-seven per cent allowed for Assembly's Home Missions, as the just and fair proportion of the Assembly's benevolences.

III. That churches and pastors be urged to observe Home Mission week, November 21-28, and that Sunday School Superintendents be urged to observe Chrildren's day for Home Missions on November 28.

BYRON CLARK, Chairman.

The Rev. Dr. J. R. Bridges, was heard in the interest of the *Presbyterian Standard*, and his address was referred to Special Committee consisting of Rev. Leonard Gill, Rev. J. W. Orr, Rev. Neal L. Anderson and Elder J. P. Russell.

The Rev. A. W. Crawford, was heard in the interest of the Church and Manse Erection Fund. At the close of the address, Bro. Crawford introduced to the Synod, Miss Essie Johnston, his helper in connection with the Church and Manse Erection Fund.

The Rev. W. C. Barrett of the Baptist Church, and Rev. W. L. Killiam of the M. E. Church, were invited to sit as visiting brethren and introduced to Synod.

The Standing Committee on the Narratives, to formulate an Address to the Churches, Rev. D. H. Rolston, D. D., chairman, submitted the following address which was adopted and ordered to be published in the *Presbyterian Standard* and read from the pulpit by all our ministers:

COMMITTEE TO REVIEW NARRATIVES OF PRESBYTERIES AND PREPARE AN ADDRESS TO THE CHURCHES.

Your Committee reports that narratives on the state of religion from all the Presbyteries, except the Presbytery of Albemarle, have been placed in our hands. From the information furnished us in these narratives we recommend the following address to the Churches:

I. The faithfulness of our people generally in attendance upon the services of the sanctuary is a cause for rejoicing and is heartily commended by the Synod.

Churches in towns and cities that are somewhat discouraged because of poor attendance of members and others upon the Sabbath evening services are exhorted to give more attention to the matter of making the evening service serve a distinct purpose in the church, making it as thoroughly evangelistic as possible, and seeking to enlist the interest and sympathy of the people, especially the young people in personal work and the ministery of sacred song in connection with this service as a probable means for securing improvement in attendance upon it.

- II. The family alter is still apparently much neglected. Pastors, elders and deacons should do all in their power by precept and example to establish the family alter in homes in their congregations where it is now neglected.
- III. The general report of a well-observed Lord's Day on the part of the members of our churches is to be heartily commended. However, there are exceptions to the general conditions that require a word of caution touching this important matter. Occasional presentations of the Scripture doctrine concerning the proper observance of the Lord's Day from the pulpits of our churches, and carefulness of example on the part of officers and members of our churches is necessary to prevent laxity of views and sinfulness of practice in this matter so vital to the cause of true religion. The doctrine of the Lord's Day as a holy-day rather than a holiday must be zealously promulgated to counteract the drift of the times in the wrong direction.
- IV. Concerning the training of children in the Scriptures and catechisms, Synod would remind the churches that no amount and no degree of excellence in this work on the part of the Sunday schools, whose work is to be most heartily commended, can take the place of instruction of children in religion in their own homes and by their own parents. Parents cannot shift this responsibility to any others. The family is God's appointed institution for the rearing of a Godly seed and by it the work of early training must be faithfully done if the best results are to be obtained. The Sabbath school is to be commended and encourged as aid to, rather than a substitute for, the home in the religious instruction of our youth.
- V. Judging from the reports from the Presbyteries our people are growing in faithfulness in worshipping God with their substance. Synod would exhort to a diligent cultivation of this grace throughout our bounds. Synod also calls upon the churches to be faithful in the temporal support of the ministry that the spiritual work of the ministry be not hindered.

VI. Synod would record its profound gratitude to the Triune God for special manifestations of the Holy Spirit's presence and power in many of our churches. There seems to be the sound of going in the tops of the mulberry trees, and pastors and churches are exhorted to press forward courageously in the work of private personal and public evangelism. World affairs for the past year seem to have rendered men more scrious-minded than they have been hitherto and it seems that harvest of souls are ripe for the reaping. Let us enter in and gather fruit unto life eternal.

VII. Worldly conformity is not reported as widely prevalent but it is easily evident that there is still too much of it for the good of the church. The churches are exhorted to set their faces steadfastly against it and by precept and example to steadfastly reprove, rebuke and exhort with all long-suffering and doctrine.

"We beseech you brethren by the mercies of God that ye present your bodies a living sacrifice, acceptable to God, which is your reasonable service and be ye not conformed to this world, but be ye transformed by the renewing of your mind that you may prove what is that good and acceptable and perfect will of God."

Finally, brethren, be strong in the Lord, and in the power of His might.

You will note that there are only 214 Young People's Societies reported, a decrease of 3 Societies since last year.

We would call the attention of this body to the action of the last Synod, "That the Synod earnestly recommend that each of its pastors and sessions consider anew the training of their young people in sociteies which embody the pinciples of the Christian Endeavor Movement, and which shall be subordinated to the authority of the session."

Realizing the supreme importance of properly training our young people to be the future leaders in our church, we earnestly urge our pastors to organize our young boys and girls into the Covenanter and Miriam societies or Junior Christian Endeavor, the older ones into some societies like the Christian Endeavor.

The Report of the Permanent Committee on the Sabbath and Family Religion was received and adopted, and is as follows:

REPORT OF COMMITTEE ON SABBATH AND FAMILY RELIGION.

Your Committee on the Sabbath and Family Religion respectfully reports: that from the sources of information furnished, we find considerable difficulty in determining the true status of these most important aspects of vital religion, but we are led to report a retrogression, accounted for, not so much from a declination in vital piety within the church, or lack of moral principle without it, but rather because of the couditions that have arisen through the spirit of the age in which we are living. The spirit of commercialism that so dominates the present time, causing so many to "look upon the things that are temporal," has led many to neglect "the things that are eternal" and in no respect is this more patent than in the matters of the Sabbath and Family Religion.

The fact that today so many are running "to and fro" as a result of multiplied modes of travel, is a cause of much Sabbath desecration, and of violation of the true spirit of the Lord's Day.

Your committee believes that even greater than the baneful influence of the violation of the "Sabbath Law," is the growing neglect of the "Lord's Day Obligation" which is manifesting itself in an ever-increasing failure to attend the services of the House of God by an ever-increasing number of the members of our churches.

Regarding the matter of Family Religion,, your committee, from information in hand, is compelled to report, that this exceedingly important duty, which is really the solution of so much that is vital to spiritual power and progress in Church life, and to individual piety and growth, is sadly on the decline. The rebuilding of the family altar, and the return to Bibical instruction in the homes of our people, will prove to be the greatest potences in the preservation of a holy Sabbath.

RECOMMENDATIONS.

- 1. That Presbyteries be asked to devote at least one hour at either the Spring or Fall meeting to the consideration of "Ways and Means" for the advancement of these important objects.
- II. That the week in January generally designated as the "week of Prayer," be observed as recommended by the General Assembly's

committee on Sabbath and Family Religion, viz:—That the five nights set apart for this purpose be observed as follows: Monday, Tuesday, Thursday and Friday evenings be devoted to the four Assembly's causes, and that Wednesday evening be devoted to the consideration of Family Religion with a view to the revival of family alters, and their erection where they have not before existed.

H. E. GURNEY, Chairman.

The Standing Committee on the Report of the Directors and Trustees of Union Theological Seminary, Rev. W. McC. White, D. D., Chairman, made the following report which was adopted, and pending its adoption the Synod heard an address on Union Theological Seminary by Dr. W. L. Lingle, the Moderator, one of the Professors of the Seminary. (See the Report of the Board in the Appendix.)

The Committee on Union Theological Seminary begs to report as follows: The information imparted to the Synod of North Carolina through the annual report of the Board of Directors of the Seminary can but cause us to "thank God and take courage." It is highly gratifying in many particulars, some of which are noted below:

- I. The large number of students in attendance, 105, of whom all but 17 were accredited college graduates;
- II. The appointment of Rev. Eugene C. Caldwell, D. D., to the Chair of Bible and Literature and New Testament Exegesis, and of Rev. Edward Mock, D. D., to the Chair of Hebrew and Old Testament Exegesis. The addition to an already strong faculty of these men, whose soundness in the faith and large abilities and deep piety are well known throughout the Church, must cause this school of the prophets "to go from strength to strength," becoming continually more potent for good in the work committed to it;
- III. The publication in book form of the valuable lectures, that have been delivered on the James Sprunt foundation to be permanently preserved and made available to all, will widen the influence of these most profitable lectures.
- IV. The continual improvement of the "Union Seminary Review," the election of an executive officer to serve the Seminary, installation of a central heating plant, and the safe financial situation all tend to indicate satisfactory conditions obtaining in the Seminary.

- V. Among the items of interest reported to us is to be noted with our special pleasure and approval is the introduction of a full and thorough three years course without Greek and Hebrew for candidates recommended by the Presbyteries to the Seminary for instruction with these omissions. This is just one of those advance steps so quietly taken by this institution that prove it to be awake to the church's needs as well as truly aggressive progression in all right direction.
- VI. Lastly, we cannot fail to say that the Synod of North Carolina has cause to congratulate itself and to give thanks to the Head of the Church, that we have a Seminary with so strong a body of instructors, whose learning, orthodoxy, consecration and spiritulity command the unquestioning confidence of the Church, an institution from within whose walls the Church may receive ministers into her bosom with full assurance as to the principles instilled into these young men, who, in these times of disbelief prevailing and appearing in most unexpected quarters, stand firm in the faith of our fathers. For such an institution located within our bounds to supply our pulpits, we can never be too thankful.

Your Committee has but two recommendations to offer:

- 1. That the directors, Rev. D. I. Craig, D. D., and Mr. C. M. Brown, whose terms expire this year, be re-elected to succeed themselves for a term of five years.
- 2. That, in the view of the formation of the Appalachian Synod, within whose bounds our director, Rev. R. F. Campbell, D. D., resides, the Synod of North Carolina, makes no appointment of a director to fill the place made vacant by the removal of Dr. R. F. Campbell from our bounds, but instead to invite the Synod of Appalachia to share with the three controlling Synods in the management and maintenance of Union Seminary, and to appoint a director to fill the place vacated by Dr. Campbell. It is further recommended that the Synod of North Carolina suggest to the Synod of Virginia that it do likewise and request the Synod of Appalachia to elect one director in place of one now elected by the Virginia Synod.

The Synod took recess until 7:30 o'clock p. m.

THIRD DAY—Evening Session.

Gastonia, N. C., Thursday, Oct. 28, 1915.

The Synod met at 7:30 o'clock p. m. together with a large congregation, the Rev. A. W. Crawford, Superintendent of Synodical Home Missions, presiding. After the devotional exercises and pending the presentation of the Home Mission report, Mr. R. E. Magill, Assembly's Secretary, was heard in the interest of Publication and Sabbath School Work in its relation to Home Missions. At the close of this address the Synod was led in prayer by the Moderator.

The Rev. A. W. Crawford, Supt., then presented and read the report of the Committee on Home Missions, which was received. Pending the consideration and adoption of the report, addresses were made by the Superintendent, Rev. Dr. O. G. Jones, Evangelist, Rev. J. K. Hall and Rev. A. T. Lassiter.

During the consideration of the report, in accordance with the recommendation of the Committee it was moved and adopted that the Standing Rule, fixing the time for hearing the report on Home Missions, be changed, and that hereafter the consideration of Synodical Home Missions be fixed for Wednesday evening and that the consideration of Foriegn Missions be fixed for Tuesday evening. The recommendations of the report were adopted, one by one, and the report as a whole was adopted, and is as follows:

REPORT OF THE SYNODICAL HOME MISSIONS COMMITTEE.

With profound thankfulness to God for the seal of His blessing which He has put on the Home Mission Work of the Synod throughout its history, and with especial gratitude for His blessing in the year that has closed, your Committee would respectfully present this, the 27th annual report of the work committed to it.

The closing year has been in the main and essential features among the very best in all the history of the work. There has been a large increase in professions of faith and in additions to the church over most previous years and we have had more men in the work than any previous year. There has also been a good increase in contributions over last year and over most preceding years, but this increase is not commensurate with the increase in the work, and we would candidly report to the Synod that we are unable to do the work which the Lord has opened to us and into which he is thrusting us with the contributions which the churches have been placing at our disposal.

Figures are often uninteresting to many, but when they stand for souls saved and the kingdom of our Divine Lord extended, they are more eloquent than any oratory.

We have had engaged in the work the Superintendent, our two General Evangelists, Rev. Messrs. William Black and O. G. Jones, D. D., and 36 men in the local fields.

Our Evangelists report in brief, as follows:

Rev. William Black reports:—16 meetings held inside the bounds of the Synod. In these meetings 860 professions of faith; 290 additions to the Presbyterian Church; 1 church organized; 1 Sunday school organized; \$1103.79 raised for Synod's Home Missions; \$1527.87 raised for congregational and other purposes; 188 persons promised to establish family worship; 3000 persons promised to read the Bible and to pray daily.

He also prepared the programs for three Elders' and Deacons' Institutes on Evangelism and conducted one of these Institutes in which 100 or more persons pledged themselves to engage in personal service for the winning of souls. He was absent holding meetings in other States for nearly two months without salary from the Committee. In this work out of the State we rejoice likewise in the blessing of God in over 400 professions of faith and 120 additions to the Presbyterian Church.

Rev. O. G. Jones reports that he has held 19 meetings in the Synod in which there were 891 professions of faith; 264 additions to the Presbyterian Church; 2 churches organized; 5 Christain Endeavor Societies organized; \$616.00 raised for Synod's Home Missions; \$205.00 raised for other purposes.

In the report of the 36 men in the local fields, especial attention is called to the splendid results of Local Evangelism, single men reporting as high as 80 additions in their own fields.

SUMMARY OF THE SYNOD'S WORK.

Adding the reports of the General and Local Evangelists we have

the summary of the whole work for the year: 39 men employed for the whole or a part of the year; 85 weak organized churches and 40 other missions stations regularly supplied; 3749 sermons preached; 2333 professions of faith; 1164 additions to the Presbyterian Church; 16 Sunday schools organized; 10 churches organized; 3 church buildings erected; \$2150.00 raised for the Synod's work.

A full financial statement is appended hereto, in which we note especially that to support this work we have received from the churches and individuals of the Synod \$10,436.13, all of which we have expended in the prosecution of the work. In addition, we have borrowed from the bank, \$2000.00, to cover a past indebtedness (about \$500.00) and to prosecute the work, and we are due the workers in the field \$920.08 to October 1st.

THE OUTLOOK.

We emphatically state to the Synod that we believe our Divine Lord in His providence is opening up the way for the extension of our beloved Church and through it His kingdom, especially in the eastern section, as well as in the mountains, as never before in the history of the State.

Into it He is literally thrusting us and there is no way for the Committee to go backward or to stand still. Go forward we must at His command, and with every movement forward a much larger proportionate blessing has come.

Facing the tremendous and insistent calls which come to us from the great need and opportunity, the Committee has determined to go forward, trusting first in God, who we believe is calling us onward and who can move the hearts of men to provide the means to do His will, and trusting in the loyalty and devotion of His people throughout the Synod. Therefore, appropriations to the amount of \$14,285.00 have been made for the work of the coming year and we are carrying nearly three thousand dollars over from previous years.

We therefore submit to the Synod for its adoption the following Recommendations:

1. That for the support of this work the sum of \$20,000.00 be apportioned, the same amount as heretofore to the several Presbyteries, except Asheville, assigning the amount formally apportioned

to Asheville to the Superintendent to be raised by him from private and individual sources.

- 2. That in view of the greatly increased work we have undertaken and the burden which we now carry, the pastors and churches be called upon in the name of the Lord we serve to provide the full amount of their apportionments as the minimum of their gifts for the support of this work.
- 3. That while recognizing fully the great obligations which rest upon us for that portion of the western territory which remains to us, without any neglect of it, we recognize in the severance of a large part of the mountain territory from our work a special call of God to the great opportunities which He is opening to us in the great eastern section, and that we pledge ourselves anew to the support of our brethren there with every power at our command.
- 4. That, with grateful appreciation of and thankfulness to God for the work of our two General Evangelists, the Rev. William Black and the Rev. O. G. Jones, D. D., for the year past, they be re-elected to this office for the cusuing year, and that we pledge ourselves anew to the great work of Evangelism among our churches throughout the Synod.
- 5. That at the same time we would lay great and special emphasis upon the great opening for Local Evangelism and that we call upon the Presbyteries to greatly increased attention to this part of our Home Mission Work and pledge ourselves to every possible support of them in it.
- 6. That it be made a standing rule of Synod that Wednesday night be set apart for the popular meeting for Synodical Home Missions.
- 7. In view of the great need of the mountain territory which has gone into the new Synod, the Committee has appropriated the lump sum of \$800.00 to the Presbytery of Asheville and \$800.00 to the portion going from Concord, for this year, with the recommendation to the Synod that this appropriation be continued from year to year upon a reducing scale of \$200.00 a year in each case until eliminated
- 8. That Rev. A. W. Crawford be reelected Superintendent and General Evangelist for the ensuing year.

CHURCH AND MANSE ERECTION LEAGUE.

The subscriptions taken for this work are now rapidly lapsing from age and the Executive Committee found it necessary during the year to enter upon the reorganization of the whole. To this end Miss Essie Johnston was employed to make a re-canvass of the churches of the Synod for this fund.

Against great obstacles, in the time she has been engaged she has added 117 subscribers to the League yielding an annual increase of \$350.00 for the fund. We recommend to the Synod that her services be continued under the direction of the Superintendent, and that our pastors and people be urged to receive her cordially, and to do everything in their power to aid her in this great work. The treasurer's detailed statement of the fund for the year is appended hereto.

TOTAL HOME MISSION WORK OF THE SYNOD AND PRESBYTERIES COMBINED.

Many of the men in the local fields are supported in part by both Synod and Presbytery, so that their work appears in both summaries. Adding the work of Synod and Presbyteries, making such eliminations as not to count twice we have 104 men employed; 226 weak churches regularly supplied; 80 other mission stations; 10,251 sermons preached; 4,959 professions of faith; 3,013 additions to the Presbyterian Church; 41 Sunday schools organized; 17 churches organized; 13 church buildings erected; \$41,248.00 expended on the work.

Finally, to get the full view of the Mission Work done in the bounds of the Synod by its churches there should be added the large work of "Congregational Home Missions." We have not the various items of this work done by the congregations in their own immediate communities but the General Assembly's Minutes show the churches of the Synod reported for the last ecclesiastical year \$32,863.00 expended for Congregational Missions. The addition of this sum would approximate a year's expenditure by the churches of the Synod for Home Mission Work in its bounds, namely, \$74,111.00.

All of which is respectfully submitted by the Committee.

A. W. CRAWFORD, Chairman.

The report was adopted by the Synod and by a rising vote Rev. A. W. Crawford was re-elected Superintendent and General Evangelist, and Rev. Messrs. William Black and O. G. Jones, D. D., General Evangelist, for the ensuing year.

Supplementary Report.

The Synod referred to this Committee an Overture from the Bureau of Ministerial Supply of the Synod of Virginia. In reply thereto we would recommend that the Synod appoint a special committee of three to confer with the said Bureau of the Synod of Virginia and to take such action as they think wise.

A. W. CRAWFORD, Chairman.

The Synod then adjourned with prayer by the Moderator to meet tomorrow morning at 9:00 o'clock.

FOURTH DAY-Morning Session.

Gastonia, N. C., Friday, Oct. 29, 1915.

The Synod met at 9:00 o'clock a. m., and the devotional exercises were conducted by the Rev. G. F. Kirkpatrick.

The Minutes of yesterday's sessions were read, corrected and approved.

The Standing Committees on the Records of Presbyteries reported through the Rev. E. D. Brown, Chairman for the eight Committee, as a whole. The report was received amended and adopted, and is as follows:

The Committee on the Records of the various Presbyteries would recommend:

- 1. That the records of Asheville, Fayetteville, Orange, Wilmington, Concord, and Mccklenburg be approved without exception.
- 2. That the records of King's Mountain be approved with the following exceptions: (1) On page 289 the record shows that Presbytery elected a Regent of the Orphan's Home, which is a Synodical office. (2) The narrative was approved, but not recorded in the minutes—See page 290.
- 3. That the records of Albemarle be approved except that the narrative was not recorded.

In response to a communication from the Presbytery of King's Mountain protesting against the mutilation of her record by the Synod last year in Hickory. We recommend that the Synod make this reply to the Presbytery of King's Mountain: The mutilations were made by an individual without the knowledge of the Synod, and in approving the records without exception the Synod did not approve the mutilations. The Synod regrets the occurence, and sympathizes with the Presbytery in her protest.

We further recommend that in the future committees on Presbyterial records be charged to make no corrections or marks of any kind on minutes until said corrections have been approved by the Synod.

Respectfully submitted.

The Judicial Committee, Rev. W. E. McIlwaine, Chairman, reported that no business had come into their hands. The report was received and approved.

The following resolution, offered by the Rev. William Black, was adopted:

Resolved—That Synod appreciates the generous offer of the Mountain Retreat Association, through its President, Rev. R. C. Anderson, to donate one of its best lots most conveniently located for the purpose of erecting thereon a dormitory or home for the Ministers of this Synod in which free lodging can be had, and being desirous to comply with the condition to secure it free, namely, of erecting thereon this building, and believing that the same would not only furnish one of the most delightful and beautiful places for rest and recreation but also a place where the finest religious advantages are to be had, does hereby appoint the following Committee who shall endeavor to secure the necessary funds and erect a suitable building, provided that said Committee shall not incur any debt in carrying out this resolution. Committee: A. L. McCallum, W. H. Sprunt, B. R. Sellars, Rev. W. Me. White, Rev. W. M. Fairley, Rev. D. H. Rolston.

The following resolutions, offered by Dr. H. G. Hill, was adopted:

Resolved—That in view of the fact that after the present meeting the Presbytery of Asheville and certain Counties of the Presbytery of Concord, will separate from us, and enter other ecclesiastical relations, the Synod of North Carolina would express profound regret at this proposed separation, and would deem its deed to no desire for parting with us, but rather to a noble response to a stern sense of duty and a purpose to advance Christs Kingdom.

Resolved 2nd—That we would express a cordial appreciation of the personal excellencies of many of these brethren and of their labor of love with us, during many years in brave endeavor to overtake the spiritual destitutions in our own Synod.

Resolved 3rd—That we bid them "God-speed" in their new relations, and grant them the slight pecuniary aid promised for four years in their struggle with spiritual want, as a small token of our interest in their work, and pray in the language of the Aronic benediction,

"The Lord bless you and keep you. The Lord make His face to

shine upon you and be gracious unto you. The Lord lift up His countenance upon you and give you peace."

The report of the Permanent Committee on Christian Education and Ministerial Relief was received, taken up seritum and adopted, and it is as follows:

REPORT OF COMMITTEE ON CHRISTIAN EDUCATION AND MINISTERIAL RELIEF.

With reference to the general report of the Executive Committee on Christian Education and Ministerial Relief, we recommend:

1st. That the pastors of the churches in the Synod be urged to call attention of their churches to the decrease in all departments of this work during the past six months, amounting to nearly \$5,000.00 and endeavor to increase their contributions to this cause that this important work may not suffer, but have its proportionate share in the general progress of the Church.

2nd. That the special days and week of prayer for Women's Work and for School and Colleges, in February, be observed.

3rd. That the churches be informed of the Nation-wide campaign in Christian Education now being projected by all the evangelical churches of America, and especially to the efforts being made to encourage and strengthen the departments of Bible and Religion in all our institution.

4th. That we commend the earnest efforts of our Executive Secretary to minister to the spiritual need of our young men in the State Institutions and in this connection that the churches be urged to adopt the Students Official Membership Card.

- II. With reference to the proposed Presbyterian Normal School to be established at Montreat, we recommend that the following directors be appointed:
 - 1 To serve one year Dr. A. D. McClure.
 - 2 To serve two years W. H. Belk.
 - 3 To serve three years Dr. H. G. Hill.

III. We nominate as candidates for Permanent Advisory Committee on Christian Education and Ministerial Relief Dr. W. J. Martin and Dr. C. G. Vardell.

The Standing Committee on the Records of Synod, Rev. H. B. Searight, Chairman, made the following report which was adopted:

We have examined the printed minutes of the Synod and find that they contain much instructive historical matter, well arranged and neatly printed. We would commend our Stated Clerk for his efficient work.

The report of the Ad-Interim Committee on the Coordination of Schools and Colleges was submitted by the Rev. J. M. Wells, D. D. The report was adopted, and the Stated Clerk was directed to furnish the *Presbyterian Standard* a copy for publication. The report is as follows:

REPORT OF THE AD-INTERIM COMMITTEE ON CO-ORDINA-TION OF SCHOOLS AND COLLEGES.

Your Committee was directed to study the entire problem of the Schools and Colleges of the Synod regarding co-operation, co-ordination, equipment and financial support, and to report its findings with recommendations.

In addition to this there has been referred to us that part of the report of the Committee on Schools and Colleges which embraced the recommendations of the Presbyterian Educational Association of the South in regard to Synodical organization.

This Educational Association, as is well known to many members of the Synod, was organized at Montreat in January, 1914, to advance the cause of Christian Education in our Church, and is now seeking to unify the work in our Synods and in the Church at large, and their recommendations have been adopted by the Permanent Advisory Committee on Education appointed by the General Assembly. There are certain of these recommendations that your Committee deem it inadvisable to embody in this report, as the time, in our judgment, is not ripe for them yet, but we call attention to the fact that this Educational Association and the Advisory Committee of the Assembly have covered exactly the ground that this Committee was directed to traverse, and that our recommendations are in line with these unifying forces in the educational life of our Church. We therefore recommend the following:

- 1. That all future canvasses for endowment and equipment funds, as soon as co-ordination be secured, be joint canvasses, including all institutions of the Synod and Presbyteries, instead of separate canvasses—it being distinctly understood that no separate canvass now in progress is to be interfered with.
- 2. That we endorse the plan of the Executive Committee of Christian Education and Ministerial Relief for a Church-wide campaign to increase the resources of our educational institutions.
- 3. That we impress upon the entire membership of our Church their financial responsibility to our educational institutions.
- 4. That in addition to student fees all our educational institutions seek to secure adequate endowment and annual offerings from our churches.
- 5. That in place of the Assembly's recommendation that all institutions be co-ordinated and placed under Synodical control, the Synod look forward to and strive for a good preparatory school in each Presbytery to Davidson College, our standard College for men.

That it look forward to and strive to have at the earliest possible time,

- (1.) A standard College for women;
- (2.) A College, perhaps not of standard grade, but of high grade, that shall shape its curriculum and regulate its fees so as to be within the reach of those of moderate means;
- (3.) A Collegiate Institute. An institution to do the work of a finishing school for those who do not desire to do the full degree work of either of the other schools:
 - (4.) A Junior College or Colleges.
- 5. That this whole question of Standardization and Co-ordination of our educational institutions be committed to the Synod's Committee on Schools and Colleges for further study and future recommendations to the Synod and that the Presbyteries be urged to confer and co-operate with this Committee, so that we may have a unification of our educational work as far as possible.
- 6. That the Bible be the corner-stone of instruction in each of our institutions.
 - 7. That this Committee be discharged.

The special Committee to whom was referred the address of Dr. Bridges, editor of the *Presbyterian Standard*, made the following report, which was adopted:

Your Committee to draft suitable resolutions expressing our appreciation of the great work the "Standard" is doing in our Synod.

We have heard with a great deal of pleasure the address of Dr. J. R. Bridges, the worthy and efficient editor of the "Standard," and while we greatly appreciate the splendid work he is doing, we believe that the "Standard" could be brought up to a higher state of efficiency if Dr. Bridges could give his entire time to the editing of the paper. To this end we urge that all pastors and sessions to place the paper in the hands of their people and that when possible someone be appointed to make a canvass of the congregation.

That those who are now in arrears in their subscriptions, be urged to pay up.

That the management of the "Standard" be urged to increase their capital stock as soon as possible, so that Dr. Bridges can devote his whole time as editor of the paper.

That the pastors, clerks of sessions and Stated Clerks be urged to supply the "Standard" with Church news.

That we again express our appreciation of and pledge our support to the "Standard" as the organ of the Synon.

The report of the Permanent Committee on Publication and Sabbath Schools was presented, read and adopted by a rising vote. The report is as follows:

REPORT OF SYNOD'S COMMITTEE ON PUBLICATION AND SABBATH SCHOOL WORK.

Your committee would respectfully report:

In regard to the Publication work of the Church it will suffice to make grateful mention of the fact that our Committee at Richmond reports a prosperous year. In spite of the financial depression the sale of books and periodicals was in advance of the previous year. The handsome new building in Richmond is now occupied and substantial progress is reported in the southwestern depositary at Texarkana. In our Sabbath school work the great outstanding fact of the year is the passing of the General Superintendent of Sabbath Schools and Young People's Societies, the Rev. A. L. Phillips, D. D., who was called home March 2, 1915. Truly a great man and a prince has fallen in Israel.

For years Dr. Phillips conducted the affairs of his responsible office with distinguished ability and success, and easily took rank among the foremost leaders and specialists in Sabbath school and young people's work in the nation. It will be no small task to find a man to fill his place. Dr. Phillips was a native of North Carolina, and this Synod will feel a special interest in the movement to raise \$50,000 among the Sabbath schools and young people's societies of the Church, to be known as the "A. L. Phillips Memorial Fund," to be used in the work of the Assembly's Training School for Lay Workers, at Richmond, Virginia.

In this connection we desire to call attention to the large and instructive cloth chart (hanging on wall of church) specially prepared for this meeting of Synod by the committee at Richmond, which shows our Sunday school progress for the past fifteen years. It is well worth study. Some of the facts displayed thereon are so full of encouragement and inspiration as to call for special mention.

While the number of our churches has been increasing 35 per cent, the number of schools has grown at the rate of 50 per cent. The membership of the churches has increased 53 per cent; while the membership of the schools has grown 133 per cent.

More than half of those added to the church on profession last year were from the Sabbath school. In estimating the gratifying advance in this most important work, the above figures take no account of the splendid progress made in better methods and equipment, improved literature, more thorough organization and more intelligent and systematic instruction. Surely there is a cause here for profound gratitude and a renewal of zeal in pressing this divinely favored work.

This chart shows the school population of North Carolina to be 1,345,909, while the total Sunday school enrollment for the State is only 539,237, leaving an army of boys and girls 806,672 strong to be enlisted. Surely this is a challenge to faith and patriotism.

In the past year we have increased the number of our schools by 33, and the membership 5713, making total number of schools 455, and the total membership 47,276. This is 51 less than the number of churches. The membership is 5907 less than total membership of churches but on the other hand it is 5184 more than the resident membership reported.

Your committee recognizes the futility of reading a complicated series of tabulated figures and refers the Synod to the Minutes of the Assembly for 1915, page 287, for the complete table of statistics of the Presbyteries. We note that the total of funds contributed for all purposes was \$37,001, an increase of just \$36 over the previous year, or an average of 78 cents a member. As an indication of the aggressive manner in which our churches are pushing the Sunday school work you will note that 19 of our churches report a larger number on the Sunday school roll than on the church roll. And that, leaving out Concord Presbytery which does not report on this, 44 churches are conducting one or more mission schools. Every one of these ought to be put on the honor roll of the Synod, especially the Fayetteville church with ten schools, Rocky Mount with six, Gastonia six, Clarkton five, Wilmington First four, and a number of others with three schools.

Five field workers have been laboring within the bounds of the Synod during the year under the direction of the Richmond Committee. In return for this it is somewhat humiliating to report that the gifts of all our schools to Sabbath school Extension amounted to only \$1466, which was a falling off of \$525 from the year before.

RECOMMENDATIONS.

We recommend as follows:

1. That the Presbyteries urge upon all the churches the importance of zealously pressing the work of Sabbath school extension and Sabbath school improvement, taking Dr. Phillips, motto, "BIGGER AND BETTER," as the watch word. Presbyterial and local institutes are heartily recommended whenever practicable.

Let our goal be no less than a school, open all the year, in every church; a mission school for every church; and a membership, including Cradle Roll and Home Department, not less than the membership of the church.

- 2. That the class room work in our schools will not overlook the memorizing of the Scriptures and the Shorter Catechism.
- 3. That an hour be given at the next meeting of the Synod for hearing the report of the committee and holding a popular Conference the second day at 10:00 o'clock a.m.

The following report of the Special Committee on the erection of the Centennial Movement at Alamance Church was received and adopted:

Your Committee on the Centennial Monument at Alamance church would report the work done at a cost of \$384.87; That there has been received from all sources \$319.41; That there is a balance due of \$65.46.

We recommend:

That such Presbyteries as will do so are urged at once to send in to the Chairman of the Committee the amount assessed.

That the Rev. E. C. Murray, D. D., be added to the Committee and that the Committee thus enlarged arrange for a special service of dedication.

That upon such occasion the Committee arrange to secure the balance of the inbebtedness.

The Committee on Bills and Overtures made the following report which was adopted:

Your Committee on Bills and Overtures report-

There has been placed in our hands a communication from Dr. Geo. O. Bachman, Stated Clerk of the Synod of Appalachia:

In response to this your committee recommends that Synod approve the action of the General Assembly in appointing Rev. A. A. McGeachy, D. D., principal, and Rev. Melton Clark, D. D., alternate, to bear from this Synod greetings to the new Synod at its first meeting on the first Tuesday in November, 1915, in the First Presbyterian Church of Bristol, Tennessee. And that Synod pay the expenses of said Commissioner.

The Standing Committee on the Minutes of the General Assembly, Rev. J. J. Hill, chairman, made the following report which was adopted:

REPORT OF STANDING COMMITTEE ON MINUTES OF THE GENERAL ASSEMBLY.

Your Standing Committee on the Minutes of the General Assembly report that they have examined same and would respectfully call the Synod's attention to the following actions and recommendations:

The Assembly authorized the establishment of the new Synod of Appalachia, and that the Presbytery of Asheville and the Churches in the Counties of Mitchell, Avery, Watauga and Yaucey be transferred to the new Synod. (See page 22)

On the subject of Christian Education the Assembly recommended that the Synod be the Educational unit; that our Educational institutions be placed on the budget of Synod's and Presbyteries, the method to be left to them: that all future canvasses for endowment and equipment funds be joint canvasses, including all educational institutions of the Synod, instead of separate canvassers. (See page 34)

The Assembly created an Advisory Committee (with alternates) to the Executive Committee on Christian Education, the members of which, in the future, shall be nominated by the Synod. (See pages 34 and 35)

The Synod is urged to co-ordinate and articulate the educational work within its bounds as soon as possible. (See page 35)

Churches, Presbyteries and Synods are called upon to unite with others in the celebration of the four hundredth anniversary of the Protestant Reformation, October 31, 1917. (See pages 36 and 39)

The Assembly set apart the last Sunday in February as a day of Special Prayer for the Schools and Colleges and the youth gathered in them, and that the preceding Thursday be set apart as a day of prayer to be observed by the Woman's Auxiliaries, and that the whole preceding week be observed in our homes, and as far as possible, in our educational institutions, as a season of special prayer for the outpouring of God's Spirit on these institutions and the youth of our Church and our land and the world. (See page 36)

The Standing Committee on the Report of the Board of Regents of the Orphans' Home, Rev. W. S. Wilson, D. D., Chairman, made the following report which was adopted. (See Report of the Regents in the Appendix)

REPORT OF COMMITTEE ON REPORT OF THE REGENTS OF THE ORPHANS' HOME.

The report of the Regents which was placed in our hands is a very encouraging one in every respect and the Synod records its profound thanksgiving to Almighty God for His manifold blessings on this institution so dear to our hearts. The Home now has its new school building, the central heating plant will soon be completed, the farm and dairy have been so managed as to contribute materially to the support of the occupants of the Home, and best of all Our Father in Heaven has graciously answered the prayers of His children all over the State for the restoration to health of the efficient and beloved Superintendent, Rev. W. T. Walker. He has also guided those in charge during Mr. Walker's illness so that the interests there have not suffered.

Your Committee would emphasize in the minds of all the members of the Synod that the Treasurer's report shows a small deficit in the support fund and urge our pastors and people to such liberality as will make a repetition of this state of affairs impossible.

Your Committee make the following recommendations:

1. That the sum of \$25,000 be apportioned among the Presbyteries as follows:

Albemarle \$3,500; Concord \$4,000; Fayetteville \$5,000; King's Mountain \$1,500; Mecklenburg \$4,500; Orange \$5,000; Wilmington \$1,500.

- 2. That our pastors and church officers would give such aid to Miss Victoria Hudson, the Field Agent, when she visits them, as will enable her to reach our Sabbath Schools and ladies' societies for purpose of interesting them in the support of the Home and extending the circulation of "Our Fatherless Ones."
- 3. That in view of the absence of the Superintendent and the deficit in the support fund and the blessing of Providence on our own homes all our churches be urged to make a Thanksgiving offering for the support of the Orphans' Home, and that they make special effort to secure a liberal offering.

- 4. That Synod renew its urgent request to all our Sabbath Schools to make an offering for this cause on one Sunday in every month.
- 5. That the Stated Clerk write a letter to Rev. W. T. Walker assuring him of the Synod's gratitude to God for sparing his life and of our continued prayers for his complete recovery.
- 6. That Mr. W. M. Cumming, Mr. J. R. Young and Mr. O. L. Clark, whose term expires at this meeting, be re-elected as members of the Board of Regents and that Rev. S. L. Cathey be elected to succeed Rev. W. R. Minter.

The Standing Committee on Systematic Beneficence Rev. C. E. Hodgin, Chairman, made the following report which was adopted:

REPORT OF STANDING COMMITTEE ON SYETEMATIC BENEFICENCE REPORTS.

The total amount contributed by the Synod to all the benevolent causes during the past year is \$353,431, as against \$312,414 for last year, showing an increase of \$41,017. However, the majority of the Presbyteries gave less than they did last year. Only two Presbyteries gave an increase over the previous year. Orange Presbytery gave an increase of \$55,554, and Asheville Presbytery gave an increase of \$55,554, and Asheville Presbyteries was as follows: Mecklenburg, \$9,661; Concord, \$4,888; Wilmington, \$4,421; Albemarle, \$1,074; Fayetteville, \$545; King's Mountain, \$70.

Your Committee of Nominations would respectfully report as follows:

To this Committee has been referred the duty of nominating a successor to Rev. E. L. Siler, Permanent Clerk of Synod, who leaves us after this session of Synod to go into the new Synod of Appalachia.

We recommend that the Synod, in accepting Bro. Siler's resignation, express to him our high appreciation of his faithful and efficient service in this position, and our sincere regret that he can no longer serve our Synod in his present position.

We recommend, further, that Rev. Dr. E. C. Murray be elected to succeed Rev. E. L. Siler as Permanent Clerk of this Synod.

To this Committee was also referred the communication from the Assembly's Committee of Systematic Beneficence, calling attention to the fact that the term of our Synod's lay representative on that committee expires with the next Assembly, and that he is eligible for re-election for one more term, and also reminding us that our Synod has no ministerial representative on the Assembly's Committee of Systematic Beneficence.

We nominate our present representatives, Mr. R. A. Brand as principal, and Mr. E. P. Wharton as alternate, to serve for another year, and we also nominate as our ministerial representative on that committee Rev. Dr. Neal L. Anderson, with Rev. Jas. H. Henderlite as his alternate.

To this committee was also referred the duty of nominating a successor to Dr. W. J. Martin, who has offered his resignation as Chairman of Synod's Permanent Committee on Schools and Colleges. We would recommend the election of Rev. Dr. W. S. Wilson to this position.

The report of the Ad-Interim Committee on Elders' and Deacons' Evangelistic Institutes was received, read and adopted. The same Committee was re-elected for another year, with the name of Rev. E. R. Leyburn, D. D., in the place of Rev. E. L. Siler. The report is as follows:

REPORT OF COMMITTEE ON ELDERS' AND DEACONS' EVAN-GELISTIC INSTITUTES.

Your Committee appointed by the last Synod on Elders' and Deacons' Evangelistic Institutes, would respectfully report as follows:

IN FAYETTEVILLE PRESBYTERY, your Committee held an Evangelistic Institute in the First Presbyterian church of Fayetteville, N. C., Jan. 22-24, inclusive, which was attended by 28 ministers, 53 elders, 39 deacons, a large number of Sunday school teachers and officers and a very large number of other persons. A most excellent program was prepared and was fully carried out and it was apparent to all that great good was done. It was a most enthusiastic Institute and a deep spiritual tone pervaded every part of the exercises. A Personal Workers League was organized and is growing.

IN WILMINGTON PRESBYTERY, an Institute was held at Wallace, N. C., July 20-22 inclusive, at which there were present 10 ministers, 24 visiting elders, and 20 deacons, representing 18 churches of the Presbytery and 2 visiting ministers of the churches, and many Sunday school officers and teachers. The congregations were large, the interest was earnest and deep. A resolution was passed urging the Committee to continue the Institute yearly.

IN ALBEMARLE PRESBYTERY, an Institute was held at the First Presbyterian Church, Rocky Mount, N. C., July 24-26, inclusive, at which there were present 6 ministers, 14 elders and 5 deacons, representing 10 churches and a considerable number of Sunday school officers and teachers, and while the attendance was small the interest increased from the first and arose almost to enthusiasm at the closing service on Sabbath night when the congregation was large.

IN KING'S MOUNTAIN PRESBYTERY, a Deacons Convention was planned for and held by the deacons, in the First Presbyterian church, Shelby, N. C., at which convention many topics were discussed and some of them bearing directly on the evangelistic work. Your Committee has not the exact data as to the attendance but understands that it was well attended and much good accomplished and on account of the similarity of the gatherings thought it best to let this convention take the place of the Evangelistic Institute for this year and did not hold the planned Institute in this Presbytery.

IN ASHEVILLE PRESBYTERY, no Institute was held because of the fact that the gatherings at the Montreat conferences included many of the ministers, elders and deacons from this Presbytery and it was thought best to let this take the place of the Institute there.

IN ORANGE AND CONCORD PRESBYTERIES, no Institutes were held by this Committee for the reason that no suitable time was found when it did not conflict with something going on either in those Presbyteries or with some of the Institutes appointed in other places, so that no one of your Committee could attend. It is greatly regretted by your Committee that Institutes in these Presbyteries were not held and especially since a most cordial invitation had been extended by the good people of the First Presbyterian church, Salisbury, N. C.

IN MECKLENBURG PRESBYTERY, an Evangelistic Institute was held in Mulberry church, August 24-25, inclusive, under the auspices of a local Presbyterial Committee which was attended by 27 ministers, 67 elders, 53 deacons, many Sunday school officers and

teachers and a large number of other persons. This was a most enthusiastic and spiritual gathering at which much good was done and evangalism was discussed in many phases, and so complete was the work it was not necessary to hold another Institute in this Presbytery by your Committee.

IN FAYETTEVILLE PRESBYTERY, at its fall session much time and attention was given to the discussion of evangelistic topics and the same may be true of other Presbyteries, but your Committee has not the information.

A most cordial invitation to hold an Institute was extended by the good people of the First Presbyterian church, Gastonia, N. C., and your Committee hereby expresses its thanks and great appreciation for this and the other invitations extended and for the most hospitable entertainment at all the Institutes.

Your Committee believes there is great necessity for an awakening all along evangelistic lines and is unamimous in the opinion that these Institutes furnish some of the best means possible for arousing interest and bringing about the desired awakening, and recommends that the Synod appoint a Committee to take this matter in charge.

The expenses of these Institutes were not large and consisted almost entirely in payment for printing and postage, with a small amount for traveling expenses of some speakers outside the bounds of the Presbytery where the Institutes were held, and were met in part by collection and the rest paid by the members of your Committee.

ANNUAL REPORT OF UNION THEOLOGICAL SEMINARY IN VIRGINIA.

The Board of Directors and Trustees of Union Theological Seminary in Virginia, with grateful acknowledgment to the Head of the Church for His blessings upon this institution during the past session, would respectfully report to the Synod of North Carolina:

- 1. That 105 students have been enrolled during the year, and that of these 88 are college graduates, 14 have taken college courses in part, and have had no college training.
- 2. That the students have as a rule been blessed with good health; that they have prosecuted their studies with diligence and success; that they have continued and enlarged the active and fruitful city mission work which they have carried on for so many years at such places as the State Penitentiary, the City Jail, the Boy's Reformatory, the City Almshouse, the Soldiers' Home, the Nurses' Home, the Railroad Shops, and the Seventeenth Street Mission to Colored People, and that recently they have inaugurated a weekly street preaching service in the needy district around the Old Market.
- 3. That the eight instructors have done their work with fidelity and thoroughness, as shown by their detailed written reports as to the matter, methods and results of the work in their several departments.
- 4. That the Seminary has a valuable acquisition to its teaching staff in the Rev. Eugene C. Caldwell, D.D., who has served throughout the year as Professor of Hebrew and Old Testament Exegesis.
- 5. That the Seminary has sustained a heavy loss in the death of the Rev. Thomas R. English, D.D., Professor of Biblical Literature and New Testament Exegesis, who has for twenty-two years served the institution faithfully both as professor and as clerk of the faculty.
- 6. That the Board has elected and inaugurated the Rev. Eugene C. Caldwell, D.D., to the Henry Young Professorship of Biblical Literature and New Testament Exegesis.

- 7. That the Board has elected the Rev. Edward Mack, D.D., of Cincinnati, to the McCormick Professorship of Hebrew and Old Testament Exegesis, and that he has accepted the position and will enter upon the discharge of its duties at the opening of the next session.
- 8. That, in addition to the curriculum leading to the degree of Bachelor of Divinity, the Board has authorized the faculty to offer to candidates who have been instructed by their Presbyteries to omit Greek and Hebrew from their Seminary work a full and thorough three years' course without Greek or Hebrew, the completion of which shall be recognized by the award of a diploma (without the degree of B. D.) as distinguished from the mere certificates by which partial work is recognized.
- 9. That during the past year three volumes of lectures delivered on the James Sprunt Foundation have been published under the imprimatur of the Seminary, to-wit: "Christian Psychology," by the Rev. Prof. James Stalker, D.D., of Aberdeen; "The Bearing of Recent Discovery on the Trustworthiness of the New Testament," by Sir Wm. Ramsay, D. D., LL.D., D.C.L., of Edinburgh; and "God's Book and God's Boy," by the Rev. A. F. Schauffler, D.D., of New York. The Trustees would again express their gratitude for the founding of this lectureship which is making such numerous and notable contributions to a strong and wholesome Christian literature. The James Sprunt lectures for the coming session will be delivered by the Rev. G. Campbell Morgan, D. D., of London, on "The Preaching of the Word."
- 10. That the Union Seminary Review continues to increase in interest and value under the editorship of Professor W. L. Lingle. It is the only quarterly review published in our church, and is rendering a unique service to our reading ministers and laymen, by its extended articles from contributors of weight in every part of our territory, including the professors in our sister Seminaries; by its special studies of the missionary work of the church which appear in every number; and by its numerous, discriminating and helpful reviews of new books on theology and religious subjects of present-day interest.
- 11. That, certain friends of the Seminary in Richmond, having given to the Trustees \$15,000 for the purpose of enabling the institution to secure the services of an executive officer for a specified period of years, the Board has elected to this position, Mr. Wm. R. Miller, the Secretary and Treasurer of the Seminary, and that he has entered upon the discharge of the duties of this office.

- 12. That the Board has authorized the installation of a central heating plant for the Seminary buildings, and other extensive improvements looking to greater convenience and greater economy in running expenses.
- 13 That the finances are in a thoroughly healthy condition, but, that, in view of the fact that the number of students has nearly doubled in the last ten years, there is urgent need of a large increase in the scholarship funds for the aid of worthy and needy students in meeting their necessary expenses.
- 14. That the Synod of West Virginia has associated itself with the Synods of Virginia and North Carolina in the support and control of the Seminary and is now represented on the Board by four directors.

THE REPORT OF THE REGENTS OF THE ORPHANS' HOME.

The Regents, under existing conditions, can make a satisfactory report for the year ending October 1st 1915. The health of the inmates of the home has been generally good, but during the latter part of the summer and early fall, the Rev. W. T. Walker, our Superintendent has had a severe attack of typhoid fever, disqualifying him for his duties, and devolving more care upon his co-workers. In answer to many prayers Brother Walker's life has been spared, and he has been partially restored to health. That he may regain his vigor, the Regents have given him a vacation of six weeks to December 1, 1915, and putting the Home for that period under the care of Miss Janie McEachin, the lady Principal-She, the assistant Treasurer, and the heads of the different departments, have manifested great fidelity, and shown good management during Brother Walker's illness. The following exhibits from those in charge of different departments, will give a fair conception of the condition of the Home: There are 202 Children at present in the institution, and the number will be increased so soon as the second story of Rumple's Hall can be prepared for their reception. The Graded School Building and Auditorium was completed last Jan'y and has been occupied by the School since early spring. A contract has been made for constructing the Central Heating plant, near the Railroad, to warm seven buildings at a cost of \$11,500. The contractor thinks it will be in operation before very cold weather.

The Farm—Our Farmer reports the aggregate products of the farm as worth \$1,695.00; expenses for seed, guano, composts \$150.00; Net \$1,545.00.

Truck Farm—Value of products \$1,100.; expenses seed, guano, composts \$105.00; net \$975.00.

Poultry Yards—Has 100 hens, furnished 100 chickens, 50 dozen eggs.

Dairy—Our dairyman reports cows 40, bulls 2, ox 1, calves 10, hog_s 65. Value of products \$2,498.21; expenses salary, feed \$2,-181.57; net \$316.54.

STANDING RULES OF SYNOD.

Revised and Adopted October, 1905.

I.—GENERAL RULES.

(Pertaining to the Synod as a Body.)

- 1. The Stated Meetings of this Synod shall be held annually, and unless otherwise ordered, in the month of October, beginning on the Fourth Tuesday of said month at 11 a.m.
- 2. The Parliamentary Rules of Order, adopted by the General Assembly, and published in the Book of Church Order, shall be the Rules of Order for the guidance of Synod.
- 3. The officers of the Synod shall be a Moderator, a Stated Clerk, a Permanent Clerk, a Temporary Clerk, a Treasurer, and a Board of Trustees consisting of five members. The Moderator and the Temporary Clerk shall be elected at each Stated Meeting and the Stated Clerk, the Permanent Clerk, the Treasurer, and the Board of Trustees shall be elected every three years, counting from 1886.
 - 4. The Synod shall elect annually:
 - (a) A Superintendent of Synodical Home Missions.
 - (b) A General Evangelist.
 - (c) Two members of the Board of Directors of Union Theological Seminary, whose term of office shall be five years—1914.
 - (d) *Four members of the Board of Regents of the Orphans' Home, term of office shall be for four years.
- 5. The Synod shall elect triennially, counting from 1886, the following committees, which shall be known as the "Permanent Committees" of the Synod.

^{*}The number of Regents changed from 10 to 16, (1910) and term changed to 4 years (1912).

- (a) On Synodical Home Missions, consisting of the chairman of each of the several Presbyterial Committees on Home Missions, and one Ruling Elder from each Presbytery. The Superintendent of Synodical Home Missions shall be "ex-officio" chairman, and the General Evangelist shall be "ex-officio" a member of this Committee and it shall be charged with the conduct of the work of "Synodical Home Missions" under the direction of the Synod and in harmonious co-operation with the several Presbyteries.
- (b) On Foreign Missions.
- (c) On Assembly's Home Missions, including Colored Evangelization and Evangelistic work. (1910).
- (d) On Christian Education and Ministerial Relief, including the Causes of Assembly Schools and Colleges and the Assembly's Home and School. (1910).
- (e) On Publication and Sabbath Schools.
- (f) On the Sabbath and Family Religion.
- (g) On the Bible Cause,
- (h) On Woman's Work,
- (i) On Synodical Schools and Colleges. (1911).
- (j) On Young People's Societies, Brotherhoods, Covenanters, etc. (1911).
- (k) On Systematic Beneficence. (1911).

These committee, except the first named, shall consist each of a chairman appointed by the Synod, together with the Presbyterial Chairman of the Several Causes, respectively. And it shall be the duty of the committees to take into consideration everything bearing upon the Causes which they represent calculated to inspire fitterest to increased knowledge and to promote the growth and glory of Christ's Kingdom, and to report in writing through their chairman at each meeting of Synod.

(1) A Historical Committee, consisting of three members including the Stated Clerk, who shall be "ex-officio" chairman. It shall be the duty of this Committee to be a medium of communication and information with other like Committees or Societies, and to have a watchful care for the preservation of all records, documents and papers belonging to the Synod and to collect and preserve all possible material of historical value pertaining to the Synod, and report from time to time on all matters of historic value and interest.

- 6. The Stated Clerk, the Pastor of the Church in which Synod shall meet, and the Ruling Elders appointed to represent said Church, shall constitute a Committee on Enrollment. This Committee shall meet in the church at a time appointed before the opening of Synod and prepare the roll of Synod, and to this Committee each member shall be required to report for enrollment. The roll thus prepared shall be called at the organization of Synod. Additional enrollment shall be made by blank slips distributed through the Synod and collected by tellers appointed by the Moderator.
- 7. The first half hour of each Morning Session shall be spent in devotional exercises conducted by the Moderator or by some one appointed by him, and the last half hour of each Morning Session shall be given to the hearing of a sermon, or of a public address on some cause of the Church.
- S. The Synod shall recede from business during the afternoon of the second day in order that the various Committees may meet and prepare their work.

II.—SPECIAL RULES.

(Pertaining to the Duties of Officers and Committees.)

- 9. The Moderator. It shall be the duty of the Moderator, at an early hour in the proceedings of the regular meeting, to appoint the following Standing Committees, which shall usually consist of not less than three members each:
 - (e) On Bills and Overtures.
 - (d) A Judicial Committee.
 - (e) On Address to the Churches.
 - (f) On the Minutes of the General Assembly.
 - (g) On the Report of the Directors of Union Theological Seminary.
 - (h) On the Report of the Regents of the Orphans' Home.
 - (i) On the Presbyterial Reports on Systematic Beneficence.
 - (j) On the Report of the Trensurer and his books-Auditing Committee.
 - (k) On the Records of Synod.
 - (1) On the Records of the Presbyteries-Eight Committees.
 - (m) On Resolutions of Thanks.
 - (n) On Leave of Absence.

To these Committees shall be referred without a vote, unless there is objection, all reports, documents, communications, and other matters pretaining to the several subjects upon which they are appointed, and it shall be their duty to formulate reports upon the matters referred to them and to present the same to the Synod for action.

It shall also be the duty of the Moderator, in the interim of the meetings of Synod when a vacancy occurs, in any offices of the Synod, by death, resignation, or removal from our bounds, to fill such vacancies by the appointment, until the next meeting of Synod. And also, upon the occasion of the death of a minister, it shall be his duty to appoint a committee of one, to prepare a Memorial sketch of the deceased, to be read in the Synod ensuing, and to be spread upon the Records.

10. The Stated Clerk. It shall be the duty of the Stated Clerk when he is elected and enters upon the duties of his office, at the opening of Synod immediately succeeding that at which he is elected, to report to the Synod in writing and in full whatever he has received from his predecessor, in the way of Records, Books, Papers, Documents, Furniture, etc., and the condition of the same when received.

The Stated Clerk shall conduct the correspondence of the Synou and he shall be the permanent (ex-officio) chairman of the Standing Committees on Special Orders and Statistics. He shall publish a notice of the time and place of the meeting of Synod at least once a month before the appointed day. He shall secure such reduced rates of railroad travel as may be possible, and he shall sign all necessary certificates for the same, or for other official purposes of the Synod or its members. He shall prepare a detailed docket of business for the next meeting, and cause the same to be published in the Appendix of the Minutes of the last meeting. He shall have at each meeting of the Synod accessible to the Moderator a sufficient number of dockets, a copy of the last printed Minutes of the General Assembly, and a copy of Alexander's Digest. He shall duly engross the Minutes of the Synod after their approval, and transcribe the same into a book to be known as the "Synod's Official Records," and he shall transmit said Records annually to the General Assembly for review. He shall cause to be published annually, in pamphlet form, at least one thousand copies of the Minutes of each meeting, as soon as practicable after adjournment, and distribute the same among the members and Church Sessions. He shall cause to be published in the Appendix or

the Printed Minutes, the reports of the Presbyteries on Statistics and Systematic Beneficence, the reports of the Permanent Committees without their recommendations, the annual report of the Directors of Union Theological Seminary, a roll of the Ministers of Synod by Presbyteries, and a list of the Officers, Appointees and Permanent Committees, together with the Standing Rules. He shall cause to be published every five years, according to Rule adopted in 1874, but counting from 1896, the names of the Ruling Elders and Deacons with their respective postoffices, belonging to the churches composing the Synod, and the Stated Clerks of the Presbyteries shall be required to furnish the Stated Clerk of the Synod with the necessary information for the execution of this rule. He shall forward a copy of the printed Minutes, annually to the Librarians of Union Theological Seminary, Davidson College, and the Presbyterian Historical Society, in Philadelphia, and he shall file at least three copies in the Archives of the Synod. He shall also from time to time have the printed Minutes bound in suitable volumes and deposited in the Archives of the Synod. The Stated Clerk shall be charged with the further duty of reporting to the Moderator any vacancies to be filled by him, and of any deaths in the Ministry that may occur, and of reporting to the Synod the expiration of the terms of appointment of its officers and committees according to the Standing Rules.

- 11. The Permanent Clerk. It shall be the duty of the Permanent Clerk to take, with the aid of the Temporary Clerk, the daily minutes of the Synod. To read said minutes as required by the Synod, for Synod's information, correction and approval. To turn over such minutes to the Stated Clerk of Synod for engrossing or publication, to serve as the official reporter of the Synod. As such reporter: (a) To prepare a daily account of the proceedings for the daily papers; (b) To make account as full, complete and vigorous as possible, stressing those matters of interest to the general public; (c) To have typewritten copies made of such account, and send daily to all the larger dailies of the State, and to such other papers as may seem wise.—1914.
- 12. The Treasurer. It shall be the duty of the Treasurer to keep a strict and accurate account of all the funds received and disbursed, showing what Presbyteries have paid or have not paid their assessments, and for what purpose the funds have been disbursed. He shall submit to the Synod annually, his book, together with a report of the receipts and expenditures, presenting vouchers for the same.
 - 13. The Trustees. It shall be the duty of the Board of Trustees,

as the Synod's medium or agency, in all matters requiring the use or aid of the civil law, to receive, take charge of, and manage to the best advantage, and account to Synod for, according to law, all property and estate belonging, or which may accrue and enure to this Synod; and they shall hold in trust, subject to the order of Synod, the said property, and all legacies and bequest which may be willed to the Synod in behalf of charitable and other objects under its control, and they shall make a full report, in the premises, whenever occasion or circumstances shall require.

- The Permanent Committees. It shall be the duty of any or all of the chairmen of the Permanent Committees, including the President of the Board of Regents of the Orphans' Home, if deemed advisable, to arrange for, and to hold popular meetings in the interest of the respective causes they represent. These popular meetings, if held, shall be in connection with, and at the time of presentation of the Report of the Committee, and they shall in no wise interfere with the Standing Orders of the Synod. And it shall be the rule, as far as practicable, to hear in this connection and at this time the Secretaries of the General Assembly, and other representative brethren, in the interest of the corresponding cause which they may represent. And it shall be the duty of the chairman of the several committees, in arranging for the aforesaid meetings, to correspond with the representative brethren, who are expected to be present prior to the meeting of Synod, as to the time when they are expected to be heard agreeably to the Standing Rules.
- 15. It shall be the duty of the Moderator immediately following the selection of the next place of meeting to appoint a Committee of Arrangements whose period of responsibility shall extend from the close of the Synod to the close of the next and whose business shall be to arrange the entire program of business for the next meeting of Synod conformably to the Standing Orders of Synod. This committee will consist of five members, one of which shall always be the pastor of the church where the Synod is to meet and another the retiring Moderator.—1911.
- 16. It shall be the duty of the Standing Committee on the Records of Synod to examine the Official Records, and report with special reference to the condition of the same and as to the neatness and faithfulness in the execution of the work, and whether or not the records have been sent up and approved by the General Assembly.

Appendix 391

- 16. It shall be the duty of the Standing Committee on the Records of the Presbyteries to confer with the Stated Clerks of the Presbyteries whose records they are appointed to examine before submitting their reports to the Synod in order that the Clerks may have opportunity to make explanation in regard to the records before the matter is brought before the Synod. And after the records are examined, the chairmen of the several committees shall meet in committee of the whole and compare, classify and adjust to a common Standard of Judgment their criticisms and exceptions. They shall then elect one of their number who shall act as chairman of the committee of the whole, and who shall submit the judgment or criticism of all the committees on all the records in his one report to Synod.
- 17. It shall be the duty of the Standing Committee on Leave of Absence to receive and pass upon, before presenting their reports to Synod for approval, all excuses for absence from the last and present meeting of Synod, for tardiness, for absence without leave from the last meeting, and for leave of absence from the present meeting. All excuses shall be rendered to this committee and this rule shall apply to all the members of Synod, except Foreign Missionaries, and infirm ministers who are not required to attend the meetings of their Presbyteries. It shall be the duty of this committee to refuse leave of absence to any member, except upon urgent reasons.
- 19: It shall be the duty of the Ad Interim Committee on Memorials, to write simply and briefly a sketch, and not an extended history of the deceased. It is designed for obvious reasons, that shall in no wise interfere with the Standing Orders of the Synod, the sketch shall embrace only the chief dates and main facts in reference to the life, work and death of the deceased.

III.-MISCELLANEOUS RULES.

- 20. It shall be the duty of each member, unless released by a vote of the Synod, when providentially prevented from attending the Synod, to address a letter to the Moderator stating reasons for his detention.
- 21. It shall be the duty of the Stated Clerk of the several Presteries to furnish the Stated Clerk of the Synod, when applied to, with all necessary information required, and with a corrected roll or ministers and their postoffices annually, and also a roll of the Elders, Deacons and churches, with their postoffices once every five years.

The Stated Clerks are enjoined to be careful, accurate and punctual in filling out all blanks sent to them, and returning them to the Stated Clerk before the meeting of Synod.

- 22. It shall be the duty of all members of Synod, and especially the chairmen of committees, in preparing written reports to be presented to this body, to write the same in a plain and legible handwriting, and it is desirable that the chairmen of the Permanent Committees furnish the Stated Clerk with an extra copy, if possible, or their annual reports, respectively.
- 23. The roll shall be called at each meeting before final adjournment and those who are absent without permission shall be noted by the Clerk as "absent without leave," and they shall be required to report to the Committee on Leave of Absence at the next meeting ana answer for the irregularity.
- 24. It shall be a Standing Rule, until otherwise ordered, that the Treasurer of Synod pay the expense of the representative of Union Theological Seminary in attending the annual meeting of Synon.—1906.
- 25. It shall be a Standing Rule that the Devotional Exercises at the opening of each day's session of the Synod be put into the hands of the Standing Committee on Devotional Exercises.—1906.

IV.-STANDING ORDERS.

The following Standing Orders shall be observed by the Synod:

- (1) The Synodical Communion shall be held at 11 o'clock a.m. of the second day without a sermon.
- (2) The Memorials of the deceased Ministers shall be read immediately after the Synodical Communion Service.
- (3) The Popular Meeting in the interest of Foreign Missions shall be held on the evening of the first day.—1915.
- (4) The Popular Meeting in the interest of the Synodical Orphans' Home shall be held at 11 o'clock on the morning of the third day.
- (5) The Popular Meeting in the interest of Assembly's Home Missions shall be held in the afternoon of the third day at 3 o'clock.
- (6) The Popular Meeting in the interest of the Sabbath and Family Religion shall be held in the afternoon of the third day at 4 o'clock.

- (7) Synodical Home Missions evening of second day-1915.
- (8) Preaching each day at the last morning hour.
- (9) Synod recedes from business afternoon of the second day.
- (10) Sunday School work second day at 10:30 o'clock.
- (11) Work among students in State institutions second day at 10 o'clock.
