

# SYNOD OF NEW YORK

### A. D. 1891.

THE SVNOD OF NEW YORK met, agreeably to appointment, in the First Church in the City of Watertown, on Tuesday, the 20th day of October, A. D. 1891, at half-past seven o'clock P. M., and was opened with a sermon by the Moderator, the Rev. ANDREW V. V. RAYMOND, D. D., of the Presbytery of Albany, on John 1:4: "In him was life; and the life was the light of men."

After the sermon, the Synod was organized with prayer by the Moderator.

Overtures, memorials, appeals and complaints were called for, and the papers presented were placed in the hands of the Stated Clerk.

Printed copies of the Docket of Business, and of the Minutes of the last Stated Meeting were distributed.

The Records of the Presbyteries were presented, and were referred to the Examining Committees, whose reports were made the order of the day for Thursday, at three o'clock P. M.

The Committee on Systematic Beneficence presented the following report, which was accepted, and its recommendations were adopted :

In 1879, the General Assembly appointed a Committee on Systematic Beneficence, designating it "A Committee of Organization and Instruction." Its duties are thus described : "This Committee should see that each Synod has a Committee of Benevolence. Its endeavor should be to secure such attention to the subject by these Committees that the matter of Systematic Beneficence and Church Work will be kept constantly before ministers and churches until these three points are attained: 1. Each church has a proper scriptural plan. 2. Each church contributes to every Board. 3. Proper and fresh information on the general work of the Presbyterian Church is constantly presented to church courts and individual churches." The province of the Synod's Committee is all this, and much besides. In compliance with the will of the Assembly, the Synod, in 1883, appointed a Committee on Systematic Beneficence. In 1885 the Assembly instructed "all Synods to appoint committees on each of the Boards of the Assembly, and also a Committee on Systematic Beneficence." By the action of the Synod, in 1886, the Standing Rule was altered so as to read, "Before the adjournment a committee of one minister and one elder on each of the Boards of the Church, shall be appointed to serve for one year, and these committees, with a general chairman to be appointed at the same time, shall constitute the Committee on Systematic Beneficence." Technically, the instructions of the Assembly have been obeyed; but has not the practical effect been unsatisfactory ?

Your Committee fails to see how it is in its power to discharge efficiently its two-fold duty of representing the Boards and laboring in the field of service designed as its special province. It therefore asks to be relieved from all duties consequent upon the representation of the Boards, with a view to far more efficient provision for them both on the floor of the Synod and among the churches.

Farther, your Committee is agreed that a great obstacle in its way is the present inexact method of reporting to the Assembly the gifts of the Synod. The Committee is to tabulate the financial statistics of the Synod, that the churches may be edified and instructed; but there is little instruction, and less edification, when the statistics are so arranged that truthful deductions from them are impossible. The deductions presented last year occasioned severe criticism. Vet the Committee was honest in its conviction, and if wrong in some of its conclusions, it was led into error by the inexact character of the tables in the Assembly Minutes. That its work may be facilitated, and satisfactory results obtained, some wise change in the statistical blanks of the Assembly is desirable, by means of which such deductions may be made as shall render impossible the grave charge of disloyalty where ground for it does not exist.

The year now closed has been one of promise. Document No. 1, entitled "Keep the Feast," was issued in connection with the distribution of the statistics ordered by the Synod. How generally the feast was kept is unknown to your Committee. The large increase this year in the gifts to the Missionary Boards, warrants a belief that the labor of communicating the facts, and sending out the appeal, was not in vain.

Your Committee rejoices in the promotion of its recent colleague, Rev. Rufus S. Green, D. D., to the chairmanship of the Assembly's Committee. Official communication of an encouraging character has been established between the two committees.

By comparing the statistics of this year with those of the preceding year, it appears :

1. That the total gifts of the Synod have decreased \$23,872.

2. That the gifts to benevolence at large have increased \$93,801.

3. That the congregational expenses and the Assembly Fund have decreased \$117,673, while the gifts to miscellaneous objects have increased \$72,393.

4. That the direct gifts to the Church Boards have increased \$26,429, while the payments by the Boards to the Synod have decreased \$3,898.

5. That the difference between the amounts credited in the Assembly Minutes to work represented by the Boards, and the actual receipts of the Boards, is \$312,665. This difference, added to the gifts called "Miscellancous," shows a disbursement of \$670,661 to objects outside of the Church Boards.

6. That deducting, from the actual receipts of the Boards, their disbursements within the Synod, there has been contributed to all the Boards the net sum of \$329,988, equal to \$2.05 for each communicant; the number of communicants, excluding the foreign Presbyteries, being 161,361, an increase of 3,135.

V. Comparison of Presbyteries in the Order of Percentage of Collections.

It is recommended :

I. That this Committee be relieved of all the duties consequent upon its representation of the Boards.

11. That the Synod constitute eight Permanent Committees, one on each of the Boards of the Assembly. Each Committee shall consist of four ministers and three elders, five of whom shall be appointed with a view to residence contiguous to the locality selected as the headquarters of the Committee. These Committees shall be located as follows: Home Missions, Albany; Foreign Missions, New York; Education, Syracuse; Sunday School Work, Brooklyn; Church Erection, Boston; Relief Fund, Troy; Freedmen, Buffalo; Aid for Colleges, Rochester. It shall be the duty of these Committees: I. To familiarize themselves with the methods and the needs of the Boards, with a view to aiding the Synod in devising ways and means of more fully expressing its sympathy and co-operation in the great missionary and benevolent work of the Synod. 2. To inform themselves fully respecting the disbursement of the funds of the Boards within the bounds of the Synod, and labor to decrease the same. 3. To give fresh information, respecting the present financial condition of the Boards, in brief annual reports, not to occupy in reading more than ten minutes each.

III. That the Synod instruct this Committee to communicate with the Assembly's Committee and other Synodical Committees on Systematic Beneficence, with a view of securing a design for a more satisfactory statistical report.

IV. That, in view of the action of the Assembly, Minutes of 1891, the following plan for convening an annual Synodical Missionary Congress be submitted to the home Presbyteries, with the request that they carefully consider the same and signify their approval or disapproval, with reasons, to a Special Committee of the Synod, prior to June I, 1892. In case a majority of the Presbyteries approve in general the plan submitted, it shall be worked out in detail by this Special Committee, aided by the suggestions of the Presbyteries, and presented to the Synod next year for final action.

#### PLAN FOR A SYNODICAL MISSIONARY CONGRESS.

Before April 1st in each year the chairmen of the Permanent Committees of the Synod on the Boards of the Church and on Systematic Beneficence, shall meet, and choose one of their number chairman of a Committee of Arrangements, to select a place and arrange the program for a Synodical Missionary Congress, to be convened on the evening of the first Tuesday in June. This Congress shall be a deliberative body only, called by direction of the Synod, and presided over by the Moderator of the Synod.

I. It shall meet for the following objects :

I. To afford ample opportunity for spreading before the people the needs of our missionary and benevolent work in a manner more personal and effective than can be secured by the printed page.

2. To provide a Synodical Conference on the distinctively Presbyterian objects of beneficence, that by means of the knowledge thereby secured, and the personal interest and sympathy thereby stimulated, a larger proportion of our benevolent funds may find its way directly to the treasuries of the Boards.

3. To secure the co-operation and increase the intelligence of many of our most efficient and liberal laymen, who have no seat in the courts of the Church, and hence are but rarely brought into close sympathy with the organized missionary work of the Church.

4. To arrange a meeting place for missionaries, secretaries, pastors, laymen and lay-women, where, relieved from the technicalities necessarily consequent upon the meetings of the Church courts, and provided with time enough, they may engage in earnest prayer and conference concerning their duties and privileges in laboring for the evangelization of the world.

II. The members of this Congress shall be chosen in the following manner: Each *Presbytery* shall elect as many ministers and elders as are elected to the Synod, and according to the same plan. Each *Church* shall send one representative, who shall be appointed by the Session from among the members of the congregation. Each *Woman's Presbyterial Society* shall send three representatives, elected by its corps of officers.

III. The sessions of the Congress shall be arranged so that each Board, and the Committee on Systematic Beneficence, shall have an assigned place on the program; and each Permanent Committee shall select speakers and topics for the portion of the program assigned to it by the Committee of Arrangements. The officers of the Boards, and the members of the Synod's Committees on the Boards, and on Systematic Beneficence, shall be *ex-officio* members of the Congress.

IV. Any overtures, suggestions or resolutions respecting the work of the Church may be sent to the proper Permanent Committee of the Synod, and with its approval may be presented to the Synod.

V. The report of this Congress shall be made to the Synod by the chairman of the Committee of Arrangements.

The Synodical Superintendents presented their report, and addressed the Synod.

The report was accepted, and is as follows:

Our work has been prosecuted in the eastern district through the entire year, and in the western for six months. Consequently the accompanying statistics represent only eighteen months of labor:

We are happy to report the continued support and encouragement of both ministers and churches, who listen to our reports of need and work with increasing interest.

The weaker churches welcome us with expressions of gratitude for the sympathy which we bear to them from the Presbyteries and stronger churches. By these things we are stimulated and encouraged, and our success has been found largely in this co-operation.

The Presbyteries are increasing very greatly in the practical interest taken in their weak churches. The committees are giving more and more attention to the work; and how the stronger shall help the weaker is frequently the leading topic in the meetings of Presbyteries. This is one of the most hopeful signs as to Church work in the older States. And our Synod will have to make greater progress yet if we are to keep pace with our neighbors.

In obedience to the Synod, we have done what we could to secure funds for Synodical Aid. Besides personal efforts with churches and Presbyteries, we issued a postal card circular in March, and sent it to all the ministers and vacant churches in the Synod.

We have used our best efforts for economy in the supply of the churches, and encouraged contiguous churches to unite their strength in the support of the means of grace.

We have prosecuted the work in the usual ways of pulpit supply, evangelistic meetings, pastoral visitations in vacant churches, aiding churches to raise money for congregational purposes, giving advice, presiding on various occasions, and doing whatever we could whereby we might be useful. It has been a pleasure also to act as a medium of information between ministers and churches.

The transformation of population that is constantly going on because of business changes and by death, with the immigration of a different class of people, promises no rest to the Sýnod and Presbyteries in carrying on the work of the Church in our bounds.

In most respects the work is encouraging; but the discouraging feature is the fact that there are church doors closed for want of money to support men sufficiently in the small fields.

The report of the Permanent Committee on Synodical Aid and the report of the Treasurer of the Synodical Aid Fund, were presented and accepted. The consideration of these reports was made the first order of the day on Thursday.

Papers were reported by the Stated Clerk, and referred as follows :

To the Committee on Bills and Overtures :

I. An overture from the Presbytery of Rochester respecting the transfer of the Church of East Kendall.

2. An overture from the Presbytery of Otsego, on the subject of Theological Education.

3. A communication from the American Sabbath Union.

To the Committee on Judicial Business :

I. An appeal of Mrs. Ella B. McKelvey from a decision of the Presbytery of Nassau.

2. An appeal of James Waddell from a decision of the Presbytery of St. Lawrence.

3. An appeal of Alexander Dunn and others from a decision of the Presbytery of St. Lawrence.

4. A complaint of William D. Lord against the Presbytery of Buffalo.

The Committee of Arrangements reported, recommending

That it be the second order of the day on Thursday to hear the Rev. Charles L. Thompson, D. D., in behalf of the Board of Aid for Colleges; the Rev. Allen Macy Dulles, in behalf of the Board of Education; and the Rev. Walter Laidlaw, in behalf of the Board of Missions for Freedmen.

The recommendation was adopted.

A recess was taken until half-past two o'clock P. M.

Closed with prayer.

WEDNESDAY, October 21, 2.30 o'clock P. M.

The Synod met and was opened with prayer.

The Committee on Religion and Public Education presented the following report, which was accepted :

Your Committee, acting upon the instructions of the Synod, communicated with similar committees appointed by other bodies, and arranged for a Conference in the city

Oct. 21st,

of New York, November 17th and 18th, 1890. This Conference was attended by thirtythree delegates from twenty-four ecclesiastical organizations, representing ten Protestant denominations. In three sessions it thoroughly discussed the whole question, both the secular and religious views of the functions of the State being eloquently defended by distinguished speakers.

Papers were read by Rev. Prof. G. R. Crooks, D. D., Rev. S. B. Beiler, and Rev. Joseph E. King, D. D., Methodist Episcopal; Rev. Wayland Spaulding and Rev. W. H. Ward, D. D., Congregational; Rev. David G. Wylie, Ph. D., Presbyterian; Rev. Lewis Francis, Reformed; Rev. B. B. Tyler, Disciple; Rev. J. C. K. Milligan, D. D., Reformed Presbyterian; Rev. W. T. Sabine, D. D., Reformed Episcopal; Rev. Arthur Brooks, Protestant Episcopal; and Rev. J. B. Remensnyder, D. D., Lutheran.

At the close of the discussion a unanimous vote of the Conference adopted as its platform the following

#### STATEMENT OF FACTS.

"I. The commonwealth of New York divorces the Church from the State, and does not attempt the work of the Church; but, at the same time, in accordance with its constitution, it teaches Christian morals and maintains religious exercises so far as it finds this expedient for the purposes of the State.

"2. At present this State teaches Christian morals, and maintains religious exercises in its State University, in its Benevolent and Reformatory Institutions, and in a large number of its Common and High Schools."

These facts this Conference notes with great satisfaction.

#### DECLARATION OF PRINCIPLES.

"1. For the preservation of the constitutional right thus exercised by New York State, it is proper and wise that the extent to which religious exercises be maintained in any school under the care of the State be left to the general voice of the constituency of such school, with strict care that no right of conscience be violated.

"2. For the interest and preservation of the State, expediency demands that practical morals be taught, as an essential part of the curriculum, in every public school.

"3. To this end our people must see to it that the right persons be appointed as school officers and as school teachers in every district of each city and county in the State. They should in no case be selected because of political party affiliations, but in all cases solely because of their fitness for the positions which they are to fill; and this should be especially insisted upon in the case of School Commissioners and Trustees, and of City Superintendents and Boards of Education.

"4. Suitable text books in morals should be provided for the use of teachers or pupils or both, as circumstances may require, and in every school in the State the Ten Commandments should be taught."

Upon the basis of this platform, a Committee of the Conference, appointed to carry on the work begun, has organized "The League for Moral Instruction in Public Schools."

Among the most valuable papers presented at the Conference was one by William Allen Butler, LL.D., in which he discussed the Religious Basis for Moral Instruction in Public Schools from a legal point of view, and with special reference to the Constitution and Laws of New York. A copy of this paper is herewith submitted, and your Committee takes pleasure in calling attention to the abundant justification which it affords for the position hitherto taken and defended in this Synod.

The League contemplates holding another Conference upon this subject, and therefore your Committee requests to be continued for another year to communicate with similar Committees appointed by other bodies. Several members of the Committee having removed or died, it is recommended that, if the Synod see fit to continue its Committee, it

be enlarged by the addition of the Rev. John Hall, D. D., and the Rev. Charles L. Thompson, D. D.

The request was granted and the recommendation adopted.

The Committee on Sunday School Work presented the following report, which was adopted :

In view of the large number of children and youth, in the bounds of the Synod, who are not receiving religious instruction, either at home or in any Sabbath School, it is recommended:

I. That the Synod urge upon the several Presbyteries the necessity of a house to house visitation, for the purpose of securing the attendance at Sabbath School of all children not now attending any other school; and that each Presbytery, either by an organization of its own, or in co-operation with the system of the State Sunday School Association, or any other agency, endeavor to secure and maintain a thorough canvass of all the territory within its bounds.

2. That this Committee be merged in the Permanent Committee of the Synod on the Board of Publication and Sabbath School Work, and that the latter prepare a letter setting forth the needs of this work, and send a copy to the Chairman of the Sabbath School Committee of each Presbytery, with the request that he bring the subject before the Superintendent of every School in his Presbytery.

3. That the Chairman of the Sabbath School Committees of the various Presbyteries be instructed to report, in detail, to the Synod's Committee, the result of their endeavors, not later than September 1, 1892.

4. That the Permanent Committee tabulate these reports and present them at the next meeting of the Synod, with such recommendations as may seem desirable.

The Rev. Messrs. Elijah R. Craven, D. D., of the Synod of Pennsylvania, William Nesbitt Chambers, of the Oneida, Chenango and Delaware Association of the Congregational Church, and the Rev. Samuel W. Pratt, of the Synod of Michigan, being present, were invited to sit as corresponding members.

The Woman's Synodical Committee on Home Missions presented the following report, which was accepted :

For the year closing April, 1891, in the Synod of New York, the whole amount raised for Home Missions and Freedmen by the women of the Presbyterian Church, and sent through the Presbyterian Home Mission Board, was \$61,557.34, an advance in money over the previous year of \$401.80.

In additton, boxes of clothing and supplies of home comforts were sent to missionary families, and to schools, to the amount of \$44,499.89, about \$10,000 in excess of the amount sent last year. We are devoutly thankful for the small advance in funds and work, notwithstanding the constant and general plea of restricted finances.

The outlook for the coming year foreshadows more earnest efforts and prayers. We trust there will be faith enough, hope enough and love enough to meet the growing demands of mission work in our own land, for the country's and the Master's sake.

#### Oct. 21st,

The Rev. Messrs. L. Merrill Miller, D. D., and James N. Crocker, D. D., and Elder Calvin T. Hulburd were appointed a Committee to convey the salutations of the Synod to the Woman's Synodical Home Mission Convention, now in session in the Stone Street Church of this city, and to present to that body the subject of Synodical Aid.

The Pastoral Letter was presented, read and referred to the following Committee: Rev. Messrs. Edward M. Deems, Alfred E. Myers, and Milton Waldo, D. D., and Elders John C. Tucker and Horace E. Smith.

The Committee on Systematic Beneficence was constituted as follows: Rev. Messrs. Lansing Van Schoonhoven, William S. Hubbell, D. D., George C. Yeisley, D. D., and Alfred E. Myers, and Elders Francis A. Board, Edward Wells and John H. Osborne.

In accordance with the arrangement, a conference was held, on the topic "Young People and the Church."

The following was adopted unanimously, and ordered to be transmitted, with the signatures of the Moderator and Stated Clerk:

The Presbyterian Synod of New York sends hearty greetings and God-speed to the Convention of Christian Endeavor Societies now in session in Utica. See I John 2: 12-14.

A recess was taken until half-past seven o'clock P. M.

Closed with prayer.

WEDNESDAY, October 21, 7.30 O'clock P. M.

The Synod met, and after devotional services listened to addresses on Home Missions, by Rev. Messrs. Andrew V. V. Raymond, D. D., and Charles L. Thompson, D. D.

Adjourned until Thursday, at nine o'clock A. M.

Closed with prayer and the apostolic benediction.

THURSDAY, October 22, 9 o'clock A. M.

The Synod met, and the Sacrament of the Lord's Supper was administered in accordance with the arrangement.

The following Ruling Elders served the communicants : Peter Carter, Solomon E. Smith, John C. Tucker, Alfred B. Smith, Samuel Q. Brown, Sanford R. Knapp, William R. Halbert, and John A. Vance.

Prayer was offered by the Moderator.

The roll was called, and the following delegates, not previously enrolled, were reported as being present :

Presbylery of Binghamton: Minister—A. Cameron McKenzie. Lyons: Minister—A. Parke Burgess. New York: Minister—William T. Carr.

The minutes of Wednesday's sessions were read and approved.

The following telegram, in reply to the Synod's message, was received :

The New York State Christian Endeavor Societies, in convention assembled, send greetings. "Grace be unto you, and peace, from God our Father, and from the Lord Jesus Christ."

The Special Committee on the Synodical Aid Plan presented a report, which was accepted.

The Committee on Judicial Business presented the following report :

Judicial Case No. 1, being an appeal of James Waddell, an Elder of the Church of Waddington, from the action of the Presbytery of St. Lawrence, setting him aside from the active duties of his office in that Church.

It is recommended, that the appeal be dismissed, for the reason that the intent and effect of the action of the Presbytery were to cause the appellant to cease to be an active elder, which is clearly within its constitutional power. But as the word "depose" is used in connection with this action, the Presbytery is directed to amend its record, so that it shall conform to the language of the Book of Discipline.

Judicial Case No. 2, being an appeal of Alexander Dunn, James Allison and Thomas Fife, Elders of the Waddington Church, from certain action of the Presbytery of St. Lawrence, touching the same matters :

It is recommended, that the appeal be dismissed, for the reason that while the resignation, by these brethren, of their position as active elders, and the action of Presbytery in relation thereto, may be open to slight technical objection, the ends of justice appear to have been accomplished, and the peace and welfare of the Church conserved.

Judicial Case No. 3, being an appeal of Mrs. Ella B. McKelvey, from certain action of the Presbytery of Nassau :

It is recommended, that the appeal be dismissed, for the reason that while there may have been irregularities in the conduct of her trial before the session, the appellant lost her remedy by failure to comply with the terms of the Book of Discipline regarding appeals.

Judicial Case No. 4, being a complaint of William D. Lord against the Presbytery of Buffalo :

It is recommended, that the complaint be found in order, and that it be referred, for trial, to a Judicial Commission, to report during the present sessions of this body.

The recommendations were severally adopted.

The members of the Committee on Judicial Business were constituted the Judicial Commission for the trial of the complaint against the Presbytery of Buffalo.

The reports on Synodical Aid were made the first order of business this afternoon.

The Committee to whom the Pastoral Letter had been referred, presented its report, which was accepted, and the Pastoral Letter as amended was adopted, and ordered to be printed in the Appendix to the Minutes.

The Committee on the Endowment of Hamilton College presented the following report, which was accepted, and its recommendations were adopted :

Since the last meeting of the Synod, but little has been done toward the accomplishment of the object for which the Committee was appointed. During the past year, Hamilton College has experienced great changes, in the removal of three members of its faculty, and the death of one of its oldest professors, and of its president. While this may not be the occasion, or the place, to pronounce a eulogy upon the character and life of President Darling, it is proper to recognize the fact, that to his zeal for the cause of Christian education, and his love for the Presbyterian Church, is mainly to be attributed the inauguration of the plan of organic union of the College with the Church, and that measure of success which has attended the efforts in its behalf. All who were associated with him well know, how in this, as in many other directions, he devoted his great powers in unremitting and self-sacrificing labor for the advancement of Christ's Kingdom. The great changes which have recently occurred, have led your Committee to think that the present is an inopportune time to prosecute the duty with which they were charged; and to refer to Synod the question, which for some time has been asked, whether provision shall be made for farther continuance of effort in that direction.

They are thankful to be able to say, that notwithstanding the peculiar and afflictive dispensations which the institution has suffered, God's favor has been manifested in giving it a great degree of prosperity in the large number of students, the filling of the vacant professorial chairs by worthy incumbents, the appointment of an Acting President respected and beloved by all, the near anticipation of funds the income from which will greatly assist in meeting its current expenses, and above all, the earnest determination by all connected with it that its past eminence in learning and religion shall be maintained. There has also been no weakening of the ties which for so many years have existed between the College and the Church. The members of the Board of Trust and of the Faculty are mostly Presbyterians, by far the greater number of students are from Presbyterian families, and the same large proportion as heretofore is looking forward to the Christian ministry in connection with our Church.

There is, therefore, no reason why the Church should lose her interest in the College, or cease to consider it as connected with her in relations of earnest sympathy and cooperation. Neither should the idea of organic connection be abandoned, if in the providence of God, circumstances should hereafter indicate it to be desirable and practicable. But we feel that at present, in view of the religious affiliations of the College, and of the deep interest which the Church must feel in the great number of her children committed to its care and instruction, and of the large amount of money which she has already contributed toward its endowment, there should be some mutual recognition of their relation to each other.

The Committee therefore recommends :

I. That the Committee on the Endowment of Hamilton College be continued, to keep the whole matter under advisement, and prosecute the work of endowment when it shall appear feasible.

2. That this Committee should seek, from the Trustees of the College, a recognition ot visitors to be appointed by the Synod, and an invitation to them to attend the public exercises of the College, and become acquainted, as far as is proper, with its management and the character of its instruction.

3. That the Synod reiterate and emphasize the recommendation of previous years, that each Presbytery endow a permanent scholarship in Hamilton College, and call especial attention to the fact, that the offer is extended for another year, to give 500 toward each of such scholarships, for which a Presbytery shall contribute 1,000. The income of the scholarship fund of 1,500, is to apply in perpetuity toward the term bills of the student nominated by the Presbytery. The Presbytery of Geneva has already raised the amount necessary to secure the advantage of this offer, and a little effort in other Presbyteries would accomplish the same result, which would not only be a great advantage to the nstitution, but assist a large number of young men to prepare for the Gospel Ministry. We commend this subject to those who deplore the scarcity in our Church of candidates for the Christian Ministry.

The Committee on the Minutes of the General Assembly reported that it had found nothing requiring action on the part of the Synod, and its report was accepted.

A recess was taken until half-past two o'clock P. M.

Closed with prayer.

THURSDAY, October 22, 2.30 o'clock P. M.

The Synod met and was opened with prayer.

The report of the Special Committee on the Synodical Aid Plan was considered, and the following action was taken :

Resolved, I. That the report be printed and distributed to the churches.

2. That the following overture be sent to the Presbyteries, to be answered with a direct affirmative or negative :

"Shall the Synodical Aid Work in the State of New York be conducted separately from the general work of the Board of Home Missions?"

3. That the Presbyteries report their consideration of the paper, with any modifications they may recommend in the proposed plan, to the Special Committee, by or before September 1, 1892, and that the Committee be continued.

4. That the Standing Committee on Synodical Aid be directed to confer with the officers of the Board, with a view to the more effective administration of our mission work during the current year.

The Committees appointed to examine the Records of the following Presbyteries, reported recommending that the records severally be approved as far as written, namely, Albany, Binghamton, Boston, Cayuga, Champlain, Columbia, Genesee, Geneva, Long Island, Nassau, New York, North River, Rochester, Steuben, Syracuse, Troy, Utica, and Westchester.

The reports were adopted.

The Records of the Presbyteries of Chile, North Laos, Oroomiah, and Siam were not presented.

The Committee to Nominate Trustees of the Synod and Trustees and Examiners of Elmira College, presented their report, which was accepted, and the following persons were duly elected :

Trustees of the Synod: Rev. Henry M. MacCracken, D. D., Rev. Charles L. Thompson, D. D., William Allen Butler, and John C. Tucker, for the term of three years; and to fill vacancies, Rev. Alfred H. Moment, D. D., for one year, in the place of Rev. Leander T. Chamberlain, D. D., removed beyond the bounds of the Synod; and Rev. Robert F. Sample, D. D., for two years, in the place of Rev. Samuel M. Hamilton, D. D., also removed.

Trustees of Elmira College: John T. Rathbun, John I. Nicks, Newton P. Fassett, Rev. Wilson Phraner, D. D., Seymour Dexter, Hon. David C. Robinson, for the term of

three years; and in place of Rev. William R. Duryea, D. D., Rev. Henry D. B. Mulford, to serve for two years.

*Examiners*: Rev. Samuel Dunham, Rev. Marcus N. Preston, and Howard Elmer, to serve for three years.

The Rev. N. Beall Remick, D. D., Rev. Alfred E. Myers and Elder Horace E. Smith were appointed the Committee to prepare the Pastoral Letter for next year.

The Committee on the Records of the Presbytery of Brooklyn reported recommending that they be approved as far as written, with the following exception :

That the names of churches not represented in the Presbytery are not recorded.

The report was adopted.

The Committee on the Records of the Presbytery of Chemung reported recommending that they be approved as far as written, with the following exceptions :

I. There is a lack of uniformity in the use of names and titles. Only the initial letters of the Christian names are in many cases given, and abbreviations are numerous.

2. The names of the Committees on the Records of Sessions are omitted, page 410.

3. The action is anticipated in ordering the names of three ministers to be placed on the roll, and reported to the Assembly, before the letters from their respective Presbyteries, which had been applied for, had been received; page 411.

The report was adopted.

The Committee on the Records of the Presbytery of Lyons reported recommending that they be approved as far as written, with the following exception :

That, at times, only initials are used before surnames, contrary to the explicit rule of the Synod.

The report was adopted.

The Committee on the Records of the Presbytery of Niagara reported recommending that they be approved as far as written, with the following exception :

The action recorded on page 244, transferring a church, upon request, to another Presbytery.

The report was adopted.

Rev. Charles L. Thompson, D. D., addressed the Synod in behalf of the Board of Aid for Colleges, Rev. Allen Macy Dulles, in behalf of the Board of Education, and the Rev. Charles Van Norden, D. D., in behalf of Elmira College.

The report of the Trustees of Elmira College was presented, accepted, and ordered to be printed in the Appendix to the Minutes.

The Committee of Visitors to the University of the City of New York presented the following report, which was accepted :

The Committee met at the University May 12, 1891. After an extended conference with the acting Chancellor, who explained, in detail, the scope and aims of the University, the various classes were visited and the work was inspected in general. As a result we report our unqualified endorsement of the present administration of this honored institution. There are clear evidences of such intelligent and thorough supervision and direction as place the University abreast of the best educational institutions of our country. We were especially impressed with the adoption of the most approved modern methods of higher education, and the practical adaptation of the University to present needs. The new school of Pedagogy, the first in America, is but one of the evidences of this advanced and aggressive spirit. The need of new and enlarged accommodations for the Academic Department is manifest, and we learned with pleasure of the serious effort now making to secure the removal of this department to a most eligible site above the Harlem River. The province of your Committee's report seems limited; but, in addition to the general approval here given, we wish to commend the interests of the University to the sympathy and practical support of the Synod, believing that these interests present an inviting field for Christian philanthropy.

The Committee on the Next Place of Meeting reported an invitation from the Fourth Church of Albany, and recommended that it be accepted.

The recommendation was adopted with the thanks of the Synod, and it was ordered that the next annual meeting of the Synod be held in the Fourth Church of the City of Albany, N. Y.

The Session of the Church was appointed the Committee of Arrangements.

The Committee on the Records of the Presbytery of Otsego reported recommending that they be approved as far as written, with the following exceptions:

1. On page 47 is a repetition of a record made on page 42.

2. On page 51, under the head of ministers present at the opening of the Presbytery, the name of a person is recorded who was not a licentiate even, but was subsequently licensed and ordained.

Oct. 22d,

3. On pages 55 and 56, under date of September 9, 1891, there is a record of approval by the Presbytery of an action reported verbally by a member of the Presbytery as having taken place July 16, 1891, when two ministers and one elder met at what is spoken of as "the special meeting of Presbytery," though no call for such special meeting is recorded or even referred to.

The two ministers and one elder, not being a quorum, organized as a Presbytery, received a licentiate from a Presbytery in Canada, and proceeded to ordain him, and install him pastor of the church at the place of meeting.

The report was adopted.

The following minute was adopted :

Whereas, The Synod of New York deplores and reprobates the traffic in intoxicants in Africa, and

Whereas, There is an intimate relation between this traffic and the slave trade, and

Whereas, Treaties have been formulated by conferences of commissioners from this country and from the Christian nations of Europe, prohibiting this traffic, which treaties have been ratified by all the European nations represented in those conferences, and

*Whereas*, The failure of the United States to ratify these treaties is the only remaining obstacle to their immediate enforcement, and

Whereas, Vast quantities of rum are exported to those regions from within the bounds of this Synod, therefore

• *Resolved*, That the Synod of New York appoints the Moderator and Stated Clerk to memorialize the President and the Senate of the United States, and to use every effort, on behalf of the early ratification of treaties now pending, or which may yet be formulated, for the destruction of the traffic in intoxicants and in men in Africa and other unevangelized parts of the world.

The Committee on Bills and Overtures reported the following papers and recommendations:

Overture No. 1. From the Presbytery of Rochester, asking the transfer of the Church of East Kendall from the Presbytery of Niagara.

It is recommended that the request be granted, there being satisfactory evidence of consent on the part of the Presbytery of Niagara.

Overture No. 2. From the Presbytery of Otsego, asking that steps be taken for providing a limited theological education for men of limited opportunities, for limited fields of labor.

It is recommended that the Presbytery be referred for answer to the Minutes of the General Assembly for 1891, p. 176, Declaration No. 2.

Overture No. 3. From the American Sabbath Union, in reference to the opening of the World's Columbian Exposition on the Lord's day.

It is recommended that the Synod reaffirm the action of last year, as follows :

Resolved, That the Synod of New York, representing more than 1,100 ministers of the Gospel, and 165,000 Church communicants, earnestly renews its appeal to the Directors of the World's Fair, to be held in Chicago, to respect the convictions and historic practice of our Christian republic, and the law of God, and close the Exposition on the Lord's day; and that this resolution, signed by the Moderator and Stated Clerk, be forwarded to the managers of the Exposition.

The recommendations were adopted.

The Committee on the Records of the Presbytery of St. Lawrence reported recommending their approval as far as written, but calling the attention of the Presbytery to the corrections to be made in accordance with the action of the Synod in Judicial Case No. 1.

The report was adopted.

The Board of Examiners of Elmira College, presented a report which was accepted, and of which the following is an abstract :

The past year has been one of the most prosperous in the history of this institution, which has the proud distinction of being the first college established in this country for the higher education of women.

This seat of learning is located in the flourishing city of Elmira, in southern New York, and is easy of access by railway from all parts of the country.

The main building is a large edifice of brick, occupying a commanding site, and facing a beautiful campus of ten acres. Two hundred and twenty-five feet long, and, at the centre, two-thirds as deep, and five stories high, with a dome rising into a sixth story, it is commodious and well arranged, containing over seventy-five rooms for boarders, besides ample space for chapel, parlors, gymnasium, infirmary, recitations, and the use of domestics. It is heated by steam from boilers not underneath, is lighted by electricity from without, and supplied with a trustworthy night-watchman, an elevator, fire-escapes, water tanks, and telephonic connection with the fire department. An astronomical observatory, situated on a site near the campus, is well equipped.

During the past year those interested in the college were made glad by the generosity of Mr. Solomon Gillette, of Elmira, who, at his own expense, built the Gillette Memorial Music Building, containing twenty teaching and practice rooms, which are isolated from one another by padded walls and floors, and are heated by steam, lighted by electricity, and equipped with new pianos. Mr. Gillette has thus invested about \$12,000. This of itself shows the estimation in which the institution is held by a citizen of marked prudence and good judgment.

The entire property of the institution, at a fair valuation above all indebtedness, is estimated at nearly \$300,000.

By the generosity and public spirit of Messrs. Justus L. Bulkley, Thomas S. Ritch and N. B. Vaughan, of New York City, executors and residuary legatees of the estate of the late Daniel B. Fayerweather, Esq., Elmira College, through a deed of gift, becomes the prospective recipient of \$50,000. This has not only encouraged the Trustees and Faculty, but it has stimulated the hope that others may come forward with their gifts, until the amount reaches two hundred and fifty thousand dollars, the sum really needed to place the college on a firm and independent footing.

The faculty numbers twenty, with Dr. Van Norden president, whose peculiar fitness for the position impresses the committee more and more. The venerable Dr. Cowles, with his remarkable teaching ability, is rendering valuable service as an instructor. A close inspection of the work done by each professor leaves nothing to report but that which is most satisfactory. The graduates, too, are taking responsible positions, and reflecting honor on their Alma Mater.

In June, 1893, the Preparatory Department will be closed, and thenceforth the energies of the faculty will be given exclusively to collegiate work. This, your committee believes, is a step in the right direction, and will add to the efficiency of the institution.

Much might be added to show the improvements in the general work of the college, especially in the departments of Music, Art, Physical Culture and Bible Study. And a word of commendation should be bestowed on the charming home-like atmosphere of the institution. The college is commended anew to the great Presbyterian Church, whose members, it is hoped, will come promptly to its aid, with generous hearts and open hands, and bringing their daughters to be adorned with the graces of a Christian culture.

A conference was held, pursuant to appointment, on the topic "Revivals, Evangelists, and the Converting Work of the Holy Spirit."

A recess was taken until half-past seven o'clock P. M.

Closed with prayer.

THURSDAY, October 22, 7.30 o'clock P. M.

The Synod met, and after devotional services the Rev. Messrs. George Alexander, D. D., Benjamin Labaree, D. D., and Henry A. Nelson, D. D., addressed the Synod in behalf of the work of Foreign Missions.

Rev. John McClellan Holmes, D. D., and Elder Horace B. Silliman, LL. D., were added to the Special Committee on the Synodical Aid Plan.

The report of the Permanent Committee on Synodical Aid was taken up, and its recommendations were adopted. The report is as follows :

Your Committee, early in the year, called the attention of the Presbyteries to the action of the Synod asking for thirty thousand dollars for the present year. It has abundant reason for believing that knowledge of this apportionment came very generally to the churches through the proper channels. Letters were addressed to 351 churches which had not contributed to this fund up to August 1st, and collections were asked for. For the above purposes nearly five hundred letters passed between the Committee and the churches.

In addition, the Synodical Superintendents have given information as they have traveled over the State, and have sent out leaflets containing important suggestions and needful facts. The Board also issued a circular, bearing the endorsement of the Synodical Committee, showing the need of help to this fund, and asking the churches to come to the rescue.

The result has been disappointing; although, considering the stringency of money, it has not been altogether discouraging. There is a slight advance over the receipts of last year. More general inquiry has been incited, and forty-one more churches have contributed this year—in all, 500 out of 802.

For the supply of 153 churches, and a few out-stations, 133 home missionaries are now in commission. To these is granted \$29,964 in sums from \$50 upward. A few more applications are before the Board. The following statement from the Treasurer of the Board is worthy of close attention :

The Presbytery of Albany, which has always been foremost in this work, still leads, having given \$761 more to the Synodical Aid Fund than it received in appropriations. Long Island gave \$78 more, and Niagara contributed \$131 while asking nothing; Geneva asked for only \$31 more than it gave, and North River \$3 more. The remaining Presbyteries received much more than they contributed, some of them very largely in excess. This is true of some of the wealthiest Presbyteries, which are the most liberal in other benevolent work.

What is the history of Synodical Aid in our State? An able committee was appointed in 1882, "On the Condition of the Churches and Mission Work within the bounds

of the Synod." The report of this committee in 1883 led to the appointment of other committees from year to year, until, in 1886, the comprehensive plan now in operation was adopted, and urged upon the churches.

Every year since then, the Synod has strongly approved the plan, not only because justice to our mission work in the State demanded it, but also because, at the suggestion of the Board of Home Missions, the General Assembly recommended the object and action which have led the Synod to adopt such a plan of work. With such authority and in view of such strong endorsements and sanctions, we earnestly ask, what is there defective in the plan? If it were carried out according to the design and instructions of the Synod, would it not be easy to make it a perfect success?

The Board of Home Missions reports its total receipts for last year at \$849,363. Of this sum the Synod of New York gave \$184,361, or nearly one-quarter of the whole. If we add to this \$142,000 given to Home Missions through other channels than the Board, it makes the sum which the churches of our State contributed \$326,249, which is largely in excess of one-third of all the receipts of the Board of Home Missions.

Here, then, arises the question: Must the needy churches at our own doors be considered beggars, or their claims be discarded with only a slight excuse? Must papers in the west have occasion to say that the debt of the Board is, in part, compelled by the failure of this Synod to take care of its own churches? The Committee emphasizes these questions, because letters received show that the trouble is largely due to the fact that some ministers and elders are indifferent to any such plan of Synodical Aid, and are reluctant to press it upon their churches.

We are chiefly anxious that the great and good results proposed by the Synodical Aid Plan should be attained. And we are more firmly than ever persuaded, from what we have learned through large correspondence and from the increasing amounts given through the past four years, that if the Presbyteries should cordially and energetically follow the instructions of the Synod, perfect success would soon be attained.

The Committee recommends :

I. That \$32,000 be apportioned this year among the churches, in the same manner as last year.

2. That the Synod earnestly press upon its Presbyteries, its ministers and elders, the duty of bringing this object to the special attention of the churches and congregations, and of seeing that all have an opportunity of contributing to its support.

3. That the Synodical Superintendents be commended to the continued confidence and co-operation of the Board of Home Missions and of the Presbyterieş and churches within the bounds of the Synod.

The Committee on Systematic Beneficence was instructed to nominate the Permanent Committees on the Boards of the Church.

The Committee on the Records of the Presbytery of Hudson reported, recommending that they be approved with the following exceptions :

I. On pages 425, 426, the Committee on a certain reference of the Assembly presented a verbal report, recommending the approval of the plan in general, but suggesting some changes in the details. The recommendations were adopted, but there is no record of any, excepting the one to approve the plan in general. The wording is inexact or the record is incomplete. 2. On page 426 the Committee on the Minutes of the Assembly presented a verbal report, which was adopted. What was the report? And what was there in it to adopt?

3. Pages 426, 427 and elsewhere, initial letters are used instead of baptismal names.

4. At the foot of page 448 and at the top of page 449 an omission seems to occur in the phrase which reads, " the striking out of Section—Chapter twelve."

The report was adopted.

The Committee of Visitors to Adams Collegiate Institute presented the following report, which was accepted, and its recommendations were adopted :

An excellent, well equipped boarding and day school for young men and young women, beautifully located in a healthy and vigorous community, asks the interest and support of the Synod. Incorporated by the Regents in 1855, it annually receives limited aid from that source. The Regents' report in 1888, ranks it third in the list of institutions of this kind in the State. The past history of the school reads like a romance. The devotion, self-sacrifice and loyal support of many of the truest citizens of Adams and adjacent communities promise well for the perpetuity of the institution. It is free from debt, but the property is sadly out of repair. How shall the Synod aid it? Your Committee has carefully considered the various ways in which the Synod can secure control of the institution, and continue and increase its efficiency.

It therefore recommends :

1. That the Synod continue, for the present, the appointment of a committee to visit Adams Collegiate Institute.

2. That the Permanent Committee of the Synod on the Board of Aid for Colleges and Academies be instructed to co-operate with the officers of Adams Collegiate Institute with a view to placing the institution under the care of that Board.

The Committee to nominate the Permanent Committees on the Boards of the Assembly reported the following nominations :

The Treasurer's Report was presented and referred to the Committee on Finance.

The Judicial Commission appointed in Judicial Case No. 4, to hear and issue the complaint of Elder William D. Lord against the Presbytery of Buffalo, for approving the action of its Committee, in expunging certain matters from the records of the Church of Fredonia without complying with the full directions of the Presbytery, presented the following report, which was ordered to be recorded as the decision of the Synod :

The judgment of the Commission is that the complaint be sustained, so far as to pronounce irregular the action of the Presbytery in approving the report of a Committee which had expunged certain items from the Session records of the Fredonia Church, without seeking the co-operation of the Session in the performance of this act. Since, however, it appears that only harm could result from farther agitation of this matter, the Commission expresses its judgment that the case should now close, and directs the Presbytery of Buffalo to cause this decision to be inscribed on the records of the Session of the Fredonia Church.

The Committee on the Records of the Presbytery of Buffalo reported recommending that they be approved as far as written, that portion of

the minutes affected by the foregoing judicial decision not having been engrossed.

The report was adopted.

The Committee on the Observance of the Lord's Day presented the following report, which was accepted, and its recommendations were adopted :

It is with gratitude and thanksgiving that we note the growth and activity both of public opinion and of organized effort to promote the observance of the Lord's day. Seldom have the ministers of Christ been moved by more intelligent and earnest interest than now. Seldom have Christian laymen realized, so much as now, that the preserving of our Christian day of rest vitally concerns their home and business interests. But this very awakening only reveals the fact that the disease is deeply seated, and that the enemies of the Lord's day are thoroughly organized. The Committee notes with pleasure that in Syracuse, and other cities of the State, successful efforts have been made in closing on the Lord's day most if not all of the liquor saloons, and believes that there is not a town or city in the State where this same result might not be attained, if there could be a fearless, combined effort led by the Christian sentiment of the whole people. It will be a long fight, and must be a strong fight. If Christ's army falls back, the opposing forces will defiantly march in and occupy.

Your Committee regrets to note that the United Christian forces of the metropolis were either insufficient or too inactive to prevent the opening on the Lord's day of the Metropolitan Museum of Art. There is good authority for believing that this step might have been prevented, but for the apathy of Christian people. Let us hope that the experiment will prove so far a failure, that next year the Museum may be closed.

There are two avenues through which we can work. One is, and this must be first, to teach the children, and members of the church, to keep the Lord's day according to the commandment. The second is, to use all the agencies and methods that are wise and honorable, to secure the enforcement of existing laws, and to show to those who come from the lands of lost Sabbaths, that here they must respect the Lord's day.

It is therefore recommended :

1. That the Synod appoint a permanent committee of four ministers and three elders on Sabbath Observance, five of them to reside in or near the headquarters of the committee, which shall be the city of Utica.

2. That the Synod authorize the renewal of efforts to secure such changes in the sailing dates of our steamship lines as shall prevent the arrival of their vessels on the Lord's day.

3. That the Synod disapprove of the growing practice of railroad and steamboat companies of running Lord's day excursions to and from summer resorts, and the running of freight trains on that day.

4. That ministers and elders, and all Christian and home-loving laymen, do all in their power to persuade men who represent them in either the state or national legislature, to exert their influence toward maintaining, in the laws enacted, the integrity of the Lord's day. 5. That the first week in April, 1892, be observed by our churches as a week of special prayer, for the divine blessing upon all the people, that they may be led to a better observance of the Lord's day.

The Committee on Finance presented the following report, which was accepted, and its recommendation was adopted :

The Committee has examined the accounts of the Treasurer of the Synod, and compared them with the vouchers, and it finds the same correct. All the Presbyteries have paid their apportionments for the last year, except Rochester, which has paid only in part. The amount in the treasury, applicable to the expenses of the current year, is \$1,296.

It is recommended that the rate of apportionment for the present year be one-half cent for each communicant.

The Committee on Army Chaplains presented the following report, which was accepted, and its recommendation was adopted :

Your Committee hails with joy the increasing interest shown by Christians throughout our country, in the moral condition of the United States Army. The Presbyterian Church was foremost in urging needed reforms in the camp and garrison life of our soldiers. The Methodist Church followed its lead; and now the Lutheran, the Baptist, the United Presbyterian, the Congregational and Episcopal denominations have appointed committees to co-operate with ours in urging upon Congress the necessary legislation for elevating the character of our military service. Our General Assembly, in 1890 and 1891, has taken strong ground on this subject, and has recommended the Synods to prosecute this matter by States, in order thus to rouse public sentiment as to the improvement so urgently needed.

Some changes for the better have already been secured. Among these may be mentioned the discontinuance of post-traders; the abolition of Sunday morning inspections and Sunday evening parades; the recent legislation providing for discharge at the end of three years, instead of five, or even sooner by reimbursing the government for certain expenses; the requiring of certificates of good character from recruits prior to enlistment; the change in the location of recruiting stations from cities to rural districts; all of which measures will be uplifting in their effect.

. But other helps are required for the elevation of the soldier. It is still true that we have no adequate provision for his moral and religious training. In some quarters, subtle influences oppose or discourage all attempts at religious instruction for our troops. Others desire only *that* form of religion which ends in the ceremonial, and is allied to a dress-parade of piety. What is needed at once in our army is provision at every military post for a chapel and a chaplain, a library and a reading-room open to all, and a gymnasium and other health appointments similar to our best Christian Association buildings. At present, with 104 posts, we have but 34 chaplains, and less than 20 chapels for the entire' army. There are no library buildings, and but few available books. Barracks are still built to include an entire company of men, and thus the good and the bad are huddled together in a contact and a publicity constant and unavoidable by day and night. This degrading intimacy and lack of privacy could easily be remedied by subdivision of quarters. All vices flourish under the present barrack system.

Since our last report, the United Christian Commission, a society for reforming these abuses, has held its first annual meeting in Washington, and on Sunday, December 14th, a public mass-meeting was held in one of the largest churches of that city. The Hon. Redfield S. Proctor, Secretary of War, presided over this assembly, and in his opening address cited the indomitable army of Cromwell as proving that the higher the moral character of an army may be, the more effective will be its service for attack or defence. Other speakers urged the need of some competent religious teacher at every military post, and that he have every modern appliance for successful work. It was insisted with great force that a moral qualification should be required as a condition of promotion; that no officer who is addicted to gambling or to drink ought to hope for promotion, whatever may chance to be his seniority in rank; that all gambling among officers or soldiers should be prohibited by the Articles of War, and that the barrack-room should be divided into squad-rooms, thus enabling men of like tastes to associate together, and separating the vicious from the well-disposed.

A bill, embodying these and other reforms and framed by the Army Chaplains in conference, was introduced during the 51st Congress, by the chairman of the House Military Committee, and favorably reported to the House. It had the approval of that Christian soldier and statesman, President Harrison, as well as the endorsement of the Secretary of War and of many army officers of high rank. A majority of both Houses had agreed to vote for this bill, but it failed of passage because it could not be reached before adjournment.

A similar measure, called "The Army Chaplains Bill," will be presented at the next session of Congress. It has been drafted purely in the highest interests of the service, and expresses the convictions of not less than ten millions of actual communicants of Christian churches, as set forth in the recommendations of their deliberative bodies throughout our land. It aims to restore to civil life the American soldier, at the expiration of his enlistment, in such condition of person and character as to be an honor to his country and to his home.

Many of the most important garrisons of our army are included within the limits of this Synod. In view of this fact, and also of the need of increased moral and religious instruction for the enlisted men of every arm of the military service, your Committee recommends :

That this body requests the members of all our Sessions and congregations throughout the Synod, to use their personal influence with Congressmen, in securing the early passage of "The Army Chaplains Bill," and in furthering any other measures devised for the improvement of the moral condition of our soldiers.

The Synod met and spent half an hour in devotional services, Elder Peter Carter presiding.

The calling of the roll was dispensed with.

The minutes of Thursday's sessions were read and approved.

The following report was adopted :

The Committee appointed last year to consider a readjustment of the boundaries of the Presbyteries of Chemung, Geneva and Steuben, so as to provide for what may be best for all, reports as follows :

Inasmuch as the Presbytery of Chemung desires the churches connected with it to remain in its connection, and as the severing of the relation of some of these is the only change which under the circumstances could be made,

It is therefore recommended that there be no change made in the boundaries of these Presbyteries.

The Committee of Visitors to Auburn Theological Seminary presented the following report, which was accepted :

The Committee performed its duties as well as it was able. These duties are largely indefinite and optional. The Committee, however, attended the final examinations of the year, and the closing public exercises, and inspected the facilities for the instruction and accommodation of students. The work of the instructors is well and thoroughly done. The students, in the main, seemed earnest and enthusiastic in their work, and devout in spirit. The dormitory accommodations are adequate, agreeable and healthful. The campus is ample and beautiful. The library building is a fine one, with a good start toward adequacy in a working supply of books. But the Seminary lacks funds applicable to this purpose, for a permanent librarian in constant attendance, and for suitably arranging its rooms for studies of students in immediate access to the books they need. It also lacks miserably in chapel and recitation and lecture room facilities. It has no gymnasium for systematic physical culture and development.

Its presidential chair and that of Biblical Theology are unfilled and unendowed; and some of its other chairs have but an inadequate provision for the maintenance of the professors. The Synod should take effective measures for the speedy remedy of these deficiencies. Nevertheless, the Seminary is doing a great and good work, and the Synod may rest with entire confidence in the soundness of its theology, and the thoroughness of its instruction in all the branches which go to the full equipment of its candidates for the ministry. The chair of Homiletics and Pastoral Theology is happily filled by the newly elected professor, Rev. Arthur S. Hoyt.

The Seminary is commended to the prayers, the gifts and the confidence of all the churches, and of all who are seeking ample equipment for the Gospel Ministry.

# APPENDIX.

# I. PASTORAL LETTER.

With thanksgiving to God for the favor shown to its Churches, for the grace that has been vouchsafed through the preaching of the word, and for the spirit of love to the Master and of devotion to his service that has characterized, so largely, those who have been called into the fellowship of the Gospel, the Synod of New York sends greetings to all the Churches affiliated with it.

To us God has given a goodly heritage purchased for us at a great price, confirmed by the testimony of faithful witnesses who sealed their testimony with their blood, and authenticated by the presence and power of the Holy Spirit.

For all that has been done through the ministry and members of other communions we render devout thanksgiving. They are wielding an influence most potent for good. and that will be as lasting as eternity. They are co-workers in lifting men from sin to God, and in preparing the world for Christ's ultimate and universal reign. Yet, we rejoice in the special adaptation of the Presbyterian Church, in its ministry, its polity, its worship, and its discipline, to reach and evangelize the masses, to lay solid and permanent foundations of Christian principles, to develop the religious character, to furnish the loftiest motives for consecrated service, and to call it into efficient exercise. While, however, we so speak, it is far from true that we have fully met the responsibility laid upon us. We have not, as we should have done, reached out hearts and hands to those who have been calling for succor, nor have we proclaimed, with apostolic zeal, that Gospel which is the power of God unto salvation. The outcome of ministerial labor and Christian service, and of educational and evangelistic agencies, has by no means been such as in our best moments we desire, nor as we are warranted by the great commission to expect.

What is needed, if the Church is to accomplish its heaven-ordained mission, in view of the adverse influences with which it has to contend, is a firmer hold upon the fundamental truths of the Gospel, a consuming love for the souls of men, a more unreserved consecration to the Master, larger dependence upon power from on high, a tongue of fire to proclaim the great salvation, and great expectations of spiritual results.

In order to this, the Synod calls upon its ministers, elders and members to hold with unflinching firmness to the Bible as the word of God, revealing and developing the rule of life and the plan of salvation. We are living in an age of doubt, marked by a growing tendency to measure the truths of revelation by the narrow span even of man's largest attainments. Hold fast to that word which is stamped with the approval of Christ himself, and tested by the experience of many generations of believers. It has proved itself worthy of all confidence. It has brought salvation to many a lost one, and lighted many a wanderer from earth to heaven.

The Synod calls upon all to remember that the great central truth, around which all else revolves, and for the unfolding of which all else is recorded, is redemption purchased by the sufferings and death of the Son of God. This is the Gospel. There is "none other name under heaven," nor is there any other way by which the lost can be saved. This it is the mission of the Church to publish, and to illustrate by godly living. Salvation is neither a creed nor a fancy. It is not the bare anticipation of a life of bliss after death. It is deliverance from sin,—its guilt, its bondage, its power,—a deliverance without which our religion is only a delusion, and our doctrines are meaningless forms of words. It is to be feared that there is a widespread tendency to regard sin as a weakness, an error, a defect, a blemish which can be easily corrected, and not as " the abominable thing " that God hates. If we lose sight of the doctrine of sin, or fail to present it as the only thing that separates man and God, inherent in every man that comes into the world, and exposing to " the wrath and curse of God," or if we prize religion only for its incidental and reformatory influence, we take from the ministry and from the Church of God all that makes them worthy of the attention of men, and expose them to that indifference and neglect that are at the present time the occasion of serious and anxious complaint, and sore discouragement. Let us bring the Gospel to lost men as a living doctrine and a vital force, and they will welcome it.

Still farther, the Head of the Church has committed to you a most solemn trust. The Church is set not only for the maintenance of the truth, but for the perpetuation and dissemination of it. It has committed to it a generation in covenant relations to be instructed in Bible truth, and to be moulded into Christian character. The children in your households are not creatures to be clothed and fed merely. They are born for immortality. They are the Lord's heritage. Care for the children in your families as members of the flock. See to it that they are "planted in the house of the Lord," if you would have them to "flourish in the courts of our God." Familiarize them with religion as inseparable from the well ordered Christian household. Let there be "the church in the house." Bring them up in "the nurture and admonition of the Lord." Instruct them in the doctrine and polity of the Church to the privileges of which they are born. Never let the Shorter Catechism grow obsolete. See to it that the children grow up into the fellowship of their own Church, so that from them there not only may be an unfailing source of supply, but that they may become its staunchest defenders, and its most earnest and effective advocates. Call it by what name you will, let there be a society of Christian Endeavor. We need the young as a working element, if we are to have a working Church. But, still farther, call into active exercise all the working force of the Church, for its own healthful development, and for the good of those ready to perish, that so there may be built up a higher type of Christian manhood and womanhood, and a revenue of souls be gathered into the kingdom of God. See to it that the interest in the prayer meeting of the Church is maintained, and let every member be made to feel a personal responsibility for it. Remember that prayer is the Church's strong arm. It takes hold of the Most High. It wrests blessings from the Almighty. It brings God near to us. It gives to the Church a celestial atmosphere. It ensures to the agencies of the Church success in all that she undertakes for the glory of God.

But there is devolved upon the Churches the duty of giving the Gospel to those who are still in the darkness of heathenism, to those in our own land who are as yet dependent upon the Church at large for the means of grace, and to weak Churches within our own territorial limits. Humanity demands this. Our relation to Christ, the great exemplar in all missionary labor, demands this. Our covenant vows demand it. That prayer, "Thy Kingdom Come," which should be the burden of every Christian's cry, lays us under the most binding obligations.

Our religion must go down into our pockets. This Synod has an immense field to be cared for, weak Churches to be strengthened, dying Churches to be nursed back again to

life, and for all this money is needed. It must be forthcoming in abundance, or the cause of our divine Master will suffer. Let all ministers, officers and church members see to it that the Church contributes according to its means to the work of evangelization in this Empire State, and in Nèw England.

Do this, and through the Gospel faithfully proclaimed "The Lord shall comfort Zion: He will comfort all her waste places; and He will make her wilderness like Eden, and her desert like the garden of the Lord; joy and gladness shall be found therein, thanksgiving, and the voice of melody."

"Now the God of peace, that brought again from the dead our Lord Jesus, that great Shepherd of the sheep, through the blood of the everlasting covenant, make you perfect in every good work to do his will, working in you that which is well pleasing in his sight, through Jesus Christ; to whom be glory for ever and ever. Amen."

# II. REPORT OF THE SPECIAL COMMITTEE ON THE SYNODICAL AID PLAN.

I. The Synod shall undertake the work of caring for its weak churches, except those included in the Presbytery of Boston, entirely apart from the Board of Home Missions.

II. The following plan of sustentation shall be adopted :

I. In order that the work of the Synod may in no way interfere with the general work of the Board of Home Missions, every church in the Synod is enjoined to make, annually as heretofore, a contribution to the funds of that Board.

2. The moneys raised for the purpose hereinafter specified, shall be called "The New York Synodical Aid Fund," and shall take the place of contributions to the sustentation department of the Board of Home Missions.

3. The Synod shall appoint a committee of ten members, two from the bounds of each of the former Synods, to hold office for two years, one-half of the number to be elected at each annual meeting. It shall be the duty of this committee to receive all funds contributed for Synodical aid, and to appoint a treasurer, who shall make payment of the same as directed in section 6. The committee shall meet annually, before the meeting of the Synod or in connection with it, to make an estimate of the amount needed to carry on the work of Synodical aid for the ensuing year, to recommend the amount that each Presbytery shall be authorized to draw from the fund, and to recommend to the Synod such measures as the committee may deem best for securing the amount needed. The Stated Clerk of the Synod shall certify to the committee the amount which each Presbytery is authorized to draw for the ensuing year.

4. Each Presbytery shall have full authority to distribute the funds allotted to it by the Synod, subject to the following conditions:

(r) The Home Mission Committee of the Presbytery shall have a personal conference with the Elders, before recommending churches to the Presbytery for aid.

(z.) The Presbytery shall endeavor to group contiguous churches receiving aid from this fund. The exceptions shall be only where churches give evidence of speedily becoming self-supporting.

(3.) Ordinarily the Presbytery shall require, from each church receiving aid, a total contribution to the salary of the pastor equal at least to seven dollars per member.

(4) If for any reason a Presbytery fails to use the whole of its allotment, the remainder shall be subject to the control of the Synod.

5. Each Presbytery, through the chairman of its Home Mission Committee, shall, on or before October 1st, each year, send to the Synodical Aid Committee an estimate of the aid needed for the coming year by the weak churches within its bounds, in order that the Committee, upon a review of the same, may inform the Synod at its ensuing session, what is the total amount necessary to be raised.

6. It shall be the duty of each minister or missionary receiving aid from this fund to make a full report of his work, on the first day of January, April, July and October, on blanks furnished for the purpose, to the chairman of the Committee on Home Missions, in the Presbytery within whose bounds he labors; and upon the receipt and approval of such report the chairman shall issue to such minister or missionary, his order on the committee for the amount appropriated by the Presbytery for such service.

7. The Synod enjoins the churches to make contributions to this fund the first lien on their home missionary offerings.

8. In accordance with the instructions of the General Assembly, (Minutes of 1883, page 644,) the salaries of those in charge of aided churches shall be so proportioned as to give in each case an adequate support. Under this plan, until otherwise ordered by the Synod, the minimum salary of those doing full work shall be \$700. The parsonage, if there be one, shall be reckoned at the annual rental value, as a part of the salary. Special arrangements may be made with those doing partial work.

9. All ministers serving churches which receive aid from this fund shall be installed as pastors as soon as practicable. It is expected also that churches receiving aid will contribute annually, as is the duty of all our churches, not only to this fund, but to all the Boards and Funds of the Church.

to. Churches which are aided from the New York Synodical Aid Fund shall be served only by ministers approved by the Presbytery with which the churches are connected.

II. In order to the effective prosecution of this plan, and also to a thorough evangelization of our field, by the reviving of old churches and the organization of new ones, the Synod, with the exception of the territory covered by the Presbytery of

48

Boston, shall be divided into two districts, and for each of these there shall be appointed a Synodical Superintendent of weak and vacant churches and mission fields.

12. The first of these districts shall comprise the Presbyteries of Albany, Binghamton, Brooklyn, Champlain, Columbia, Hudson, Long Island, Nassau, New York, North River, Otsego, St. Lawrence, Troy, Utica and Westchester.

The second district shall consist of the Presbyteries of Buffalo, Cayuga, Chemung, Genesee, Geneva, Lyons, Niagara, Rochester, Steuben and Syracuse.

13. The Synodical Superintendents shall be appointed by the Synod, at a salary not to exceed \$1,500 per annum and expenses while on the field; the same to be paid quarterly out of the Synodical Aid Fund. They shall act in each Presbytery on the invitation, and under the direction, of the Committee of that Presbytery having charge of weak and vacant churches, and shall devote their time and efforts to the encouragement of weak churches, the procuring of pastors or supplies for vacant churches, the organization of new churches, and the general fostering and development of Presbyterianism throughout their respective districts. They shall report the results of their labors to the Synod at each annual meeting.

14. The Synod, at its annual session, shall apportion the gross amount which it approves for the next year, among the several Presbyteries of the Synod included in this plan, according to the number of their communicants; and each Presbytery shall apportion the amount assigned as its quota, among the churches within its bounds, according to their financial ability.

## VIII. EXTRACTS FROM THE STANDING RULES.

Ι.

The Annual Meeting of the Synod shall begin on the third Tuesday of October, at half-past seven o'clock P. M.

ш.

Each Presbytery shall, at its stated meeting next preceding the meeting of the Synod, and if possible not later than two weeks before such meeting, elect the number of delegates to which it is entitled, together with an equal number of alternates, as prescribed by the organic rule under which the Synod is constituted, namely:

"The Synod of New York shall be composed of equal delegations of ministers and ruling elders from each Presbytery in the following proportion: each Presbytery, the number of whose ministers and churches taken together is not more than 14, shall send one minister and one elder; each Presbytery containing more than 14 and not more than 28 ministers and churches taken together, shall send two ministers and two elders; and so in like proportion for every additional number of 14 ministers and churches taken together, or for the fraction thereof; *provided*, that no Presbytery shall be entitled to send more than ten ministers and ten elders."

#### 1V.

The Stated Clerk of each Presbytery, immediately after the election, shall send to the Stated Clerk of the Synod a certified list of the delegates and alternate delegates chosen by the Presbytery to represent it at the Synod; and from these lists shall be made up the official roll.

At the calling of the roll at the opening session, the names of the principals who have thus been reported, or of alternates duly substituted, shall be included; but when alternate delegates appear in place of their principals, such delegates shall report in person privately to the Stated Clerk of the Synod, before their names shall be substituted upon the roll for those of their principals.

Duplicate lists of delegates and alternates shall be sent promptly by the Stated Clerks of the Presbyteries to the Chairman of the Committee of Arrangements.

VII.

A complete roll of the ministers and churches of each Presbytery shall be sent by its Stated Clerk to the Stated Clerk of the Synod, at least ten days before the annual meeting.

#### VIII.

Each Presbytery, immediately after its Fall Stated Meeting, shall forward to the Stated Clerk of the Synod a Statistical Report and History of its Acts and Changes, for the year preceding, as required by the Form of Government, Chap. N. Sec. 9. These reports shall be printed in the Appendix to the Minutes.

#### XIV.

To provide for the necessary expenses of the Synod, the several Presbyteries shall furnish, annually, amounts proportioned respectively to the number of their communicants, according to a rate *per capita* determined at the previous meeting of the Synod. And if no action has been taken, the rate shall be six mills for each communicant.

These sums shall be due and payable to the Treasurer on the first of October, when the Synod's fiscal year shall terminate.

#### XVII.

The Minutes of the Synod shall be printed, under the direction of the Stated Clerk, as soon as practicable after the adjournment; and a copy shall be sent to every minister, to every elder whose name is on the roll of the Synod, and to the Session of each vacant church, within the bounds, severally, of those Presbyteries whose apportionments for Synodical expenses have been paid.




