REPORT ON STATE MISSIONS.

About sixteen years ago the State mission Board was organized by the Baptist State Convention. The Baptists of Alabama at that time were doing almost nothing for the mission cause. Through the influence of this board, largely, they have greatly increased their contributions for Home and Foreign Missions and they are now supporting fifty-four men in different parts of the state. On account of the stringency in money matters, which is now so seriously affecting the whole country the Board was not able to meet its obligations to the men in its employ for the quarter ending June 30th, and soon another quarter's salary will be due, and still the treasury is empty. We learn these lamentable facts from the corresponding secretary who is present with us. At the last meeting of the Association we made, what was believed to be, a progressive step to name to each church an amount which they were asked to try to raise. From the reading of the letters we fear some did not even try—churches report the full amount raised. Your committee feel sure that this is a good plan to adhere to. We therefore recommend that we try to raise \$500. The amount suggested by the State Board; and that a careful committee be appointed to apportion this amount out among the churches. This is only twenty-two cents to the member. Surely, if we propose to continue to claim to be Missionary Baptists, we will not refuse to give this small amount. Brethren, do not be idle now our country is being rapidly filled with strangers. Many of them are good people wno will help to improve our country, but many others bringing vices and immorality which will be destructive to the moral and spiritual intents of our children. New and strange doctrines are beginning to be preached in our country. We must put against these talse doctrines, the gospel in its purity. The State Mission Board commends itself to our people for its efforts to supply the new towns and Respectfully submitted, W. Y. Adams, Chairman. destitute with the gospel.

REPORT ON FOREIGN MISSIONS.

The duty to send the gospel, is not limited to our own country. Where-ever a lost child of Adam is found God's people are to carry or send the gospel, which is the power of God to save them. Our Foreign Mission Board, located at Richmond, Va., has missionaries in Mexico, Brazil, Africa, China, Italy and Japan. Alabama is represented in the mission forces in the toreign field in the person of Mr. Crawford and Miss Thornton in China, Rev. John W. McCollum and his wife in Japan and Mrs. Moseley and Miss McCormic in Mexico. Alabama contributed last year for Foreign missions \$7,753.67 which was more than the state ever

contributed before in one year. Etowah Association gave of this amount \$112.93, one church giving \$94.83 of this amount, leaving \$18.10 which was given by eight of the other churches, which leaves fourteen churches of this Association that gave not one cent for the salvation of lost souls beyond our borders. In the coming year when the Baptists of the whole world are moving to celebrate the centennial of modern missions, let us hope that the spirit of missions shall so stir the hearts and consciences of our people that they will never again send a letter to the Association which does not show something done for the saving of the heathen World. In conclusion, we would recommend the appointment of a committee of five to be known as the Centennial Committee, to co-operate with the State Committee to arrange mission meeting in our borders for the coming year. REPORT ON HOME MISSIONS.

Your committee on Home Missions report, on investigation we find that during the last conventional year that the board had four hundred and six workers in the field as against three hundred and seventy-one the year before. The results of these labors show a corresponding increase. Baptisms 5,349, a gain of 872 over the preceding year. Total additions to mission churches for the year 9,987. Churche: constituted by these workers 267. Sunday Schools organized 336. Houses of worship built 143. The sum expended in their erection \$60,473.00. The above is some of the results of your home work. It should be the motto of every Baptist in this broad land, "The World for Christ." Brethren, let us push forward the good work until it, revolving round this great centre, shall keep broadening until it shall reach the utmost verge of human habitation.

REPORT ON RELIGIOUS LITERATURE.

The press is the most powerful and efficient human agency ever devised for the distribution of knowledge. It is a fountain from which is continually flowing waters both bitter and sweet. It is an agency for good under wise Christian control, but under the management of the world it is satan's most effectual way of sowing the seed of error and preparing the hearts and minds of the masses for the accomplishment of his own wicked purpose. He has sought to undermine the foundation of our belief in God through such works as Tom Payne, Voltaire and Ingersoll. In modern times he has adopted a far more subtile method for corrupting the tastes and defaming the morals of men. The press is flooding the world with trashy works of fiction and adventure, many of which are damning in their influence. Such works as the life of Jessie James and Rube Burrows ought not to be tolerated in any Christian household. The Police Gazette and other papers abounding in obscene stories and pictures should be discarded and many of the secular papers are filled with the details of crimes and adventures that should not so much as be mentioned in our homes. How then can we stem the tide of iniquity? How can the press be enlisted in the interest of Christianity? First, let us as individual Christians see to it that no book, periodicals or newspapers come to our homes that are even questionable as to their moral character. Let us encourage the reading of such books and periodicals as will elevate the tastes and cultivate both the head and the heart. As a denomination we should use our own hymn and song books, our own Sabbath School literature such as is published by the Sunday School Board of the Southern Baptist Convention or the American Baptist Publication Society. We should take one State organ, the Alabama Baptist and encourage its circulation among our people. As Baptists we should certainly patronize our own publication societies and these lend a helping hand in publishing the truth as held and practiced by us. Respectfully submitted,

REPORT ON SABBATH SCHOOL.

Your committee on Sabbath School submit the following report for your consideration:

We find that only about one-third of the churches composing this Association maintain Sabbath Schools and that only a small portion of these schools are in a flourishing condition. Therefore, we have to report a lamentable lack of interest on the part of our churches in this most important work. We also note from the letters sent up that where there is no Sabbath School the churches are in a half dead-alive condition. We offer the following as some of the reasons that cause this failure on the part of the churches of our Association to do their duty: 1st, A non-conception of the power and influence of the Sunday School for good, and general in-difference to the cause of our Master. 2d, An inclination among the members of our churches to visit around the country on the Sabbath seeing what others are doing rather than looking after their duty to their churches and families. 3d, We are afraid that a great many of our individual members try to corrupt their influence and laziness with that much abused and little understood doctrine of "what will be will be." Your committee earnestly recommends that the churches be urged forward in this work, where it is already undertaken, and that the churches where they have no schools be requested by the Association to try this great work and give it a fair and prayerful attention. We would also urge upon our schools the duty of using the literature of our Southern Baptist Convention which we are sure is second to none and more nearly meets the needs of our Southern schools.

AMENDMENT.

RESOLVED 1, That it is the sentiment of this body to recommend and urge the churches composing this Association to appoint the fifth Sunday in November (this year) 1891 as a suitable time for the organization of district Sabbath School Societies to the furtherance of this Sabbath School work and also that such work may become more systematized.

Resolved 2, That each school be allowed one messenger for each twenty students or fraction thereof at said organization provided, however, that each school shall be entitled to two messengers.

Resolved 3, That the moderator of this body appoint some person, or persons to locate a place for said meetings of Sunday Schools and to call the same.

Resolved 4. That such societies shall report to result of their labors to this Association—either for approval or to the contrary at her next annual convention.

Bro. B. L. Murphree read report on Temperance which was discussed by Elder J. H. Glazener followed by the choir singing "Turn 'your Glasses down Boys." Report was then adopted.

REPORT ON TEMPERANCE.

We, your committee on Temperance, submit the following: Cognizant of the fact that this subject of Temperance in its most popular significa-tion, applies only to the use of intoxicating drinks. We desire only to speak of this subject in this sense. This evil of intemperance is one of the greatest and most formidable of all that the church has to contend with, and it becomes doubly so, because this evil is fostered and nurtured within the very folds of the church. So long as church members persist in supporting such an evil, though indirectly, just so long will our land be condemned to its servitude. It is conceded by all, that to destroy an evil is to strike at the very root of it; hence, admitting the fact, that the young men of our land are largely to blame for the spread and growth of this monster of intemperance, and are following its dictates to their own inevitable ruin, yet they are solely to blame for the present state of affairs when they are encouraged in this vice by men who are influential members of the church, who under the vain and silly subterfuge, that it is necessary to their health; drink themselves and sell their brother, under the name of medicine, whiskey which is ofttimes better than that obtained at the saloon. Owing to the rapid strides made by the medical men of our country there are found substitutes which will take place of whiskey in all cases of disease. We therefore urge upon our brethren to abstun absolutely from the use of all ardent spirits either as a beverage or as a medicine. Whenever the churches make this a rule and strictly enforce it, then and not till then will the vile curse of intemperance sicken and die. We recognize the fact that the traffic in intoxicating liquors should be suppressed in toto, but it is a fact that no law can be enforced that does not meet with the approval and support of the masses. We think a mistake is frequently made therefore bringing on heated prohibition campaigns prematurely. It should be recognized by the church that the fight against the liquor traffic should be in the direction of educating the people to realize the enormous evil of this business, that there may be in the near future a spontaneous, universal uprising of the people against it.

REPORT ON EDUCATION.

CONSTITUTION.

The name of this Association shall be "The Etowah Baptist Association." The officers of the Association shall be a Moderator, Clerk and Treasurer, who shall perform such duties and perform them in such a manner as is ordinarily required of such officers. They shall be elected at or near the opening of each an nual session of the body.

The membership of the Association shall be such churches as shall see fit and be

permitted to represent themselves in its sessions by delegates.

Each church shall be entitled to one delegate for each twenty-five members or fractional part thereof, but every church shall be entitled to at least two delegates.

The object of this Association shall be the advancement of the Redeemer's dom, not only within its bounds, but throughout the world. It shall aid and encourage by means of its influence those grand institutions and agencies which, in the providence at God, have been established by the wise and good among our brethern for the spread of the Gospel throughout the world, for the distribution of the Bible among those destitute of it, for the education of young men for the work of the ministry, as well as the cause of education generally; for the promotion of the Sunday-School cause the aguse of the more agency.

Sunday-School cause, the cause of temperance, etc.
The Association shall employ such means and adopt such measures as shall seem best calculated to cultivate Christian unity and fellowship among the brethren within its bounds, to provoke the brethren to love and do good works, to stir up the pure minds of the brethren by way of remembrance, to secure individual advancement in the divine life, in every way as individuals, to illustrate to the world the reality of the religion of Jesus Christ.

BY-LAWS.

Preparatory to the organization of the Association, an Introductory sermon shall be preached by a member appointed at the previous session, and another shall be named at the same to perform the duty in case of the failure of the first.

The service being performed, the Moderator, or if he is absent, the oldest minister present, shall open the Association by prayer.

He shall call for letters from the churches, when the delegates shall present them and take their service order.

them and take their seats in order.

them and take their seats in order.

4. When the Association is regularly organized, as prescribed in the Constitution, the correspondence from other Associations shall be called for, the letters read and the messengers received by the right hand of followship from the Moderator. The messengers shall be invited to seats in the Association and accorded the privilege of speaking on any subject before the body, but not of voting on any. Other visiting brethren may be invited to seats with the same privileges and prohibition.

5. Subjects not embraced in the last minutes may, at the discretion of the Association, be taken up at any time when there is no business directly before the body.

6. Any subject not confained in the minutes must be regularly brought forward

6 Any subject not confained in the minutes must be regularly brought forward by motion, which shall be seconded before it can be taken up. After this it shall be considered as properly at the disposal of the Association, unless it be withdrawn by the mover.

7. No one shall speak oftener than three times on the same subject, unless permitted by the Association. The speaker shall always rise to his feet and address

the Moderator.

8. Silence and decorum shall be observed by every member of the Association while the body is in session, and more especially in time of debate. All personal reflections and remarks tending to wound the feelings of brethren shall be strictly

9. No member of the Association shall leave the house while the Association is in session, without leave from the Moderator.

In order to expedite business, committees shall be raised at the discretion of the Association, who shall be named by the Moderator.

The meetings of the Association shall, on each day of the session, be opened

and closed with prayer.

12. The minutes of each day shall be read at its close and opening of business, after prayer, each succeeding day, when the names of the delegates shall be called; and the whole minutes of the session shall be read at its close and signed by the Moderator and Clerk.

Any alteration of these by-laws may be made at any meeting of the Associa-

tion by two-thirds of the members present.

RULES OF ORDER.

The rules of order usually observed by deliberative bodies of this kind shall be observed by this Association.

If any point of order be raised by any member of the body, it shall be decided by the moderator; but appeal may be taken from his decision to that of the body, "Mell's Parliamentary Practice" shall be used as authority in regard to questions

of order.

ARTICLES OF FAITH.

There is one and but one God, who is a spirit, omniscient, omnipotent, omnipresent, eternal, unchangable, infinite in goodness and wisdoin, of inviolable truth, perfectly just, of immaculate holiness, the Creator of all things, the preserver of all, and the supreme ruler over all.

The Godhead is a Trinity—the Father. Son and Holy Ghost—three persons in one

essence.

The Son became incarnate, thus uniting in himself the divine and human natures that he might become the mediator between God and man; man's final judge, and by his life, death and resurrection the redeemer and Savior of his people.

The Holy Spirit is the sanctifier and comforter of God's people. He is, through the divine word, the author of the new spiritual life produced in man in his regen-

eration

The Holy Seriptures were given by divine inspiration as a revelation of God's will to man eoneerning bim, and constitute to him an infallible rule of faith and

practice.

Adam and Eve, the first man and woman, were created holy, and for a time served the Creator acceptably living innocently and happy in his favor; but Adam, having been placed under a covenant of works, violated it, and brought the penalty of the violation upon himself and his descendants.

All men partaking of the consequences of the fall, are both totally deprayed and

All men partaking of the consequences of the fall, are both totally depraved and guilty of actual transgression of God's laws.

No man can free himself from his native depravity, or from condemnation. No man can save himself. There is no way of salvation but by Jesus Christ.

The Christian Sabbath is the first day of the week, and should be kept holy and consecrated to the service and worship of God in obedience to the command, "Remember the Sabbath day to keep it holy," and in commemoration of the resurrection on that day of our Lord and Savior Jesus Christ.

The ordinances of the Gospel are two--Baptism and the Lord's Supper. The Great Head of the church required the perpetual observance of these ordinances by the churches as such and under their authority.

the churches as such and under their authority.

Baptism is the immersion of the believer in water by one duly qualified and authorized to administer the rite. It is prerequisite to church membership.

A Gospel church is a company of baptized believers organized under the law of its Great Head, for the advancement of God's kingdom in the world. The officers of the church are its pastors and deacons. Each church is an independent body, subject only to the commands of its Great Head. The work required of the church is missionary in its character. "Go ye into all the world and preach the Gospel to every creature.

The Holy Spirit continues the work of sanctification upon those whom he has regenerated to the end of life, and thus saves all who are regenerated from apostasy. All who will be finally saved were chosen of God the Father before the foundation of the world, and given to Jesus Christ in the covenant of grace; yet all who will be lost will have rejected of their own will a proffered salvation.

The bodies of all who die will be raised from the dead and reunited to their spirits

for the judgment of the great day

In the last day Jesus Christ will come to judge the world, and having assembled all men before him, will pass sentence upon them according to their works.

Heaven is a place to which the righteons will be received, and made perfectly happy in their presence and enjoyment of God forever.

Hell is a place into which the wicked may be cast, to suffer everlasting punishment for their piece.
