## MINUTES

The Judson Baptist Association convened in her forty-first annual session with Abbeville Church, Henry county, Alabama,

October 2nd, 1891.

The introductory was preached by Elder A. L. Martin, upon the 17th verse of the 16th chapter of Matthew. At the close of the sermon prayer was offered by Brother J. P. Dawson, of Sang the first doxology and benediction was then Georgia. pronounced by Brother W. M. Burr, of Columbia.

## AFTERNOON SESSION.

At 2 o'clock Brother J. B. Ward, Moderator, called the asso-After singing "Am I a Soldier of the Cross?" ciation to order. Brother Burr lead in prayer. The moderator, on behalf of the good citizens of Abbeville, welcomed the messengers and visitors to their hospitality.

## ORGANIZATION.

Brother J. B. Ward, the moderator, announced that it was now in order to elect a moderator and clerk for the ensuing year. Brother Ward tendered his resignation and called Brother Malone to the chair. On motion, the regular order of business was suspended and Brother Ward was re-elected moderator by acclamation. Under the same rule and order Brother W. A. McClendon was re-elected clerk. The moderator and clerk thanked the body for a renewal of their confidence, after which the regular order was resumed and the body adopted its regular order of business.

- rst. Called for petitionary letters. A letter from Adoniram church was presented and read, asking membership with us. At our last session Adoniram church was declared out of order and was excluded from our membership upon the ground that she had for her pastor one who was disqualified. She having recanted, asked forgiveness and desired to be reinstated; and, on motion of Brother A. J. Armstrong, Adoniram church was again received into the association, upon the following condition, to-wit: That the members be erased from membership that joined Adoniram church under S. A. Savell's administration while he was in disorder. The moderator extended the hand of fellowship to the messengers of that church and welcomed them to seats with us.

- 4th. Appointment of Committee on Preaching. The following were appointed: E. Oates, Armstead Armstrong, with messengers from Abbeville church.

On motion, the moderator was allowed further time to appoint the other committees.

Brother J. W. Herndon moved that we meet at 8:30 a. m., adjourn at 12 m. and meet at 2 p. m. The motion was concurred in.

The moderator appointed Brother Dawson to preach to-night. On motion, the body adjourned till 8:30 a.m. to-morrow. Benediction by Brother Malone.

## SECOND DAY.

SATURDAY, OCT. 3, 1891.

At 8:30 a. m. the body was called to order by the moderator. Devotional exercises were conducted by Brother Malone. Roll call was dispensed with. The minutes of yesterday were read and, on motion, adopted.

## REPORT OF THE EXECUTIVE COMMITTEE.

The Executive committee of the Judson Association beg leave to submit

the following report:

Your committee had a meeting at Abbeville on the 3rd day of November, 1890, and upon a full investigation of the financial condition of the Association, ascertained that the available fund then on hand for general purposes, amounted to \$108.55, from which was deducted the balance of \$62.50 due Bro. A. L. Martin for his services as evangelist during the associational year ending September 30, 1890, leaving unexpended, and available for the present year, the sum of \$46.05. We further found that the available fund for the present year, (1891) for general purposes, including church and individual pledges, as well as the balance of \$46.05, hereinbefore mentioned, amounted to \$161.05.

A portion of this fund was voted to Brother Barnes at the last session of the association, but upon investigation, it was evident that the fund so voted the association, but upon investigation, it was evident that the time so vice to him was intended, at the time of donation thereof, for other purposes; and there being some doubt on the mind of Brother Barnes as to whether the action of the association in voting the money to himself was not had without full investigation of their right to dispose of the fund in that way, he made known to the committee that he would decline to accept the same, insisting that all of the money should be applied to the purposes for which

it was originally intended.

Appreciating the motives of Brother Barnes in declining this fund, and commending him for his high sense of propriety, the committee felt under obligation to take some step for his relief, and instructed the Clerk to address a letter to each church in the association, stating the facts, and asking each to take up a contribution for the benefit of Brother Barnes, and remit the same to the Treasurer of the association. The letters were promptly written and we hope that in response thereto liberal contributions have been sent up,

Appreciating the importance of continuing the policy of evangelical work within the bounds of the association, which has heretofore been pursued by the association, and feeling that in that way, more perhaps than in any other with the limited means at our command, we could accomplish the most good, and in pursuance of the authority conferred upon us, your committee entered into a contract with Brother A. L. Martin, employing him as the evangelist of the association for a term of four months, at \$50.00 per month, he to travel from place to place, within the bounds of the association, at such times and places as in his judgment might be best, and in his work to impress upon the churches and brethren generally the importance of the Mission cause, and to awaken a deeper interest on that subject. Also to preach and give religious instruction and advice. Brother Martin has pursued this work with zeal and assiduity, and we feel that his labors have been blessed. His report will show fully the character and scope of his work. We recommend that the association should continue this character of work. The land is ours if we will go forth in the name of the Lord and take it.

The contract with Brother Martin was made with a view to the fund then in sight, to wit: \$161 05, and with the intention of asking the association to order the payment of the deficit, whatever it may be. Bro. Martin will be due, when his work is completed, which has been done, with the exception of ten days, which will soon be rendered, the sum of \$200.00, and has been paid to date the sum of \$107.64, leaving the balance of \$92.36, which we ask to be paid, a portion of which is covered by pledges which will be paid in at this session. ## REPORT ON HOME MISSIONS.

We, your committee on Home Missions, beg leave to make the following

We find that the number of missionaries employed over the previous year

we find that the number of missionaries employed over the previous year to be forty-three; number baptized, 4,477; received by letter, 3,621; total admissions, 8,098; Sunday-schools organized, 336; churches constituted, 267; houses of worship built, 84; amount received by Treasurer, \$68,279.76. This represents the actual work done by the Baptists of the South.

The reports from all parts of the field occupied by the Home Mission Board are most encouraging, and especially that of Cuba. Five years ago that island was turned over to the Home Mission Board, and since then Bro. Diaz, with his native assistants, has had marvelous success. We now have 21 missionaries; 1,700 members; 2,000 in Sunday-schools; 700 in day schools, and 20 young ministers are being instructed.

The field to which the Home Mission Board devotes itself grows wider
every year, and \$6,500 is given by the Baptists of the State of Alabama, for

the purpose of carrying on this great and good work.

Brethren, we have reports of this kind from year to year, and they go practically unbeeded. Is there nothing that can be done to stimulate the people of the Judson Baptist Association to Asense of duty on this important subject? Let us try and see if we can't do something for our Mission Boards in the next twelve months, and thereby have part in the great and glorious work that is being done in the Master's cause.

## REPORT OF A L. MARTIN, EVANGELIST OF JUDSON ASSOCIATION.

DEAR BRETHREN:

I do not deem it necessary to set out in this report the contract under which I have been acting as evangelist of the Association during the year just closed, for the reason that the Executive Committee, by whom I was

just closed, for the reason that the Executive Committee, by whom I was employed, will, I am satisfied, make report with respect thereto.

I beg leave to state, however, that I have, to the best of my ability and understanding, carried out the contract which I entered into with your committee, with the exception of ten days, which I will complete in a very short time. It affords me pleasure to say that my work has been pleasant and I am confident not devoid of profit. In all of my travels I have been well received and the brethren and people generally have manifested an interest in my work and aided me in its performance.

The Lord has put it into the hearts of very many to give aid and comfort as I went from place to place in his name proclaiming the truths of the gospel. In the fear of God and under his blessing I am bold to say that he has seen fit to prosper his work in my hands, for which I return thanks

has seen fit to prosper his work in my hands, for which I return thanks unto him and pray that in his good providence he will continue to use me as an humble instrument to carry the word of truth to as many as he has

ordained shall in that manner receive the same.

I am indeed grateful for the undying evidences I have that God has seen fit to use me in the advancement of his kingdom upon earth. We have every evidence of the favor and blessing of God in the prosecution of our evangelical and mission work. All the indications of providence are to the effect that now is the "fullness of the time" for that character of work, and I have been careful to urge it upon the brethren generally. The spread of I have been careful to urge it upon the brethren generally. The spread of the gospel is patent on every hand and the churches should fully realize the responsibility now resting upon them to an increased effort in that behalf. May the Lord show us our full duty as missionaries and move us to perform I have indulged in these reflections for the reason that my work has, of necessity, been in that line.

the following services:

Number of days actually engaged in travel and preaching. 90; number of miles traveled, 705; humber of sermons preached, 79; number of religious services and conversations with families and advice on religious topics, including prayer services, (but not including prayers with and advice and instructions to persons on religious topics with whom I spent the night or happened to meet casually, of which I kept no account), 26.

I made it a point in my work to take an interest in every matter pertaining to the churches and to do whatever I could for the advancement of the

cause. I was also specially careful to urge a deeper interest in the mission work and to impress upon the brethren the importance of keeping up good

Sunday-schools and prayer-meetings. I fear that our churches are not up to the full measure of their duty with respect to Sunday-schools and prayer-meetings. A good Sunday-school is the hope of the church and a regular and earnest prayer-meeting is a sure and unfailing safeguard. The house of prayer is never the house of dissension. The foregoing is only a brief summary of my work.

We think that we ought to do all that we can to educate those who are trying to prepare for the ministry. Brethren, what are we doing? Do we appreciate the opportunity that God has given us for doing good? Are we thankful for our religious institutions—the Judson and the Howard, and other religious institutions? Are we doing anything towards educating any one in this Association? Respectfully submitted,

## CONSTITUTION.

ARTICLE 1. This union shall be known and distinguished by the style

ART. 2. This Association shall be composed of representatives from the churches in the union, in the following ratio: All churches composed of one hundred members and under, shall be allowed two messengers; those having over one hundred and fifty members, three messengers; those having over one hundred and fifty, and not two hundred members, four messengers; over one nundred and fifty, and not two nundred members, not messengers; and so in graduation—one messenger for every fifty members; who shall be required to furnish satisfactory evidence of their appointment by their churches, before they take their seats.

ART 3. The messengers, when convened, shall organize themselves into a deliberative body, by election of a Moderator and Clerk. These officers shall be chosen by ballot at each annual meeting, and continue in office

until new ones are elected.

ART. 4. The Association shall not interfere with rights of the churches of which she is composed. She shall regard them as independent bodies in all matters of internal government, and shall only act as an advisory council, assuming no authority except what is expressly delegated to her by the churches, or evidently implied by the very nature of this compact; she, nevertheless, claims authority over her own members, the messengers of the churches, and in justice and propriety must have power to withdraw from and disown all churches that depart from the principles of this compact by

becoming unorthodox in faith, or disorderly in practice. She should, therefore, regard all the churches united under this Constitution with a vigilant eye for good. Her principal business shall be to promote the glory of God by extending his kingdom of grace on earth, through the medium of preaching the gospel and other means, in accordance with the gospel; to cultivate union and fellowship with all the churches of Christ, and especially with those united in this Association.

ART. 5. Newly constituted churches, or churches dismissed from other

Associations of the same faith and order, may be admitted into this union by their sending up their messengers to an annual meeting, with a petition, and by those messengers agreeing to the Abstract of Principles herewith

published.

ART. 6. The churches of this union shall transmit to every annual session. ot this Association written communications, specifying the names of the messengers, number in fellowship, baptized, received by letter. dlsmissed, excluded, restored and dead, since last session, and all other information which the churches may deem important, which shall be read and minuted

ART. 7. This Association shall have a fund, supplied by the voluntary contributions of the churches, and all money thus contributed shall be transmitted from the churches and paid over, through the Committee on Finance, to the Treasurer, who shall be elected by ballot, and hold his office during the pleasure of the Association. He shall receive and manage the funds according to the order of the Association, and present annually for insertion in the minutes, a clear and full statement of all receipts and expenditures.

ART 8. This Association shall furnish the churches with the minutes of

every session.

ART. 9. This Association shall not take cognizance of any query sent up by the churches unless they have endeavered to solve the same and failed, nor of any difficulty between churches, unless they have pursued the directions contained in the 18th chapter of Matthew, and have not been able to settle them; then the Association shall take such matters into consideration and act upon them at her discretion.

ART. 10. It shall be the duty of the Clerk of the Association to keep a regular file of printed minutes of every session of this body, and deliver

over the same to his successor in office.

ART 11. This Association, when convened, shall be governed by proper Rules of Decorum, which she is authorized to form and amend, according to

her own views.

ART. 12. This Constitution may be altered or amended at a regular meeting of this body, by a concurring voice of two-thirds of the members. present; Provided, such alteration or amendment be approved by a majority of the churches.

## ARTICLES OF FAITH.

ARTICLE 1. We believe in the existence of one only true and living God, and that he has made himself known to his people under the name of the Father, the Son and the Holy Ghost, the same in essence, and equal in divine perfection.

ART. 2. We believe the Scriptures of the Old and New Testaments are the

word of God, and the only rule of faith and practice.

ART. 3. We believe in the doctrine of election, that God chose his people in Christ before the foundation of the world; that they should be holy and without blame before him in love, having predestined them to the adoption of children by Jesus Christ, according to the good pleasure of his will.

ART. 4. We believe in the doctrine of original sin.

ART. 5. We believe in man's incompetency to recover himself from the fallen state he is in by nature, by his own will and ability.

ART. 6. We believe sinners are justified in the sight of God only by the

imputed righteousness of Christ.

We believe that God's elect shall be called, regenerated and sanct-

ified by the Holy Ghost.

Arr. 8. We believe that nothing can separate the true believers from the love of God, but that they will be kept by the power of God through faith

unto salvation.

ART. 9. We believe that Baptism and the Lord's Supper are ordinances of Jesus Christ; that the true believers are the only subjects of these ordi-

nances, and that immersion only is baptism.

AET. 10. We believe in the resurrection of the dead and a general

judgment.

ART. 11. We believe that the punishment of the wicked to be everlasting, and the joys of the righteous will be eternal.

ART. 12. We believe that no minister has a right to administer the ordinances, unless he is called of God, and come under the imposition of hands by a presbytery, and is in fellowship in the church of which he is a member.

## RULES OF DECORUM.

Every query sent up to the Association by any church in the Union, shall be read and put to a vote by the Moderator whether it shall be debated or not; and if there be a majority for it, it shall be taken up and investigated; but if not, it shall be withdrawn, provided always, that those be first considered which affect the union of the churches.

2 Every motion made and seconded shall come under the observation of the Association, except it be withdrawn by the member who made it.

3. Every person who speaks in debate shall rise from his seat and address the Moderator; and he shall not be interrupted while speaking, unless he depart from the subject in debate.

4. No person shall speak more than three times upon the same subject

without leave of the body.

5. No member shall abruptly break off or absent himself without leave of the body, and if he so does, he shall be marked as an absentee.

The names of the members of the Association shall be enrolled by the

Clerk, and called over as often as the body may require.

7. The Moderator shall be entitled to the same privilege of speaking as any other member, provided the chair be filled, but he shall not vote except the body be equally divided.

8. It shall be the duty of the Clerk to keep a regular record of the pro-

ceedings of the body.

9. The minutes of the Association shall be read and signed by the Moder-

ator and Clerk before the body rises.

10. Amendments may be made to this form of government by two-thirds of the members in session.
