.....MINUTES.....

The Zion Baptist Association met in Forty-first Annual session with Macedonia church, Escambia county, Ala., on Friday, Oct. 15th, 1897, at 11 a. m. Introductory sermon preached by Eld. J. M. Robinson; prayer by Rev. J. W. Deer. After a short intermission for dinner messengers assembled in house at 1:30. Letters from churches called for and read—22 in number. When letter from Bethany church was read, brother J. W. Cross moved that said letter be held over for the present, and that a committee of five be appointed to investigate into condition of Bethany church, and to report as early as practicable during sitting of this body. Committee consisted of J. W. Cross, Richard Clary, L. A. Sims, Y. S. Cook, A. P. Wyrosdick. Body then went into permanent organization by election of brother J. T. Watson, moderator; W. P. Howell, clerk, and J. W. Cross, treasurer. Called for correspondence; Eld. J. E. Deer, responded from Conecuh Association. Called for petitionary letters. Received one from Pleasant Ridge church. On motion letter was received and messengers given seats in the body. Moderator appointed following committees:

On Education—E. A. Brantley.

Sunday Schools—H. H. Hollis.

Religious Exercises—Pastor Sweeney and messenger from Macedonia church.

Nominations—W. L. Morris, G. W. Hart, J. W. Sims.

On motion adjourned to meet at 9 o'clock Saturday morning.

SATURDAY MORNING SESSION.

Body met at 9 o'clock Saturday morning. Renewed call for correspondence. Elder Geo. M. Parker responded as representative of State Mission Board and Orphans' Home. Following committee appointed on finance: J. A. Hart, H. A. Hughes and S. S. Overstreet. The Moderator appointed following committees for Associational year: Temperance—E. A. Brantley. Missions—Rev. G. M. Parker. Education—E. Beasley. Orphanage—J. M. Sweeney. Ministerial Education—H. A. Mason. Sunday Schools—Rev. J. M. Robinson. Consistency—Y. S. Cook. Executive committee, G. E. Hicks, chairman; J. W. Cross, M. A. George, Sr., Revs. G. M. Parker, J. M. Robinson. The Moderator appointed the following committee on Orphans' Home: Sepulga church, Ida McIntire; Pleasant Grove, N. Brantley; Mt. Pleasant, M. E. Whaley; River Falls, M. A. Barrow; Searight, Cornelia Bagley; Magnolia, E. Coon; Macedonia, E. Elliott; New Providence, Amanda Clary; Shady Grove,

Called for report on Education, when E. A. Brantley presented the following: (See app. A.) Adopted. Renewed call for correspondence, when Eld. Holley, of Pensacola Bay Association and S. W. Parker and L. B. Parker, of Conecuh Association responded. Called for report of committee on condition of Bethany church, which was read and adopted. (See app. Z.) Report on ministerial education called for when J. M. Robinson, chairman, presented the following: (See app. B) Spoken to by chairman and others. Adopted. On motion a collection was taken for ministerial education, amounting to \$2.00. On motion all vouchers were to be turned over to clerk, instead of finance committee as heretofore. On motion a committee on consistency was appointed as follows: Y. S. Cook, E. J. Beasley, N. R. Stewart. Report on religious literature made by Eld. H. A. Mason. (See app. C.) Report Spoken by chairman and others. Adopted. Motion to adjourn to 9 o'clock Sunday morning, which was amended by adding that no business be attended to except discussion of Sunday school report and the usual devotional exercises.

SUNDAY MORNING SESSION.

Reassembled in the house at 9 o'clock. The motion to defer transaction of regular business until Monday morning was received. Sunday school report made by Chairman H. H. Hollis, adopted. On motion the adoption of Sunday school report was reconsidered, and subject again opened for discussion, participated in by Bro Cross and others. Report adopted. (See app. D.) Adjourned for preaching. Eld. Geo. M. Parker occupying pulpit in the church and Eld. J. E. Deer at the arbor. Sunday collection amounting to \$7 98.

Body reassembled for business at 2 o'clock. Called for report on orphanage, Evergreen, made by Chairman Sweeney. Spoken to by chairman, Elder Geo. M. Parker and others. [See appendix E.] Report adopted. On motion the regular order of business was suspended, when brother Brantley introduced the following:

"Resolved, That this Association meet at its next annual session on Wednesday before the 3rd Sunday in October, 1898, with Mt. Olive church, near Pontus, Butler county, Ala., at 10 o'clock a.m.

Pending discussion of report body adjourned to 9 o'clock Monday

MONDAY MORNING SESSION.

Body met pursuant to adjournment. Discussion of report on Missions resumed, when Elder L. M. Thomasson's report of his evangelistic labors was read, and on motion, incorporated into the general missions report. Report spoken to Elders Parker and Sweeney and others. Adopted. On motion of Eld. Parker a collection was taken to remunerate Eld. Thomasson for said evangelistic work, amounting to \$8 50. Report on nominations read. [See app. G.] Adopted. Report on consistency read. (See app. H.) Adopted. Report of Finance committee made by chairman. (See app. J.) Adopted. On motion of Bro. Y. S. Cook, the clerk was instructed to have Articles of Faith printed in the minutes. On motion the treasurer was instructed to forward to the proper parties the funds raised for the various purposes now in his hands. On motion Elder Geo. M. Parker was elected delegate to the Southern Baptist Convention. On motion the clerk was instructed to have 400 minutes printed. On motion of Elder Geo. M. Parker, the Executive committee was instructed to raise, if possible, \$200 for evangelistic work in the bounds of Zion Association, and that in order to do this, they apportion their amount among the churches. On motion of Bro. E. A. Brantley the following was read and unanimously adopted:

Resolved, That the sincere and heartfelt thanks of this body are hereby extended to the brethren and friends of Macedonia church and surrounding country for their kind and lavish hospitality during our stay among them.

On motion body adjourned to meet with Mt. Olive church, on Wednesday before the third Sunday in October, 1898, at 10 o'clock a m.

REPORT ON EDUCATION.

We, your committee on Education, beg leave to make the following report: The zeal for education seems to be on the upgrade. Parents seem to show a spirit of unrest along the line of education, seeking for better teachers and schools of longer duration. We would encourage parents to greater efforts in securing for their children a higher order of education, realizing that the rising generation must be what the present generation make them.

Education enables them to think right and reason from cause to effect, thereby avoiding many mistakes in life. The advancement in education among our people should make them more particular as to the character of matter that is put before them to read. In these times of political as well as religious discussions, we fear our time is too much given to reading secular newspapers. We do not condemn the reading of these, but we do desire to urge upon the brotherhood the great importance of reading something more elevating and wholesome. And as Baptists, we would recommend first of all, the reading of the Baptist book, the Bible. Second, we would also urge upon our people the importance of taking and reading the Alabama Baptist and other Baptist papers. For advanced classes we would recommend the Howard College and Judson Institute as being worthy of the patronage of the Baptists of Zion Association.

REPORT ON MINISTERIAL EDUCATION.

Our people, however, have made such advances in literary culture

and general education has become so widely disseminated, that to be leaders now, as they have always been, and which is, by divine appointment, their true relation to mankind, the minister must be by education on many lines, furnished with the equipment necessary to this end. But while this is all true, we would emphasize the Bible as the chiefest and all-important book for them to be instructed in and familiar, so that they may be able to daub with no untempered mortar, but prove themselves worthy of God's approval.

ABSTRACT OF FAITH, WITH PROOF TEXTS.

Art. VI. We believe that sinners are justified in the sight of God only by the imputed righteousness of Jesus Christ.—2 Cor. 5: 21; Eph. 1: 7; Col. 1: 13, 14.

Art. VII. We believe that God's elect shall be called, regenerated

and sanctified by the Holy Spirit.—John 6:37; 2 Tim. 1:9.

Art. VIII. We believe that saints shall persevere in grace, and never finally fall away.—John 10:28-30.
