AUBURN, ALA., Oct. 16, 1894.

The Forty-ninth Session of the Tuskegee Association convened with the Baptist church at Auburn, Alabama, Tuesday, October 16, 1894.

The former Moderator, Elder G A, Hornady, and the Clerk, Elder C. W. Buck, both being present, they called the meeting to order at 11 o'clock a. m, and proceeded to organization.

REPORT ON HOME AND FOREIGN MISSIONS.

Called for, read, and adopted as follows:

HOME MISSIONS.

From the last annual report of the Home Mission Board made to the Southern Baptist Convention, held in Dallas, Texas, last May, we make the following extracts:

During the year the Board had employed 381 missionaries, who had done 16,280 weeks of service. Their missionaries were distributed, 1 in Alabama, 23 in Arkansas, 24 in Cuba, 5 in District of Columbia, 51 in Florida, 5 in Georgia, 6 in Indian Territory, 24 in Kentucky, 17 in Louisiana, 5 in Maryland, 6 in Missouri, 22 in Mississippi, 5 in North Carolina, 10 in Tennessee, 12 in Oklahoma, 105 in Texas, 1 in Virginia, 48 in Western Arkansas and Indian Territory, 9 in Western North Carolina, and 2 in West Virginia. From this distribution of labor we get an idea of the vast extent of what we call our Home Mission work. remember that our Home Mission Board undertakes to give the gospel to all classes of our nation, white population; to the negroes living in every part of this wide field; to the German and French population in Mary. land, Kentucky, Missouri and Louisiana; to the Mexicans in Texas, to the Indians in their western home, and to the Cubans on their native island, we get some idea of the marvelous variety of work demanded of the Home Board.

During the convention year ending 30th April last, the Home Board received contributions to the amount of \$56,622.82. By adding the amount on hand at the beginning of the year and continual funds collected during the year, the aggregate is \$67,768.51. Of this sum Alabama Baptists gave \$3,759.95. To the Alabama Baptist State Convention held in Marion last July, our Board of State Missions reported that for the eight months last past, Alabama Baptists had contributed to the Home Mission Board \$1585.00. Last week's Alabama Baptist states that for the past five months Alabama Baptists have given to Home Missions \$549.10. These figures show that we are doing almost nothing for this department of our Mission work; and this last remark is as true of our brethren in sister States as of us in Alabama. If your committee understand aright the report of our Home Mission Board, and if we are not widely mistaken as to the spirit of Southern Baptists, there is very little interest now felt in the work this Board is

attempting to prosecute.

We make some statements in regard to our foreign mission work based on the last annual report of our Foreign Mission Board submitted to the Southern Baptist Convention last May.

Pagan fields, in which Southern Baptists are doing work, are Japan, Africa and China.

CHINA.

We now have in China 15 male and 14 female missionaries, assisted by 7 unordained missionaries and 21 native helpers, making whole number of mission workers 57. We have 13 organized churches with 1,067 members. Their contributions for the year were \$1,544.52, about one and a half dollars each. Baptized during the year 122. In China was our first foreign mission work. We began in South China in 1845; the year the Southern Baptist Convention was organized.

AFRICA.

In Africa we have 4 male and 4 female missionaries, 1 native and 1 unordained helper, making our working force number 10. We have 5 or-

ganized churches with 166 members. Their contributions for the year amounted to \$125.50, a little less than a dollar each. Our mission work in Africa began in 1850, 44 years ago. Our missionaries there baptized during the last year 24 persons.

JAPAN.

In Japan we have 2 male and 2 female ordained missionaries, 2 male and 2 female unordained missionaries, making our total mission force in that country 8. We have in Japan 1 church with 31 members. Contributions last year \$15. about 50 cents each. Our work in Japan was begun in 1889, only 5 years ago. Baptisms last year 9

Mexico, Brazil and Italy.

In Italy we have 2 male and 1 female missionaries, 13 ordained and 14 unordained natives, making in all 30 workers. We have 17 churches with 372 members. Contributions last year \$395, a little more than a dollar each. Baptisms 1sst year 38. Our work in Italy began in 1870, 24 years ago.

BRAZIL.

In Brazil we have 9 male and 6 female missionaries, 7 unordained male and 2 unordained female missionaries, making 24 mission workers. We have 11 churches with 618 members. Contributions last year \$12.30, about \$2 each. Baptisms during last year 159. Our first work was done in Brazil in 1882, 14 years ago.

MEXICO.

We have in Mexico 10 male and 9 female missionaries. Also 6 unordained females, 5 ordained natives, and 10 unordained natives, making 39 workers. We have 37 churches with 1163 members. Their contributions last year amounted to \$2,600.25, more than \$2 each. Baptisms last year 277. Our mission work in Mexico was begun in 1880, 14 years ago.

We here see that the Southern Baptist Convention has employed in foreign fields, all told, 159 missionaries; that our missionaries have gathered and organized 84 churches, with an aggregate membership of 3,417. We find that our churches in foreign lands contributed last year \$5,910.27, and that there were added to them during the year by baptism 476 members.

FINANCE.

During the last convention year our Foreign Mission Board received from all sources \$106,332.69, and was in debt at the close of the year \$30,823.78. The necessary outlay of this Board is now about \$10.000 per month, or \$120,000 per year. Receipts during the current year are falling far short, and unless they increase rapidly, the first of next May will find the Board with a much heavier debt than that reported last May.

By reference to report made by our Board of State Missions to the last

By reference to report made by our Board of State Missions to the last Alabama Baptist State Convention, held in Marion last July, you will see, that for eight months, the Baptists of our State had given to foreign missions \$3,285.99, a fraction more than \$400 per month. From reports sent up to this Association by the churches, your committee fears that the Tuskegee Association is falling behind her past record in trying to give the gospel to the world.

REPORT ON TEMPERANCE.

It gives your Committee much pleasure to be able to report an improved condition in the churches of this Association relative to the subject and practice of temperance. Within the past few years there has been a steady upward tendency in the sentiment regarding the evils of intemperance and against professed Christians yielding to so questionable a practice. Total abstinence is the accepted platform as regards sale or use as a beverage upon the part of Christians.

It is true that in some of our churches a few members are retained in fellowship who are guilty of using intoxicants as a beverage, and some few are guilty of intemperance, but such rest under the condemnation of their brethren, and are considered a stigma and disgrace upon the fair

honor of the church and the Christian profession.

Christian charity so-called has thrown the mantle of forbearance over the weakness of these unfortunate members with the hope that they will be yet led to break away from their deadly sin and be saved to Christian usefulness, and manifest their love to Christ by a better and purer life.

We regret to say that saloons have been opened and legalized in two places within our associational bounds, and there are a few blind tigers kept out in the jungles by some violators of law and honesty, but these are not encouraged or countenanced by any true Christian or honest citizen.

No member of any church who respects his own character or the fair name of his Master's cause, will be found frequenting such associations. It is claimed both by the church and by the world that no Christian can tamper with this evil without dishonoring his profession and usefulness.

The time has passed when any man, whether Christian or not, will be considered true to his citizenship, family or church who deals in or uses strong drink as a beverage. It is acknowledged by all that the sale and use of strong drink is not only a great wrong, but is a monster curse upon society and the State. It is an enemy to public interest, a burden upon the tax-payer, it is the manufacturer of criminals and a disgrace to the Christian power of any community.

If the Christian forces in our Association and churches will arise in

the might of their power and influence against this great enemy, it will not be long before its hydra face will be ashamed to be seen or known Respectfully submitted, C. W. Buck.

REPORT ON DOCUMENTS AND STATE OF RELIGION.

We beg leave to report that we glean from the letters sent up that there seems to be a deep spiritual feeling pervading the churches. We are glad to note the fact that quite a number report revivals during the year. All the churches report Sunday schools except four. Some of these have had schools part of the year

Union Grove and Pleasant Grove churches ask for the Association to hold its next session with them. We recommend that Pleasant Grove

be its next place of meeting.

We are gratified to state that both of these churches have been aided

by the Association financially during the past year, and that neither of them has had the Association to meet with them since their organization. Respectfully submitted, W. E. Hudmon, Chairman.

Pleasant Grove church, 6 miles west of Salem, was unanimously selected as the place to hold the next session of the Association, Tuesday after the second Sunday in October, (15th) 1895.

REPORT OF COMMITTEE ON ORPHANS' HOME.

Immediately after the meeting of the Alabama Baptist State Convention in November last at Greenville, a special committee appointed, visited Evergreen, Ala., to inspect a certain property which had been offered for sale. This property was purchased for a permanent Orphan's Home, with eighty acres attached, for the sum of \$5,000, payable in three annual payments. The first was due and paid Jan. 1, 1894, the second installment will be due next January, amounting to about \$1,800. Every Baptist Church, Sunday School, Missionary Society and individual feeling an interest in this great work, is urged to send what they can during the month of December next to meet this demand. Send to Rev. John W. Stewart, Financial Secretary Orphans' Home, Evergreen, Ala.

There are now thirty-two children in the Home. Two have been adopted into good Christian homes. This institution should occupy a very warm place in every Christian heart, and we recommend that Pastors and Sunday School Superintendents bring the Home before their people, and have a special collection taken quarterly for its support.

We further recommend that the Tuskegee Association appoint a Stand-

ing Committee to report annually.

Your committee believe the institution to be in a healthy condition spiritually and physically, but will continually require the fostering care of the denomination. Two of the pupils have been recently baptized, and others are concerned about their salvation.

Much interest was manifested by the brethren in speeches and promises relative to this work.

The report on education being called for, was read and adopted.

REPORT ON EDUCATION.

Education progresses as never before in the history of man. Along all lines of science of thought and revelation, knowledge increases—its scope widens, its methods multiply and its spirit intensifies.

Private, State and religious institutions vie with each other in effort.

Surely we are upon the threshhold of the world's broadest thought. Our educational efforts present two phases—that of the secular and religious, or state and denominational. We wish to note three special facts

involved in the secular phase.

1. The interest of common schools demands our earnest consideration and support. They supply those influences in which society is crystalized, and which conserve all the vital powers of our civilization, reaching and touching our whole people, and being the sole means of training for the majority of our young. The common schools should receive the heatty support of every citizen. It is a sad fact that 57 per cent. of our population cannot read, and that only \$500,000 are expended annually for this cause. We pay a net profit to fire insurance of \$746,000, 55 per cent. more than the sum total appropriated to education.

2. The next fact is that of sectarian influence in our schools. One of

the prominent colleges of the State being located within our bounds, attention is specially directed to this fact in connection with this institution.

In the Λ . & M. College located in Auburn we have the following approximated sectarian exhibit:

The Methodist have 8 teachers, and draw \$12,000 in salaries.

The Episcopalians have 5 teachers, and draw \$8,000 in salaries.

The Presbyterians have 5 teachers, and draw \$6,000 in salaries.

The Baptists have 2 teachers, and draw \$4,000 in salaries.

These four denominations approximate the following numbers in the State:

The Baptists 108,000, Methodists 88,000, Presbyterians 21,000 and Episcopalians 7,000. While the Baptists have the largest membership in the State, they supply the smallest number of teachers and draw less money than the smallest. These facts savor of sectarianism as being developed in this college.

Your committee would make but one suggestion concerning the matter i. e., that the responsibility for Baptist weakness in this college be located, whether it be in the denomination at large, the immediate representatives in the college or this association in whose bounds it is located.

3. The third fact is the appropriation of public funds to sectarian institutions. Several million dollars of public money has been appropriated to Catholic institutions in the city of New York alone within the last few years. Over \$3,000,000 have been appropriated to Catholic schools among the Indians alone, during the last five years.

Coming nearer home. We learn that public funds are being appropriated to sectarian schools in our own State. Yea, within the bounds of this Association.

The appropriation of public money to sectarian institutions is the first and insidious step toward the unholy a liance of Church and State.

Deliverance from the curse which this alliance brings has been purchased by martyr blood, and whatever may savor of its restoration should be resisted with unyielding devotion. Our liberties can not be too zeal-ously guarded.

The second phase is "Denominational Education." While the State furnishes the volume, the seets supply the strength and genius of our

training.

It is the sheet anchor of our civilization, and should not, therefore, be

displaced.

As a denomination, we foster in the State two schools. The Howard and the Judson. The Howard has completed the fifty-third year of its history, and at this date has more than 150 pupils. The Board of Trustees are pleased with the success attending their efforts. The faculty are efficient and enthusiastic in their work. The students are orderly and earnest. The Bible is used as a text book, and all the students, not already converted, except one, were converted last year.

The Judson has opened with sixty-five boarders, and is encouraged

with the prospects for the year.

It maintains the high standard of refined culture that has made it famous throughout the land. These schools are earnestly commended to the public, and to Baptists specially, as being eminently worthy of their support and patronage.

Ministerial education demands special consideration. The Convention asks \$3,000 with which to sustain twenty-two young preachers at the college, and eight at the seminary. They are the girts of the Lord to the churches, and should be trained for their great work. The training for

the field ministry, a work not heretofore attempted by the denomination

is a special demand of this age.

Of the 1,000 white Baptist preachers in Alabama, less than 150 have received the training of the schools. More than 850 are therefore left without an effort on the part of the denomination to supply them with helpful training. This field of effort is now commending itself to the brethren.

Wednesday, 2:30 p. m.—Association reassembled, and after singing and prayer by Bro. Hudson, the discussion of the report was resumed, Brethren Harris, Mell, Shaffer, Lloyd, Anderson and others speaking to it.

Dr. Roby offered the following resolutions.

WHEREAS, We have heard with pleasure of Bro. Anderson's "Corre-

spondence Course" in behalf of ministers on the field, and

Whereas, We have also heard with pleasure of the action of the Ministers' Conference of East Alabama in regard to the "Correspondent Course, therefore

Resolved, first, That we endorse the action of the Ministers' Conference

of East Alabama.

Second, That we commend the "Correspondence Course" as eonducted by Bro. Anderson, to our churches as one of the objects of regular contributions.

Report on Sunday Schools read, and after being spoken to by Brethren Buck, Harris and Shaffer, was adopted as follows:

Your Committee report that out of the twenty churches composing this Association, fourteen of them report regular Sunday Schools in active work, with an average membership of 550 scholars, 85 officers and teachers, making a total of 635. Two of the churches remaining have had schools during a part of the year. The other three report no school, because of a membership too much scattered to attend, (one church not reporting).

In one or two instances, no doubt, the excuses may be legitimate, but we are persuaded that in most of the cases the fault lies at the doors of the parents in not exercising proper Christian interest and zeal in the

spiritual instruction of the young.

We believe that when there is zealous effort made a Sunday School can be sustained in almost every neighborhood in the bounds of our Association. One great want in successful Sunday School operation, is more grown up children from among the church membership. The extreme ignorance of the Seriptures among many of the grown and older Christians, is to be deplored. They are too old to attend the Sunday School, and have not the time to read and study the Word at home. We regret to say that this want of interest exists in the towns as well as

in the country. I doubt if there is a parent, man or woman, in this Association, who may not be benefitted by becoming a regular scholar in

the Sunday School.

Another great need in successfully keeping up an interest in the Sunday School is a "Good Library," composed of interesting and instructive books and literature, setting forth those gospel truths and principles which we profess to believe and teach.

These books are written by some of our best and most earnest Christian teachers, and are selected by experienced judges, with a view to instruct and indoctrinate. Our Colportage Board at Montgomery have many hundreds of these books in store, from which can be selected a good

library suitable to the needs and finances of any of our schools.

The greatest want is more love to God, and desire for the salvation of

souls upon the part of parents and teachers, men and women.

The end of Sunday School work should be to lead to Christ all who come within reach of our influence and instruction. Every lesson to be properly taught and learned, should be prayed over. We can best teach and influence that child, man or woman, for whom we have faithfully sought help of God.

We recommend the prayerful consideration of these suggestions, and believe that an honest effort to do our duty will greatly enlarge this

work upon our hands during the next year.
