MINUTES.

The Twentieth Annual Session of the Macedonia Baptist Association met with County Line Church, Wayne county, Mississippi, on Friday before the first Lord's day in October, A. D. 1899.

The appointee from last session, Eld. D. Henson, being present and filled with the Spirit, services were opened by Eld. A. J. Easley by reading from the 1st to 22d verse of the 17th chapter of St. John. Sang hymn "I love my Savior, God;" then a very feeling prayer was offered by Bro. Easley. Elder D. Henson then took the stand and dwelled for about one hour on these words: "Behold, what manner of love the Father hath bestowed on us," which will be found in the 1st verse, 3d chapter, 1st Epistle of John.

The audience was then dismissed one hour for refreshments,

which was on the ground in abundance for all.

The congregation then re-assembled in the house for the transaction of business, sang hymn "Once more we come be-

fore our God;" prayer by Eld. A. G. Whit.

The house was then called to order by Eld. O. Lynes, Vice-Moderator. Then the Moderator proceeded to appoint the following committees, viz:

Next in order was the call for petitionary letters. Bro. O. R. Carrell came forward representing Zion's Rest Baptist Church by letter. He, together with the letter, was received, when the Moderator gave him the right hand of fellowship, welcoming him to a seat with us, and the church is now recognized as a member of the Macedonia Baptist Association.

It was moved and adopted that we now go into an election for officers for the ensuing year. Bros. J. J. Massey and M. F. Smith were appointed as tellers and the vote taken, which resulted in the choice of Eld. A. J. Easley, Moderator; Elder O. Lynes, Vice-Moderator; J. W. Henson, Clerk and Treasurer.

Next in order was the call for correspondence, when Bros. E. W. L. Davis, G. W. Smith and J. Slay responded from Leaf River Association, Eld. A. G. Whit from Red Creek Association. The Moderator gave them the right hand of fellowship and seated them with us.

Bros, Dan. Sullivan, E. J. James and the deacons of the

church were appointed to act as preaching committee.

Next in order was to appoint the following committees, towit:

On motion, the Association then adjourned to meet at 9 o'clock Saturday morning. Benediction by Eld. D. Henson.

The Moderator called the house to order at 9 o'clock, pursuant to adjournment; sang hymn, "Grace 'tis a charming sound."

First in order was roll call and absentees noted; then com-

Committee on Missions made their report, which was adopted after a very interesting discussion by O. Lynes, A. G. Whit, D. Henson and J. J. Massey; O. Lynes, Chairman; (marked C).

Committee on Investigation made their report, which was read and adopted, I. E. Easley, Chairman; (marked D).

Then 65 cents was found due the clerk, which was paid.

On motion, the Association then adjourned one hour for dinner, and to have preaching by Bros. Patrick and Moss; and, after serving refreshments on the ground in abundance for all, the congregation was drawn in the house by singing, and the delegates composing the body proceeded to the transaction of business.

Resolved, That we now adjourn to meet with Johnson's Creek Church, Green County Mississippi four or five miles west of Fruit Dale, Alabama, M. & O. R. R., on Friday before the fourth Lord's Day in September, A. D. 1900.

(C) REPORT ON MISSIONS.

We believe that the great work of the churches is the preaching of the Gospel to the world. We do, therefore, recommend that the churches of our body wake up and engage in this all important work. We recommend that the Association now in session take such steps as in their wisdom will best accomplish this end.

CONSTITUTION.

ARTICLE 1. This Association shall be composed of members chosen by the different churches of our union, who, upon procuring their credentials, shall be entitled to seats, and members thus chosen and convened, shall be known as the "Macedonia Baptist Association."

ART. 2. This Association shall, annually, upon convening, proceed to choose from the members present a Moderator and Clerk to preside over the deliberations of the body and to keep order and make correct entries and minutes of their proceedings, and in their deliberations they shall be governed by the Rules of Decorum annexed to this Constitution, which rules may be altered or amended as the Association may think proper.

ART. 3. This Association shall have no power to interfere with or infringe upon the internal rights and privileges of the churches, but shall be only an advisory council and convention of the churches, to answer such questions as are lawfully sent up by the churches and give such advice as may strengthen the union and promote the happiness of the churches.

ART. 4. Matters of dealings shall not be introduced by individual members but sent up by the church, clearly set forth in writing, with a statement that they have striven to reconcile the matter but have failed. Then the Association may take it under consideration, and a decision by a majority shall be an advisory answer.

ART. 5. All matters that relate to secular business and progress of the Association as a body, with the preaching of the Word to the attending congregation, at their annual session, must be introduced by motion. ART. 6. This Association shall pass no resolution touching the liberty of the churches or individual members on pecuniary matters, but each shall have the liberty to act in the matter for himself.

ART. 7. New churches may be admitted into this union by messengers bearing letters of application if, upon examination, they be found orderly and orthodox. Upon their reception the Moderator shall give them the right hand of fellowship.

ART. 8. Each church shall be entitled to two delegates until her number shall amount to one hundred members, and one additional

delegate for every fifty members over.

ART. 9. The churches shall trausmit to each annual session of the Association written communications specifying the names of their messengers; the number received, restored, and deceased since the last meeting of the Association, together with the whole number then in fellowship.

ART. 10. This Association shall open and continue a correspondence

with such of her sister Associations as she may think proper.

Constitution or depart from orthodox principles of the Gospel,

ART, 11. This Association shall have the power to exclude from her body or union, after due labor, any church that may violate the

ART. 12. This Association shall have a fund, to be supplied by voluntary contributions of the churches, or otherwise, as may be gratuitously contributed; and all moneys contributed by the churches shall be transmitted by their messengers and paid over to the Clerk, who shall be in charge of said fund and dispose of the same agreeable to order, and at every annual session make a fair and substantial report thereon.

ART. 13. A suitable and well-bound book for the Association shall be provided, in which the Articles of Faith, Rules of Decorum, and the Minutes of this and each succeeding session of this Association shall be legibly transcribed and properly paged and indexed by or under the inspection of the Clerk, who shall be allowed to receive a fair compensation for his services; and it shall also be the duty of the Clerk of this Association and each of the churches to procure, if practicable, and preserve a regular file of the printed Minutes of this Association.

ART. 14. Any proposed alteration or amendment to this Constitution shall be spread upon the Minutes, and at the next session, on the concurreace of two-thirds of the members present, shall be adopted

or amended.

ART. 15. Each church of this Association shall be entitled to four delegates, by amendment of the 8th Article of this Constitution, until the Association deems it proper to again resume said 8th Article in its original meaning.

RULES OF DECORUM.

1. The Association shall be opened by prayer or praise.

2. The Moderator and Clerk shall be chosen by the suffrages of the members present.

3. The Moderator shall be considered judge of order, and shall have a discretional right to call to order at any time.

4. Any member dissatisfied with a decision may appeal to the Association the same day, but at no other time.

5. But one shall speak at a time, who shall rise to his feet, and, obtaining permission, may proceed.

6. The Moderator, when addressed by a member for permission to speak, shall signify the same by naming the person or otherwise.

7. No member shall be interrupted while speaking, except he depart from the subject under debate or use words of personal reflection.

8. Every motion made and seconded shall come under the consid-

eration of the Association, unless withdrawn by him who made it.

9. Every case taken up by the Association shall be decided on or

be withdrawn before another shall be offered.

- 10. When a question is taken up, after allowing time for debate, the Moderator shall put the question fairly to the Association for decision.
- 11. Any person wishing to retire, shall first obtain permission from the Moderator.
- 12. No member shall speak more than twice on the same proposition without permission of the Association, nor more than once until every member wishing to speak shall have spoken; nor shall any proposition be made to close the subject until the debate has been carried through.

13. The appellation "Brother" shall be used in the Association by

members in their address one to the other.

14. The roll of the names of the delegates shall be called on Monday morning, and no names shall appear on the Minutes who do not answer to their names, unless leave of absence be granted or satisfactory excuse be rendered.

15. No member shall be tolerated in any practice which shall tend

to interrupt public speaking.

16. The Moderator shall be entitled to the same privilege of speaking as any other member, provided he appoint another member to his seat during the time; but he shall not vote on any question unless the Association be equally divided.

17. Any member violating these rules shall be reported by the

Moderator, at his discretion, but only on the breach made.

18. These rules may be altered or amended when a majority present may think proper to do so.

- ART. 6. We believe that sinners are justified in the sight of God only by the imputed righteousness of Jesus Christ.—Acts 13:39; Rom. 5:11-12, 23:25; Gal. 2:16.

ART. 7. We believe in the preservation of the saints.—Psalms 37:23,

23:28; Micah 7:8; John 5:24, 10:28; Rom. 8:35-49; 1 Peter 1:3-5.

ART. 8. We believe that Baptism and the Lord's Supper and Feetwashing are ordinances of Jesus Christ, of perpetual obligation, and that none but true believers are fit subjects for these ordinances. John 1:33; Matt. 3:13-17, 28:19-20; Acts 1:22, 2:41; Matt. 6:26-29; 2 Cor. 1:23-26; John 13:14-15.

ART. 10. We believe that no one is qualified to preach or administer the ordinances of the Gospel, except he be called of God as Aaron; is set apart by and is in good standing with the Church of which he is a member, and come under the hands of the presbytery. Mark 3:14; Acts 14:23; 1 Tim. 2:7, 5:22; Heb. 5:4; John 4:2; Acts 8:28.
