Morning Session, September 21st.

At 8:30 o'clock the Moderator opened the Association by

reading 1st Psalm. Prayer by Bro T B Miller.

An opportunity was given for the recognition of visiting brethren when Brother A E Burns was recognized in his official capacity representing the State Board of Missions and the Alabama Baptist.

Report on deceased ministers read and adopted.

On motion the regular order of business was suspended and the association joined in prayer in behalf of the family of Bro L W Raynes, deceased, and the serviving ministers of the association.

On motion the association adjourned at 11 o'clock for preach-

ino.

On motion Bro John L Ray was admitted to the floor to be heard on the report.

On motion the subject of the Sabbath Schools was postponed till 9 o'clock tomorrow morning.

The executive committee was retained for another year, which was as follows: A B Griffith, G M Ball, R S Dean and W F Wilder.

Adjourned to meet with Union church Friday before the 4th Sabbath in September, 1896.

SUNDAY SCHOOLS.

Your committee on Sabbath Schools submit the following report: This being one of the chief questions in our associations and conventions one might suppose it an easy matter to get up statistics in making such report, but it is very difficult, made so by the churches failing to state in their letters to the association whether or not they have a Sunday School. In our association from 16 churches we have eight Sabbath Schools reported. This perhaps is about an average of the state, and of the Southern Baptist Convention. We heartily recommend the Sunday School Literature published at Nashville, Tenn., under the auspices of the Southern Baptist Convention. We would called the attention of the brethren of this association to the fact that we have a Sabbath School Convention in the bounds of this association and as some of them do not seem to know it, or at least they do not attend, we would like to know whether the brethren of this association think it expedient to try longer to keep up a Sunday School Convention in its bounds? We urge the churches of this association to take a deeper interest in the Sunday School work. Let those that have them keep them alive, and prosperous, for our church members and our children need to be taught the word of God which is able to make them wise unto salvation. Let those churches that have no Sabbath Schools organize one at the earliest day possible for no church can hope to be very prosperous without a Sabbath School, especially is this true of a church that has preaching but once a month. DECLARATION OF FAITH AND PRACTICE.

ARTICLE I. We believe that there are three that bear record in Heaven: The Father, Word and Holv Ghost; and that these three are one, the only living and true God, the Creator and Preserver of all men of the Universe.

II. We believe the Word was made flesh in the person of the man Christ Jesus, who is God over all, and blessed evermore.

III. That all scriptures as contained in the Holy Bible is given by inspiration of God, and is profitable for doctrine, for correction, for reproof, instruction in righteousness, that the man of God may be perfect, thorougaly furnished unto all good works.

IV. That the law and testimony as set forth in the Scriptures is the only rule of faith and practice to Christians in their spiritual concerns, and in their conduct as individuals and as members of the churches.

V. That Adam, the natural head and representative of all mankind, fell from his state of original purity, and that by his

disobedience all his posterity are made sinners.

VI. That by the obedience of Christ alone sinners are restored to the favor of God, and through His unmerited mercy receive regeneration, pardon, justification, sanctification and

glorification.

VII. That those blessings are communicated by that Holy Ghost sent down from Heaven, so that those who are saved are saved by grace, through faith, and that not of themselves; not of work, lest, any man should boast; not by words of righteousness which they have done, but by the washing of regeneration and renewing of the Holy Ghost.

VIII. That God works all things after the counsel of His own will; foreknown unto Him are all His works from the beginning, and that of course, all that the Father bath given to Christ shall come to Him, and that He will raise them up at the last day, so that His sheep will hear, His voice shall never perish become dead to the world and to sin, be made alive to God and when He who is their life shall come, appear with Him in glory.

IX. We believe that believers should obey the commandments of Christ, and maintain good work for necessary uses.

X That sinners of the vilest character may obtain salvation

through Christ without money and without price.

XI. That there will be a resurrection of the dead and a general judgment, according to the decision of which the wicked shall go away into everlasting punishment, and the righteous to life eternal.

XII. That God has instituted a church on earth, existing in distinct bodies, the only scriptural members of which are the faithful in Christ Jesus, called to be saints, who are immersed in water in the name of the Father, of the Son and of the Holy Ghost, and who have given themselves to the Lord and to one another in the church relation by the will of God their voluntary consent.

XIII. That each church of Jesus Christ is independent of all authority but that of her head, and that she has under Him the exclusive power of managing all her concerns of judging of the qualifications of her own members for the offices they are to fill, and of choosing her own officers in conformity with the

direction of the Word of God.

XIV. That the officers of the churches are pastors are deacons only.

XV. That scriptural baptism is an ordinance of the Gospel and consists in immersing the body of a disciple of the Lord

Jesus in water upon a profession of his faith in Christ.

XVI. That the Lord's supper is a standing ordinance in the Church of Christ, consisting in a believing participation of bread and wine, to be observed in commemoration of the suffering and death of Christ, and to show forth His death until He comes the second time.

SUNDAY SCHOOL CONVENTION.

FARILL, ALA., Aug. 3d, 1895

The Cedar Bluff Baptist Sunday School Convention appursuant to the call of the Executive Committee with the Firs Baptist Church of Farill on above date. Introductory sermon by Eld. J. N. Webb. Text: Romans 1st chapter. Adjourned until in the afternoon.

The Convention was called to order at 2 o'clock by the Moderator reading the 19th Psalm. Prayer was offered by Bro. Ramsey. The election of officers resulted in electing T B Miller, Moderator, and D O Preskitt, Secretary. On motion the regular order of business was suspended until 7:30 o'clock to-night and the general business of the Convention taken up. On motion the present Executive Committee was retained for another year. On motion the Executive Committee was instructed to call the next Convention together so as to embrace the first fifth Sunday after February, 1896. On motion Bro J N Webb was added to the Executive Committee and D O Preskitt was retained corresponding secretary of the Convention. Adjourned to meet at 7:30 o'clock.

Convention met Sunday, August 4th, at 9 o'clock a.m. and was called to order by the Moderator. Bro T B Miller read the 19th Psalm after which prayer was offered by Bro H T Leath. The regular program was taken up: First subject for discussion was: Are societies in churches according to God's word. Bro H T Leath opened the discussion followed by Bro L W Raynes. On motion the subject on discussion was passed and the next subject on the program was taken; subject being, "What is Gospel Temperance?" The discussion was opened by Bro J N Webb. No other speaches on this subject the Convention adjourned until 1:30 o'clock p. m. Convention met as adjournment and was called to order by the Moderator. After singing prayer was offered by Bro Thos Rineheart. On motion the subject on discussion was passed and the next subject on program was taken up, "The duty to maintain prayer meeting and Sunday School in every church." V A Bell, the speaker appointed to discuss this subject, being absent a motion was made and carried to pass this subject and take up the next. Subject, "What are the evidences of a true christian." Discussion was opened by Bro J R Ramsey followed by Bro Leath. On motion the speakers who were going to discuss the remaining subjects were limited to speak not over ten minutes. The next was "How to make the Sunday School more attractive." Bros J C High, J F Preskitt, J N Webb, W H Johnson, L W Raynes and J R Ramsey discussed the subject. On motion the convention adjourned.
