MINUTES.

SATURDAY, Oct. 5th, 1872.

The Judson Baptist Association convened in its Twenty-Second Annual Session, with the Abbeville Church, Abbeville, Hensy county, Alabama, at 10 o'clock a. m. The Introductory Sermon was preached by Eider L. R. Sims, from 2nd Cor. 6th chapter and 1st verse,

"We then, as workers together with him, beseech you also that ye receive not the grace of God in vain."

At 2,30: p. m. the delegates reassembled in the church, and were catled to order by Elder L. R. Sims, Moderator. Prayer by Elder P. M. Callaway.

The letters from the clurches composing the Association were called for and read.

The Association then proceeded to the election of officers, which resulted in the choice of Elder L. R. Sims, Moderator, and J. L. Williams, Clerk.

Upon a call for Petitionary Letters, Bluff Springs church, Henry county, Alabama, presented a letter asking admission as a member of this Association, and, on motion, was received and the moderator, in behalf of the association, extended to her delegates the right hand of fellowship, with an invitation to seats in the body.

MONDAY Oct. 7th

Prayer Meeting in the church, at 8 o'clock-a. m.

At 9 o'clock the body was called to order by the Moderator.

The call for Petionary letters was renewed, and none received; also the call for correspondents was renewed, and none received.

The report of the committee on missions was called for, and the committee, not being ready, was:allowed longer time.

The committee on Deceased Ministers handed in their report, which was read and adopted. See appendix A.

The report of the committee on Sunday Schools was called for and read A motion to amend was accepted by the committee, and a motion to adopt was lost.

The report of the committee on Documents was called for, read, and, after some amendments; the report was adopted See appendix "C."

The report of the committee on nominations was called for read and adopted See appendix "B."

The report of the Executive committee, was called for read and adopted See appendix "D."

Upon a call for volunteers to go as correspondents to sister associations, the following brethren reported their names and were appointed accordingly.

The committee on missions, handed in their report which was read and adopted : See appendix, "E."

Eld D. Rogers handed in a request from the Pilgrim's rest Baptist Church, for the next session of this body to be held with her; which request was on motion granted. The hour for Preaching having arrived, the following resolution was adopted, to-wit.

Resolved that this body continue in session, until all the business is disposed of, taking a recess of one hour at noon.

On motion it was resolved that the next session of this body shall commence on Saturday before the 1st Sunday in October 1873.

The Report of the treasurer was called for, read and adopted See appendix F.

On motion of Eld E. M. Knowles, this association resolved

to reunite with the general association.

On motion, the Moderator appointed a committee, consisting of A. L. Martin, D. Rogers, and B. Herndon, to nominate delegates to be appointed to the general association.

The following query was handed in to-wit: "Would it be according to gospel order, for any Baptist church, in the bounds of the Judson association, to receive a member from the freewill Baptist in her body upon a letter of dismission, in full fellowship, wi hout rebaptism?

The query was contertained and discussed; pending which the body adjourned to meet again at 1 o'clock P. M. Prayer by Eld T. E. Langley.

Preaching in the M. E. Church, at 11 o'clock, by Eld W. A. Cumbia, from John 14th chapter 2nd verse. "I go to prepare a place for you." At 1 o'clock, the meeting met pursuant to adjournment, and was called to order by the Moderator.

To answer the query handed in before adjournment was first in order, and a motion to answer in the negative prevailed.

The following Resolution presented by Eld D. Rogers, was, on motion, adopted.

Resolved, That we advise all the churches of our association against receiving into their fellowship from freewill, whitities Campbellites, or any other denomination, held by us as being in disorder, without Baptising such aplicants.

The Report of the committee on Finance was handed in, read and adopted, See appendix G.

The circular letter, of Eld A. L. Martin; was handed in read, and approved and ordered spread upon the minutes of the association, See appendix H.

The following Resolution offered by Eid W. A. Cumbia, was adopted.

Be it Resolved, That the thanks of this body are due, and are hereby tendered, to the brethren and friends of Abbeville, and vicinity, for the very hospitable manner in which they have sustained us during our stay among them.

And be it further resolved, That we tender our thanks to our Methodist brethren for the use of their house of worship during our session.

A special committee consisting of Bros. J. R. Morris, A. B. Fowler, and J. Irwin, was appointed to investigate the claims on this body of Elds. L. R. Sims, and Phil. Belcher, for services rendered in preaching in the destitution this year, as Missionaries, and recommendsuch action as they think proper going to their payment. It was resolved by the body that this association agree to support Eld Phil. Belcher at the same time laboring in the destitution and other places, as much as his strength will admit of, and a collection, by pledges, for his support, amounting to \$40,00 was taken up.

The following resolution, by J. W. Malone, was adopted.

Resoluced That the Pastors of each church composing this association be requested to take up collections in their respective churches, quarterly for the purpose of reising funds, for the support of Eld. Phillip Belcher.

Report of special committee on the claims of Elds L. R. Sims and Phil. Belcher was banded in read and adopted. See appendix I.

Pledges for Missionary purposes was taken up amounting to \$100,00.

A special committee, consisting of P. M. Callaway, T. E. Langley, and J. Irwin, were appointed to recommend to this body the best policy to pursue in relation to members of the church trafficking in spirituous Liquors Bro J. R. Morris, was appointed to write a circular letter to the next session of this body.

A special committee, consisting, of E. M. Knowles, J. C. Skipper, and T. F. Espy, was appointed to investigate the matter and say what amount of funds would be required, to support Eld Phil. Belcher.

The special committee appointed to recommend a policy in relation to the traffick of spirituous Liquor by members of the church, made the following report which was adopted.

Your committee recommend the association to advise the churches composing the same not to tolerate the traffick of ardent spirits, in any quantity, to be used as a beverage.

The following resolution, by J. R. Morris, was adopted.

Resolved That the clerk receive twenty-five dollars for his services, and that we appropriate \$35,00 for minutes.

The special committee appointed to nominate persons to go as delagates to the general association, presented the names of the following brethren, who were appointed accordingly. 5. R. Sims, P. Beleher, A. L. Martin, J. Tyler, T. F. Espy, E. M. Knowles, D. Whiddon, and J. C. Skipper, after which the delagates extended to each other the parting hand, and the association:adjourned to meet with the Pilgrams rest Baptist church, Henry County, on Saturday before the 1st Sunday in October 1873.

The field is the world, and until the Gospelies preached to every creature, we are not at liberty to withhold our Lords money, nor conclude that our part of the mission work is done.

Within the bounds of associations bordering on our own there is.

a large and alarming destitution; and as brethren bound by the same fraternal ties, and working in the vineyard of the same Loid, should we not enlarge our bounds by helping our brethren in their large destitution, which lies so near the door of our own association ?

APPENDIX H-THE WANTS OF ZION-CIRCULAR LETTER.

Dear brethren, one of the great wants of the churches, in our section of the country is scriptural instructions, in the doctrines of grace. Many of our people do not know what the Baptist doctrines are many of our ministers fail to preach the distinction docurines of scripture either because they do not know them, or because they do not believe them. If it was for the want of knowledge, then it is either the fault of the preacher or the churches to which he preaches.

It is his fault if he wilfully neglects to study the Bible : bnt if he has not time to study the Scriptures, on account of the pressing wants of his family, then it is the fault of the church or churches which he serves, and you, Dear Brethren of the churches of the Judson Association, if you could be instructed in the great doctrines of grace that distinguish you from all other people, you must untie the hands of your ministers, and cut them loose from all secular employment, so that they may give themselves wholly to the word of God and pray-This is absolutely necessary in order that the Pastor er. himself may be able to teach these doctrines, because he can not be expected to teach what he does not know. He can not know these things without study; he can not study without time; he can find no time without means, and he can not have means unless they are supplied by his churches. If he be compelled to raise the means of support by his engagements in a secular calling, he will not have time to study God's word, to understand which requires the minister's whole and undivided time,

God's word requires you to support your ministers ; and, if you would have them be able to contend for the faith once delivered to the saints ; if you would be properly instructed in these precious doctrines, you must sustain them so that they may scripturably devote themselves to this great work.

Art. V We believe in man's incompetency to recover himself from the fallen state he is in by nature, by his own will and ability John vi 44 45; Rom xi 6; Eph ii 89.

Art. VI We believe sinners are justified in the sight of God only by the imputed righteousneess of Christ. Isa. 4vii, 8; Acts iv, 11; 12; Rom iii, 21-36, and v, 6; viii 9,

Art, VII. We believe that God's elect shall be called, regener ated and sanctified by the Holy Ghost. John vi, 63 and xvi, 13 14, 1 Cor ii, 10-12: 14 Cor. i, 10 12: Eph, ii 1 10: 11 Tim, i 9; Tit, iii, \$47.

Art, VIII. We believe that nothing can seperate the true be lievers from the love of God, but that they will be kept by the power of or God through faith unto salvation, John vi, 37, x 28-30, xiii, 23; Phil, 1, 6; Hebrews vi, 7, 8; Peter i, 5,

Art. IX, We believe that Baptism and the Lord's Supper are ordinances of Jesus Christ; that true believers are the only subjects of these ordinances, and that immersion only is baptism.— Matt iii 5-12: Mark i. 5: Luke iii, 3: Acts ii, 58-42: John iii, 23: Rom, vi, 3, 4: Col, ii, 21 I Peter iii, 21; Acts xviii, 8,

Art, X, We believe in the resurrection of the dead, and a gencral judgment. Job xix, 26 27 : Daniel xii 2 : Hos, xiii, 14 : Mark xii, 24 27 : H Cor v 10.

Art. XII, We believe that no minister has a right to adminis-

ter the ordinances, unless he is called of God, and come under the imposition of hands by a presbytery, and is in fellowship in the church of which he is a member, Isa, Ixvii, 6, Matthew ii, 7, Acts xiv, 23. Romans xii, 6. 7, I Cor i, 1, II Cor, v, 18, Col iv 17, I Tim 1, 12,

DECORUM.

1. Every query sent up to the Association by any Church in this union, shall be read, and put to vote by the Moderator, whether it shall be debated or not; and if there be a majority for it, it shall be taken up and investigated, but if not, shall be withdrawn: provided, always, that those be first considered that affect the union of the Churches.

2. Every motion made and seconded shall come under the observation of the Association, except it be withdrawn by the member who made it,

3. Every person who speaks in debate shall rise from his seat and address the Moderator and shall not be interrupted while speaking, unless he depart from the subject in debate, or use indecorous language.

4. No person shall speak more than three times upon the same subject, without leave of the body.

5. No member shall abruptly break off or absent himself with out leave of the body, and if he does, he shall be marked us an absentee,

6. The names of the members of the Association shall be enrolled by the Cierk, and called over as often as the body may require.

7. The Moderator shall be entitled to the same privilege of speaking as any other memoer, provided the chair be filled ; but he shall not vote except the bady be equally divided.

8. It shall be the daty of the Moderator to see that these rules are strictly observed by the body.

9. It shall be the daty of the Clerk to keep a regular record of the proceeding of the body.

10. The Munites of the Association shall be read and signed by the Moderator and Clerk before the body rise.

11. Amendments may be made to this form of government by two-thirds of the members in session.
