EIGHTEENTH ANNUAL MEETING OF THE KOREA MISSION,

Held in Seoul, Korea, September 24—October 4, 1902

FIRST DAY.

September 24, 1902.

MORNING SESSION

The Korea Mission of the Presbyterian Church in the United States of America met in the Central Church at the Government Hospital, Seoul, and the whole morning was spent in prayer and praise, the subject considered being. "Conditions of Victory, Spiritual and Material."

The first hour was led by Rev. W. L. Swallen on the topic, "Fellowship with God," Josh. 1. 5, 17; the second by Rev. J. S. Gale on "Familiar Acquaintance with God's Word," Josh. 1. 8; the third by Rev. C. E. Sharp on "Courage," Josh. 1. 7, 9, 11.

After the prayerful consideration of these topics, the Sacrament of the Lord's Supper was administered by Rev. W. E. Parsons, D. D., of Danville, Illinois.

The Committee on Arrangements for Annual Meeting presented the program in print reporting that the meeting had been changed from Pyeng Yang to Seoul and recommend-

ing that the events of the program be fixed one day ahead of

the dates assigned and that the morning sessions begin at 9 o'clock. The Mission approved the change of the Annual meeting to Seoul, and adopted the recommendations of the Committee.

The Examination Committee reported that Messrs. Bruen and Sidebotham had passed the examinations prescribed for the third year and Messrs. Barrett, Blair and E. H. Miller had passed and Mr. Welbon completed the examinations prescribed for the first year.

Dr. Underwood was elected to fill the vacancy on the Examination Committee, term to expire 1905; Mr. Bruen to fill the vacancy on the Estimates Committee, term to expire 1905; Mr. Baird to fill the vacancy on the Christian News Committee, term to expire 1904.

A letter from the Secretary of the M. E. Mission, South, was read and the Chairman was instructed to appoint a delegate to convey our fraternal greetings to that Mission.

The Secretary was instructed to inform the other Missions that for 9.40 A. M. Saturday September 27th, we had made the reception of fraternal greetings the order of the day.

After the singing of a hymn and prayer by Mr. Lee the Mission adjourned.

SECOND DAY.

Sept. 25, 1902.

MORNING SESSION

The Mission met at 9 A. M.

Devotional exercises were led by Rev. E. A. Marshall of Chicago, Ill.

The minutes of yesterday's meetings were read and approved.

The retiring officers then yielded their places to the officers elect.

Rev. W. B. Hunt, the new Chairman, appointed the following committees:-

The Board having referred certain questions concerning Dr. C. H. Irvin to the Mission for answer, it was moved by Mr. Gale and duly supported that the chair appoint a committee of five to investigate the matters involved.

On motion of Mr. Whittemore this motion was laid on the table, and made the order of business for 11. 30 this morning, the Mission to meet in closed session.

Seoul Station then presented its General Report through Dr. C. C. Vinton.

After a recess and the singing of a hymn, Fusan Station presented its General Report through Rev. Cyril Ross.

At 11.30 A. M. the special order of the day, the consideration of the motion concerning the appointment of a committee of five to investigate the matters involved in the Board's reference of certain questions concerning Dr. C. H. Irvin was taken up.

After much discussion the following resolution was adopted:

"Resolved that the Chair appoint a committee of five to ascertain the nature of the charges against Dr. Irvin, to tabulate them, and present the charges as tabulated to the Mission for its consideration."

The Mission then adjourned, being led in prayer by Mr. Swallen.

AFTERNOON SESSION

The Mission having again assembled at 2:30 P. M. the devotional exercises were led by Rev. E. H. Miller.

The reading of the minutes of the morning's session was postponed until tomorrow.

Rev. H. O. T. Burkwall of the British and Foreign Bible Society and Rev. D. A. Bunker of the American Bible Society were given the privileges of the floor.

The report of the Special Bible Committee (Report I) was then presented by Dr. Moffett and the report was adopted.

The amended constitution of the Permanent Executive Bible Committee having been brought before us by the Special Bible Committee for ratification or otherwise, it was decided to consider it section by section. The amended constitution being considered section by section each section in turn was adopted.

It was moved by Dr. Wells and duly supported that the constitution as a whole be ratified. Mr. Adams then moved and it was seconded that we add "tentatively for one year."

On motion of Mr. Gale the further consideration of the constitution was made the order of the day for September 29th, Monday, at 10.45 A.M.

After a brief recess and a duet sung by Mr. and Mrs. Blair, the Chair appointed the following committee on the charges against Dr. Irvin: Mr. Gale, Dr. Moffett, Mr. Sharp, Mr. Adams, Mr. Sidebotham, Mr. Whittemore, the Chair adding a sixth member with the consent of the Mission. The Seoul General Report was discussed and with the Fusan General Report was referred to the proper committees.

On motion the reading of the Syen Chynn and Taiku General Reports was made the first order of the day for tomorrow.

On motion the Mission adjourned, being led in prayer by Mr. Sharp.

THIRD DAY.

September 26th, 1902.

The Mission assembled at 9 A.M. and the devotional exercises were led by Rev. J. E. Adams.

The minutes of yesterday's sessions were read and adopted. Mrs. Sidebotham was present for the first time.

The Syen Chyun Station General Report was presented by Dr. A. M. Sharrocks.

After recess the Syen Chyun report was discussed.

The privileges of the floor being extended to the visiting brethren, Rev. W. E. Parsons, D. D., of Danville, Ill., participated in the discussion.

Taiku Station then presented its General Report through Rev. J. E. Adams, and it was then discussed.

The Syen Chyun report and the Taiku report were on motion referred to the proper committees.

It being moved by Mr. Whittemore that a full abstract of the minutes of the Annual Meeting with the important reports of Committees be printed, Messrs. Whittemore and E. H. Miller were appointed a committee to ascertain the probable cost of printing the same.

Seoul Station requesting that Miss Wambold's furlough be granted from next May and that Mr. Gale be allowed a special furlough of four months next summer, the matters were referred to the Apportionment Committee.

A communication from the Southern Presbyterian Mission was read and placed on file.

The Mission adjourned with prayer led by Rev. Mr. Harrison of the Southern Presbyterian Mission.

FOURTH DAY.

September 27th, 2902.

The Mission assembled at 9 A. M. and the devotional exercises were led by Rev. Graham Lee. The minutes of yesterday's session were read and approved after correction.

Mrs. C. A. Clark was present for the first time.

The hour for the reception of fraternal greetings having arrived, Rev. D. A. Bunker of the M. E. Mission pre-Sented greetings in behalf of that Mission, which were responded to by Dr. J. H. Wells. Rev. C. G. Hounshell presented greetings in behalf of the M. E. Mission, South, and Rev. Graham Lee responded. Rev. H. O. T. Burkwell presented the greetings of the British and Foreign Bible Society, and Rev. C. F. Bernheisel responded. The Y. M. C. A. Secretary for Korea, Mr. P. L. Gillett, presented greetings, responded to by Rev. E. H. Miller.

A verse was sung by the Mission and all the visitors present, and a recess was taken.

On motion, the report of Committee on charges against Dr. Irvin was made the order of the day for 12 o' clock, the Mission to meet in closed session.

The General Report of Pyeng Yang Station was read by Rev. W. L. Swallen.

The committee on charges against Dr. Irvin brought in a report and the report was adopted, and a committee of nineteen was appointed to deal with the matters involved.

A letter from Dr. Irvin was read by the Secretary.

Committee on Conference in 1904 reported through Dr. Vinton, and the report was adopted.

Mission adjourned, being led in prayer by Mr. Kearns.

FIFTH DAY,

September 29th, 1902.

Mission met at 3.30 P.M. the hour having been changed by common consent.

The devotional exercises were conducted by Mr. Hunt.

The minutes of the last meeting were read and approved.

The Secretary read letters from the Board under dates of August 12th, 15th and 26th. Questions asked in letter of August 12th were referred to the proper committees. The matter concerning outfit allowance and furnishing of Mission houses brought before us in the letter of August 26 was referred to a committee of three for consideration. A letter from the Permanent Executive Bible Committee was read and referred to the Apportionment Committee.

A recess of fifteen minutes was taken.

After recess Mission again assembled.

Mrs. C. C. Vinton was present for the first time.

The report of the Committee of nineteen on investigation of charges against Dr. Irvm was heard, and adopted.

The following members were elected to serve on the General Committee of the 1904 Conference: Dr. Vinton, Mr. Sharp, Mr. Hunt.

Committee on withdrawal from South Kyeng Sang Province reported through Dr. S. A. Moffett (Report II) and the report was adopted and the committee discharged.

The Pyeng Yang General Report was then discussed and referred to the proper committees.

The consideration of the constitution of the Permanent Executive Bible Committee was made the special order of the day for to.45 A.M. tomorrow.

On motion the Mission adjourned, prayer being offered by Rev. C. A. Clark.

SIXTH DAY.

September 30th, 1902.

Mission met at 9 A. M. and Rev. W. L. Swallen conducted the devotional exercises.

The minutes of the last meeting were read and approved after correction.

The Property Committee presented a partial report through Dr. Field. On motion this was taken up item by item.

Item 1 was adopted.

Item 2 was referred back to the Committee.

Items 3 and 4 were adopted.

Item 5 was referred back to the Committee, with instructions to bring in plans for an average house, both one story and two story.

The consideration of the amended constitution of the Permanent Executive Bible Committee being the order of the day, Dr. Wells' motion to ratify the constitution as a whole,

with the amendment proposed by Mr. Adams to add "tentatively for one year," came up for consideration. After discussion the question being put, the amendment was lost and the amended constitution as a whole was then ratified.

A recess was taken after which a song was sung by Mrs. Moffett and Mrs. Kearns.

The Treasurer, Dr. C. C. Vinton, reported and the report was adopted.

The Educational Committee reported through Dr. Moffett (Report III).

Sections 1, 2, and 3 were adopted.

Section 4 was referred back to the Committee.

Sections 5, 6, and 7 were adopted.

The Editorial Committee made a partial report verbally.

The Committe on Seoul Records reported and the report was adopted.

Dr. C. C. Vinton reported for the Korea Field (Report IV.) The report was referred to the Editorial Committee.

The Business Manager of the Christian News, Dr. C. C. Vinton, reported (Report V). On motion the Mission adjourned, Mr. Bruen leading in prayer.

SEVENTH DAY.

October 1st, 1902,

Mission assembled again at 9 A. M. and Rev. W. M. Barrett conducted the devotional exercises.

The minutes of the last meeting were read and approved.

The matter of division of territory with the Australian Presbyterians was referred to the Evagelistic Committee.

The Medical Committee presented a partial report through Mr. Adams (Report VI). It was taken up section by section.

Sections 1 and 2 were adopted.

Section 3 was referred back with instructions to bring it in with recommendations concerning a physiciau in Fusan.

Section 4 was adopted.

Section 5 was referred back to the committee.

Section 6 was adopted.

A brief recess was taken after which a solo was sungyb Mrs. Sharp.

The Evangelistic Committee reported (Report VII) through Mr. Swallen.

Section 1 being taken up Dr. Field was allowed two helpers and the section was referred back.

Section 2 was Treferred back.

Sections 3 and 4 were adopted.

Section 5 was referred back.

Sections 6 and 7 were adopted.

The Finance Committee reported through Dr. Avison (Report VIII) and the report was adopted.

The question of the use of unexpended balances being brought up, it was referred to the Finance Committee.

The Jacobson Memorial Committee reported (Report IX), through Dr. Avison and the report was adopted.

The Committee on salaries of single men reported. The report was referred back. Dr. Moffett was added to the committee and made its chairman.

Mr. Bernheisel reported the Mission Statistics. The report was referred back for correction.

A letter from U. S. Minister, His Excellency Hon. H. N. Allen was read. The letter was referred to the Southern Presbyterian Mission, and the Secretary was instructed to inform Dr. Allen of this fact.

Mission adjourned with prayer by Dr. Moffett.

EIGHTH DAY.

October 2nd, 1902.

Mission met at 9 A. M. and the devotional exercises were conducted by Rev. C. E. Sharp.

The minutes of the last meeting were read and approved.

The Examination Committee made a partial report verbally, reporting that Miss Barrett and Miss Henry had passed the examinations prescribed for the first year.

The Committee on Mission Records reported and the report was adopted.

The Committee on Fusan Station Records reported and the report was adopted.

The Committee on Taiku Station Records reported and the report was adopted.

The Committee on Syen Chyun Station Records reported and the report was adopted.

The Committee on Statistics reported (Report IX) and the report was adopted and ordered printed.

The Educational Committee presented a supplementary report which was adopted and the report of the Educational Commitee (Report III) was adopted as a whole.

The Rules and By-Laws Committee reported (Report X) and the report was adopted as a whole.

The Committee on Furnishing of Mission houses, Mr. Lee, Mr. Welbon, Mrs. Baird reported and the report was adopted unanimously.

Report of Committee on Pyeng Yang Station Records was presented and the report was adopted.

The Secretary was instructed to send greetings to Miss Strong, Mrs. Gifford, Mrs. Leck, Mrs. Gale and Mr. and Mrs. Moore, and to convey the hearty thanks of the Mission to Mrs. Gifford for her excellent services.

After a brief recess the Pyeng Vang mixed quartette favored us with a selection of music.

The Medical Committee presented a supplementary report.

Items 1 to 5 were adopted.

Item 6 was amended to read as follows: "That we approve the request of Pyeng Yang Station for a new hospital to replace the plant to be turned over for the use of the Girls' School, and request the Station to prepare plans for the same and submit them with estimates to the Mission through the proper committees."

Items 7 to 10 were adopted.

The report as a whole was adopted.

The report of Committee on salary of single male missionaries was presented, the reportbeing taken up item by item.

Items 1 and 2 were adopted.

Items 3 and 4 were referred back to the committee.

The Editorial Committee reported through Mr. Gale (Report XI).

Items 1 to 10 were adopted,

Item 11 was referred back.

Items 12 to 19 were adopted.

The Chair was instructed to appoint a committee of two to draw up resolutions appropriate to the death of Mr. Leck, to be presented to the Mission, his family, and the Board. The Chair appointed Dr. Sharrocks and Mr. Lee as such committee.

The following resolution presented by Mr. Gale was adopted :

"We would record our sense of loss at the removal from our midst of Rev. H. G. Appenzeller of the Methodist Episcopal Mission, and in loving memory of him as a Christian brother and fellow-worker would express our appreciation of his great services in the founding and building up of Christian work in this empire.

"We also convey to Mrs. Appenzeller our heartfelt love and sympathy, and pray that God may give her all needed grace in this time of overwhelming sorrow."

The Committee on salary of single male missionaries presented an amended report (Report XII) which was adopted.

It was decided that when we adjourn we adjourn to meet at 8.30 tomorrow morning.

The Committee on the Christian News reported through Mr. Baird and the report being considered section by section each section in turn was adopted and the report was adopted as a whole (Report XIII).

By vote of the Mission the prayer-meeting topic book was allowed to use the imprint of the Chistian News.

On motion the Mission adjourned with prayer by Dr. Wells.

NINTH DAY.

October 3rd, 1902.

Mission met at 8.30 A. M. and the devotional exercises were conducted by Rev. A. G. Welbon.

The minutes of yesterday's session were read and approved after correction.

The Examination Committee reported verbally that Mrs, Blair had passed the examinations prescribed for the first year.

The Property Committee presented a supplementary report (Report XIV).

Items 2 and 6 were adopted.

Item 5 was referred back to the committee.

Item 6 1-2 was amended to recommend that we ask the Board to supply the funds, and adopted.

Them 7 was referred back.

Items 8-12 were adopted.

Action on items 13 and 14 was deferred.

Items 15-22 were adopted.

Action on item 23 was deferred.

Action on item 24 was deferred until after the report of the Apportionment Committee.

Item 25 was amended, adding the whole cost of the house, Yen 3500, and it was adopted as amended.

Items 26 and 27 were adopted,

A short recess was taken, after which a solo was sung by Mr. Lee.

Rev. G. H. Jones of the M. E. Mission North made a few appropriate remarks.

The Apportionment Committee made a partial report. At the request of the Apportionment Committee, the Mission entered on an informal discussion of the question:

"Shall we temporarily place one of our new families in Mokpo until a married man can be placed there by the Southern Presbyterian Mission, in order that that Mission may not be compelled to adandon that station?"

On motion the matter was referred to the Apportionment Committee.

At the request of the Apportionment Committee the Mission informally discussed the question:

"Shall it be our policy to look toward the abandonment of Fusan as a station as soon as feasible."

On motion the matter was referred to the Apportionment Committee.

The Mission adjourned to meet at 7.30 P. M.

EVENING SESSION

The Mission meeting at the appointed time, devotional exercises were led by Rev. C. E. Kearns.

It was decided by vote that the next annual meeting be held in Pyeng Yang.

The following resolution was adopted :

"Resolved, That in defining the boundaries between Seoul and Wonsan Stations we recognize the counties of Ichun and Hoiyang as belonging to the Canadians, and that Seoul Station embrace all the territory as far as and including the official towns of Pyengkay and Kimsung."

The Ecitorial Committee presented an amended roport, which was adopted, and the report as a whole was adopted. (Report XI).

It was moved by Mr. Adams and duly supported that a balance from an appropriation for the purchase of a preaching room, Ven 252.25; also a balance from the yet unfinished sale of a property in the city, Ven 150.67, or a total of Ven 402.92, being in the hands of Taiku Station: we ask the Board to transfer Ven 67 towards purchasing a site for a woman's guest room, and Ven 175 for the completion of Mr. Bruen's house appropriation. Action on the motion was deferred:.

The Evangelistic Committee presented a supplementary report which was adopted and the report as a whole was adopted. (Report XII).

The Apportionment Committee presented its report. ($R\epsilon$ port XV).

The recommendations concerning Fusan were adopted as a whole by a vote of 22 to 0, 27 voting members being present

The recommendation concerning the non-appointment of Dr. Moffett to Bible translation was adopted.

In the apportionment of Mr. Gale of Seoul Station, the Mission added, "other labors not be interfere with Bible translation."

The Chairman appointed as Committee on Arrangements for Next Annual Meeting, Mr. Baird, Miss Best and Mr. Bernheisel.

After a recess, the Apportionment Committee continued its report.

In the apportionment of Mr. Bernheisel of Pyeng Yang Station the Mission added, "and another helper."

The Secretary was instructed "to send our heartiest expression of thanks to Mrs. Fischer for her contribution to the enjoyments of the Annual Meeting. The amazing rapidity with which these refreshments have disappeared leaves no doubt as to how they were appreciated. Thanks, greetings and kindest remembrances from us all."

The committee appointed to ascertain the cost of printing the minutes and committee reports presented its report verbally. The Mission ordered the minutes and committee reports printed.

The Chairman of the Mission was added to the Committee on Arrangements for Next Annual Meeting,

A letter from the Conncil Hymn Book Committee was read and referred to the Mission Hymn Book Committee.

The Property Committee presented an amended and snpplementary report. (Report XIV).

On motion, the Mission decided to reconsider its action taken *ad interim* in response to the circular letter from Taiku Station under date of Jan. 7, 1902 authorizing the sale of nunsed property in Taikn. It being reconsidered the action was reaffirmed.

On motion, the Mission asked the Board to approve the sale of the above mentioned Taiku property.

Items 5, 7, 13, 14, 23, 29-32 of the Property Committee's report were adopted. The report of the Property Committee was adopted as a whole.

Dr. Vinton presented the following resolution:

"Whereas, The building of the honse for Rev. F. S. Miller must be proceeded with at once; and

"Whereas, the Mission has been depending npon the use for this pnrpose of 3000 Ven still remaining of the Chung Tong property forfeit;

"Therefore, Resolved, That the Mission request Board approval of this use of the money."

The resolution was adopted.

On motion the Mission adjourned with prayer by Rev. W. B. Hunt.

TENTH DAY.

October 4, 1902.

The Mission met at 8.30 A. M. and the devotional exercises were led by Rev. C. A. Clark.

The minutes of yesterday's sessions were read and approved.

A memorial of Mr. Leck was presented by the committee appointed to prepare the same, and the Mission ordered it spread on the minutes. It was as follows:—

"Whereas, Our Heavenly Father in His good providence has seen fit to remove from our number our beloved brother, Geo. Leck,

"Resolved, That we the members of our Mission in session express our deep sorrow in the loss of this devoted worker, and our appreciation of the work he had already accomplished.

"He was a man most capable in natural abilities, earnest in his desire to do God's will, faithful in the discharge of all duties, and a man marked in the sweetness and amiability of his disposition.

"We wish to express our implicit trust in Almighty God in all His dealings with us, and to Mr. Leck's relatives in America our sincerest sympathy in the deep sorrow they have sustained.

"We request that these resolutions be spread upon our minutes, and copies be sent to Mrs. Leck and Mr. Leck's parents.

The report of the Hymn Book Committee (Report XVI) was received and adopted.

The Estimates Committee reported. (Report XVII).

Moved and seconded that the action of two years ago not to allow Seoul Hospital expenses to exceed Yen 2000 be for the present waived. Carried.

After recess and the singing of a hymn, the Estimates Committee continued its report. The report of the Estimates Committee was adopted as a whole.

The Apportionment Committee made a supplementary report, which was adopted, and the report was adopted as a whole. The Committee on Arrangements for Next Annual Meeting presented a report, which was adopted. (Report XVIII).

It was moved and carried that if in the judgment of the Arrangement Committee circumstances shall render a change of place or time expedient from those decided by the Mission they shall submit the matter by circular letter to the Mission and act upon the vote so obtained.

Dr. Avison read a statement before the Mission, and it was ordered that it be put on file, and sent to the Board with the action of the Mission in the case of Dr. Irvin.

The Mission proceeded to the election of Committeemen. The following were elected:

On Property Committee, Mr. Lee.

On Evangelistic Committee Mr. Whittemore. Mr. Lee.

On Medical Committee, Mr. Whittemore.

The Resignation of Mr. Gale from the Hymn Book Committee was accepted.

The resignation of Mrs. Baird from the Editorial Committee was accepted.

On Editorial Committee, Mr. Gale was elected, and Mr. Baird in place of Mrs. Baird, resigned.

On Educational Committee, Dr. Underwood.

On Finance Committee, Mr. E. H. Miller.

On Special Bible Committee, Mr. F. S. Miller.

On Rules and By-Laws Committee, Mr. Bruen.

On Examination Committee, Dr. Moffett.

On Hymn Book, Mr. Lee, and Mr. F. S. Miller in place of Mr. Gale, resigned.

On Christian News Committee, Dr. Sharrocks.

It was moved and seconded that the Mission request the Board to transfer Yen 682.28, the unused portion of an appropriation for Study and Class Rooms for Miss Chase at Fusan, to Syen Chyun, to be used for the same purpose. Carried.

It was moved and seconded that the Mission request the Board to transfer the monies now in the hands of Taiku Station, as mentioned in its report, towards the purchasing of the enlarged site now being asked for.

The chair was instructed to appoint a committee of three to edit the minutes of the annual meeting. The chair appointed Dr. Vinton, Dr. Field and Mr. E. H. Miller as such committee.

The unused balances of traveling expenses to annual meeting were referred to the Mission Treasurer for adjustment,

The Secretary read the minutes of today's session and they were approved.

Devotional exercises were conducted by the Chairman, and the Eighteenth Annual Meeting of the Korea Mission of the Presbyterian Church in the United States of America adjourned.

REPORTS.

1.-Report of Special Bible Committee.

We are glad to be able to report that the Permanent Executive Bible Committee has finally reached unanimous action on the adoption of a constitution—a copy of which is presented with this report. It is now before the Mission for ratification.

You will see from Article II Sec. 2 that the Bible Societies have granted the principle for which our Mission has been contending.

This they were willing to do as soon as, by a somewhat lengthened correspondence, the position of the Mission was made clear to them.

There now seems to be nothing to prevent the harmonious co-operation of the Missions and the Bible Societies.

In adopting this constitution the Permanent Executive Bible Committee also adopted the following resolutions, viz:

r—"Resolved that we express to the American, the British and Foreign, and the Scotch Bible Societies our conviction that this constitution adequately meets the needs of Bible work in Korea, and that we most earnestly request their sanction of the same and their co-operation in the work under its provisions.

2—"In view of the size of the field and the provisions of the constitution for one agent (a common agent) we express our conviction that the interests of Bible work in Korea and the principles of comity make the appointment of a second agent unadvisable and an action to be deprecated unless there is a material change in the present conditions."

In regard to translation work we can report that progress has been made in the revision of the New Testament, while in the Old Testament several books have been translated by individual members of the Board and are ready for the consideration of the whole Board.

Great changes have been made in the Board of Translators. Dr. Scranton's resignation from the Methodist Mission made vacant his place on the Board while the greatly lamented death of Mr. Appenzeller removed one of the most faithful and industrious members.

At the February meeting of the Committee, Mr. Jones of the M. E. Mission (North) and Mr. Moffett of our Mission were elected members of the Board and at the June meeting Dr. Hardie of the M. E. Mission (South) was elected. Mr. Jones accepted the appointment with the approval of the Mission and is now one of the Translators. Dr. Moffett has not accepted the appointment and Dr. Hardie's acceptance is still in doubt. There are therefore now but three working members on the field although Dr. Underwood is expected back very soon. The P. E. B. C. has therefore taken steps towards the election of others at its next session.

We would here also make note of the presence during the year of Rev. H. O. T. Burkwall as the acting agent of the Bible Society. His presence and influence in the Bible work has been a source of great satisfaction and benefit.

2—That it took action deferring the erection of a house for Mr. Sidebotham until the Mission should act on the question of re-enforcements for the Fusan Station.

III.-Report of the Educational Committee.

We note that the Educational Institutions are being satisfactorily conducted according to the policy heretofore outlined and we congratulate the Mission upon the progress made in the development of the Intermediate School in Seoul, and the Academy in Pyeng Yang, and upon the marked improvement in the Girls' School in Seoul. The policy of having all the members of the Station co-operate in building up and in teaching in these institutions is one we hope to see continued.

We also note with satisfaction the successful execution of the plan wherein 100 nyang is "considered an equivalent of full support" in the Girls' School and we recommend the continuance of the same plan.

We recommend that in order to their ultimate greatest efficiency in making the educational institutions a true and powerful factor in the evangelization of Korea, Miss Barrett and Mr. E. H. Miller, while being assigned some work in the Girls' School and in the Intermediate School, shall be directed to give considerable time to direct evangelistic work both in city and country.

We recommend the approval of the plan for the assignment of another missionary to the teaching force of the Pyeng Vang Academy as soon as a qualified man is available.

In order to secure a greater exchange of help between the stations so that the Training Classes for Helpers may be made even more efficient than they have been, we recommend that the Apportionment Committee make some provision along this line.

We recommend that in the Pyeng Yang Station special systematic Theological instruction be provided for the Spiritual Leaders of the Church who must necessarily become the first generation of ministers.

We recommend that the Committee on Rules and By-Laws be requested to prepare a clause whereby it shall be the duty of the Educational Committee to consult with those in charge of Educational Institutions concerning their work, before their report and to report recommendations on the Educational work of the whole field.

We recommend the approval of the plan for the erection of a building for the Industrial Department of the Pyeng Yang Academy, the amount,—about Y 2000—having been provided from private funds.

We recommend the approval of the plans of the Pyeng Yang Station for the development of the Girls' School under Mrs. Wells' care into a Boarding School and the plan for the ultimate use of the present Hospital plant for the same.

We recommend no change in the rule as to age of entrance to the Girls' Boarding Schools, but would emphasize the fact that the rule is not an inflexible one.

IV.-Report on "The Korea Field."

The little paper which the Mission last year gave me permission to issue has gone out four times since that meeting, and with what success you who have now grown accustomed to it can tell much better than I. Personally my thanks are due to many of the members of the Mission for their kind assistance in furnishing the addresses of their friends, and in ordering copies mailed regularly to such friends. The number of subscribers in America has also proved unexpectedly large, so that the list of those to whom the paper is being mailed each quarter exceeds a thousand very considerably. The first issue, used largely by way of speciman copies, was paid for by a young people's society in Brooklyn. Since then the paper has actually paid expenses, though I refused an advertisement offered me. One gratifying fact was the prompt exhaustion of the thousand copies first printed of the second number and the accumulation later of so many orders for it as to justify its reprinting. (There seems no doubt that the publication has been of service to the work of our Mission by making it better known in the home lands. The only regret I have in connection with it is that there are some parts of the field, both under our own and under sister missions, from the workers in which I have found it impossible to obtain the copy I desired to insert.

Having demonstrated, as I believe, the desirability and feasibility of such a periodical in our Mission, I now tender the control of "The Korea Field" in every way to the Mis sion, hoping that you may see your way to adopt the infant and to rear it to hearty maturity.

V.-Report of the Business Manager of "The Christian News."

In the subscription department of "The Christian News" the year has been one of plodding sameness. Much credit is due the agents in the three northern districts for the energy with which they have pushed the paper. To them are due a large part of the 337 subscriptions we are now carrying upon the books. Whereas through much of the year we printed an edition of 500 or even 550 copies, this was reduced at the beginnig of July by cutting off all those magistracies, 180 in number, which had shown no recent disposition to pay up. Out of this number prompt payment was immediately made on behalf of the magistracies in South Kyeng Sang and South Pyeng An Do, and 59 were thus speedily restored to the register. It has been found impossible to obtain any number of paying advertisements, those of the Bible and Tract Societies being inserted gratis as a department of missionary work. The following is an analysis of receipts and disbursements :--

A balance struck between these two totals will show that nearly \$350 is yet to be drawn from the Board's appropriation to pay an as yet unpresented printer's bill, nothing having been in fact, drawn from that source since last November.

VI.-Report of Medical Committee (As Adopted).

The Committee recommends:--

D · . . .

1. While your Committee recognize an irregularity in the mode of engagement of the Japanese nurses now employed in the Seoul Hospital, yet we recognize the necessity of the step and its advantage and recommend that the action be approved and their employment continued. At the same time this is to be considered as a special case and in no wise as a precedent for the future.

2. Whereas, Mr. Severance of Ohio has added to his other benificencies to our Mission by offering to support a Missionary physician who shall act primarily as a substitute physician in our various stations as need may arise, and when not so employed be assigned medical work in connection with the Severance Hospital,

Resolved, That we express our deep appreciation of his generosity and wise interest in our work, and

Resolved, That we request the Board to send us the physician in accordance with this offer as soon as possible, but would call attention to the fact that such substituting work alone in our, five stations will consume at least six years of the physician's eight year term of service.

3. That the request for yen 294 increase over last year in current medical work in Taiku be approved.

4. That we approve the increase of yen 200 in estimates for current expenses for Syen Chun Hospital.

5. That we approve the payment of yeu So traveling expenses of the two nurses in the Seoul Hospital, and yeu 500 for salaries for the present fiscal year ending April 30, 1903, and yeu 600 for salaries for next fiscal year ending April 30, 1904.

6. That the request as given in the estimates of Seoul Station for increase in the current expenses of the Severance Memorial Hospital be approved.

7. That we approve the request for appropriation of yen 250 for additional medical and surgical outfit for Pyeng Yang Hospital.

8. That the Taiku Hospital be built with an accommodation of sixteen beds, and that we approve the request of Taiku Station for an appropriation of yeu 500 over the yeu 6000 already granted for the building of the hospital.

9. That we approve the request for an appropriation of ven 1000 for the working equipment of the Taiku Hospital.

10. That we approve the request of Pyeng Yeng Station for a new hospital to replace the plant to be turned over for the use of the Girl's School, and request the Station to prepare

plans for the same and submit them with estimates to the Mission through the proper committees.

11. That the question of reinforcing Fusan Station by a new medical man be deferred until next annual meeting.

12. That the request for yen 2300 for finishing and equiping the Fusan Hospital be deferred for one year.

13. That on the request of Fusan Station for yen 294 for additional sanitarium expenses yen 201 be granted.

4. That the use of \$80 gold, already appropriated contingent on Mission approval for two beds in Pyeng Yang Hospital, be approved.

VII,-Report of Evangelistic Committee.

I. We recommend that Dr. Field, Mrs. Welbou and Mrs. Sharp be granted one womau helper each whose time shall be used as much as possible in country work.

II. Also that a Bible woman be granted Seoul Station to work in connection with the Yun Mot Kol church to be under the general direction of Mrs. F. S. Miller and to be used as the Woman's Work Committee of the Station may arrange.

III. Also that Mrs. Avison be permitted to employ a Bible woman to work in connection with the Severauce Hospital and Ku Ri Kai church.

IV. We approve Dr. Avison's plan of maintaining a book room in front of the Hospital for evangelistic work and that the request for yen 150.00 for maintainance of same be approved.

V. Recommended that permission be granted to build the Woman's Guest Room in Taiku.

VI. Also that we approve the request of 200 yen for the Pai Chun Rest House.

VII. Also that Mr. Bruen be allowed one helper, but that no helper be granted Mr. Barrett until next Annual Meeting.

VIII. We recommend the steps taken for the unification of the work in Seoul during the past year. IX. We approve the plau of Dr. Moffett of building a book store and reading room in Pyeng Yang and we recommend that it be put in charge of a Station committee of three of which Dr. Moffett shall be chairman and which shall superintend it and determine its policy. As the funds are provided by Dr. Moffett we also recommend that he shall have exclusive charge of the same and not be required to report upon them.

X. We recommend to the attention of the itinerating missionaries, the importance of impressing upon the male members of the Korean households their duty of teaching their wives and daughters to read.

VIII.-Report of Finance Committee.

The Committee has had very few decisions to make during the year.

The only questions submitted to it were:

1. Fusan Station asked whether it must return to the Mission Treasurer the amount received from the sale of a Station building or whether the Station might use the amount in one of the forms of its work.

The answer was that the amount must be turned over to the Mission Treasurer.

2. The auditing of the Treasurer's Books. This was accomplished in due form and all having been found correct a report to that effect was rendered to the Board.

3. The distribution of the cut in the estimates amongst the several Stations. This was done according to the usual rule of allotting it according to the total amounts used by the Stations in native work, reckoning the items of entirely Mission interest as constituting a separate group and following out the suggestion of last year that a distinction be made between new and old work. New work was cut double the proportion of old work while restored work was classed as new work.

XI,-Report of the Editorial Committee.

I. Your committee would report the publication of the Mental Arithmetic by Miss Doty presented last year in due form. There were 2000 copies printed and they are now in the hands of the Custodian of the Korea Religious Tract Society.

II. We also report the publication by the K. R. T. S. of the Advanced Arithmetic, Part I, prepared by Dr. Field and we recommend that she complete the work in the preparation of Part II.

III. We further report the publication by the K. R. T. S. of Volume III of Mr. Gale's Thousand Character Series and a fourth volume prepared in manuscript containing selections from the best Korean authors, this volume to complete the set. These books are a graded series leading from the Primary to work in the Intermediate schools and the Committee recommends their use.

IV. Mrs. Baird has completed a translation of Gray's Botany for Common Schools and it is now ready for the press. It is to be published with a hundred illustrations. The book is prepared for students in the Academy and Intermediate schools and we trust that it will soon be ready for use.

V. Part I of a work on the Trinity has been prepared by Mr. Swallen and we recommend the completion of the remaining second and third parts.

VI. A compendium of Church History also prepared by Mr. Swallen is now being published in "The Christian News." Part I embraces a period from A. D. 30 to 325. We recommend the continuation of the work as it will fill a needy place in class instruction of helpers and leaders.

VII. Two Commentaries on I Corinthians have been prepared, one by Mr. Swallen and one by Mr. F. S. Miller. Mr. Miller's is already published in book form and Mr. Swallen's is now being printed in "The Christian News." Each was nnaware of the other's being similarly engaged. The Committee regrets the fact that two members should toil over the same work at the same time while so many demands remain unsupplied. The desire of the Committee is to keep in touch with all literary workers and so prevent any such misurderstanding in future. We recommend that Mr. Swallen's work be arranged for publication as soon as the revised text of Corinthians can be secured.

- (3) A Book on Surgery.
- (4) Hygiene (Portions printed in the Christian News).

These translations are the collected lectures that Dr. Wells has given his students during the year.

The Committee however cannot see its way clear to recommend that the doctor give any considerable portion of his time to translation.

XII. Your Committee notes the following theological works under way :

 "The Gate of Wisdom and Virtue," by Mr Swallen. XVII. Mr. Gale reports progress in the revision of the Dictionary and Grammatical Forms.

XVIII. Your Committee believes that the Mission's burden of literary work is already so great that it cannot see its way clear to recommend the taking over of "the Korea Field." Our publications at home call for all items of interest that we can furnish and as these publications reach a much wider constituency it is the opinion of your committee that it would be unwise to recommend the absorption of time and effort in this undertaking.

XIX. We call attention to a by-law adopted last year that relates to literary work in the hope that it will be read and acted upon in future : "No member of the Mission is authorized to enter upon the preparation of tracts, books or other literature.without conferring with and securing the approval of the Editorial Committee.

"Where any work has already been begun, a report should be made to the Editorial Committee concerning the progress made and the scope contemplated."

XII.-Report of Committee on Salary of Unmarried Men.

We recommend that the Mission represent to the Board its conviction,

Ist. That the salary of an unmarried man should be larger than that of a single woman, his personal expenses being greater and his necessarily more public life involving greater expense.

2nd. That the amount decided upon last year by the Board viz. \$625, is not an adequate amount for an unmarried man in Korea.

3rd. In view of the steady increase in the cost of living in Korea, we believe that a reduction from the former salary, viz. \$833.33, will fail to secure the most efficient service from the men and the best returns to the Board and would be an unwise action militating against the most economical use of Board funds.

4th. We therefore request the Board to make the salaries of all the single men the same and to make no reduction from the former amount, \$833.33.

XIII.-Report of the Committee on the Christian News.

During the past year the Christian News has been conducted according to Mission appointment by Mr. Gale as Editor in Chief and Dr. Vinton as Business Manager. In the absence and illness of Mr. Gale in June and July and parts of other months Mr. F. S. Miller acted as editor.

Subscribers not paying subscriptions have been dropped from the roll, thus diminishing the size of the issue, but the Editor, Business Manager and Station Agents are to be congratulated on the increase of paid up subscriptions from 140 /10 337. We urge upon the attention of all the Mission the importance of taking every step to increase the subscriptions to this important organ of our work. Should it prove possible to obtain a paid up subscription list of 1000 it will probably be possible to reduce the subscription price one half.

In order to relieve the Editor of the labor of writing requests for literary contributions we recommend that steps be taken by the Mission to secure such contributions from members of our own and other Missions. While the Editor in Chief in virtue of his position shall decide what contributions are suitable for publication yet we recommend that other persons be appointed in charge of special departments. They shall seek from others, or themselves write, articles pertaining to the departments assigned them.

We suggest that as a rule these articles be short, of perhaps about 500 characters each. The work thus required of each person will not be large, but a larger number of the missionaries will in this manner be brought into sympathy and touch with the paper. We recommend the following appointments: Editor in Chief, Rev. J. S. Gale; Assistant Editor, Rev. F. S. Miller; Business Manager, Dr. C. C. Vinton.

2. We approve the buying of the site intended for Mr. Sidebotham's house in Fusan.

3. We recommend that the Fusan Station Property Committee be instructed to sell the piece of property in old Fusan formerly used for dispensary.

4. We also approve the request of Tai ku Station for 100 yen for site, 175 yen for enclosing and 3350 yen for a house for Mr. Barrett.

5. (a) We approve the plans drawn by Mr. Gordon for a two story house and a one story two-room-deep house respectively as model average missionary dwellings, the total for two story house being $2275\frac{1}{2}$ sq ft inside walls and exclusive of partitions. The total of a one story two-room-deep house being 1812 sq ft inside walls, exclusive of partitions.

(b) The plans while giving a general idea of a missionary dwelling may be varied in arrangement and relative size of room but the total area shall in no case for a two story dwelling exceed 2400 sq ft and for a one story two-room deep dwelling shall not exceed 1900 sq ft inside of walls, exclusive of partitions.

(c) We further recommend that the upper floor of a two story dwelling be divided into 3 or 4 bed-rooms as the requirements demand, together with bath room, linen closet and clothes closets for bedrooms and space for hall and stairs.

(d) Wire screen and shutters, storm-windows and doors when necessary, should be included in appropriations. Available attic room to be rough boarded and a stairway provided. Ceilings down stairs to feet in height; up-stairs 9½. All wood wook inside and out including floors should be painted or oiled.

(e) While the general policy of the Mission is to furnish quarters for one servant's family only, it is permissible when local necessities demand it, to increase such quarters.

6. That the request of Pyeng Yang Station for permission to erect a building for press room and work shop for the Academy, to be built with private funds, be granted.

6½. That the request of Pyeng Yang Station for permission for Dr. Moffett to add at Board expense another room to his house, be granted.

7. We approve the request of Seoul Station for 200 yeu for the site for the Intermediate School, of which 6786 yeu are already held by the Board for this purpose. We recommend asking for 6786 yeu as a special appropriation and 2414 as a regular appropriation.

8. We approve the request of Seoul Station for 300 year for a weil for Mr. Gale and F. S. Miller.

9. We approve the repetition of the request of Seoul Station for 500 yen to buy the piece of ground necessary to complete Mr. Gale's house site.

10. We approve the repetition of the request of Seoul Station for 500 yen to buy the piece of ground lying between Mr. F. S. Miller's house site and the Girls' School site.

11. We approve the site between the Girls' School and the Intermediate School as a site for Mr. E. H. Miller's residence.

17. We approve the request of Seoul Station for 2500 yeu additional for the Severance Hospital, this being for a smaller building than was originally planned, the additional cost being due to rise in price of material for buildings.

18. We approve the plan of Taiku Hospital giving accommodation for 16 beds, garret to be plain boarded, the whole cost of building not to exceed 6500 yen.

19. We approve the purchase of field for Woman's guest room at Taiku.

20. We approve the repetition of the request of Taiku Station for yen 175 for a cistern.

21. We approve the request of Fusan Station for 200 yen for servants's quarters on the place now occupied by Mr. Sidebotham.

22. We recommend that action on request of Fusan Station to build Woman's waiting room to the hospital be deferred.

23. We approve the request of Seoul Station for appropriation of 1500 yen for site for Mr. Welbon.

24. We approve the request of Syen Chyun Station for 3500 yen for a house for Mr. Kearns.

XV.—Report of Committee on Apportionment of Sub-Stations and Work.

RECOMMENDATIONS.

In view of the following considerations

Ist—The Australian Presbyterian Church has a Mission of two ministers, a physician (who has been ordained) and their wives and three single ladies in Fusan which with reenforcements expected, is able to care for a portion of South Kyeng Sang Province; 2nd—Taiku is the strategic point of the two provinces North and South Kyeng Sang;

3rd—The Northern part of South Kyeng Sang Province in which there is a portion of our work already developed and operated from Fusan is equally accessible from Taiku;

4th—With but the one Station, Taiku, we could still easily look after all the work now connected with both Stations and Taiku could then be manned according to the needs of the work as it developed until it becomes another fully equipped Station like Seoul or Pyeng Vang, therefore, *Resolved*

1st—That we request the Board to sanction the consolidation of the work of the two Stations into one at Taiku.

2nd—That we look forward to the consummation of this plan and the removal of our force from Fusan within two years, during which time the work now carried on in and from Fusan is not to be a bandoned but developed as a part of the future consolidated Station.

3rd—That we appoint a committee to enter into negotiations with the Australian Mission concerning the division of territory and also to investigate the possible sale or other use of our Fusan property—this committee to report to the Mission at next annual meeting.

4th—That this committee be instructed also to present this matter fully to the Board.

Also, as bearing indirectly upon this question of consolidation of forces in the South, *Resolved*,

Ist—That we request the Board for its sanction to the opening of a new Station in the territory lying between the three Stations, Seoul and Taiku of our Mission and Chun Ju of the Southern Presbyterian Mission—this new Station to be located at Kong Ju or at some other point in that region.

2nd—That we appoint a committee to investigate as to the best place to locate this new Station, the committee to report at the next annual meeting and to bring in recommendations on this and other questions involved.

Also that the committee on the Fusan-Taiku matter consist of Messrs Adams, Sidebotham and Lee.

That the committee on the question of a new Station consist of Dr. Moffett and Messrs. F. S. Miller and Bruen.

In regard to the communication from the Bible Committee we recommend the reply that the mission having already set aside two men for Bible Translation, we do not see our way clear to assign Dr. Moffett also to this work.

XVI.--Hymn Book Committee.

During the year two editions of the Hymn Book have been issued, one an edition of 10000 ordinary size with some fifty new hymns added, and a large type edition of 2500.

The capital in the hands of the Committee being insufficient the latter edition was a trial one issued by subscription. As it sells for only one half again as much as the small edition it will be in large demand and a new and larger edition will probably soon be called for.

As regards the edition with notes, a circular was sent by Mrs. Baird to each Station asking for subscriptions at the rate of one yen and twenty five sen per copy. An edition of 315 has been subscribed for and we have assurances from Mr. Beck that an edition of this size can probably be secured at the rate named. In case the cost should prove to be somewhat more we ask permission of the subscribers to order the edition without further notification.

Official notification of the Council's action towards adoption of the Mission Hymnal as a Council Hymnal having reached this Mission, we recommend that the Mission elect its Hymn Book Committee as heretofore, empowering it to transfer the Hymn Book to the Council at such time as satisfactory arrangements shall have been completed.

The Custodian reports that he has sold to date 6129 and has in hand 3871 of the edition of 10000. We have in stock and accounts due about seven hundred forty yen capital.

We shall probably have to print an edition of 10000 before the transfer can be made. For this we need 900 yen, not to mention 700 yen needed for the large type edition. Even though the book be transferred to the Council we cannot ask the other Missions to pay a great deal more than in proportion to their consumption which is one twelfth of the issue. $\xi \rightarrow$ we cannot depend much on that source of supply. Consequently we must ask for at least 400 yen more capital for the Hymn Book Fund.
