The Secretary read the minutes of last annual meeting and the record of ad interim actions.

The Examination Committee presented a partial report, announcing that Mr. Clark, Mr. Kearns and Mrs. Kearns had passed the examinations prescribed for the first year, and that Miss Samuels had passed an examination on seven months' work.

Dr. W. O. Johnson made a request that, as he desired to return home on health leave, a committee of physicians be appointed to examine him, and the Mission instructed the Chair to appoint a committee of three physicians to make such examination and report to the Mission.

The Chair at a later hour appointed Drs. Avison, Sharrocks and Vinton as such committee.

The committee on Arrangements for Annual Meeting reported through Dr. Baird and the report was adopted.

The Mission adjourned, being led in prayer by Mr. H. B. Gordon.

SECOND DAY.

PYENG YANG, Sept. 11th, 1903.

The Mission assembled at 9 A. M. and the whole morning was spent in prayer and praise, the topic being "What God has Wrought," Ephesians I. The thoughts of the first hour were led by Rev. N. C. Whittemore, on Spiritual Blessings, Ephesians 1, iii; of the second hour by Rev. F. S. Miller, on Acceptance in Christ, Ephesians 1, v-vi, and of the third hour by Rev. H. Loomis, on The Revelation of His Will, Ephesians 1, viii-ix.

After the prayerful consideration of the above topics, the Sacrament of the Lord's Supper was administered by the retiring Chairman, Rev. W. B. Hunt, the bread and wine being distributed by Rev. H. M. Bruen and Dr. A. M. Sharrocks.

SECOND DAY.

AFTERNOON SESSION, 2, P. M.

The Mission having assembled again at the appointed hour, devotional exercises were led by Rev. C. A. Clark.

The minutes of previous meetings were read and approved after correction.

The retiring officers then yielded their places to the officers-elect, the retiring Chairman presenting the new Chairman, O. R. Avison, M.D., with a gavel made by Koreans.

After a few appropriate remarks by the new Chairman, he named the following committees:--

The hour for fraternal greetings having arrived, Rev. W. A. Noble presented greetings on behalf of the M. E. Mission and Rev. H. M. Bruen responded. Rev. H. Loomis of the American Bible Society presented greetings and Rev. C. E. Kearns responded.

After recess the Secretary read communications from the Australian Presbyterian Mission Council, "Re Organization of an Independent Korean Presbyterian Church," and "Re Division of Territory with the American Presbyterian Mission (North)." These communications were referred to the Evangelistic Committee and it was instructed to bring in a report recommending a mode of procedure.

The Secretary read a communication from Fusan Station asking the Mission to investigate the whole subject of the cut as apportioned by the Finance Committee. The matter was referred to a special committee consisting of Messrs, Whittemore, Hunt and Barrett.

Seoul Station presented its General Report through Mr. Sharp.

The Mission adjourned, being led in prayer by Dr. Underwood.

Pyeng Yang, September 12th, 1903, 8.30 A. M.

The Mission assembled at the appointed hour and devotional exercises were led by Rev. H. M. Bruen.

The minutes of the last session were read and approved.

A committee consisting of Drs. Moffett and Underwood was appointed to prepare letters to Rev. F. F. Ellinwood, D.D., L.L.D., and Rev. A. J. Brown, D.D., Secretaries of the Board, expressing the feelings of the Mission as the one lays down and the other takes up the correspondence with the Korea Mission.

The report of Seoul Station read yesterday was referred to the proper committees.

Fusan Station presented its General Report through Mr. Sidebotham, and the report was referred to the proper committees.

Taiku Station presented its General Report through Mr. Barrett and after discussion it was referred to the proper committees.

On motion the Rules and By-Laws Committee was instructed to bring in some recommendation as to the date to which Station Statistics and Reports should be brought up.

Pyengyang Station presented its General Report in part through Mr. Beruheisel.

Mission adjourned being led in prayer by Mr. Welbon. R. H. SIDEBOTHAM,

AFTERNOON SESSION, 2 P. M.

The Mission assembled at the appointed time and devotional exercises were led by Rev. W. N. Blair.

Mr. Bernheisel completed the reading of the Pyeng Yang Station General Report, and it was referred to the proper committees.

The Secretary read a letter from the Board Treasurer with reference to the outfit for new missionaries, and the chair was instructed to appoint a committee of five to consider the matter and bring in recommendations to the Mission.

The Chair at a later hour appointed Mr. Bernheisel, Mr. Lee, Dr. Sharrocks, Mrs. Avison and Miss Shields as such committee.

The committee appointed to make a physical examination of Dr. W. O. Johnson reported and the report was adopted.

The Chair was instructed to appoint a committee of two to draft appropriate resolutions on the deaths of Rev. and Mrs. W. V. Johnson, and a similar committee on the death of Mrs. F. S. Miller.

The Chair at a later hour appointed Mr. Clark and Miss Wambold as the former committee and Mr. Lee and Miss Doty as the latter.

On motion it was decided to meet the Koreans on Tuesday September 15, at 3.30 P. M.

The place of the next annual meeting was fixed for Seoul.

The question of holding the annual meeting in 1905 on Sorai Beach was referred to a committee consisting of Dr. Underwood, Mr. Lee and Mr. Huut.

A brief statement of work done in connection with the Central Presbyterian Church, Seoul, by Rev. W. D. Reynolds, Jr., of the Southern Presbyterian Mission, was read and referred to the proper committees.

The Mission adjourned being led in prayer by Mr. Loomis. R. H. Sidebotham,

FOURTH DAY.

PYENG YANG, September 14th, 1903, 8.30 A.M.

The Mission assembled at the appointed hour, and devotional exercises were led by Rev. C. E. Sharp.

The minutes of Saturday's sessions and Sunday's meeting were read and approved.

A telegram from the Korea Mission of the Presbyterian Church of the United States was received. It read as follows:—

Presbyterian Mission, Pyengyang,

God give you successful meeting.

Junkin, Moderator.

The Secretary was instructed to reply to that Mission, now in session in Seoul, sending greetings.

Sunchun Station presented its General Report through Mr. Kearns, and it was referred to the appropriate committees.

The Chair appointed the following Committee on Arrangements for next annual meeting:

Mr. Clark, Miss Doty, Mrs. Underwood, Mr. E. H. Miller.

A medical certificate from Dr. C. H. Irvin in the case of Dr. W. O. Johnson having been placed in the Secretary's hands, the Mission referred it to the special committee, Drs. Avison, Sharrocks and Vinton.

The Mission Treasurer, Dr. C. C. Vinton, reported. The report was laid on the table until the report of the Finance Committee should be heard. (No. 2).

The Finance Committee reported through Mr. E. H. Miller, the report being taken up section by section. (No. 3).

Section 1 was adopted. Mr. Sidebotham wished to record his vote as opposed to the adoption of this section.

Section 2 was laid on the table.

Sections 3-5 were adopted.

The report of the Treasurer was taken from the table and adopted.

The Evangelistic Committee presented its report in part (Section 1) and it was adopted. (No. 4).

The Mission adjourned to meet Wednesday, September 16, at 8.30 A. M., being led in prayer by Mr. H. B. Gordon.

FIFTH DAY.

Pyeng Yang, September 16, 1903, 8.30 A. M.

The Mission assembled at the appointed hour, and the devotional exercises were led by Rev. E. H. Miller.

The minutes of Monday's session were read and approved.

The Examination Committee reported verbally in part, announcing that Mr. Smith and Miss Samuels had passed the examinations prescribed for the first year, and Mr. Bernheisel the examinations prescribed for the third year.

Statistical Committee, Dr. C. C. Vinton, reported, and the report was adopted after correction. (No. 5).

The Medical Committee presented a recommendation as to the work of Miss E. H. Field, M.D., after furlough. The matter was laid on the table.

Dr. W. O. Johnson was excused from further attendance on the Mission meeting.

The Special Bible Committee reported through Mr. F. S. Miller. (No. 6).

Sections 1-4 were adopted.

Recess was here taken, after which Rev. E. F. Hall favored the Mission with a solo.

The Special Bible Committee's Report was continued.

Sections 5-6 were adopted and the report as a whole was adopted. $\$

The Apportionment Committee made a preliminary majority report, and Mr. Bruen presented a minority report and Mr. Sidebotham still another. (No. 7).

After much discussion and voting the majority report was adopted.

Mr. Bruen resigned from the Estimates Committee, the resignation was accepted, and Mr. Barrett was elected in his place.

In view of the illness of Mr. Whittemore and his necessary absence from committees, the Mission appointed Dr. Sharrocks as full voting member, until Mr. Whittemore's recovery, on the Apportionment Committee, the Senior-member-only provision of the Rules and By-Laws being waived; and the Mission Chairman was instructed to fill the temporary vacancies on other committees. The Chair appointed

Mr. Lee on the Committee on the Cut.

Dr. Sharrocks on the Evangelistic Committee.

Mr. Swallen on the Medical Committee.

Mr. E. H. Miller on the Rules and By-Laws Committee.

Mr. Hall addressed the Mission on the importunate need for new workers, and he was requested to prepare a brief statement of the need to be used in arousing the church at home.

The Mission adjourned, being led in prayer by Mr. Hall. R. H. SIDEBOTHAM,

SIXTH DAY.

PYENG YANG, September 17, 1903, 8:30 A.M.
The Mission assembled, and devotional exercises were led by Rev. W. M. Barrett.

The minutes of yesterday's session were read and approved.

The Educational Committee presented its report through Dr. Moffett. It being taken up section by section, the whole report was adopted with the exception of Section 7, which was referred back to the committee. (No. 8).

The Evangelistic Committee presented its report through Mr. F.S. Miller. (No. 4). It being taken up section by section,

Sections 1-7 were adopted.

Section 8 was amended.

Section 9 was adopted.

Section 10 was under consideration when the Mission adjourned to meet at 2:30 P. M., Mr. Hunt leading in prayer.

AFTERNOON SESSION.

The Mission assembled again at 2:30 P. M. and after the singing of a hymn, the consideration of the Evangelistic Committee's report was resumed, section 10 being again taken up.

Sections 10-13 were adopted.

While considering Section 14, Mr. Hall read the letter prepared by him at the request of the Mission concerning the imperative need of new missionaries for Korea. Section 14 was amended ordering the printing of Mr. Hall's letter also, and the section was adopted.

The report as amended was adopted as a whole.

The Rules and By-Laws Committee presented an amendment to the Rules and By-Laws adding another standing committee as follows:—"On Nomination, three members, to recommend two names for each vacancy to be filled upon the permanent committees, these names to be announced in advance." The amendment was adopted.

After recess a solo was rendered by Mr. E. H. Miller,

The Chair appointed Miss Snook on the Narrative Committee in place of Mrs. Baird resigned.

The Medical Committee presented an additional report through Dr. Vinton. (No. 9).

Sections 2-9 were adopted.

Section t was taken from the table, the committee was given the privilege of withdrawing this section, and section t being withdrawn, the report as a whole was adopted.

The Committee on the Consolidation of Fusan and Taiku Stations into one at Taiku presented its report which was adopted. (No. 10).

The committee on resolutions on the death of Mrs. F. S. Miller reported, and the report was adopted, and ordered spread on the minutes. It was as follows:—

"In the Fall of 1892 Mrs. F. S. Miller arrived in Korea to begin her life as a Missionary. For nearly eleven years God used her for this work and then He called her to a higher service.

"It is eminently fitting that this Mission should pass resolutions upon the death of this devoted worker. "Mrs. Miller was first of all a wife and mother, and her home was a centre from which radiated an influence felt alike by both Koreans and foreigners. When at Mrs. Miller's one always felt at home. Mrs. Miller loved Korea and she loved Koreans, and the Koreans loved her in return.

"She had a good knowledge and use of the Korean language, and she gave herself freely as her strength permitted to the

people she had come to help.

"For several years her health was not good and she suffered much, but she never complained, and through it all was manifest a calm and simple trust in her Heavenly Father.

"She was beloved by all, and her going-although to her a

great gain—is to us an unspeakable loss.

"We extend to her husband and motherless children our sincerest love and sympathy, and pray that behind the sorrow and affliction may be seen the tender heart of a loving God.

The committee appointed to investigate the manner in which the cut had been apportioned among the various stations reported and the report was adopted. (No. 11).

The Mission adjourned, being led in prayer by Mr. Gordon.

SEVENTH DAY.

September 18, 1903, 8:30 A. M.

The Mission met and devotional exercises were led by Rev. W. L. Swallen.

Mr. Ross was present for the first time.

The minutes of yesterday's sessions were read and approved.

On motion the rule adopted by the Mission yesterday creating a Committee on Nomination was reconsidered. After several motions had been lost, the original action was reaffirmed. The Chair appointed Dr. Moffett, Mr. Whittemore and Mr. Bruen as Committee on Nomination.

The Finance Committee presented a supplementary report. Section 2 was adopted.

Section 6 was amended and then adopted.

The report was adopted as a whole. (No. 3).

The Educational Committee re-presented Section 7 of their report in an amended form. It was adopted and the report of the committee was adopted as a whole. (No. 8).

The Special Bible Committee presented a supplementary report which was adopted. (No. 6).

The committee appointed to consider the advisability of holding the Annual Meeting in 1905 on Sorai Beach reported. (No. 12). Section I was amended and then adopted, and in accordance with its provisions the remainder of the report was referred to a special committee. The Chair at a later time appointed Dr. Underwood, Mr. Swallen, Mr. Lee, Dr. Sharrocks, Mr. Sidebotham and Mr. Bruen as such committee.

The Editorial Committee reported through Mr. Swallen. The report with one amendment was adopted. (No. 13).

The Committee on Resolutions on the deaths of Rev. and Mrs. W. V. Johnson reported. The report was adopted, ordered spread on the minutes and copies sent to the relatives. It was as follows:

- "During the last year it has seemed good to our Great Captain to recall two of His commissioned ones who were about to enter upon their life work among us and who had before them, as we thought, the promise of long life and rich, beautiful service.
- "Mrs. Emily Hartman Johnson went Home from Kobe, Japan, on the thirteenth of January as she was on her way to the field. Walter Virgil Johnson, her husband, after two months of brave effort in the midst of indescribable loneliness followed her on the eighteenth of March from Seoul, Korea. It is hard for us to understand such dispensations, so much to do and so few to do it, and yet these called away!
- "Mrs. Johnson we knew best from what we had seen of her in her husband's life. From that we know her to have been one of those clean, pure, strong characters upon whom one instinctively leans. Mr. Johnson leaned on her in a way beautiful to see while she was with him, but peculiarly pathetic when she was gone. Perhaps the best word said

of her was that little tribute of her husband when he lay almost within the dark shadow, and turning to the nurse he said softly, 'I loved a little girl once and in all the years we knew one another not one wrong or unkind word ever passed between us.'

"'No one touched Mr. Johnson's life who did not realize his steadfast faith, but better than that was his unselfishness. In the midst of his own great sorrow which he seemed to feel as it is not given to many of us to feel, and in all his loneliness his thought was always for others, and especially in his last illness his thought seemed to be always, not of his own poor, aching body, but for others lest in caring for him they should be overtaxed.

"We wish to express our own great sense of loss and our deepest sympathy and love for those who mourn at home, especially for those parents who gave them to Him to be used as He thought best. The world is better because they have lived, and they are not dead, only sleeping.

"We recommend that these resolutions be spread upon the Minutes of the Mission and that copies be sent to Mr. and Mrs. Johnson's parents.

The committee on Apportionment presented its report on Substations and Work through Dr. Underwood, and the report was adopted. (No. 7).

A supplementary report also concerning division of territory with the Australians was adopted, and the committee was ordered to present the matter to Rev. G. Engel, a member of that Mission among us, and to report again to the Mission.

Committee on Seoul Station Records reported. Section 3 was stricken out and report adopted. (No. 14).

Dr. Underwood, Mr. Welbon, Miss Doty, and Miss Wambold were excused from further attendance on the Annual Meeting.

The Mission then adjourned to meet at 3 P. M., and was led in prayer by Mr. P. L. Gillett.

After the singing of a hymn, the Committee on Christian News reported through Dr. Baird and the report was adopted. (No. 15).

The committees on Sun-chun, Pyeng Yang, Fusan, and Taiku Station Records reported, and the several reports were in turn adopted. (No. 16-19).

The Committee on Outfit for New Missionaries brought in a report which was heard in part. It was decided to refer it back to the committee, which was instructed to have it printed and circulated among the members of the Mission for suggestion, and then after correction to send it to the Board.

The Committee on Mission Records reported and the report was adopted. (No.20).

The committee to whom the medical certificate in the case of Dr. W. O. Johnson had been referred informed us they had endorsed it, and the Mission then by vote approved said certificate.

The Jacobsen Memorial Committee presented its report which was adopted. (No. 2:).

The Chairman was instructed to appoint a member in place of Dr. Underwood, absent, on the committee to prepare letters to Drs. Ellinwood and Brown, and the committee was given the privilege of sending the letters direct to these gentlemen, without previous presentation to the Mission.

The Committee on Hong Mun Su Kol Church was discharged.

The Committee on Estimates reported. (No. 22). Pyeng Yang Station was requested to present to the Estimates Committee definite statements as to the money needed for Helpers, Teachers, etc. While considering Seoul Station's request for grading Intermediate School site, 500 Yen, it was decided to reconsider the section of the Educational Committee's report which deals with the matter. On being reconsidered, the action was reaffirmed and the Educational Committee's report as a whole was again adopted.

After the reading of the Estimates of Pyeng Yang and Seoul Stations had been completed, the Examination Committee presented a report which was adopted. (No. 23).

The Mission adjourned, being led in prayer by Mr. Lee.

EIGHTH DAY.

Pyeng Yang, September 19, 1903, 8:30 A. M. The Mission met and devotional exercises were led by Rev. W. E. Smith.

The minutes of yesterday's sessions were read and approved.

The Estimates Committee resumed its report. During the reading of the report, the question of Mr. Hall's salary being raised, the following resolutions were adopted:

"Whereas the Board has sent Mr. Hall out on a salary of \$625, while all other single men of the Mission receive two-thirds of a married man's salary,

"Resolved, That we ask the Board to raise his salary to \$833.33 and to date such increase from the time of his arrival on the field, September 1, 1903,

"Also Resolved, That we reaffirm our action of last year (a copy of which shall be sent to the Board) requesting the Board to give to all unmarried male missionaries who shall hereafter be appointed to Korea two-thirds of a married man's salary."

The estimates of all the Stations having been agreed on the order of preference for new property was under consideration, when recess was taken.

After recess, a solo was sung by Mr. Lee.

The Mission having gone into closed session, the Apportionment Committee presented a supplementary report, concerning division of territory with the Australians, which was adopted.

At this point, Seoul Station asked the Mission to request the Board to send Rev. A. A. Pieters to Korea. The Mission by vote unanimously requested that such appointment be made.

The Special Committee on the Location of a New Station between Seoul and Taiku reported. The Mission asked 5,000 yen from the Board for the opening up of a new station between Seoul and Taiku, and the report of the committee was adopted. (No. 24).

The Mission adjourned to 2 P. M., being led in prayer by Mr. Clark.

AFTERNOON SESSION, 2 P. M.

Mission assembled, and after the singing of a hymn, the order of requests for new property was again taken up, and with one change was adopted. (No. 22).

The Finance Committee was instructed not to figure any cut next year on the salaries of the Japanese nurses in the Hospital at Seoul, nor on the typewriter asked for the Mission Secretary.

The Mission ordered the insertion in the estimates of the item, Removal of the Girl's School, Seoul, 4,000 yen, as a special request, it being understood that plans shall be approved by the Property Committee ere the request for the money is sent to the Board.

It was decided to ask our Board to grant us liberty to cooperate in the organization of an Independent Korean Presbyterian Church, according to the plan adopted by the Council of Missions in Korea, copies of which were filed with the Secretary.

The Chair appointed Dr. Vinton as member of the committee on letters to Drs. Ellinwood and Brown in place of Dr. Underwood, absent.

The Property Committee presented its report. The plan for Pyeng Yang Hospital was referred to a committee of five, Mr. Lee, Mr. Bruen, Mr. Hunt, Dr. Avison and Dr. Sharrocks, to consider and revise such plan if necessary, with power to approve the same.

The report of the Property Committee as amended was adopted. (No. 25).

The Committee on Nomination Reported.

The Property Committee's report was on request reconsidered, a section announcing the approval of the plan for Mr. Kearns' house was added, and the report as amended was adopted.

The following were elected on the permanent committees:

The Committee on Arrangements for next Annual Meeting reported fixing the date of the next meeting for September 26, 1904 and the report was adopted. (No. 26).

The following request from Seoul Station was received and approved:

"We request permission of the Mission to exchange the plant at Kon Dang Kol for another site centrally located plus a proper compensation, and request that Seoul Station be empowered to act in conjunction with the Board in the matter."

The Hymn Book Committee reported, the report was adopted, and the committee continued. (No. 27).

The following committee on Reformed Spelling was elected: Dr. Baird, Mr. Gale, Dr. Underwood.

The following resolution was adopted:

"Resolved, That as Dr. Field has asked the judgment of the Mission as to her future work, we request her to pursue her studies while on furlo with a view to devoting her main time to work along evangelistic lines after her return from furlo."

The Committee on 1904 Conference reported and the report was adopted. (No. 28)

The Mission ordered the various stations to consider whether the station reports should be read aloud at annual meeting, and to forward before February 1, 1904, their opinious to the Committee on Arrangements, who were instructed to prepare the program according to their best judgment in view of the opinions expressed.

The Committee on Rules and By-Laws presented a partial report. The Statistical year was fixed from July 1 to June 30, and the mention of monies on the Statistical Forms fur-

nished by the Board was ordered to be made in Japanese currency. An amendment was made to the article on *ad interim* circular letters, adding,

"Should the subject to be voted on directly concern the interests of more than one station, no vote shall be recorded until all the stations concerned have had opportunity to express their opinions."

After the reading of a part of the proposed edition of the Rules and By-Laws, the Committee was authorized to print the proposed Rules and By-Laws and to send copies to the members of the Mission for suggestions and corrections.

The Mission adjourned, until 7.30 P. M., being led in prayer by Rev. G. Engel, of the Australian Mission.

REPORTS.

II.—Treasurer's Report.

The treasurer has nothing new to report to the Mission except the increase of his duties consequent on the steady increase from year to year of the number of missionaries whose salaries he pays and whose freights and charges he calculates. During the past year he handled a considerably larger amount of actual cash, by reason of the two payments, aggregating nearly 60,000 yen, received from the palace officials in settlements for the Chung Dong property. Beside this, however, nearly 100,000 yen worth of bills of exchange had to be sold to supply the further needs of the Mission, an indication how much of the foreign mission contributions of our Church is expended upon this field.

III.-Report of Finance Committee.

During the year the Finance Committee has made decisions as follows:

I. On the question raised by Fusan Station of the use by Stations or individuals of unused balances already drawn from the Mission treasury before the expiration of the financial year, the Finance Committee decides that each Station or individual must determine for its self or himself whether the amount on hand practically belongs to the work of the closing year or to that of the year just beginning and account for it accordingly.

If it is decided that it belongs to the new year that much less should be drawn during this year instead of refunding it to the treasurer so that his book keeping may not be involved in the transaction, but notice of the amounts must be sent to him. In this way the intention of Sec. 77 of the Manual will be achieved and the amount will practically have reverted to the Board treasury.

Concerning balances still left undrawn in the hands of the Mission Treasurer, they have already lapsed to the Board and cannot be used unless the Board in answer to a Mission request adds the amount to the appropriation for the year.

2. The cut on appropriations as allowed by the Board was distributed among the Stations and Mission items. Two items not put by the Mission and Board among the cuttable items were by the Committee so considered and so reserved with Classes I, II and VIII from the cut.

These were personal house rent of missionaries not provided by the Board with residences, and the salaries of Japanese nurses employed under contract, these replacing a Board appointed American nurse at decidedly less expense.

3. As has been the rule in recent years new and restored work was cut at double the rate on old work, but in this matter the committee would recommend

That the rule heretofore in use that new and restored work be cut at twice the rate old work is cut be repealed and that hereafter all work on the estimates sheets of Mission not specifically exempt be on a par for the purpose of the cut.

4. We would also recommend that items of personal house rent for missionaries not provided houses by the Board be exempt from cut insomuch as it is in lieu of the house which the Board furnishes to its missionaries and is not related to "native work" and should be as untouchable as salaries in gold.

Also that the Committee be authorized; to call the attention of the Board to the propriety of putting the item "Rent for missionary houses" in some uncuttable class.

- 5. The books of the Treasurer were audited in due form, found correct, and the fact attested to the Board.
- 6. The Committee begs to recommend the following schedule of salaries as the maximum to be paid to Native Workers, the increase being due to the great rise in the cost of living in all parts of the country.

Native Helpers 15 yen per month.

Language Teachers and Literary Assistants 12 yen.

Bible Translators 24 yen.
Bible Women 8 yen.

Literary Assistants of more than eight years service 15 yen.

Reynolds, Jr., its hearty thanks for the excellent services which he has rendered in connection with the Central Presbyterian Church, Seoul, and assure him that we should appreciate highly such services as he may be able to render during the coming year in connection with the work of Seoul Station.
- 13. That we recommend that the Mission express to Mr. H. B. Hulbert its hearty thanks for the excellent services which he rendered in connection with the Sai Muu An Church, Seoul.
- 14. That we recommend that each Station of the Mission writes a short narrative showing the needs of the Station, and this narrative, which shall not exceed 400 words, be sent to Rev. C. A. Clark as editor who shall have the same printed and one sent to each Presbyterian clergyman in America, the funds for the same to be raised by private subscription—and that Mr. Hall's letter be printed separately and circulated with this.

VI.—Report of the Bible Committee.

I. At the March meeting the Secretary reported the sales of Scriptures during 1902 as follows:

II. At the regular June meeting (held July 17th) the Board of Translators reported, under date of June 19th, that they had held 141 sessions during the mission fiscal year, and had revised from I Cor. 7th to the first part of II Thessalonians.

"In the discussion which followed the reading of this report," to quote from the minutes, "a very general feeling of dissatisfaction with the progress made by the Translators found strong expression. It was felt to be desirable that Translators should be freed as much as possible from other duties, and it was unanimously resolved;—"That a sub-committee be appointed to formulate resolutions to be presented to the Methodist Episcopal Mission and to the Presbyterian Mission asking that their representatives on the Board be more entirely set free for translation work." The Chairman named Messrs. Kenmure and Moose as the sub-committee.

Recognizing the fact that our representatives on the Board of Translators have been ready to give their full quota of time to translation work, nevertheless, we recommend

That the Mission emphasize the fact that in its appointment of work to Dr. Underwood and Mr. Gale Bible Translation is to be given the first consideration and all other work assigned to be carried on so as not to interfere with the very best effort upon Bible Translation.

III. A letter was read from Mr. Loomis saying that the American Bible Society had approved the Constitution adopted by the Bible Committee Sept. 17th 1902 "with the understanding that Article VII is amended by the omission of Section 3," "and with the further understanding that the right of the American Bible Society to a proportionate share in the appointment and removal of the joint agent be officially recognized by the British and Foreign Bible Society and the National Bible Society of Scotland." Also a letter from the two British Societies agreeing to these changes was read.

Article VII Sect. 3 arranges for the reprinting of the Bible Committee versions "with alterations in the terms for God, Spirit, and Baptism."

It was agreed that Article VII Sect. 3 be struck out and that in Article VIII the date of making the Annual Report be changed from October to February as the Societies desire their reports to close with the fiscal year. Also that the Constitution as a whole be adopted and that, with the approval of the Bible Societies, the new Constitution go into effect January 1st, 1904. The Constitution as so changed comes before the Mission for adoption and your Committee recommend such action.

IV. At the June meeting contracts were let for the printing of

each type in two styles of page and in various bindings, including the more expensive styles.

Also for 10,000 each of the Gospels and Acts. Also it was agreed to print an edition of 5000 Lukes in the cheapest form practicable, so that they may be sold for one cent per copy for evangelizing purposes.

V. The following action was taken: "Inasmuch as the Presbyterian Council, the Methodist Mission, the Korean Religious Tract Society, and all the religious newspapers in Korea, have adopted the system of spelling Korean known as the Gale system, and as we as a committee approve of the same, and believe that there will arise no demand for editions in the old system:—Therefore, be it resolved that all the Korean publications of the Bible Societies be published in this system." The motion was unanimously adopted.

VI. Your committee also recommends that the Mission place on record its very great appreciation of the presence at its meetings for some years past of Rev. H. Loomis, the Agent of the American Bible Society. His practical and spiritual counsel has been most helpful and it is with deep regret that we hear from him that this is probably his last visit to us, the arrangement by which the three Bible Societies are represented by one common agent making it unnecessary that he should continue his oversight of the field. We would express

to the American Bible Society our great desire that it make provision for his presence with us at least once a year.

VII. As there is a possibility that the revision of the N. T. may not be finished in time to be used in the large editions lately ordered printed by the P. E. B. C. we direct the Special Bible Committee to endeavour to see that the edition of the N. T. in which the unrevised translations are used be limited to a total of 7000 in the less expensive bindings.

We recommend that in answer to the communications of the Australian Presbyterian Council "Re Division of Territory with the American Presbyterian Mission (North)" that we make the following reply:

That the statement of Mr. Robert E. Speer is not an official statement of either this Mission or our Board.

We beg leave to suggest the following plan as the one which appears to us most wise:

That the seven districts of Eul San, (술산). Ki Chang (괴장), Eun Ryang (은양), Ku Chai (커제), Chin Hai (진해), Ko Sung (고성), and Ryang San (량산), (the village of Pum Ku (범구), excepted), be the exclusive territory of the Australians.

That the seven districts of Kim Hai, (김해), Chil Won (칠원), Milyang. (밀왕), Yungsan, (령산), Eung Chun, (응전), Changyung (창령), and Changwon (창원), (except within 15 li of Masaupo) be the exclusive territory of the Americans.

That the remaining counties of South Kyung Sang Do be unassigned until work shall develop.

That in the further development of the work we would suggest that the Australian Mission direct its efforts toward the southern half, and that the Australian Mission direct its efforts to the northern half of the unassigned territory, and we express the hope that in case work of the American Mission arises in the southern half of the unassigned territory, the Fusan Station may see its way clear to turn the work over to the Australian Mission, and that in case work of the Australian Mission arises in the northern half of the unassigned territory, the Australian Mission may see its way clear to turn the work over to the American Mission.

We recommend that Messrs. Hall, Bruen and Sidebotham be a committee to represent the views of the Mission to the Australian Mission, and that if the above plan is acceptable to the Australian Mission we instruct this Committee to present the matter to the Board, asking its sanction of the plan.

Report of the Educational Committee.

- 1. We recommend the appointment of Dr. Underwood, Dr. Baird and Mr. Gale as a Committee on Terminology, they to co-operate with such other bodies as may be interested in the same subject with a view to preparing a list of Scientific and Technical Terms so as to secure uniformity in use throughout Korea.
- 2. We recommend that Dr. Baird, Mr. Gale and Mr. E. H. Miller be a committee to prepare a tentative course of study for Boys' Primary Schools and Academies, copies of this to be printed and given general circulation.
- 3. We recommend that Miss Best and Miss Barrett be appointed a committee to prepare a Tentative Course of Study for Girls' Primary Schools and Advanced Schools for Women and Girls, copies to be printed and given general circulation.
- 4 We would call attention to the establishment of or spontaneous springing up of mixed schools, with a view to recommending great caution, that they may not be allowed to grow into a system of co-educational schools. We would recommend their discouragement rather than their encouragement.
- 5. Recognizing the need Normal Class Instruction. We recommend the preparation of a Course of Study for Teachers of Primary Schools and that the committee on Course of Stuty for boys' Schools, Dr. Baird, Mr. Gale and E. H. Miller, be the committee.

SEOUL.

6. We recommend the approval of the project for the removal of the Girls' School Buildings and their re-erection on the site reported by the station.

- 7. Concerning the project for the erection of the main building for the Intermediate School. We recommend.
- (a) That until the further development and growth of the school render more imperative the erection of the Main Building, the needs of the school be met by the erection of a smaller building which shall afterwards become a subsidiary building.
- (b) We also recommend that this building, not to exceed 3,000 yen in cost be so erected that it may be used as Scientific Building when the Main Building shall be built.
- (c) We also recommend the approval of the requests for 500 yen for repairing the building now occupied by Mr. E.H. Miller, for use as temporary class rooms, also the request for 50 yen for apparatus.
- 8. We recommend that Mr. Gale be again placed in charge of the Intermediate School with Mr. E. H. Miller as Assistant Superintendant and, that Mr. E. H. Miller be in charge of the Manual Labor Department.
- 9. We recommend the assignment of Mr. Moore to special work as Teacher in the Intermediate School for Boys and in the Girls' School.

The ultimate aim of all our work must be the bringing of men and women to a knowledge of Jesus Christ, and their growth in Him, and the value of all our service must be judged according as it contributes directly to this end. As compared with other branches of missionary activity, we feel, if care is not exercised, that the medical work will receive more than its proportionate share of financial support.

- V. Your committee would also note that some time has been spent upon what might be called miscellaneous literary work. F. S. Miller and W. M. Baird in the examination of tracts for the K. R. T. S., F. S. Miller, Mrs. Baird, and W. C. Swallen in the writing of new hymns. And Dr. C. C. Vinton in proof reading and in putting through the press of a large number of publications of various sorts.

Your committee considers the adoption of the new spelling premature and recommends:—

- 1. That the Mission instruct its representives on the Bible Executive Committee to use their influence to delay the introduction of the new spelling into the new edition of the New Testament and portions.
- 2. That the Mission suggest that the Tract Society postpone the general use of this system in their publications until more unanimity of opinion has been reached on the subject.
- 3. That the Mission elect a committee of three to bring the question of reform in spelling to the attention of the other missionary bodies, and those engaged in publications in the Korean language with a view to securing uniformity throughout Korea.
- 4. We recommend that a copy of these resolutions be sent to the secretary of Presbyterian Council of Missions in Korea.

XV-Report of the Committee on the Christian News.

- I. During the past year the Christian News has been conducted by Mr. Gale as editor and Dr. Vinton as business manager. Mr. F. S. Miller, as assistant editor has edited the paper since Mr. Gale's departure in April.
- II. As a rule the plan of assigning departments to various members of the mission has proven satisfactory. Nine out of the sixteen heads of departments have contributed as assigned them. The rest will, we trust, do so before the end of the year. Others have contributed very acceptable articles, and we hope that the fact that no department has been assigned will not prevent anyone from contributing.
- III. Dr. Vinton reports that the circulation has increased from 335 to 400, the great obstacle to the growth of the last being the difficulty of securing its distribution through the country offices. Complaints to the postoffice department and the intercession of the American legation, have brought some hope of success in this part of the work. We recommend that efforts be continued, especially on the part of those engaged in country work, to increase the list of subscribers.

Details of receipts and expenditures could not be rendered to us by the business manager, but current receipts are re-

ported to have amounted to about 350 yen, which sum has met the ordinary current expenses aside from printing, and has left some surplus. The board has been drawn upon for 351.65 yen to meet printer's bills. In order to conform to custom we recommend that the finance committee of the mission be asked to audit all expenditures for the Christian News and report to the mission at the next annual meeting.

We nominate Rev. J. S. Gale as editor, Rev. F. S. Miller as assistant editor and Dr. C. C. Vinton as business manager of the Christian News.

XXIII.—Report of Examination Committee.

We would call the attention of the Mission to the fact of the increasing number of those who make request to defer their examination a year, thus taking four or five years for the course which should be covered in three years.

The Committee has reached the conclusion that in the oral examinations those who fail to reach a grade of 60 % in either Conversation, Reading or Translation and Analysis should be conditioned on such subject, even though the average grade be above the passing mark. Those thus conditioned will be expected to take an examination on the conditioned subject before proceeding to the next year's examination.

The Committee expects to revise the course of study during the year and report to the next Annual Meeting.

The Committee expects to make provision for the written examinations to be given in June, the papers to be sent to the Committee for examination.

XXVIII. Report Upon the Conference of Missionaries in Korea in 1904.

During the interval of a year that has elapsed since the General Committee met in Seoul the various committees have been at work, trying to perfect the arrangements for the Conference. Difficulties of various kinds have been encountered, and for obvious reasons it has been impossible to work to the entire satisfaction of every one. The Executive Committee has held monthly meetings and it has been the endeavor of this committee to follow out as closely as possible the plans adopted by the General Committee. Every action that has been taken by this committee was thoroughly discussed and was passed by the consent of the entire committee present. In many cases the opinions of parties outside of the committee were asked and weighed in making the decisions.

The following six committees have been at work:—(1) Programme, (2) Local Arrangements, (3) Hospitality, (4) Publication, (5) Finance, (6) Transportation. The Executive Committee, as you understand, is composed of the chairmen of these committees.

We will take up the work of each committee in order to get a clear idea of the present status of the preparations for the Conference.

I. The Programme Committee. This committee held two meetings last fall and drafted a rough outline programme. The secretary, Mr. Hunt, took this to Pyeng Yang and with the other member of the committee living there, Mrs. Baird, prepared an outline programme, which he sent to the chairman at Seoul. The chairman and Mrs. Campbell, the members at Seoul, went over this programme and then presented it to the Executive Committee as an outline programme. The Executive Committee adopted it, after making some changes, and ordered a tentative programme to be printed for distribu-

tion. This was done, and while it was not and is not the desire of the Executive Committee to have in any degree an ecumenical conference, invitations were extended to certain persons outside of Korea to take part in the programme. It was not thought at all probable that any considerable number of these persons would be able to take part in the programme. The result justified our expectations, and only eight conditional acceptances have been received, including those who are to take part in devotional services. In addition we have been promised papers from some who cannot attend the conference on such subjects as "Missionary Work among Lepers" and "The Blind," &c. These papers can be used or not as we desire.

We accompany this statement with a programme with the names and subjects attached. It is in some degree tentative as yet. There are some interesting subjects that might be worked in, such as "Methods to increase Christian Social Fellowship between the Missionary and the Native Christian," and "Language Study, Methods and Experiences (the personal teacher, text-books, &c.)." We trust that by the end of the year we shall be able to have the programme complete and pretty nearly in a permanent form.

- II. The Local Arrangements Committee. This committee has not had very much work to do as yet. They canvassed the ground and reported that they considered the best
 place to hold the Conference would be the First Methodist
 Episcopal Church in Chung Dong.
- III. The Hospitality Committee reported ou dates, and the Executive Committee set the date of the Conference from Sunday, September 18th., to Sunday, September 25th., inclusive. The committee prepared two addresses to the public, one a letter of information to missionaries in Korea and the other a letter to friends of missions outside of Korea. These were sent out by the committee to persons approved by the Executive Committee. Attempts have been made to secure rates from the hotels in Seoul, but the committee is not ready yet to report.
- IV. The Publication Committee. Upon the recommendation of this committee stationery was printed for the use of the members of the Executive Committee.

The committee presented a form of announcement of the Conference for the newspapers, and a list of about one hundred publications to which the announcement should be sent. These were adopted by the Executive Committee, but upon motion are yet held back till we can learn whether the General Committee desires to have them published.

V. Finance Committee. Upon the report of this committee the Executive Committee decided to adopt and send ont to the missionaries a request for subscriptions to defray current expenses. The form of request as presented by this committee was adopted. Upon a full vote of the Executive Committee Mr. Hugh Miller was elected Treasurer of the Conference.

The Executive Committee decided that all persons outside of Korea who take part in the programme shall be entertained during the continuance of the Conference; however, that it is not possible to pay any one's travelling expenses.

Upon motion the Finance Committee was instructed to write to The Christian Publishing Company of London and other publishing companies and secure offers to publish in book form the addresses, discussions, and other matter of importance to the Conference.

VI. Transportation Committee. This Committees has been at work trying to secure reduced rates from steamship lines on the Pacific and from Japan to Korea. While no formal report has been made yet, we understand that very favorable rates have been secured on the lines from Japan to Korea.

The Executive Committee found it advisable to institute a new committee, a committee on Exhibit. This exhibit was defined to mean a display of all kinds of Korean articles. The committee was directed to look into the matter and make an estimate as to what sum of money will be needed to make the exhibit a success. They have not yet reported.

There seems to be a tendency on the part of some persons to take a hypercritical attitude toward the action of the Executive Committee in its preparation for the Conference. We think that this arises from a lack of knowledge of the plans and work of the committee rather than a lack of sympathy with the idea of the Conference. We therefore hope that at this time the matter will be thoroughly discussed, the scope

of the Conference become well understood, and the entire missionary body, throwing aside personal opinions and prejudices wherever there is a majority against them, will unite enthusiastically to make the Conference one of blessing and benefit to every missionary in Korea.
