AD INTERIM ACTIONS

1903-4.

November 18, 1903, Narrative prepared by Narrative Committee of Mission, forwarded to Board, without approval of Mission Chairman or Secretary.

On request of Pyeng-yang Station, Dr. and Mrs. H. C. Whiting were assigned to Pyeng-yang until the return of Dr. J. H. Wells from furlough.

A paper entitled, "Suggestions for Missionary Outfit and Travel—Korea Mission," designed to take the place of a similar paper circulated by a special Mission committee, was sent around the Stations by an unnamed party or parties. It received the hearty endorsement of members of the Mission, and was by vote substituted for the "Suggestions" of the committee appointed by the Mission. As this now adopted copy of "Suggestions for Missionary Outfit and Travel" had been amended in several places by several members of the Mission the Secretary edited the list of suggestions and sent it on to the Board.

On request of Fusan Station 100 Yen was transferred from Class IX to Class VII in the appropriations of Fusan Station for 1903-4.

The request of Fusan Station that the Mission ask the Board to place the salaries of all the single men of the Mission on an equality was not granted.

The request of Seoul Station that the Mission ask the Board to grant as a sepecial appropiation the traveling expenses of Lera and Lawrence Avison, children of Dr. O. R. Avison, from Korea to America was granted, and the request was sent on to the Board.

The Board having referred to the Korea Mission the request of Mrs. George Leek that she be re-appointed to this Mission and to the Household Department of the Girls' School at Pyeng-yang, and the judgment of the Mission having been asked, the Mission replied by letter, "Mission does not consider the proposed return expedient. Letters will be sent you soon." As the Board had requested answer by cable, and code words could not be sent, the following answer was sent, "Leck, no."

On March 8, the Secretary received the following eable from the Board:

"Adams coming. Should wife return Taiku?"

Telegrams were sent to Hon. H. N. Allen, U. S. Minister to Korea, and to Taiku Station. Dr. Allen replied that he considered Southern Korea as safe as formerly, and Taiku replied "Come." Therefore the Secretary cabled the Board an affirmative response.

On the basis of a medical eertificate given by H. C. Whiting, M. D., the Mission asked for a furlough for Mrs. Cyril Ross to America, and the medical certificate and request of the Mission was sent to the Board.

On the request of Pyeng-yang Station, the Mission allowed Miss Best to leave the field shortly before her furlough was due to accompany Mrs. Ross to America.

TWENTIETH ANNUAL MEETING OF THE KOREA MISSION OF THE PRESBYTERIAN CHURCH IN THE UNITED STATES OF AMERICA.

Held in Seoul, Korea, September 20—October 3, 1904.

The Korea Mission of the Presbyterian Church in the United States of America assembled for the opening session of its Twentieth Annual Meeting in the Central Presbyterian Church, Seoul, September 20, 1904, at 2 P. M., and the afternoon was spent in Prayer and Praise, the general subject being "Sons of God," I John 3: 1, 2, 3.

Rev. H. G. Underwood, D. D., led the thoughts of the Mission on "The Privilege of Sonship;" Rev. H. M. Bruen on "The Hope of Sonship;" and Rev. S. A. Moffett, D. D., on the "Duty of Sonship."

After the prayerful consideration of the above topics, the Sacrament of the Lord's Supper was administered by Rev. S. F. Moore, the elements being distributed by Rev. H. C. Whiting, and Dr. J. W. Hirst.

SEOUL, SEPTEMBER 21, 1904.

The Mission met at 8:30 A. M., and Rev. W. N. Blair conducted the devotional half hour on "God's Messages."

After the devotional exercises, in the absence of the Chairman, Dr. O. R. Avison, the Secretary called the Twentieth Annual Meeting of the Korea Mission to order.

Rev. W. B. Hunt was made temporary chairman.

The reading of the Secretary's records of last year's proceedings was dispensed with, and the record of 1903-

4 ad interim actions only was read. This record was approved.

The Chairman came in and took the Chair.

The Examination Committee reported in part, announcing that Mr. Blair, Mrs. Blair, Mr. E. H. Miller, Mr. Sharp, Dr. Sharrocks and Miss Snook had passed the examinations prescribed for the third year and that Miss Brown, Mr. Hall, Miss Kirkwood, Mr. Koons, Dr. Null, Mrs. Null, and Mrs. Bruen had passed the examinations prescribed for the first year.

Dr. Underwood called the Mission's attention to the fact that Dr. H. N. Allen, now U. S. Minister to Korea, had 20 years ago today landed in Korea as the first Protestant missionary to this country, and he moved the Secretary send Dr. Allen an appropriate telegram of congratulation. The motion was carried.

The election of officers for the ensuing year then took place, Messrs. Bernheisel and Koons acting as tellers. The following officers were elected:

The Committee on Arrangements reported. The report was amended and adopted.

The retiring Chairman, O. R. Avison, M.D., then with appropriate remarks, yielded the Chair to the Chairman-elect, Rev. H. G. Underwood, D.D.

Mr. Clark in behalf of the Committee on Arrangements presented the new chairman with a gavel, which he received with a fitting speech. He and the Secretaries-elect then took up their duties.

Mr. Smith presented the General Report of Fusan Station and it was discussed.

The hour for fraternal greetings having arrived, Rev. W. B. Scranton, M.D., presented greetings in behalf of the Korea Mission of the Methodist Episcopal Church, and Rev. E. F. Hall responded. Rev. R. A. Hardle, M.D., presented greetings in behalf of the Korea Mission of the

Methodist Episcopal Church, South, and Rev. S. F. Moore responded.

After recess and the singing of a hymn, the Taiku report was called for, and as it was not ready, it was made the order of the day for first thing Friday morning.

Mr. Sidebotham resigned from the Evangelistic and Property Committees and his resignation was accepted.

The chair appointed Dr. Avison in place of Mr. Lee, absent, and Mr. Smith was elected in place of Mr. Sidebotham, resigned, on the Property Committee.

The chair appointed Dr. Baird in place of Mr. Lee, absent, and Mr. Hall was elected in place of Mr. Sidebotham, resigned, and Miss Snook in place of Miss Chase, on furlough, on the Evangelistic Committee.

The chair appointed Mr. F. S. Miller in place of Mr. Swallen, absent, on the Editorial Committee, and Mr. E. H. Miller in place of Mr. Lec, absent, on the Hymn Book Committee.

The chair announced that Mrs. Baird and Mr. Adams had been appointed on the Examination Committee in place of Miss Best and Mr. Swallen, absent.

Fusan Station's requests were now presented by Mr. Smith, and the Fusan report and requests were referred to the proper committees.

Mr. Whittemore moved that for this meeting the Estimates Committee consist of one member from each station, and the motion was carried. As Fusan and Sunchun Stations were not represented, Mr. Hall and Dr. Sharrocks were elected to serve on this committee.

It being moved that Mr. Pieters be regarded as a senior member of the Mission, the question was referred to the Examination Committee.

It is decided that this afternoon the stations report in the following order: Pyeng-yang, Sunchun, Seoul.

On motion the Mission adjourned, being led in prayer by Dr. Baird.

The Mission again met and the devotional exercises were led by Rev. H. C. Whiting, M. D., on the topic, "Divine Companionship."

Mr. Koons presented the General Report of Pyengyang Station, Mr. Bernheisel answered questions on the same, and presented the Pyeng-yang requests. The Report and requests were then referred to the proper committees.

After recess, Dr. Sharrocks presented the General report of Sunchun Station and also its requests. These matters were referred to the proper committees.

The matter of the estimates, appropriations and cut as brought up by Sunchun Station was referred to a committee of five to be appointed by the chair, of which Dr. Underwood should be chairman.

On motion the Mission decided to hold a closed session after the reading of Seoul and Taiku's reports Friday morning.

The Mission adjourned, being led in prayer by Rev. C. G. Hounshell, of the M. E. Mission, South.

Mr. E. H. Miller presented the Seoul report and requests. After discussion these were referred to the proper committees.

Mr. Bruen presented Taiku Station's Report. As the printed report made no reference to Mrs. Null's medical work, Taiku Station was allowed to place an inset concerning her work. Mr. Adams presented the requests. A request for Yen 4,500 for a house for Mr. Barrett being presented, it was referred to the Property Committee with the instruction that that committee consider and report on the subject of what houses are desirable for unmarried workers living alone. A request for completing the hospital equipment was presented and was referred to the Medical Committee in conjunction with Taiku Station. The report and requests were then referred to the proper committees.

After recess the Mission went into closed session.

The Committee on the Location of a New Station between Seoul and Taiku made a partial report verbally, and the report was discussed.

While the discussion was in progress, the Mission adjourned to meet at 2:30 p. m., being led in prayer by Dr. Moffett.

Mr. Ross then presented the claims of the city of Kangkai as a site for the new station approved in North Pyengan Province, and a general discussion took place.

On motion the two matters laid on the table earlier in the afternoon were taken from the table, and all three questions therefore came under discussion.

On motion the Mission adjourned, being led in prayer by Dr. Gale; and met in informal session at the Severance Memorial Hospital for the formal opening of that building.

Mrs. O. R. Avison opened the building with a silver key, and the Mission and many guests entered. Under the direction of O. R. Avison, M. D., physician in charge, all joined in song, Rev. N. C. Whittemore led in prayer, Rev. J. E. Adams read the Scriptures, Rev. S. A. Moffett, D. D., offered the dedicatory prayer, and Rev. H. G. Underwood, D. D., made the dedicatory address. Appropriate remarks were made by Rev. W. M. Junkin of the Korea Mission of the Presbyterian Church in the United States and by Rev. J. R. Moose, of the Korea Mission of the Methodist Episcopal Church, South. Rev. R. H. Sidebotham led in closing prayer, and the Mission and its friends were shown the building and its equipment.

The Mission met at 8.30 A. M. and Rev. A. G. Welbon conducted devotional exercises on the topic, "Knowing God by the Spirit."

The minutes of yesterday's session were read, corrected, and approved.

After recess, it was decided that when we adjourn we adjourn to meet tomorrow morning.

The special committee on the location of a new station between Seoul and Taiku reported, and the report was referred to the Evangelistic Committee. It was as follows:—

The Committee on New Station in Cheung Cheng Province reports as follows:—

We recommend

- 1. That a station be opened at the city of Cheng Ju.
- 2. That an integral part of the station be a book store with a colporteur at Cho Chun Market on the railroad 40 li from Cheng Ju which shall serve also as a depot for supplies and a rest house.
- 3. That Mr. F. S. Miller be appointed to open the station, and that he be relieved of his work in Kyeng Keui Province.
- 4. That we request an appropriation of 1,500 Yen for the preliminary expenses in connection with the opening of the station—estimated as 800 Yen for site, 500 Yen for temporary quarters in Cheng Ju and 200 Yen for book store on the railroad.
- 5. That the Board be requested to provide for the inauguration and the future support of this station by the special gifts of some individual or church so that this advance in work shall not interfere with the work now in operation in stations already established.
- 6. That upon the return of Dr. and Mrs. Johnson to Taiku Dr. and Mrs. Null be appointed to this station.
- 7. That a new Clerical Missionary be requested of the Board with a view to appointment to this station.
- 8. That Dr. Moffett spend at least one month during the year associated with Mr. Miller in the opening of the new station.

The Treasurer, Dr. C. C. Vinton, presented his annual report which was adopted. It was as follows:—

As usual the treasurer finds little to report except to assert that he has tried to do his duty for another year. Several new missionaries added to our mission have correspondingly increased his opportunities for service. The variations in rates of exchange have been greater the past year than we are accustomed to meeting, a change partly due to the war. At the same time changes in the policy of the local branch of the Dai Ichi Ginko have made it impossible for us to secure as favorable rates from them as from other banks in the selling of our commercial paper, and they have shown less disposition than previously to oblige us in other ways. A willingness on the part of the Hong Kong and Shanghai Banking Corporation to concede points of accommodation hitherto refused is declared to be a bid for our custom, and it seems probable that before long it will become desirable to transfer the mission's principal deposit to the latter bank.

The Bible Committee reported and the report was adopted. It was as follows:—

At the meeting of the Permanent Executive Bible Committee held Oct. 2, 1903, the action of July 17, 1904 recommending that the publications of the Committee be in the new spelling, was reconsidered and laid on the table.

10,000 New Testaments in No. 4 type.
15,000 " " " " 5 " and
40,000 Gospels and Acts (10,000 each, omitting
the Gospel of John) were ordered printed in the old
spelling.

It was agreed to sell the Gospels and Acts at two cents Korean on and after January 1st, 1904.

At the meeting of February 15th, 1904, "the Agent announced formally that the Bible Societies had all notified their acceptance of the new constitution of the committee," so the committee became "The Bible Committee

of Korea" and the Agent became the Agent of the three Bible Societies.

We hope to see the completed tentative edition of the New Testament out of the press in a month or two from now.

The members of the Board of Translators have done considerable work on individual versions of books of the Old Testament and we hope these will be printed as fast as finished, and ask the mission to so request.

The Hymn Book Committee reported and the report was adopted and the Committee discharged. The report was as follows:—

Our hynm book fund was found to be eight hundred ninety five Yen and this was turned into the Council Hynn Book fund to which the other Presbyterian Missions have agreed to contribute in a like proportion to their representation on the Council. One Mission has so paid and the others are expecting the funds from home soon. This being our final report we request that the Committee be discharged.

The Committee on Pyeng-yang Station records reported and the report was adopted.

The Committee on division of territory with the Australian Presbyterian Mission presented its report and it was adopted. It was as follows:—

To the Korea Mission of the Presbyterian Church in the United States of America.

Your Committe appointed to present the views of this Mission to the Australian Presbyterian Mission in Korea relative to the division of territory presents the following report.

1. That the Committee presented the proposals of this Mission to the Austrialian Mission, and that the proposals were accepted by them. (See their letter of

acceptance of Oct. 22nd, 1903.)

2. That the division of the "unassigned territory" into "northern half" and "southern half" is described as follows: "a straight line drawn from the junction of the 막동 (Nak Tong) and 남 (Nam) rivers to 지리산및 (Chirisanmayk) shall be the dividing line, so that those districts whose district-towns (county scats) fall south of the line, viz., 항안 (Haman), 의량 (Euiyang), 단셧 (Tan sung), 진유 (Chinju), 사형 (Sachun), 고양 (Konyang), 하돗 (Hatong) and 낙형 (Namhai), shall be considered south, and those districts whose district-towns fall north of the line, viz., 초계 (Chokei), 연천 (Yupchun), 구정 (Kuchang), 안의 (Aneui), 항상 (Hamyang), 산청 (Sanchung) and 삼가 (Samka), shall be considered north, in the interpretation of the terms "southern half" and "northern half" of the "unassigned territory."

3. That the matter was duly reported to our Board of Missions in New York, asking its sanction of the division, and, that the Board gave its sanction. (See Mission Letter from Secretary Brown of Dec. 26, 1903).

4. That a formal agreement was signed by the Secretary of this Mission, and by the Secretary of the Australian Mission, a copy of which we herewith present.

The Committee on a tentative Course of Study for Girls' Primary Schools reported, and the report was referred to the Educational Committee.

Dr. Vinton present a report on the Korea Field, which

was adopted. It was as follows:-

The four issues of "The Korea Field" put forth during the past twelve months have met as kindly a reception as their predecessors. The subscription list has now reached an even twelve hundred copies, or within some four or five of that number, and it is evident the November number must be increased to twelve hundred and fifty copies. There is never lack of material for such a publication on this field and the narratives told by our missionaries seem to gain easy readers at home. The papers presented at the Conference of last Thursday with the discussions upon them and with much other material coming to hand at this time of many gatherings is of such deep interest that the editor has determined to print in November a double number containing as much as is feasible of such information. Surely the great church at home must not be left in ignorance of the heart-stirring discussions which are this month our daily food. The sheet continues to pay its expenses in full, and so proves one of the most satisfactory of our many mission efforts at accomplishing commendable ends.

The Committee on Vicennial Conference reported and the report was adopted, and the Committee continued. The report was as follows:—

During the fall and mid-winter the Committee eontinued its work in preparation for the Conference and the outlook was very bright for a successful Conference and for one largely attended by visitors from outside of Korea. In February however the outbreak of the war soon made it apparent that no Conference would be feasible upon the scale projected. Even the meeting of the General Committee called for the middle of that month could not be held because the members were unable to get to Seoul at that time. Early in March the Executive Committee took the responsibility of declaring the Conference postponed and in May, again finding the situation somewhat modified, took the step of calling a Conference of missionaries from Korea only to celebrate by a programme of one day's duration only the historic event of the entrance of Dr. Allen into Seoul on September 22nd., 1884. This is the Conference which occurred last Thursday and which proved so successful and so enjoyable to all. On that day the General Committee suggested the holding of a week's Conference at the same date in the year 1909 to celebrate the twenty-fifth anniversary of the same event, and the proposition was cordially adopted and the choice of delegates to form a General Committee for that Conference was requested to be made by the several Missions at their annual gatherings in 1906.

The Board having referred to the Mission the matter of single men's salaries, it was moved that the chairman appoint a committee on the subject, and the motion was carried.

The chair was instructed to appoint a committee to draft appropriate resolutions on the decease of Mrs. C. C. Vinton.

The Mission met at 8:30 A. M., and the devotional exercises were led by Dr. M. M. Null.

The minutes of yesterday's sessions were read and approved.

The Educational Committee brought in recommendations on points referred back to it.

The report as amended was adopted as a whole. It is as follows:

The Educational Committee reports the following recommendations.

A. GENERAL.

- 1. That the Committees appointed to draw up various courses of study be continued and that the results of their work be printed and circulated.
- 2. That Mr. Sidebotham be requested to prepare an Elementary Geography for use as a text book in Primary Schools.
- 3. That Mr. E. H. Miller be requested to prepare an Elementary Arithmetic.

- 4. That we call attention to the need of a series of Illustrated Scripture Readers and request Mr. Bruen to prepare the same.
- 5. That in answer to the Board's letter of Dec. 26 '03 concerning the fund to be used for a Memorial to Dr. John D. Wells we reply that the Mission is not yet prepared to decide the eventual location for our Theological Institutions but that as the design of all our schools is to prepare men for Christian service we deem a fitting object for the use of this memorial fund to be the Main Building for the Intermediate School for Boys in Scoul for which we are asking this year, or.

In ease this is not satisfactory to the family of Dr. Wells and the Board, and the desire is that the memorial shall take the form of a provision for distinctively Theological education we would make request that a decision upon the location of the Theological Institutions be deferred until the Council of Missions in Korea and the Mission have more fully developed plans for the Theological work, and are ready to decide the question as to location of the same, and that in the meanwhile the fund be held by the Board pending further action of Council and Mission, the interest to be available for use in furthering the work of Theological Instruction on the field.

B. SEOUL:-

- (a) Intermediate School for Boys.
- 1. Recommendation that we approve the request for an appropration of 12,000 Yen for the Main Building including heating apparatus, desks and blackboards; provided, that the present work is supported from home more in accordance with the Mission's decision as to its needs and that the Board will give a proportionate increase in approriations to cover the added work.
- 2. That we approve the request for 500 Yen for grading, provided, that the present work is supported from home more in accordance &c. &c. (as under 1).
- 3. That we approve the request for 450 Yen for alterations on the present buildings for use as dormitories.
 - 4. That we approve the request for 500 Yen (250

Yen to be raised on the field) for use in the Industrial Department, *provided*, &e. &e. (as under 1).

- 5. That we approve the request for a "Special appropriation" of 500 Yen (250 Yen to be raised on the field) for use in the Industrial Department this year.
- 6. That the itinerating members of the Seoul Station be assigned from 1 to 2 months of teaching in connection with the Intermediate School for Boys and the Girls' School.
 - (b) Girls' Sehool.

Recommendations.

- 1. That we approve the request for 4,750 Yen (750 Yen of which is for grading), for the removal and rebuilding of the Dormitory, *provided* that the present work is supported from home more in accordance with the Mission's decision as to its needs and that the Board will give a proportionate increase in appropriations to cover the added work.
- 2. That in ease the Seoul station's request for a lady evangelistic worker for Yun Mot Kol be granted, she be located in connection with the school.
- 3. That a Korean housekeeper be employed who shall also aet as a teacher of sewing and housekeeping.
- 5. That we approve the plan for using one of the graduates as teacher.

C. Fusan:-

Recommendation.

That we approve the request for appropriations for a Boy's school and for country schools, provided, that the present work is supported from home more in accordance, &c., &c., (as under B. (a) 1, 2 and 4).

D. Pyengyang:-

Recommendation.

That a special request be made to the Board to send Mr. McCune for the Academy at as early a date as possible or in ease of his inability to come within a year to send some one in his place.

The Estimates Committee brought in a question as to the manner in which Seoul Station is bringing in its

requests this year. On motion the whole matter of the manner of sending in the Estimates was referred to the special committee on Matters of Finance.

The Evangelistic Committee brought up the as yet unfinished items of its report.

A recess was taken.

After recess, the Hon. Secretary of the Christian Literature Society for China, Rev. J. Cumming Brown, D. D., and his wife were given the privileges of the floor. Dr. Brown made a few happy and appropriate remarks.

A question of a girls' school at Tonghyun was referred to the Educational Committee.

The chair appointed Messrs. Bruen, Whittemore, Hunt, and Drs. Moffett and Gale as a committee on Single Men's Salaries, and Mr. E. H. Miller and Miss Snook as a committee on Resolutions on the death of Mrs. C. C. Vinton.

A request for increase in the salary of literary assistants brought in by the Pyengyang Station was referred to the Finance Committee.

The Medical Committee reported, and the report was considered seriatim.

It was decided to meet again at 2:30 P. M.

The Apportionment Committee presented its report on proposed furloughs, and the Mission approved requests for a furlough for Miss Shields from July 1, 1905, and for Mr. and Mrs. Hunt from July 1, 1905.

The Mission adjourned being led in prayer by Rev. Eugene Bell, of the Southern Presbyterian Mission.

A furlough was

Pieters had previously been for some years in close connection with our Mission, tho not a member of it, and had already been a missionary in another field under our Board for two years, he be regarded as having had "one year's service in connection with the Mission," and as he had also "passed the language examinations appointed for the first year," he was given the right to vote.

The Examination Committee reported on the language work of Mr. Pieters, and the report was adopted. It was as follows: On the question concerning Mr. Pieter's referred to us, the Committee reports that it deems it advisible for Mr. Pieters to take a language examination next year on the 3rd year's course of study after which he shall become a senior missionary.

The Apportionment Committee presented its report.

The assignment of work having been presented, it was adopted as amended above, and the preferred list of workers also was adopted. The report of the Apportionment Committee as a whole was adopted as amended. (See Appendix I).

The Committee on Taiku Station Records reported, and the report was adopted.

It was ordered that hereafter the various committees examining Mission and station records shall place the approved reports of the committees on the several records.

Pyeng Yang Station invited the Mission to hold the next Annual Meeting in Pyeng Yang, and the invitation was accepted.

On motion, Dr. W. O. Johnson was made our commissioner to the next General Assembly.

On motion the chair was given anthority to appoint a committee to make suitable arrangements for the reception and itinerary of Mr. Nathaniel Tooker, member of our Board, and his party, if he comes to Korea. The Mission adjourned, being led in prayer by Mr. Koons.

The Mission met at 9.30 A. M., and devotional exercises were led by Rev. H. M. Bruen.

The minutes of yesterday's sessions were read, corrected and approved.

A supplementary recommendation of the Educational Committee concerning the girls' school at Tong Hyun was adopted, as follows:—

That we approve the request of Seoul station for permission to use for one year foreign funds to the extent of 34 of the expense in support of the girls' primary school at the Tong Hyun Church.

The Evangelistic Committee presented a supplementary report which was adopted.

The paragraph of the Evangelistic Committee report dealing with the proposed rest house at Andong was reconsidered and the qualifying clause was stricken out.

The Evangelistic Committee's report as a whole was adopted, as it had been amended by the Mission. It was as follows:

The Committee recommends.

- 1. That the request of Fusan Stution for a colporteur for Mr. Smith and a colporteur for Mr. Hall be approved.
- 2. That the request of Seoul Station for a colporteur and book-room at Tonghyun be approved.
- 3. That the request of Seoul Station for colporteur to work in the river villages near Scoul in charge of Mr. Moore be approved.
- 4. That the request for colporteur to work in Pai Chun under the direction of Mr. Moore be approved, the salary to be raised partly by contributions from native sources and partly from profit on books sold.

5. That the request of Seoul Station for additional helper for Dr. Underwood be approved.

6. That the request for helper for Mr. Kearns be ap-

proved.

7. That the request for colporteur for Mr. Kearns be approved.

8. That the request of Sunchun Station for permission to build the church in the City of Sunchun be approved, and that permission be given to seeure foreign, not Board, funds up to an amount equal to one-third of the cost, such funds however not to exceed Yen 1700.

9. That we extend our thanks to Rev. W. D. Reynolds of the Southern Presbyterian Mission for his services so freely given to our work in Seoul, and that we ask him so far as his assigned work will permit to continue his connection with the work of Seoul Station.

10. We would emphasize the need of Taiku Station for a qualified woman worker, and recommend that if possible, the Apportionment Committee from the present force of woman workers in the Mission assign one permanently to Taiku.

11. (Referred to Appportionment Committee.)

12. That we approve the request for an additional helper for Mr. Bruen, at least one half of his salary to come from native sources.

13. That we approve the request for an additional helper for Mr. Adams, one half of the salary to come from foreign sources for one year only.

14. That we approve the request for a colporteur for Mr. Adams.

15. That we approve the request of Taiku Station for a rest house at Andong.

16. That we approve the use of foreign, not Board, funds in building the South Gate Church in Pyeng-yang up to an amount equal to one third of the cost.

17. (Stricken out.)

18. That we approve the request for rest-house at Anju.

19. We recommend:

a. That the Mission ask permission of the Board

to take steps towards the opening of a station in Whanghai Province.

b. That this station be located at Chai Ryong Umnai.

(This section was referred to a committee to report next year, Dr. Underwood, Mr. Sharp, Dr Moffett, Mr. Hunt, and Mr. Whittemore. The committee was given power to act in the purchase of property, provided they are agreed in their decision regarding the location of the station, and the Seoul and Pyeng-yang Stations concur in the decision of the committee.)

c. That we approve the request for securing a site and temporary quarters.

20. We recommend:

a. That we re-affirm the action of last year with regard to the desirability of a station in the northern part of North Pyengan Province.

b. That looking forward to this, we approve the use of 400 Yen for the purchase of a rest house in Kangkai.

c. That the request of Sunchun Station for securing an appropriation for a station site at Kangkai be approved.

21. We recommend: (The following was substituted for the original recommendation of the committee.)

a. That a station be opened at the city of Chungju.

b. That Mr. F. S. Miller be appointed to open the station.

c. That we request an appropriation of 1500 Yen for the preliminary expenses in connection with the opening of the station, estimated as 800 Yen for site, 500 Yen for temporary quarters in Chungju, and 200 Yen for a book store on the railroad.

Messrs. Adams, Whittemore, Baird and Sharrocks recorded their votes as opposed to the adoption of the substitute for the original Sec. 21.

22 and 23 were stricken out.

24. That we approve the employment of a Bible woman to work in the Yun Mot Kol Church.

25. The above recommendations concerning new stations are made primarily on the basis of the evangelistic needs of the work and are to be considered in connection with the recommendation of the Special Finance Committee already adopted by the Mission, viz. "In respect to the question of the opening of three new stations upon this field the committee recommend that if the present work is supported from home more in accordance with the Mission decision as to its needs, and if the Board will give the new men needed and will give a proportionate increase in appropriations to cover the added work, then the Mission approve so far as the financial aspect of the question is concerned the opening of the three new stations proposed."

We recommend:

- 26. That permission be granted to Mrs. Adams to employ another Bible woman, salary to be provided from other than Board funds.
- 27. That permission be granted to Pyeng-yang Station to employ two additional Bible women, one to be in charge of Miss Kirkwood, and one in charge of Mrs. Blair, salary of both to be provided from other than Board funds:
- 28. That permission be granted to Mr. Moore to employ a Bible woman to work in the river villages near Seoul, salary to be provided from other than Board funds.

C. E. SHARP, Secretary.

The Medical Committee presented an amended report on Sec. 10 which was adopted. The Medical Committee's report as a whole was adopted as amended. It was as follows:—

The Committee recommends:

- 1. That Dr. Avison be granted the use of six student assistants.
- 2. That we approve the request of Seoul Station that Dr. Avison be granted for medical work Yen 800.00 over the amount allowed by Mission rule, being the same amount asked from the Board last year.

We call attention of Mission to the fact that the cost of the Severance Memorial Hospital and site to date is approximately Yen 28,000.00, the increase over limit placed by Mission being caused largely by the war; and that expenditures are contemplated, which Mr. Severance has indicated his willingness to meet, amounting to about Yen 4,000.00 additional for isolation ward, mortuary, walls, etc., and although admitting the desirability of the additions contemplated we would recommend:

3. That they be erected on as small a scale as is compatible with their usefulness in order that the cost of maintainance to the Board be not materially increased.

4. That Dr. Sharrocks' request to use Yen 250.00 additional, be approved, Yen 200.00 to be raised on the field.

5. That we approve the use of six student assistants by Dr. Sharrocks.

6. That Taiku Station's request for permission to raise Yen 1,000.00 for completion of hospital be approved.

7. That Fusan's request for increase in medical appropriation, amounting to Yen 330 00, be approved, Yen 200.00 to be raised on the field. One member voted in the negative.

8. That Taiku's request for increase in medical expenditures amounting to Yen 606.00 be approved; but would urge the Station to endeavor to increase the receipts from patients from Yen 100.00 contemplated in their estimates to Yen 250.00 of last year's estimates.

9. That we approve the request of Pyengyang Station for Yen 150.00 for medical work of Dr. Whiting.

1.0. That we approve the request for increase of Yen 1048.00 in Dr. Wells' medical appropriation, Yen 414.00 to come from the Board.

11. That we approve the use of six student assistants by Dr. Wells.

C. E. SHARP. Secretary.

The property committee reported, and the report being considered seriation, Sections 1-10 were each in turn adopted. Mr. Sidebotham desired to record his vote as opposed to the adoption of Section 10, as he considered the piece of furniture mentioned movable. The Property Committee's report as a whole was adopted, and is as follows:—

1. Action ad interim.

Plans for moving and rebuilding the Girls' School dormitory were approved unanimously.

Actions at this meeting.

- 1. Approved plan of study for Miss Best presented by Pyeng Yang Station. Estimated eost 650 yen.
- 2. Approved plans presented by Seoul Station for alterations in Girls' School dormitories rendered necessary on health eonsiderations. Estimated cost 200 yeu.
- 3. Approved alterations on present Intermediate School quarters. Cost 200 yen additional.
- 4. Approved the purchase of the site for Sarang in Yunmotkol suggested by Seoul Station.
- 5. Recommend, instead of a % house for Mr. Barrett, a mission house suitable for a family.
- 6. Recommend that before any plans for site or buildings shall be sent to the Mission Property Committee for approval the advice of one of the mission physicians shall be obtained and attached to the said plans.
- 7. The Emperor having made known his intention to take over the Tong Huen (Kurigai) property, we recommend:
- (a) That Scoul Station be authorized to fix the amount of indemnity to be asked in accordance with the terms of the agreement of September 1894.
- (b) That the Jaeobsen Memorial Home and the land connected with it be included in this property and His Majesty be asked to take it over and pay for it as part of the improvements made on the hospital.
- (c) That in lieu of the cash payment which is referred to in the above agreement the station endeavor to arrange an exchange with His Majesty by which we retain the Kurigai property and give him our Kon Tang Kol property, the difference in value in our favor to be paid by him.

- (d) This difference in value is estimated by this Committee at the price of a new house and site near Chong No, on which to erect the Central church, but the Committee recommend that this valuation be referred to Seoul Station as a suggestion only, the Station being authorized to fix such terms as in its judgment may be right.
- 8. Recommend that the papering of houses be considered as a proper expense to the Board, such papering to be as to quality and frequency under the supervision of the Station.
- 9. That the action regarding repair of Hospital drains by Fusan Station was technically illegal, and recommend the correction of their minutes to simple approval of repairs needed. See Board's Manual pp. 50, 52, 64.
- 10. That the action regarding Mr. Smith's china closet by Fusan Station was legal inasmuch as it is immovable furniture.

The report of the Committee on Fusan Station records was amended, adding the actions of the Mission on the points involved, and adopted.

The report of the Committee on Seoul Station record was adopted.

The Committee on Single Men's Salaries reported, and the report was adopted, and is as follows:—

1. In support of the request preferred two years ago that the salary of a single man be \(^2\)_3 that of a married one, or \$833.33 and in reply to the request of the Board for an itemized list of the average expenditures of a single man we submit the following:

- 2. We would call attention to the great increase in the cost of living in the past ten years, doubling and trebbling during this period.
- 3. We reaffirm in view of the estimates made above that a single man can not live as a progressive self respecting and well equipped missionary should, on less than \$833.33 per year. We therefore respectfully request the Board to return to the \(^2\)_3 schedule or 833.33 per year.
- 4. In view of the above estimate of yearly average expenditure for a single man, your committee questions whether our single women can live as they should on \$625.00 per year, as most of these expenditures would be approximately the same, the one item of board, yen 638.00 amounting to over half the salary. This mat-

ter however not having been referred to us we simply raise the question as to single women's salary.

A recess was taken.

After the recess, the chairman appointed Mr. Blair, Mr. Lee, Mrs. Baird and Miss Snook as the committee on arrangements for Annual Meeting.

Mr. Whittemore was appointed the fifth member on the committee on new station in Whang Hai Do.

The Mission ordered that the names of those who had not yet presented personal reports be placed on the records. They were as follows:

The special committee on matters of finance brought in a further report which after slight amendments was adopted. It was as follows:

The Special Finance Committee, having been instructed by the Mission to report upon the latest form of estimate blanks sent us by the Board, formulates the following explanations:

The First column ought to contain the actual grant for the current year, which means the amount actually to be drawn this year from the Board's treasury for given item after the cut has been imposed upon the estimates, plus the amount estimated to be raised on the field the current year for this item.

The Second column is the sum of "restored" and "new" work. "Restored" work means the amount of cut upon this item the current year. "New" work means either an added request for money from the Board's treassurv or an increased estimate of money to be raised on the field, or both. For the present year we consider it the best policy to enter "restored" work separately.

The Third column is the amount expected to be raised upon the field from any source whatsoever.

The Fourth column, being the exact amount asked from the Board's treasury, should be the sum of the first two columns diminished by the third.

We call attention to the fact that under this plan in Class IV. the amount estimated to be raised on the field during the current year for the salaries and expenses of all evangelistic native agents supported on the field should be entered in the first column. In Class V. all expenses in native schools under our charge estimated to be raised on the field should be entered in the first column. In Class VI. this plan has already been followed. In special items in other classes this same rule may apply.

In the matter of the estimate sheets, we recommend that the Mission in passing on the estimates for Classes IV and V and such portions of other classes as admits of receipts given on the field pass definitely on the last column only, which is the total amount to be asked from the Board; that the sheets be then handed back to the several stations for the first, second and third columns to be filled in accordance with our recommendations above, the sheets to be finally returned to the chairman of the Estimates Committee.

We further recommend that the By-law providing for the election of the Finance Committee of the Mission be changed to read:—(6) Finance Committee, five members, to have general supervision of all matters of finance. This committee shall appoint from its own members or others an auditing committee of three members to audit the Treasurer's and all other Mission accounts and to apportion the grant (see Article XV.), this auditing committee to be responsible to the Mission through the Finance Committee.

In the matter of the protest of Seoul Station against the smallness of the grant and the manner of making out the estimate sheets we recommend that a letter be sent to the members of the Board. Such a letter we have drafted and submit herewith.

Respectfully submitted, C. C. Vinton, Secretary of the Committee.

The letter recommended by the Special Finance Committee was adopted, and the committee given the privilege of making changes it might deem necessary.

The committee on plans for the Pyeng-yang Hospital reported, and the report was adopted, and Dr. Wells added to the committee. The report was as follows:

The committee reports progress, and asks that Dr. Wells be added to the committee, and that it be continued through another year.

O. R. Avison, Chairman pro tem.

The Committee on Resolution on the death of Mrs. C.C. Vinton reported, and the resolutions were approved and ordered spread on the minutes. They were as follows:

- "The past year has seen another from our midst called home, and tho our fellow-worker has been released from her labors and has entered into the rest of the blessed, we who remain must record our bereavement and loss.
- "Mrs. Letitia Coulter Vinton became a member of the Korea Mission in 1891, and for twelve years she had endeared herself to the hearts of all. She was but entering upon, to our short sighted vision, the prime of life: that period when preparation for life's work is completed, a preparation, could we but have seen with clear vision, that was fitting her for translation to a better sphere of usefulness in the presence of the Father.
- "All who knew her felt the loss to be a personal one, but especially in the home, where she was the center, is her cheering, helpful presence missed.
- "Because of her family of small children she had never been able to do much active missionary work, but her heart and sympathy were in that work, and as she

was able she worked through a Bible woman and in the Girls' School. Her influence was felt in a wide circle of friends who will long cherish her loving

memory.

"We extend to the bereaved husband and the children deprived of a mother's care our sincerest sympathy and love, and we pray that the abiding presence of the Comforter may be with them in all fullness.

The Rules and By-laws were adopted as a working basis for one year. (See Appendix IV).

It was decided to meet again at 2:30 P. M.

The Mission adjourned, being led in prayer by Dr. Vinton.

The Mission met again, and after song and prayer, the Christian News Committee brought in an amended report, dropping out Section 3. The report as a whole was adopted as thus amended. It was as follows:

1. Your committee would report that the arrangement of last year assigning articles for special departments to particular individuals has on the whole worked well. While a few have not responded, for the most part

the work assigned has been done.

2. The Business Manager reports that all the provincial governments except one have been dropped from the subscribers' list on account of non-payment of subscriptions. There has been a net increase in the subscribers roll however of at least thirty. He also reports that in spite of all effort on the part of the American Minister and Consul General poor postal service in the country greatly hinders our circulation. The total receipts of the year to date have been Yen 1,149.80. The total disbursements Yen 1,213.16.

- 3. In relation of the matter of last year's accounts referred to the Committee by the Mission, we would recommend that the Business Manager be instructed to bring up his books to date and submit them to the Finance Committee for auditing within one month after the close of the Mission Meeting, and that the Finance Committee be instructed to audit the same.
- 4. In view of the fact that the committee has received from the Business Manager no itemized financial statement for the past year such as would admit of auditing, we would make the same recommendation in this matter as in the preceding section.
- 5. We recommend that the subscription price of the paper be fixed at one Japanese yen, including postage.
- 6. We would recommend that in addition to a collector and news agent at each station, the station appoint to him a Korean assistant, to secure contributions from suitable Korean sources, such contributions to be forwarded through the local agent.
- 7. We would recommend that the Editor put in a department of "Comment on Current News and General Progress of the World," making it somewhat similar to that page in the "Interior" or other of our home church papers.
- 8. While as yet owing to lack of type it has been impossible to print the paper in other than the new style of spelling we would recommend that as soon as possible we return to the old style of spelling, with the exception of Q, until such time as the queston of spelling shall become definitely settled.
- 9. We would recommend that contributors exercise eare with regard to the too frequent use of 是太 in their articles. It should be remembered that the majority of our readers are not scholars and therefore the language should be made simple and easy to understand.
- 10. We would recommend that for the coming year Dr. Gale be considered as Editor in Chief, Mr. F. S. Miller as Assistant Editor, and Dr. Vinton as Business Manager.
 - 11. For the coming year from Jan. 1st, 1905 to

Jan. 1st, 1906 we recommend that the following arrangement be made for the heads of departments.

Mr. Swallen, N. T. Sunday School Lessons.

Mr. E. H. Miller, Prayer meeting topics.

Mr. Moore | Devotional Articles.

Mr. F. S. Miller, Articles on leading men to Christ.

Dr. Sharrocks, Useful Information.

Mrs. Baird, Articles on care of home.

Dr. Baird, Educational Topics.

Mr Clark, Foreign Missions and Church News.

Mr. Bruen, Articles for Children.

Mr. Kearns, Ten Historical Articles contemporaneous with Biblical Times.

Messrs. Whittemore, Sidebotham and Bernheisel, selected articles, ten each.

Also such articles from members of other missions as can be secured.

Respectfully Submitted,

The special committee on certain matters pertaining to the Christian News reported, recommending that for the coming year the size, price and frequency of publication be the same as during the past year. The report was adopted.

The sections of the report of the special committee on matters of finance which had been laid on the table were taken off the table.

Section 2 was re-laid on the table.

" 3 was stricken out.

The report as amended was adopted as a whole. It was as follows:

The special committee appointed to receive the papers relating to certain propositions concerning its financial relations and to advise the Mission in regard to its action upon them have met and considered these propositions, and they would report as follows:

- 1. In respect to the question of the opening of three new stations upon this field the committee recommend that, if the present work is supported from home more in accordance with the Mission's decision as to its needs, and if the Board will give the new men needed and will give a proportionate increase in appropriations to cover the added work, that then the Mission approve, so far as the financial aspect of the question is concerned, the opening of the three new stations proposed, in North Pyengan Do, in North Chung Chung Do, and in Whang Hai Do.
- 2. (Not adopted, but laid on the table.) In respect to the plan presented by Sunehun Station with reference to the distribution of the grant, the committee find it so indefinite and that so little has been done toward the working out of the necessary details, that the committee cannot recommend it to the Mission The facts presented to support the proposition do not impress us as of sufficient weight to demand the action suggested.

While the election was in progress, on motion each station was ordered to elect one member, to serve on a Mission committee to consider the best plans for shortening the sessions of the annual meeting, or making it a delegated body, or in some other way saving some of the great drain made upon the time of all the members of the Mission by the annual meeting.

Mr Smith, Dr. Irvin and Dr. Vinton were elected a committee to look into the advisability of work for

lepers in Korca.

Finance Committee reported on the salaries of literary assistants, recommending a maximum salary of 15 Yen per month. The report was adopted.

It was moved and carried that as Messrs. Whittemore and Kearns had sent on to the Board one copy of their personal reports, and had only filed one copy with the Mission Secretary, they be not required this year to file another copy with the Secretary.

The Estimates Committee began its report. After the consideration and adoption of the estimates of Fusan and Sunchun Stations, the hearing of the remainder of the report was postponed.

On motion, the matter of what shall constitute a quorum of the Mission was referred to the Rules and Bylaws committee.

It was decided that for next Monday morning a majority of those present in Seoul shall be considered a quorum.

Dr. and Mrs. Avison were permitted to present their personal reports at a later time.

The Mission adjourned to meet Monday, October 3, at 8.30 A. M. being led in prayer by Mr. Whittemore.

The minutes of Saturday's sessions were read, corrected and approved.

The report of the Committee on Seoul Station Records was reconsidered, and it was decided that only that portion of the report in which both members of the committee agree should be considered the report of the Committee. The report was re-adopted.

A communication from the clerk of the Council of Presbyterian Missions was read, as follows:

To the Secretary of the Presbyterian Mission North. Dear Sir:

I beg leave to call the attention of the Presbyterian Mission North to the action of the Council on the report of the "Committee on Church Government," suggesting action on the part of the Presbyterian Mission. I am sorry not to have a copy of the report to present to you, but the contents of it are sufficiently well understood for intelligent action.

Respectfully submitted, C. F. Bernheisel, Clerk of Council.

It was moved that in accordance with the action of the Council on the subject of Church Government and the request of the Council we send a copy of the action to the Board earnestly requesting permission to unite in the formation of an Independent Korean Presbyterian Church according to the plans of the Council; and that Dr. Moffett be appointed to send the communication to the Board with explanations. The motion was earried.

The Narrative Committee was on motion discharged.

The matter of the manner in which permanent committees are elected was on motion referred to the special committee on shortening annual meeting.

The Estimates Committee continued its report.

The Mission decided to ask for a furlough for Dr. and Mrs. Moffett from March, 1906.

The Estimates for the Seoul, Pyengyang and Taiku Station and the Mission, and the preferred list for new property was read and with some changes adopted.

The Estimates as a whole were adopted as amended. (See Appendix II).

The Statistical Committee reported, and the report was adopted with minor changes. (See Appendix III).

On motion the question as to the place of next annual meeting was reconsidered. An invitation from Seoul Station also was presented by Dr. Gale. On reconsideration, the invitation of Pyengyang Station was again accepted.

On motion the Mission indicated its expectation of

meeting in Seoul two years hence.

The report of Mr.Clark as the Committee on the letter to be sent to the pastors at home was heard and adopted.

The manner of printing the minutes was left to the

discretion of the Secretary.

The minutes of today's session were read and approved after correction, and the minutes of the whole annual meeting were approved.

The chairman, with the assistance of Dr. Moffett, Mr. Hall, and Dr. Gale conducted closing devotional exercises, and the 20th annual meeting of the Korea Mission of the Presbyterian Church in the United States of America adjourned.

APPENDIX IV.

STANDING RULES AND BY-LAWS OF THE KOREA MISSION OF THE PRESBYTERIAN CHURCH IN THE UNITED STATES OF

AMERICA.

ADOPTED AS WORKING BASIS FOR ONE YEAR, OCTOBER 1st, 1904.

ARTICLE I. ANNUAL MEETING.

1. The annual meetings of the Mission shall begin on or about the 20th of September. The Committee on Arrangements shall cause a notice of the place and time of meeting to be sent to all Stations at least six weeks prior to the time of meeting.

2. The sacrament of the Lord's Supper shall be administered at each annual meeting by the retiring Chair-

man or by the person he may select.

3. At each annual meeting, officers shall be elected, reports presented from each Station, each missionary, and each committee of the Mission; and estimates for appropriations shall be made.

4. In the interim between Mission mectings, any subject which cannot, without serious hindrance to the work, be delayed till the following annual meeting (the Station to decide its urgency) may be brought before the Mission by means of a circular letter which shall contain full particulars concerning the matter to be voted upon, and after an opportunity to vote has been given in all the Stations, it shall be sent to the Mission Secretary, who shall announce the result to the Mission and forward the result to the Board if necessary. Should the subject to be voted on directly concern the interests of more than one Station, no vote shall be taken until all the Stations concerned have had opportunity to express their opinions.

ARTICLE II. OFFICERS.

- 1. The officers of the Mission shall be Chairman, Secretary, Assistant Secretary, and Treasurer, to be selected annually by ballot at the first business session of the annual meeting.
- 2. The Chairman, Secretary, and Assistant Sccretary shall take office at the opening of the second business session, and the Treasurer at the beginning of the fiscal year.
- 3. The duties of the Chairman are those that usually belong to that office, including the appointment of all committees not otherwise provided for, and the filling, when necessary, of all vacancies on committees which occur between annual meetings. In case of disability of the Chairman his ad-interim duties shall devolve upon the Sceretary.
- 4. The duties of the Secretary shall be to keep the records of the Mission; carry on all correspondences for the Mission except as otherwise provided for; to receive all circular letters after they have been voted on, to ascertain the result of the vote, and report the same to the Mission at once, to the Board if necessary, and to the next annual meeting; to have printed the ad interim actions of the past year, the minutes of the annual meeting with the reports as adopted of all important committees, together with a list of all special and permanent committees, and their officers, and to supply each Station with enough copies for its missionaries; and to send the minutes of the meeting with a separate list of all Mission actions requiring Board action, to the Board within two weeks after the close of the Mission meeting.
- 5. The Assistant Secretary shall assist the Secretary in the discharge of the above duties as far as practicable.
- 6. The duties of the Treasurer shall be those laid down in the Manual.

ARTICLE III. COMMITTEES.

The committees of the Mission shall be divided into three classes;—permanent, annual, and special.

A. Permanent Committees.

- 1. The members of these committees shall hold office three years, their offices expiring in rotation, the election to take place at the close of each annual meeting, a nominating committee recommending suitable persons to fill the vacancies.
- 2. Should a member of any committee be absent from the annual meeting, or go home on furlough expecting to be absent from only one annual meeting, his place shall be considered "temporarily vacant," and the Mission Chairman shall appoint a substitute; with these exceptions, that members of the Property and Finance Committees going on furlough, and members expecting to be absent from two annual meetings shall lose their places and the Mission Chairman shall appoint a substitute until annual meeting, when the Mission shall fill the vacancy by ballot, and in case the term of office expire at the close of annual meeting, the one election shall be both for the unexpired and the new term.
- 3. The Permanent Committees shall organize immediately after the close of the annual meeting and the several officers elected shall be printed with the list of committees.

The Permanent Committees and their duties are as follows:—

- (1). Property Committee, six members, at least one from each Station. It shall examine and pass upon all plans for new buildings or alterations involving an expense of more than Yen 100, the local members to be agents of the Property Committee to see that its provisions are carried out. (See also Manual sec. 53-4.)
- (2). Evangelistic Committee, six members, each Station to be represented, one member at least to be a lady. It shall have supervision of the evangelistic work, training classes, woman's work, and native evangelistic workers; and shall recommend methods and policies.
- (3). Medical Committee, five members, of whom two shall be physicians. It shall act as an advisory board with the physicians, consult with them concerning their work, both accomplished and contemplated, with recommendations on the medical work of the whole field.

- (4). Editorial Committee, three members. It shall have supervision of the literary work of all members of the Mission, and of the work of publication. It shall present a summary of the year's work with recommendations
- (5). Educational Committee, three members. It shall have supervision of the educational work of the Mission, and consult with all members having supervision of schools or normal training classes, as to work accomplished and contemplated.
- (6). Finance Committee, five members, to have general supervision of all matters of finance. This Committee shall appoint from its own members or others an Auditing Committee of three members to audit the Treasurer's and all other Mission accounts and to apportion the grant (see Art. XV.) this Auditing Committee to be responsible to the Mission thro the Finance Committee.
- (7). Examination Committee, six members. It shall examine the junior missionaries annually, act as advisory committee along the line of studies of the junior missionaries, and shall arrange for quarterly examinations during the first two years. It shall notify new missionaries on their arrival, of the course of study and the persons to whose oversight they have been assigned. It shall report to the Mission the names of those who have passed the exminations, and shall report to the Board in detail.
- (8). Rules and By-Laws Committee, three members. It shall receive suggestions for changes in the Rules and By-Laws, reporting upon them to the Mission, shall codify all rules of the Mission as adopted from time to time, and shall seek to state concisely the policy of the Mission on all important points as that policy develops.
- (9). Bible Committee, two members, who shall represent the Mission on the Bible Committee of Korea and shall act as the channel through which the Mission actions shall be brought to the attention of that Committee. The Mission representatives in the capacity of a Mission Committee shall also make an annual report to the Mission calling attention, either as information or as a basis for action on the part of the Mission, to such

matters relating to the Bible Committee of Korea as they shall deem necessary and they shall when necessary make recommendations thereon.

- (10). Estimates Committee, one member from each station. It shall examine all requests for appropriations and make recommendations concerning them to the Mission. (See Manual sec. 44).
- (11). Christian News Committee, three members. Editor-in-Chief and Business Manager not to be eligible. It shall have oversight of all matters pertaining to the Christian News.

B. Annual Committees.

The annual committees shall be appointed by the Chairman at the second business session of the annual meeting, and shall be as follows:—

- (1). On records of Mission and Stations, a committee of two for the Mission, and two for each Station, to see whether all minutes are properly kept and all actions in conformity with the Manual of the Board, and the Rules and By-Laws of the Mission.
 - (2), On statisties, one member.
- (3). On apportionment, one member from each Station, who may be nominated by his Station, to recommend the location of workers, the apportionment of work, and requests for reinforcements.
- (4). On arrangements for the next annual meeting. It shall prepare the program for the annual meeting, have it printed and each Station supplied with copies a month before the meeting.
- (5). On nomination, three members, to make nominations to fill vacancies at regular elections in the permanent committees, presenting two names for each vacancy, nominations to be announced at least one day before the time of election.

C. Special Committees.

By vote of the Mission special committees of any size may be appointed to perform any duties which the Mission may assign to them. Their members shall hold office until the assigned duties are completed and the report of the committee acted upon by the Mission.

ARTICLE IV. STATIONS.

- (1). A quorum shall consist of a majority of the voting members on the field.
- (2). Each Station shall hold regular monthly meetings at which time all orders on the Treasurer shall be read and approved, Board letters read, and the work of the past month reviewed and plans made for the coming month.
- (3). At the first regular monthly meeting after the annual meeting, or at some other time agreed on by the Station, each Station shall elect a Chairman, Secretary, Property Committee, and such other officers and committees as it shall deem wise, and shall at once inform the other Stations, Mission Secretary and the Board if a new secretary is elected. These officers shall perform the duties usually devolving on the same, and the Secretary on behalf of the Station, shall conduct all correspondence not otherwise provided for, and shall keep on file all letters and circulars from the Board, and all other communications to the Station.
- (4). The Station shall approve employment of all native workers who receive their salary in whole or in part from Mission or other foreign funds. This shall include the approval of the individual employed, and the amount of money to be paid from Mission funds. The term "Native workers" in this section shall include all natives regularly employed in evangelistic, medical, educational or literary work.
- (5). The Station shall have charge of all Board property within its territory, as more particularly defined under Article XIII, and shall apportion houses among its various members.
- (6). The Station shall have oversight of the work of all its members, shall see that the work apportioned by the Mission is adhered to, each item in its proper proportion, and shall strive to make the work of all its members a unit in method and policy.
- (7). The Station shall in accordance with Art. XV. apportion the grant among the various items approved by the Board.

(8). A new Station shall remain part of the parent Station until the beginning of the fiscal year for which regular separate estimates are made for it by the Mission, but the Mission may place certain appropriations at the disposal of the new Station before it becomes independent of the parent Station.

ARTICLE V. MISSIONARIES.

- 1. Members of the Mission shall be entitled to vote in both the Station and the Mission after one year of service in connection with the Mission and the passing of the language examinations appointed for the first year, except that married ladies shall not vote.
- 2. Members of the Mission shall be divided into two classes, junior, who have not yet passed their third year examination, and senior, who have passed. Junior missionaries shall not be eligible for service on the Editorial, Educational, Examination, and Apportionment Committees, nor to the Chairmanship of the Mission, nor shall they be allowed to open new Stations.
- 3. All whether voting members or not are under the direction of the Mission and the Station, and may be assigned such duties as the Mission or Station deems fit-

ARTICLE VI. EXAMINATIONS.

- 1. Examinations shall be in charge of the Examination Committee and shall take place at such time as the committee shall arrange. Each missionary shall be examined annually with a written and oral examination until a period of three years has been covered and three examinations have been passed. No missionary—except in the case of married ladies—shall be considered to have passed the final examination (written and oral) until he has passed the oral part of at least two of the annual examinations before the Examination Committee at the time of annual meeting.
- 2. The member appointed by the Examination Committee to have charge of the language study of any particular missionary shall advise with him in the selection of a teacher, counsel with and direct both teacher

and missionary in the prosecution of the study, and shall examine the missionary quarterly until be passes his second year's examinations, reporting on such examinations to the Examination Committee of the Mission.

3. The course of study shall be such as the Mission shall approve on recommendation of the Examination Committee, the same to be printed.

ARTICLE VII. THE COUNCIL AND THE NATIVE CHURCH.

- 1. The organization and government of the native church having been intrusted by the Mission and Board to the Council of Presbyterian Missions in Korea, it shall be the duty of each Station and missionary to carry on all its organizing and governing of the native church in accordance with the rules framed by the Council.
- 2. All actions of the Council or of its committees which pertain to the organization or government of the native church shall be considered binding upon the Mission and its Stations and missionaries, until the Mission declares its unwillingness to accept any particular decision.

ARTICLE VIII. OUTSTATIONS.

- 1. An outstation, commonly called a group, shall consist of at least five adherents, two of whom at least have been received as catechumens, who have met together on the Sabbath for the worship of God for at least one month.
- 2. It shall be our policy to establish strong well manned groups in important central positions, rather than a large number of weak ones, uniting as far as possible in one group believers in close proximity to one another.
- 3 It shall be the duty of each missionary (1) to visit the groups under his charge quarterly if possible, (2) to assign to native laborers under his charge their circuits, and to give them instruction concerning their work, (3) to provide a course of Scripture instruction for each group. As soon as shall be deemed wise, (4) to appoint a leader or leaders for each group and to instruct them in their duties, (5) to lead each group to contribute either

for the support of the native agent laboring among them or of persons laboring in new fields, and to make contributions for the poor and other special objects.

ARTICLE IX. Evangelistic Agents.

- 1 Evangelistic agents are leaders, helpers, colporteurs and Bible women.
- (a) A leader is a native Christian selected by the missionary in charge, who shall take charge of the regular services in the absence of the missionary or helper, and shall have general oversight of the group over which he is appointed. He shall receive no pay for such service, and shall be responsible only to the missionary appointing him.
- (b) A helper is a Christian personally attached to a missionary as his special assistant in evangelistic work.
- (c) A colporteur is a Christian employed for the distribution or sale of books
- (d) A Bible woman is a Christian woman employed for the distribution of Christian literature among women, and in biblical instruction.
- 2. In employing these evangelistic agents, leaders excepted, the Station shall recommend to the Mission that certain persons, their names being given, beemployed in the various capacities. If the Mission gives its consent, the Station may then employ the person approved, they becoming responsible to the Station through the missionaries who have oversight of their labors.
- 3. No Station shall employ or pay any evangelistic agent without Mission approval, except it be temporarily in special cases and the consent of the Mission shall be obtained if it is desired to make his employment, permanent. This must not be construed as hindering the Station from filling any vacancies which may arise between Mission meetings in its staff of evangelistic agents.

ARTICLE X. EDUCATIONAL WORK.

A. Schools.

1. The schools of the Mission now organized or to be organized, consisting of (1) Primary or Parish schools,

- (2) Middle, Boarding or High Schools, (3) Colleges and Seminaries, shall be under the general supervision of the Educational Committee. (Art. III.)
- 2. Primary or Parish Schools: In places where there is a sufficient Christian constituency, primary schools should be organized and supported by the native church, and except by special Mission assignment such schools with their teachers shall be under the direct supervision of the missionary in charge of the district or congregation. In exceptional cases assistance from Board or other foreign funds may be granted, such assistance not to exceed one half the current expenses of the school, but the Mission may remove this restriction in the case of Girls' schools.
- 3. Middle Schools, Boarding and High Schools, Colleges and Theological Seminaries: In any Station where the needs of the work make necessary more advanced education, such schools shall be organized on recommendation of the Mission. They shall be in charge of Principals, and the details of government and conditions of admission, where not laid down by the Mission, together with its native teachers shall be under the direct supervision of the Station through its Educationa! Committee.
 - 4. Teachers in all schools shall be Christians.
- 5. Courses of study so far as conditions of development will allow shall conform to those adopted by the Mission and the Council of Presbyterian Missions.
 - B. Normal Training.
- 1. It shall be the duty of each Station, where the needs of the work make necessary, to provide instruction by classes for the school teachers of its territory, such others being admitted to these classes as the Station shall deem for the good of its educational work.
- 2. The courses to be covered in such classes and the examinations to be given shall, so far as is consistent with the condition of the field, accord with courses adopted by the Mission, it being the purpose in such instruction to raise the standard of scholarship and teaching ability among all the school teachers in the employ of the Mission.

3. Each Station shall formulate its own rules for the conduct of such classes and shall appoint from its members those who shall instruct in them.

C. Theological Instruction.

Until such time as a theological Seminary shall be organized in the Korean Church, the various Stations shall upon the approval of the Mission organize and carry on classes for Theological instruction. The studens to be admitted to such classes shall be those who have been approved as candidates by the Council of Presbyterian Missions, and the courses of study to be pursued shall be those adopted by the Council.

D. Training Classes.

- 1. Each Station shall provide, when its work develops sufficiently, for at least three training classes each year, one for the instruction of the male members of the native church under its care, one for the female members, and one for the leaders and most influential Christians. Each Station shall formulate its own rules and course of study for the classes, but it shall be the endeavor to have as much uniformity in the arrangements of the various Stations as practicable.
- 2. As far as practicable the various Stations shall arrange for interchange of missionaries in connection with these classes.
- 3. Each missionary as soon as the work under his care develops sufficiently shall provide for training classes in the central groups of his work each year, and shall conduct as many of these personally as is practicable, and where impracticable shall put them in charge of competent Korean helpers. These country classes shall be conducted as much as possible in accordance with plans and policies approved by the Station.

ARTICLE XI. MEDICAL WORK.

1. The aim of medical work shall be primarily evangelistic, and all work shall be done with a view to preparing the minds of the people to hear the Gospel with gladness. There shall always be religious truth imparted with the other benefits, and the medical missionary shall

be at the head of all evangelistic work in the hospital and dispensary except where otherwise specially provided by Station assignment.

- 2. Believing that the best evangelistic results proceed from the best medical work, it shall be the policy of the Mission to establish only well equipped hospitals and dispensaries, to be of such a size that one physician shall under ordinary circumstances be able to perform all the medical work required.
- 3. It shall be the Mission's policy to make each hospital and dispensary as nearly self-supporting as possible, and to this end charges shall be made in all cases where the patient is able to pay. These charges shall be based upon the ordinary valuation of the services rendered and the drugs, etc., supplied; but the physician shall take into consideration the ability of the patient to pay' remitting such portion of the charges as may seem to him wise, even to the giving of both services and medicines free.

Foreigners other than missionaries receiving the professional services of the physician, shall pay fees approximating those paid for like services to physicians in the East who are not missionaries.

- 4. Assistants. (1). Where necessary, Korean assistants may be employed in the medical work, preference being given to Christians in their selection.
- (2). Where there are suitable Korean Christians desiring to pursue the study of medicine, such also may be used as assistants, and the missionary in charge shall devote such a portion of his time to their instruction as the the value of their services and the claims of his more direct missionary work will permit. They shall be designated as Student Assistants; they shall contract to remain through such a course of study as the missionary in charge shall designate; and the number assigned to any individual missionary shall be determined by the Mission. In case the missionary in charge shall deem some provision for the support or remuneration of such assistants desirable, he shall present to the Mission a plan covering the students' entire course, and it shall re-

ceive the approval of the Mission before such support is granted.

5. Fees, Gifts, &c. A statement of all contributions and fees received during the Board's last fiscal year from either foreign or Korean sources, shall be made by the missionary in charge in his annual report. They shall be tabulated with the other medical statistics in the general report of the Station under the heads, "Fees, Gifts, &c., from Foreigners," and "Fees, Gifts, &c., from Koreans."

ARTICLE XII. LITERARY WORK.

- 1. All literary work shall be under the direction of the Mission thro its committees: Editorial, Christian News, and Bible Committee.
- 2. The preparation of educational or religious books or tracts shall be under the supervision of the Editorial Committee, who shall make assignment in such a way as will best meet the needs of the work and provide against duplication.

ARTICLE XIII. PROPERTY.

- 1. Everything pertaining to land and buildings belonging to the Board shall be under the direct supervision of the various Stations, which in turn are responsible to the Mission and the Board.
- 2. Any Station shall purchase or sell land or buildings only on the approval of the Mission and the Board. As to deeds, diagrams of land and buildings, see Manual, Section 52.
- 3. Any Station shall erect buildings only after approval by the Mission, and appropriation by the Board, according to plans approved by the Station and Mission Property Committees.
- 4. Each Station shall appoint a Station Property Committee to draw up plans for new buildings in quadruplicate, all 'to be circulated among members of the Mission Property Committee for signature and comment, one copy to be returned to the Station, one to be kept by the Secretary of the Mission Property Committee, one to

be filed with the mission Treasurer, and one to be sent to the Board; also to superintend the erection of new buildings, carry on alterations involving an expense of Yen 100 or more, to have oversight of unoccupied property, walls and drains. Special property committees may be appointed either by the Committee or Station for the oversight of any particular piece of work. These committees shall be responsible to the appointing power and shall report to it on completion of work.

5. Upon the completion of any work assigned to the Station Property Committee, the Station shall audit its accounts and formally receive the building or work, and hold it in trust for the Board. Repairs which become necessary after that date may be paid for from the re-

pair funds.

6. Repairs not involving an expense of 5 Yen may be undertaken by the one occupying or in charge of any property, but such repairs must be approved by the Station before his reimbursement. Other repairs shall not be undertaken except on approval of the Station Property Committee.

7. The term "house repairs" shall be interpreted to mean the renewing or replacing parts of a house which time or accident has made necessary, and also such alterations as do not materially after the plan of the house these alterations or repairs not to exceed 100 Yen in any fiscal year

ARTICIE XIV. REPORTS.

1. Reports of missionaries.

a. Each missionary when present shall make a report to the Station at its monthly meeting of the work done by him since his last report and the Station shall

pass its judgment thereon.

b. Each missionary shall make an annual report to the Mission to be subnitted to his Station, at such time as the Station shall require, of the work done by him during the entire year, and the Station shall pass upon it. Two copies of this shall be filed with the Mission Secretary at the time of annual meeting, one to be forwarded to the Board and one kept on Mission file. 2. Reports of Stations.

a. Each Station shall present annually to the Mission at the first business session of the annual meeting, two copies of the statistics of the Station, on the statistical sheets furnished by the Board, the statistical year being from July 1 to June 30.

The heading "Missionaries" shall include those on furlough. "Unordained Preachers" shall include all male "Helpers." "Teachers" means school teachers only.

"Other Native Helpers" includes colporteurs under the oversight of missionaries

"Outstations. Places of Regular Meeting" means places where at least five adherents, two of whom are either catechumens or communicants, have been meeting regularly on the Sabbath day for the worship of God for at least a month.

"Average Attendance" is that of the main Sunday service for the last quarter of the year.

"Sunday Schools" include only those places which have in addition to the preaching service a Sunday meeting for the systematic study of the Bible; it is not to be considered as a name for a second Sunday service for praise and prayer.

"Other Schools" shall not include gatherings where less than three hours a week are given in instruction in secular branches.

- b. Each Station shall also present each year a general report in print of at least two copies for each member of the Mission of all the work of the Station during the year July 1 to June 30, evangelistic, medical educational, literary and building, with statistics and a statement of any proposed changes in plans or methods, and such other matters as the Station desires to bring before the Mission. Should such a report necessarily include matters which would not be for the edification of the general public, such matters may be omitted from the printed report, and present to the Mission in writing, only two copies being required.
- c. Each Station shall also present to the Mission a report of the monies desired for the next fiscal year for

all purposes, this report to be placed upon the sheets furnished by the Board.

d. All mention of monies in personal or station re-

ports shall be in Japanese currency

3. Committee Reports: Each committee of the Miseion, Permanent, Annual, and Special, shall present a report in duplicate each year to the Mission of all the work it has done, and of all the work over which the committee has supervision, and of the work it deems advisable to be done the coming year.

ARTICLE XV. FINANCES.

- 1. The Finance Committee of the Mission shall apportion the grant among the various Stations and the Mission on the basis of the Board's approved estimates within ten days after the list of approved estimates and grant has been received from the Board; and shall inform the Mission Treasurer and all the Stations of the whole apportionment at once, making the report in detail.
- 2. Each Station shall apportion the grant on its appropriations not later than the first regular monthly meeting after the amount apportioned to it is known and send a copy of the grant as apportioned by it to the Mission Treasurer at once.
- 3. Each Station shall keep a record in detail of the funds drawn from the Treasurer.
- 4. Each missionary or committee to whom funds are intrusted by any Station shall present an annual report in writing of the monies received and expended during the year, this report to be reviewed by the Station and to be subject to its approval.

ARTICLE XVI. MISCELLANEOUS.

- 1. On all points of order not covered by the usual rules of our church judicatories or these Rules and By-Laws, Robert's Rules of Order shall be used by the Mission.
- 2. These Rules and By-Laws may be amended at any meeting by a two thirds vote of the members present.
