AD INTERIM ACTIONS 1909-1910.

The following recommendations of the Executive Committee dated September 14th to 24th, 1909, were approved by the Mission November 18th, 1909. (Delay was caused by actions having been sent to Executive Committee Secretary instead of Mission Secretary.)

- 1.—That Dr. Fletcher be allowed to remain in Chai Ryung two weeks or more to meet the emergency of Dr. Whiting's trip to Japan to meet his daughter.
- 2.—That the funds which may accrue from the sale of the rest house in Hai Ju be used for a rest house in Pyeng San county. Seven negative votes.
- 3.—That Dr. Fletcher be transferred from Won Ju to Andong and that Seoul and Taiku Stations arrange for such temporary residence as is necessary.
- 4.—That we ask the Board for permission to use the money that may accrue from the sale of land in Won Ju for the purchase of a site in Andong.
- 5.-That Mr. Welbon be transferred from Won Ju to Andong. Five negative votes.
- 6.—That the extra house appropriation in Seoul Station be used for a house in Andong. Two negative votes.
- 7.-That the twelve hundred yen appropriation for a Book room in Fusan be used for the purchase of a Station site in Mil Yang.
- 8.-That Mr. Lampe be transferred to Syen Chyun.
- 9.—That Mr. Swallen be allowed to antedate his furlough, but that the date of departure be not earlier than May 16th in order that he may attend the Centennial Conference in Edinburgh.
- 10.—That we recommend that Messrs. Smith, Bruen and Moffett be appointed a committee on selection and purchase of site for Mission compound in Mil Yang.
- 11.—That we request permission of the Board to sell the Sidebotham house in Fusan and use the proceeds for the Mil Yang plant.
- 12.—That we recommend that Messrs. Welbon, Sawtelle, and Fletcher be appointed a property committee for Andong with all the power of a Station property committee. One negative vote.

(September

- 13.—That we recommend that the Executive Committee be clothed with power to conduct all transactions connected with the sale and transfer of property involved in the exchange of territory with the Methodist Episcopal Mission.
- 14.—We recommend that Messrs. Welbon, Sawtelle and Bruen be a committee on selection and purchase of Station site at Andong. Four negative votes.

The Executive Committee recommended the following, October 11-12, 1909, and the Mission approved the same November 22nd, 1909. (Same reason for delay as before).

- 1.—That in view of the statement of Dr. Irvin that he intends to offer his resignation to the Board to date from Jan. 1st, 1910, we concur with the doctor in the same and we ask the Board to allow him six months retiring allowance. Two negative votes.
- 2.—That the use of the one hundred dollars appropriation given by a church in New Jersey for the use of the Girls' School in Fusan be used to cover the deficit on the building.
- 3.—That owing to a misunderstanding the former action No. 7 be changed to read as follows: 'That the money appropriated for a Book room in Fusan be used for the same purpose in Mil Yang.
- 4.—That Messrs. Erdman, Johnson and Smith be a special auditing committee in connection with Dr. Irvin's resignation.
- 5.—As we have been instructed that the Board carries its own insurance, we recommend that the Board be requested to pay the loss by fire in Kang Kei and the Treasurer pay the amount as an emergency, the same not to exceed two thousand yen.
- 6.—That Messrs. Moffett and Lee be a committee on appraising of property turned over to the Methodist Episcopal Mission.

Syen Chyun presented a request by circular letter that Miss Chase be allowed six month's leave of absence from the field, (to date from April 10th, 1910) she to bear her own expenses. The request was approved by the Mission, nine voting in the negative, Jan. 15th, 1910.

The following recommendations of the Executive Committee, dated February 9th and 10th, 1910, were approved by the Mission February, 1910.

1.—That the Secretary be instructed to hand one copy of the agreement on division of territory between us (Pres. Church, U. S. A.) and the M. E. Church and the Australian Presbyterian Church to Dr. Underwood for the purpose of having them printed, and that enough copies be printed so that they can be inserted in the printed Minutes of the Mission.

- 2.—That we advise the Chai Ryung Station to pay the traveling expenses of Mr. Koons between Pyeng Yang and Chai Ryung out of the Chai Ryung itineration fund. Two negative votes.
- 3.—That we recommend the approval of the request of the Chai Ryung Station to exchange with the Korean Church the rest house at Eui Yul for a building better fitted for their purposes, and that they secure a proper deed for the same.
- 4.—That we recommend that the request of Taiku Station that Mr. Adams be granted full salary be approved and suggest that Taiku Station correspond with the Board on the matter. One conditional vote.
- 5.—In view of the fact that the agreement between the Australian Presbyterian Mission and the Presbyterian Church U. S. A. Mission in regard to territorial division has been approved by both Boards, that Messrs. Bruen and George Winn be appointed a committee to effect the transfer.
- 6.—That we recommend that all members of our Mission engaged in the transfer of constituency with the Methodist Episcopal Mission report the number received or dismissed to the Secretary.
- 7.— That we recommend that a record of the details of delimitation of territory not already covered by the general territorial agreement be sent to the Secretary of the Executive Committee.
- 8.—That the Secretary of the Executive Committee be requested to write to the Methodist Episcopal Mission, that, while in the agreement nothing is said in regard to the same, we understand that the lines decided upon are according to the county lines in force up to the time of the beginning of the Japanese protectorate. One negative vote.
- 9.—We recommend that the proceeds from the sale of Pai Chun rest house be used for temporary quarters in Andong.
- 10.—We recommend the re-consideration of the motion to transfer the amount from the sale of rest house in Hai Ju to Pyeng San.
- 11.—We recommend that the proceeds that accrue from the sale of the rest house in Hai Ju be divided equally between the rest house at Pyeng San and Temporary quarters at Andong. Nine negative votes.
- 12.—That we ask the North Pyeng Yang Presbyterial Committee (Tari Wewon) to allow Rev. Chyeng Ki Chyeng of Tchel San to spend

two months helping in the work in South Kyeng Sang Province, said time to be as soon as possible.

- 13.—That the expense of Rev. Chyeng Ki Chyeng's trip, including salary if necessary, be met from funds in Fusan station.
 - 14.—That Mr. Kerr be requested to spend two months helping in the opening of Andong Station, said time to be between the present date and June 1st. One negative vote.
 - 15.—That we call the attention of the Board to the imperative necessity that the vacancy made by the death of Mr. Sawtelle be filled and that Andong and Taiku Stations be requested to write to the Board on the subject.
 - 16.—That the Apportionment Committee's report, Minntes, Page 86, Sec. 14, a, 4 be changed to read, from Syen Chyun, (educational) to Syen Chyun (doctor), this doctor to take the place of Dr. Sharrocks to relieve him for work in the Hugh O'Neill Jr. Academy. The work contemplated for Dr. Sharrocks after the arrival of the new doctor will be in the Hugh O'Neill Jr. Academy and especially, the superintendence of the self-help and Industrial departments, the charge of the school farm, the treasurership of the institution and such teaching as may be carried on in connection with his other work. Six negative votes.
 - 17.—That in view of the following notification of Seoul Station to the Executive committee "that in view of the fact that Miss Shields is finding the hospital work too great a strain upon her and in view of the fact that she desires to be relieved of this work and to be assigned to some kind of work that will not be such a strain, the Station asks the Mission to request the Board to find a substitute for Miss Shields," we recommend the request be approved.
 - 18.—That the World's Sunday School Association's request that May 22nd be observed as World's Sunday School Day be endorsed by our Mission and at this time that members of our Mission give special consideration to the subject of the improvement of our Sunday Schools.
 - 19.—That the extra appropriation Yen 2,352.74 be divided among the different stations as follows:

One negative and three conditional votes.

- 20.—That the use of rent of small plot of ground in the front of the Severance Hospital for Hospital purposes be approved.
- 21.—That all special committees be requested to report to the Chairman of the Executive Committee before the June meeting.
- 22.—Whereas, the emmissaries of the Mormons have been in Korea with the evident purpose of beginning work here, we therefore recommend that Dr. Gale be asked to prepare a phamphlet showing the origin and error of this organization.
- 23.—That the traveling expenses of the Kang Kei women to and from Annual Meeting, as far as the railroad, be provided from the regular fund for Annual Meeting expenses.
- 24.—Whereas, at the last Annual Meeting the Evangelistic Committee recommended the approval of the request of the Kang Kei Station for permission to accept twenty-five hundred dollars (\$2,500.00) from the women of the Oakland Presbytery, California for a Bible Training Class building, and whereas, by an oversight, this was omitted from the property docket, we therefore recommend that this request be included in the said docket, and that the building be considered a memorial to the Rev. Dwight E. Potter.
- 25.—That Dr. Underwood be elected chairman to succeed Dr. Moffett who is to leave Korea in the spring, to take office immediately after the present meeting.
- 26.—That the next meeting of the Executive Committee be held in Pyeng Yang beginning on the afternoon of June 15th.
- 27.—That we urge the Board to send as soon as they can be found, the men and women provided under the Stewart fund.
- 28.—That each station report to the Executive Committee at the June meeting the status of the deeds of Mission property.

On motion of Chai Ryung Station, Feb. 22nd, 1910, the Mission, by circular letter, granted Mrs. W. B. Hunt leave of absence from the field for four months, no expense to the Board being involved.

The following recommendations of the Executive Committee, Feb. 25th, 1910, were unanimously approved by the Mission, March 21st, 1910.

- 1.—Recommended that the official deeds for the Mission property received at the Residency be recorded at the American Consulate.
- The Executive Committee made the following nomination for filling Mr. Lee's place on the Executive Committee until Annual Meeting, i.e. Dr. Avison, Mr. Swallen. Mr. Swallen was elected.
- 3.—Recommended that each station proceed with the greatest expedition possible to prepare a statement of its present and prospective needs, and that any enlargement of the amount asked on last year's Property Docket, or any addition thereto be sent to the Chairman, Dr. Underwood, to be submitted to the Executive Committee.

Also that the Executive Committee be given power to pass on same and arrange the order of preference, including possible change or insertion in the Property Docket and forward the same to the Board.

4.—Recommend that the Board be requested to provide the Mission treasurer with a fire, proof vault.

Note of information, Mr. Bruen was elected to succeed Mr. Lee as Secretary of the Executive Committee.

On the basis of a medical cartificate given by Dr. J. H. Wells, in consultation with Drs. Avison and Hirst, the Executive committee by a vote taken by circular letter unanimously decided Feb. 26th, 1910, to request the Board to give Mr. Lee permission to antedate his furlough.

The following recommendations of the Executive Committee, dated April 6th, 1910, were approved May 1st, 1910.

- 1.—Recommend that in view of the fact that Mr. McFarland's furlough falls due in 1912 and that their child, Ruth, has been ordered home because of sickness, we recommend that the furlough traveling expenses of Mrs. McFarland and child to America, be allowed now, as it is improbable that she will be able to return to Korea before the end of Mr. McFarland's furlough.
- 2.—Recommend that Mr. Crothers be appointed to take Mr. Sawtelle's place on the special committee in charge of property matters in Andong.
- 3.—Recommend that Mr. Erdman be relieved of two weeks of his two months appointment to South Kyeng Sang Province in view of moraurgent needs in his own territory.
- 4.—Recommend that the Board be asked to make good, out of its Fire and Marine Insurance Fund, the loss sustained by fire to the Work

Shop of the Hugh O'Neill Jr. Academy. The loss is estimated at 800 yen.

5.—Recommend that the Board be asked to appropriate a sufficient sum to pay the expenses of Dr. and Mrs. Mills' journey to and from Seoul and of Dr. Fletcher's trip to Kang Kei and back and that the Finance Committee be requested to estimate the amount.

The Executive Committee made the following recommendations, May 10th, 1910, and the Mission approved the same August 18th, 1910. (The Committee did not circulate the actions until late and the Mission Secretary after repeated letters received the last on above date).

- 1.—Recommend that in accordance with the Board's letter of April 2nd, 1910, we instruct the Treasurer of the Mission to pay Mr. Greenfield at the rate of Yen 1,000.00 from April 1st, and further.
- 2.—That we request the Board to make it the regular full salary of a married man, recalling to them the principle that our salary is not wage for services rendered but a mere living and therefore if the house is to be kept open as is planned the full amount given a family is required.
- 3.—Recommend that Mrs. Pieters be permitted to return on furlough now, but that the question of Mr. Pieters' furlough be left until Annual Meeting.
- 4.—Recommend that the question of the non-payment by the Mission Treasurer of the third installment on the Hugh O'Neill Jr. Academy Fund be referred to the Finance Committee.
- 5.—Recommend that we ask the Finance Committee to confer with the Treasurer of the Mission and the Board in New York as to whether cabled appropriations from the Board are to be regarded as instructions to pay.
- 6.—Recommend that the Chairman of the Executive Committee be requested to confer with the authorities as to extra-territoriality and report.
- 7.—Recommend the installment of city water for Pyeng Yang Station be added to the list of present and prospective needs; this item having been passed upon by the Station but omitted by clerical error.
- 8.—Recommend that we reply to the request from Miss McKenzie to be transferred from nursing to evangelistic work, that we recommend that action be deferred until Annual Meeting.
- 9.-Recommend that we regret that Mrs. Sawtelle has decided that she

cannot accept the request of Seoul Station to assist in the Severance Hospital and is leaving for the United States in the near future.

10.—Recommend that the Committee on Work for Lepers be enlarged by the addition of Mr. Geo. Winn and also that the Rev. George Engle of the Australian Presbyterian Mission be asked to act conjointly with the committee.

MINUTES

THE TWENTY-SIXTH ANNUAL MEETING OF THE MISSION.

The Korea Mission of the Presbyterian Church in the United States of America held its opening service of worship on Sunday September 4th, 1910 at 10.30 A.M., in the Chapel of the Women's Academy, Seoul, Korea. Rev. M. W. Greenfield presided. The topics considered were "Sacrifice and Power," and "Into His Likeness;" Rev. C. E. Sharp speaking briefly upon the first subject and Rev. H. M. Bruen, upon the second. Rev. Roger E. Winn and Mrs. Winn sang "Abide With Me."

In the afternoon in the Y.M.C.A. Chapel the Mission listened to an address by Rev. H. M. MacCracken, D.D., Chancellor of New York University.

The Korea Mission of the Presbyterian Church in the United States of America gathered for the opening business session of its Twenty-Sixth Annual Meeting in the Chapel of the Women's Academy, Yun Mot Kol, Seoul, Korea, Monday Sept. 5th, 1910 at 9.00 A.M.

Rev. E. H. Miller the last retiring chairman present, led the devotional exercises and called the meeting to order.

The Minutes being in print, the *ad interim* actions only, were read, and after minor corrections had been made, both were, on motion, approved.

Language Committee.—The Language Committee not being prepared to report, the Mission adjourned for a few minutes to allow the Committee time to prepare its preliminary report. After the recess the Committee stated that it still was unable to report until all papers could be examined and the report prepared.

Election of Officers.—The Mission proceeded to the election of officers, Messrs. Kerr, Genso, Geo. Winn, Crothers, and Dr. Fletcher acting as tellers.

The election resulted as follows :----

Statistical Blank.—On motion, the Chairman was given power to appoint a Committee to revise the Statistical Blank. Messrs. Koons, Roberts, Toms and W. N. Blair were later appointed.

Committee on Arrangements.—The Committee on Arrangements reported through its chairman, Rev. M. W. Greenfield.

- 1.—The time of meeting should be 9.00 A.M. to 12.15 noon, with afternoon sessions when necessary.
- 2.--The place of meeting should be The Women's Academy, Yun Mot Kol.
- 3.—Carfare should be allowed those members not residing or entertained at Yun Mot Kol at the rate of 20 sen per day.

The report was adopted.

After recess, devotional exercises were conducted by Rev. H. C. Whiting, M.D., whose subject was, "Continuing in the Spirit," taken from the instruction regarding the burnt offerings, Lev. 6:8. Dr. R. G. Mills sang the Annual Meeting hymn of last year as a solo. After the devotional exercises, Mr. Miller again took the chair and the reading of Communications and Overtures being declared in order; the Secretary read a letter from Rev. W. Carl Rufus of the Board of Control of the Pyeng Yang Union College and Academy in reference to the securing of an additional professor for the faculty of the institution. The communication was referred to Pyeng Yang Station for action as all matters concerning this institution must be presented directly from the Station to the Mission.

The chairman and officers-elect assumed their duties, Mr. Miller making a neat speech re-presentation of the unique gavel to the new chairman.

Executive Committee Annual Report.—The Executive Committee read its general report which was adopted as follows:

The personnel of your Committee is entirely new. The places made vacant during the year by Messrs. Smith, Lee, Moffett, and Whittemore, were, respectively, filled by Messrs. Bruen, Swallen, Hunt and Sharrocks, leaving Dr. Underwood the only member who sat on the Committee last fall, and of his counsel we are suddenly deprived at this time.

Since its last annual report the committee has carried to consummation several important actions all but consummated at the time of last Annual meeting, notably in regard to the division of territory with the Mcthodist Expiscopal and Australian Presbyterian Missions.

The work of concluding these important territorial agreements was put in charge of the old Committee. That with the M. E. Mission was concluded before Dr. Brown left Korea; the agreement with the Australian Presbyterian Mission was made at Taiku with Dr. Brown present although it was only formally ratified by the Home Boards in February, 1910.

Transfer of work was made with the M. E. Mission in the fall and with the Australian Presbyterian Mission in the spring when finally ratified by their Home Boards.

We regret to report that although all concerned in the transfers were requested to report the exact delimitation of boundaries with the numbers turned ever and received, the secretary has received no report from Whang Hai Province and but a partial one from Pyeng Yang.

The old committee met at Fusan in conjunction with Dr. Brown and communicated to the Board the results of its findings in the Fusan matter. The new committee elected at the last Annual Meeting have held five meetings and have initiated sixty-seven actions, all of which were subsequently approved by the Mission.

Possibly the largest responsibility laid upon this committee was the collating and arranging in order of preference the requests from all the stations for present financial needs as requested by the Board in their special communication of Jan. 15th, 1910. Your committee has appraised, collected, and turned over to the Treasurer, Mr. Genso, the sum of Yen 3,933.58, the value of the property transferred to the M. E. Mission, by the comity agreement with that body.

Such actions of the committee as were referred to the Mission for vote will be found in the Secretary's report of *ad interim* actions.

We would call the attention of the Mission to the letter of Dr. Brown under date of April 20th, 1910, regarding powers of the Executive Committee.

Committee on Work for Lepers:—The following report of the Committee on work for Lepers was read and, on motion, it was adopted and referred to the Rules and By Laws and Nominating Committees :—

The Committee on Work for Lepers begs leave to report that the Leper Asylum has been opened and is now occupied.]

The asylum was completed last October and though great preparations were made for the opening, and many invitations issued, yet on account of the unprecedented rain the occasion was not as successful as it was hoped it would be. During the winter nothing very much was done toward taking in any inmates. But at the Spring Men's Bible Training Class, there was one pitiable leper who attended. This man was the first to be taken in. He with a few others who had come from distant places were sheltered for a short time in a house near the Hospital at Fusan. In March these were removed to the Asylum and have been kept there ever since.

The number of inmates is now twenty. They are receiving as generous aid as can be supplied from a physical stand point. They also receive some instruction in the Bible.

Many of these people have come from very distant places,-one having

September

come from Kyeng Kui Province and having walked the entire distance, although every step caused great pain.

As the Asylum is situated across the bay from Fusan, in order to facilitate the doctor's going and coming a gasoline engine is now on hand but the body of the boat is as yet unbuilt.

Various communications have been held with the Leper Association which fosters this institution, and in order that they might have a better idea of the building, pictures of it were taken and sent to them. A picture of the inmates also was sent.

The Committee has been enlarged by the addition of Rev. Geo. Engle of the Australian Presbyterian Mission and Mr. Geo. Winn. Though the work in the Asylum has but just begun, physical relief has already been given to some few who have no means of helping themselves.

The committee most sincerely hopes that from now on the Asylum will grow to be a most successful institution for feeding, clothing and sheltering these outcasts. Besides these things is the presenting to them of the unsearchable riches of the Gospel which transcends anything which can possibly be done for them in the relief of physical suffering.

The special Committee on Work for Lepers, having now completed the work for which it was appointed, i.e. the ercction and opening of the Leper Asylum at Fusan now begs leave to be discharged to give way to the permanent Committee on the same.

Committee on Deportment in Girls' Schools:—A very interesting verbal report in regard to the book Miss Wambold was instructed by the Committee to prepare on 'Deportment in Girls' Schools, was given. A written statement was read and approved as follows :—

Recognizing that it is a dangerous time for the christian girls in our schools, a Committee was appointed to write out some helpful suggestions. Four ladies from different stations in our Mission were appointed. A set of questions was arranged and answered by each. In addition to the four on the Committee, eight other ladies who have had years of experience in Girls' Schools in Korea and abroad, were consulted.

The result obtained was the result of the answers obtained. All agree that to follow the highest ideal, a girl must be carefully chaperoned, and that in her conduct under the new conditions she is but carrying out the best traditions of the old.

As a christian, she is the daughter of a King; she must have noble qualities within, whose outward manifestation (or clothing) is shown in careful and modest manners. It is christian womanhood which is our ideal, not foreign customs.

The material was put in dialogue form, and published in full in the christian newspaper. The Koreans I have spoken to say that the story is profitable, and that it might be well to have it in pamphlet form.

Committee on Publishing the Twenty Fifth Anniversary Report:—The following report was read, adopted and referred to the General Fiscal Committee :

Immediately upon being appointed, your committee got to work to collect the manuscripts to be printed. This was no easy task for very few of them were in shape for publishing, and those who had them to write were loaded up with seemingly more important tasks. Unfortunately Dr. Gale's manuscript was lost in the mail and for a while it seemed that the report would have to appear without the paper on Literature. Fortunately it just came to the Fukuin Printing Co. in time to go in.

Nearly all the manuscripts were read twice. Very valuable assistance was given by Mrs. McCune while the Committee was itinerating.

At last all the work was done and the finished product was on hand in Syen Chyun Dec. 22nd; reboxed and sent off to the various stations on Dec. 24th.

Two thousand copies were printed of which twenty were cloth bound. The paper bound copies were sold for 22 sen each and the cloth bound copies for 40 sen each. This high price had to be charged because the Mission ordered 400 copies to be given free. As it was on Dr. Underwood's motion that the action was taken, the four hundred copies were turned over to him.

Of the two thousand copies nearly all are sold. About 50 still remain on hand.

The financial sheet will show receipts amounting to Yen 343.18 and expenditures Yen 324.12, leaving a balance of Yen 19.06. The check to the Fukuin Printing Co. was Yen 314.17.

Sec. 7. Recommend that we approve two more Bible women for Chong Ju, one for Mr. Cook and one for the Hospital making a total of four. Passed.

Sec. 8. Recommend that we approve two Bible Women for Chai Ryung. Passed.

Sec. 9. (a) Recommend that we approve one more Colporteur for Chong Ju for Mr. Cook. Passed.

(b) Recommend that we approve of one helper for Mr. Kagin, half salary to be raised on the field. Passed.

Sec. 10. Recommend that we approve two extra colporteurs for Andong, making a total of three. Passed.

Sec. 11. Recommend that we request Syen Chyun church to arrange that their pastor, Yang Tchyen Paik, visit the churches of South Kyeng Sang for two months. Passed.

Sec. 12. Recommend that Taiku Station supply two months itineration in South Kyeng Sang Province. Passed.

WOMEN'S MEETING.

On Wednesday afternoon, September 7, 1910, the women met to discuss together some of the peculiar problems and methods of woman's work, and we believe the suggestive plans and inspiration of that afternoon will make our work better and stronger next year. The success of the meeting was largely due to the fact that nearly everyone on the program was present or sent a substitute or her paper, and to the efficient handling of the meeting by the Chairman of the day, Miss Wambold, and the method by which she stimulated discussion.

Old problems were talked over in new lights. Among them the ever perplexing one of how much time the busy missionary has a right to take for the sightseer. Striking instances were reported of women who found Christ directly through a call in a missionary home till we all agreed with Mrs. Sharrocks that the busy home maker who could not get out to do as much work among the Koreans as she longed for could yet be grateful that God sent the women to her in her home, and receive them gladly from Him.

Notes from Miss Wambold's and Miss Samuel's wide experience in evangelistic work and Miss Snooks' experience in educational work were also a great help. Mrs. Erdman's suggestions on the "Servant Problem" and Mrs. F.S. Miller's and Mrs. Avison's papers on "Our Children" brought more comfort to the missionary whose large service must be within her home.

The only new department of work discussed was the Y.W.C.A. When we were brought face to face with the hundreds of school girls in heathen schools in Seoul and factory girls working side by side with men and boys, absolutely contrary to all Korean custom, at a wage of *15 sen a day, and some of them little girls of twelve, we felt indeed here was a new crucial situation to be faced, and wondered which already overburdened missionary was ready to meet it. A trained college woman from home to come at no expense to us, but to work in harmony with all the churches and through our Korean Christian women is one practical solution.

Appeals from Mrs. Johnson and Mrs. Sharp to a deeper love for each other and Mrs. Whiting's and Miss McKee's pleas to a more consecrated service for our Christ shall surely mean much in real results in the year to come.

Bible Committee :—The following report of the Bible Committee was presented and approved :—

The Bible Committee held two meetings, one on Oct. 13th, 1909, and one on March 22nd, 1910.

The Board of Translators, together with the Chairman and Secretary of the Bible Committee, were appointed a sub-committee to consider:

- 1.—The question of securing a suitable reference Bible in the Korean language.
- 2.—The finding of some means by which the reading of the Korean Bible may be facilitated, such as the breaking up of the printed page into sections, and the introduction of a system of punctuation.
- 3.—The publication of a special edition of Mark's gospel for use in the evangelistic compaign, the cost at retail not to exceed one sen per copy. This action was communicated to the General Council of Evangelical Missions in Korea, urging that each missionary endeavor to enthuse his people to personal work in the distribution of the same. As for the cost of the work, the committee recommended that the Koreans be expected to furnish the funds for such as shall

be used in free distribution, and that the use of foreign money be discouraged.

An allowance to dealers in the Scriptures was determined as follows: Cash payments 500 yen within a year to receive 2% bonus.

and that to booksellers supplying Scriptures on the order of Superintendents and to Colporteurs supported by the Bible Societies, a commission of 5% be allowed on the value of the Scriptures thus supplied.

The Bible Committee requested the agents of the Bible Societies to prepare a reference Bible, using the Universities' Reference as given in the Revised Version.

The Bible Translators, together with the agents of the Bible Societies, and Bishop Turner, were made a committee to decide upon a system of diacritic marks to be used in the proposed Reference Bible.

An edition of the New Testament in mixed Script, No. 6 type, was issued, similar in size of page and form to the Kuk Moon New Testament now in use.

May 29th was named as Bible Sunday, and request made that it be observed throughout the country.

A request was made by Messrs. Cowman and Kilbourne of the Oriental Missionary Society, Tokyo, asking permission to use our text for a marked Reference New Testament.

The Committee decided that permission should not be granted to any Society or individual, to use the scripture text prepared by the Bible Societies working in Korea, until such arrangements have been made as are satisfactory to this committee.

In reply to a communication sent from the Scripture Gift Mission, the Bible Committee answered that the Bible Societies are already getting out Gospels for use in the special evangelistic effort, now being carried on in Korea, and requested that any contribution the Scripture Gift Mission may desire to make for this purpose be sent through the Bible Societies at work here, so as to secure uniformity in the handling of the Scriptures in Korea.

We are glad to report that the translation of the Old Testament is completed and that the final copy is now in press.

We would call the Mission's attention to the fact, that in accordance with the Bible Committee's constitution, our Mission is now entitled to five members on that Committee, in virtue of having more than sixty-six voting members, and we would therefore recommend :

1. That the nominating committee make provision for filling out the number. On motion approved and referred to the Nominating Committee.

2. That the By-Laws be adjusted to make the Mission Bible Committee accord with the provisions of the constitution of the Bible Committee of Korea, members of five years' standing being elected for "five years consecutively, so far as furloughs, etc., with permit," their terms of office expiring in rotation. On motion approved and referred to R. & B. L. Committee.

Medical Committee :—Sections 1 and 2 re-referred yesterday were presented as sections 2. and 3. of their report. Section's 4, 5, and 6, were read. After discussion to strike out part of Section 1 and a motion to refer Section 4 to the Property Committee, the report was adopted as follows :

Sec. 6. We recommend to the Mission that a request be made to the Korean Medical Association to ask the government to recognize the diplomas given by Dr. A. M. Sharrocks of Syen Chyun to six students who have passed the prescribed examination. Passed.

Committee on Mission and Station Records :—The following report of the Rules and By-Laws Committee on Mission and Station Records was read and adopted :

The Committee begs to report that the Minutes of the Mission and Station Secretaries have been examined and approved. There is marked evidence of care on the part of Fusan and Seoul Stations, and equal evidence of carelessness on the part of Kang Kei. For the benefit of future secretaries we submit the following suggestions and criticisms:

1. The Minutes of Kang Kei are very "messy" and without exception are unsigned by the Secretary. As there is no form or clarity, it is impossible to tell where the minutes of one meeting end and the next begin.

2. Chai Ryung has too many orthographic errors to enumerate. The following illustrates the humor arising thereby: "The Property Committee reports that Mr. Hunt has purchased the *sight* of Mr. Sharp's house." Taiku, too, should exercise some care in this matter.

3. Grammatical errors are more than frequent.

4. The minutes of *Taiku Station* have no date for the meeting of about Oct. 1st.

5. The date of approval of the minutes of Aug. 9, 1909 in *Pyeng Yang* was not inserted. We would suggest that those Stations writing "approved" at the end of each set of minutes can improve their minutes by entering this item in the minutes of the following meeting.

6. No mention of opening the meeting with prayer in Chong Ju for Jan. 21st and in Pyeng Yang for several months appears in the minutes.

7. We recommend that the date be written at the top of each page of the minutes to correspond with the date of the minutes appearing on said page.

8. In approving the minutes of the previous meeting, the expressions "previous meeting" and "last meeting" are not definite. The date should be written in the minutes.

9. All "special meetings" are either "called meetings" or "adjourned meetings." The term "special meetings" should not be employed in either of these cases. *Pyeng Yang* at a called meeting on Dec. 27th and again on March 10th transacted business for which the meeting was not called. We question the legality of these actions.

10. No mention is made of those present at the meeting of Jan. 21st in Chong Ju.

11. No mention is made of the reading of the Board letters in Syen Chyun at one meeting, and dates of the Board letters was not reported in many meetings in Chai Ryung, Syen Chyun, Chong Ju, and Pyeng Yang.

12. Monthly orders are entered in too great detail in Kang Kei.

13. Monthly orders do not appear at all in the minutes of Chai Ryung Station.

14. The distribution of the grant was entered in the minutes of Fusan and Taiku Stations only.

15. Korean names have very frequently not been Romanized in the minutes of *Taiku* and occasionally in those of *Fusan* and *Chong Ju*.

16. There is no record of the election of Mr. Winn as Secretary of *Fusan Station*.

17. On March 15th, the secretary of Fusan Station acted as both chairman and secretary.

18. We call attention to other ambiguities or errors as follows: "Girls' School" for Woman's Academy" in the Chong Ju Minutes, "Missionary Ladies' House" and "Presbyterian Single Ladies' House" in the minutes of *Pyeng Yang*. Board letters were received and "read in outline" in *Pyeng Yang*.

19. The meeting of Apr. 2nd in *Chai Ryung* was illegal as there was no quorum, three members out of six being present.

20. We question the right of *Fusan Station* to transfer money appropriated for a well to the installation of water. The matter is a mere technicality but requires the action of the Mission nevertheless.

21. We question the legality of *Taiku's* action of Apr. 4th 1910, electing Mr. Adams to sit in the place of Mr. Bruen on the Executive Committee at its meeting on Apr. 6th. This can be made possible by Mission action but as the rules now stand it is illegal.

22. We recommend that all stations prepare a blank numbered to correspond with numbers of the recommendations sent by the Executive Committee and that votes on these recommendations be entered thereon. The Mission Secretary has found the greatest difficulty in determining the vote on many recommendations, and the Committee has found the same difficulty.

He read two letters one from the christians of the city and one from those of the county. In the few minutes allotted him he presented a strong appeal, saying that he represented ten thousand christians to ask that Rev. N. C. Whittemore and family and Miss Samuels move from Syen Chyun to Wiju.

The letters were, on motion, referred to the Evangelistic Committee to report later.

Time having arrived for recess, business was suspended.

After recess, Mr. R. E. Winn conducted the devotional half hour, his subject being, "Peace." Mrs. Sharp sang a solo.

Evangelistic Committee :—The Evangelistic Committee reported as follows :

Sec. 13. We recommend that the matter of a new Station at Wiju be referred to the Executive Committee to be taken up after Mr. Whittemore's return.

After discussion of almost an hour, this section was re-referred.

Sec. 14. Recommend the following percentages in Class IV. of the grant:

Evangelistic Committee :—This Committee reported on Sec. 13 re-referred yesterday ; and also on Sections 16—21. These sections with the actions taken are as follows :

Sec. 13. Whereas it seems unjust to the Koreans and the missionaries concerned to put off a decision on the Wiju question, until next Annual Meeting, we recommend:

- a. That we do not approve the opening of a separate station at Wiju as yet. On motion this was laid on the table.
- b. That the question of whether we shall ask Mr. Whittemore and others to make their residence in Wiju, though continuing to be members of Syen Chyun Station be referred to the Executive Committee who shall in Conference with Mr. Whittemore make a recommendation to the Mission as promptly as possible giving in full the reasons for and against the same and if the question be decided *ad interim*, it shall require a two-thirds vote of the Mission to pass. Approved.

Sec. 15. We recommend that Mr. Bruen superintend the evangelistic work in So. Kyeng Sang Province this coming year. Approved.

Sec. 16. Recommend that we approve the idea of a Bible institute in Second but that we do not feel that the Station plans are sufficiently matured to warrant the erection of a building the coming year. Approved.

Sec. 17. Recommend that we approve a Bible woman for Mrs. E. H. Miller, making a total of six Bible women in Seoul. Approved.

Sec. 18. Recommend that Miss Taylor's place be filled at this Annual Meeting. Referred to Apportionment Committee.

Sec. 19. Recommend that we approve Seoul's request for one additonal single woman. Approved.

Sec. 20. Recommend the following order for requests for single women: Syen Chyun, So. Kyeng Sang, Chong Ju, Chai Ryung, Taiku, Pyeng Yang, Andong, Seoul. Approved.

Sec. 21. Recommend that the request of Taiku Station to open Andong Station be granted, and the Station be opened according to the Manual, page 29. Approved.

KOREA MISSION.

Andong Station Site :—A motion was passed that the General Fiscal Committee be instructed to arrange the financial budget for Andong Station from the funds already assigned to Taiku and Seoul Stations for the work until the beginning of the new fiscal year.

Educational Committee :—The Educational Committee proceeded with its report, beginning with Section 4. Action was taken as follows :

Sec. 4. In relation to the University and Educational Foundation plan under discussion during the past year, we recommend that the Mission appoint a Committee; that it ask the other Missions to appoint like Committees, and that these Committees acting together, on the basis of the already suggested constitution, draw up a constitution such as they shall agree upon, and submit the same to their respective Missions for endorsement. At the same time they shall prepare and submit to the Missions a scheme for the propaganda of the plan. In this way we believe that the idea can best be embodied and developed, and brought to command the unanimous support of all the Christian forces of the country, and the institution, when established, occupy that position in the system of Christian education in Korea which we hope for it. Approved.

Sec. 5. Resolved, that we draw the attention of the Apportionment Committee to Section 16 of last year's report of this Committee and ask the Apportionment Committee to provide the means by which this promise shall be carried out. Approved.

Sec. 6. We recommend that one of the new men coming this year be appointed to educational work in Pyeng Yang. Referred to Apportionment Committee.

Sec. 7. In regard to Taiku's request for an equipped man for its Academy, this Committee feels that the present man is fully equipped to handle the work, but if for any reason it seems desirable that he should be in other work, we recommend the Apportionment Committee to make such a readjustment of present forces as will meet the need. Approved.

Sec. 8. We recommend that a fourth man be appointed to the educational work in Pyeng Yang College.

In the midst of the discussion, time for recess having arrived, action was deferred until after recess.

The devotional half-hour was conducted by Mr. Crothers whose subject was : "The Worth of a Soul."

Privileges of the Floor :—Business being resumed, on motion the privileges of the floor were granted to Mr. Hugh Miller of the British and Foreign Bible Society, and to Messrs Deming and Taylor of the M.E. Mission.

Educational Committee :—After further discussion on Section 8 of the Educational Committee's report, it was carried. (A fourth man for Educational work in Pyeng Yang).

Time for Adjournment:—Moved and carried that when we adjourn, we adjourn to meet at 2.30 this P.M.

Educational Committee :—The Educational Committee then read further sections of its report, action upon which was taken as follows :

Sec. 10. We recommend that the educational items of the Executive Committee property docket of last spring, in the order of their preference, be the docket which this Committee recommends to the Mission; also the following additional items:

Sec. 12. Recommend that ordinarily the Seoul Medical College be under the supervision of the Medical Committee and report to the Mission through that Committee. Approved.

Sec. 13. Recommend that we call the attention of the Mission to the fact that the *ad interim* action of the Executive Committee recommendation, authorizing the transfer of Dr. Sharrocks from Medical to Educational work, had been, upon full representation of the reasons before them, decided negatively by both this Educational and the Apportionment Committees at the last Annual Meeting, and we would question the propriety of the Executive Committee's taking action in such circumstances. Approved.

Sec. 9. In view of our Board Secretary, Dr. Brown's letter, and the necessity of a decision arising from it, we recommend that the Mission do not for the present undertake a College in Seoul but concentrate its efforts upon our institution in Pyeng Yang until that is reasonably established.

Minority Report :-- We recommend that Seoul Station be given liberty to open College work next April, if the way then seems open to it. Respectfully submitted,

Educational Committee :—Discussion was resumed on section 9 (p. 49) minority report of the Educational Committee. The motion to substitute the mimority Report was lost. The following: "In view * * * * arising from it" on motion, was striken out. Finally, after discussion of one hour and a half the following substitute presented by the Committee was adopted :

"We recommend that the Mission do not for the present undertake a College in Seoul." (Recorded thus by request.)

Rules and By-Laws Committee :—The Rules and By-Laws Committee read a report of changes in by-laws, which the Committee announced would be posted for examination by members of the Mission. Sections 8 and 10 were adopted but action, on other sections was postponed. (See p. 56, 57 for full report).

Medical Committee :—The Medical Committee further reported beginning with section 7, as follows :

Sec. 7. We recommend that the expenses incurred by Dr. Purviance and Miss McKenzie in their trip to and from Andong at the time of the illness of Dr. Fletcher, amounting to Yen 125.49, be paid out of the unappropriated balances. Carried.

Sec. 8. We recommend that Yen 300.00 of the balance in the hands of the General Fiscal Committee be given to Andong Station to provide for the medical needs of the Station for the present fiscal year. Carried.

Sec. 9. We recommend the payment of the extra expenses incurred at Severance Hospital, during the illness of several missionaries, the total amount being Yen 175.50. Carried.

On motion to adjourn, the Chairman called upon Dr. Johnson to lead in a closing prayer.

September 10th, 1910.

The Mission met at 9 A.M. in the Women's Academy Chapel. Mr. Kagin conducted the devotional exercises.

The Minutes of yesterday's sessions were read and approved. A motion to adjourn in order to permit necessary Station meetings was made and carried.

At 10.50 the house was called to order and the chairman introduced Rev. W. E. Blackstone author of "Jesus Is Coming" who conducted the devotional exercises taking as his subject "The Urgency of Whole Hearted Service."

Privileges of the Floor:—The privileges of the floor were granted to Rev. W.E. Blackstone and to Mr. P.L. Gillett, Secretary of the Seoul Y.M.C.A.

A motion then prevailed to adjourn to meet again at 3.00 P.M. and the session was closed with prayer by Dr. Baird.

3 P.M. Session.

Mr. Renich conducted the devotional exerxises, Dr. Johnson leading in prayer.

Resolutions in Regard to Dr. Underwood's Absence :—The following resolutions in regard to Dr. Underwood's absence from Annual Meeting were read and adopted :

C On account of the serious accident which befell Dr. Underwood August 25th, while at Sorai Beach he has been unable to attend this Annual Meeting.

Be it therefore resolved, that the Mission extend to Dr. and Mrs. Underwood its sympathy in this his suffering and express regret that the Mission has been deprived of his counsel, enthusiasm and fellowship at this meeting and that special prayer be offered for his speedy and complete recovery.

Language Committee :---The Language Committee reported the following :

Sec. 1. We recommend that Mr. Erdman be requested to prepare a handbook of Korean that will serve as a help for '1st, 2nd, and 3rd year students.

Sec. 2. During the past year two classes were held for the study of the language, one in Pyeng Yang for one month and one in Taiku for the same length of time. In Pyeng Yang Mrs. Baird taught, giving most valuable help. In Taiku two members of the Committee, Messrs. Gale and Bruen were in charge.

Associate Members having a Vote:—It was moved that we ask permission of the Board to grant the right to vote to Mr. McMurtric of Pyeng Yang and Miss Helstrom of Syen Chyun, associate members, both of whom have passed their first year examination. Referred to the Rules and By-Laws Committee.

Special Class for Language Study:—It was moved and carried that the Language Committee be instructed to arrange a class or classes for first and second year Language students.

Evangelistic Committee :—The following sections of the Evangelistic Committee's report were read :

Language Committee :---The following was presented by the Language Committee and adopted :

We recommend that classes of not less than two weeks for language study be held in Seoul, Pyeng Yang and Taiku at such time and under such supervision as the Language Committee can best arrange.

Privileges of the Floor:—On motion the following were given the priveleges of the floor : Dr. Bell, Dr. Wilson, Misses Martin, McQueen and Graham.

Statistician's Report :--- The report of the Statistician was read and adopted as follows :

Much labor has been given, by myself and others, to gathering and tabulating the Statistics for the past year. Owing to conditions in Pyeng Yang the statistics from our largest Station are only approximate, and under what I believe to be the facts. The Mission totals in the items of membership, etc. are somewhat more than those of last year, 561 more having been baptized this year than, last, and the adherents are, increased by almost 20000, a little more than 20%. The average attendance above a corresponding gain, and the increase in attendance at Bible Study classes is most gratifying, being more than 20%. But the financial items are all less than for the past year of only 11 months.

I recommend that the Mission collect Statistics according to the Board's new rule, i.e. to the end of the calendar year, and that they be published on a single sheet as a supplement to the Mission Minutes, and that the statistics herewith presented be included in the copy of the Minutes sent to the Board and in the one filed with the Mission Secretary, but be not made public.

I wish to acknowledge the kind assistance of Mr. Renich, whose long labors in adding totals and correcting errors alone make possible a report at this time.

Medical Committee :—The Committee reported as follows beginning with Section 10 :

Sec. 10. We recommend that in case the expenses of any serious case of illness among the Missionaries cannot be met by the Station without detriment to its medical work, such claims shall have first call on the unused balances of the Mission after being approved by the Medical Committee. Passed.

Sec. 11. We recommend that the request of Chong Ju Station for a trained nurse be granted. Passed.

Sec. 12. We recommend that the request of Seoul Station that Dr Mills be transferred from Kang Kei to Seoul for work in the Medical College be approved, this transfer to take place after a new doctor has arrived on the field for Kang Kei. Passed.

Sec. 13. We recommend that the Board be asked to send out a physician to take the place of Dr. Mills in Kang Kei. Passed.

Statistical Blanks Committee :—This Committee rendered the following report which was adopted :

Sec. 1. We Recommend: That each station "shall elect before the close of each Annual Meeting a station statistician to serve for one year; These with the Mission Statistician shall form a committee on statistics.

Sec. 2. In view of the fact that the committee, in spite of repeated meetings, has been unable to complete the proposed blank and report it to the Mission, we recommend: That' it be given permission to complete the blank and print sufficient copies to gather one set of statistics.

Sec. 3. We recommend: That the committee be instructed to translate the parts that should be transmitted to the native church and print sufficient copies to gather one set of statistics.

⁽²⁾ Sec. 4. We recommend: That the committee be continued with instructions to gather suggestions for improvements in the blank and make a final report at next Annual Meeting.

Rules and By-Laws Committee :—The Rules and By-Laws Committee report was adopted as read and posted yesterday. It is as follows :

1. That the last sentence of Art. I. 1 be changed to read, "A quorum shall consist of (20) twenty voting members, representing (6) six Stations."

2. That the last sentence of amendment 9 of 1909 be further amended to read: "The statistician shall hold office to the close of the Annual Meeting of the year following his election. His duties shall be to tabulate and report all Mission statistics before the close of said Annual Meeting." This amendment shall be known as Art. II, 6.

3. That the nomenclature of Art. III. be changed as follows: The first A. to remain, the second A. to become B, the B. to become C. and the C. to become D, and under B, the letters to be replaced by figures 1 to 5.

4. That in Art. III. A. 1, after "Taiku" insert "and Andong."

5. That the word "senior" be inserted in Art. III. A. 1, 2, 3, 5, 10, and B. 1 before the word "members" at the beginning of each paragraph.

6. That Art. III. A. 1 before "Its Annual Report" there be inserted "In order to accelerate action on the recommendations of the Committee, the Mission Secretary shall be empowered to declare them carried and forward same to the Board ten days after they have been forwarded by the Committee to the Station secretaries, unless he has received five negative votes or the negative vote of all the members of any Station in the meantime."

7. That Art. III. A. 9 second paragraph be changed to read: "The Chairman and Secretary shall be a sub-committee on apportioning the grant (Art. XV.), and distributing the balances in accordance with the Mission's instructions. This committee shall be "—to the end of the present paragraph.

8. That Art. III. A. 11 be changed as follows: "Bible Committee, five members of not less than five years standing in Korea, on a basis of 66 voting members, who shall represent" etc.

9. That Art. III A. 12 be added: "Publishing Fund Committee, three members to have the direction of funds entrusted to the Mission for publications, all funds to be used in accordance with the conditions under which given."

10. That Art. III. A. 13 be added: "Work for Lepters Committee, two persons to act in conjunction with such persons of the Australian Mission as shall be assigned by said Mission, whose duties shall be to take charge of the 1910]

property of the Leper Asylum at Fusan and in correspondence with the "Mission to Lepers in India and the East "to carry on said institution."

11. That Art. III. A. 14 be added: "Chairmen's Council, to consist of the chairman of the permanent and apportionment committees with a chairman elected for three years. They shall through their chairman make assignments of time and places for committee meetings, in order to expedite business."

12. That Art. III. A. (a) after "three years" insert, "Except the members of the Bible Committee, who shall hold office for five years, all offices expiring in rotation" etc. to the end of the paragraph.

13. That Art. III. A. (c) be changed as follows: "Should a member of any committee except the Executive, Finance, Property, and General Fiscal be absent" etc. to "appoint a substitute." "Members of the Executive, Finance, Property, and General Fiscal Committees going on furlough, or expecting" to "Mission shall fill the vacancy for the unexpired term by ballot, and in case" etc. to the end of the paragraph.

14. That in Art. III. B. "at the second business session of Annual Meeting" be dropped.

15. That amendment 15 of 1909 be dropped.

16. That amendment 13 of 1909 be added to Art. IV. 3 instead of Art. IV. 7 as indicated.

17. That there be added to Art. IV. 3 "He shall also have the Station dockets prepared and present the same to each of the committees concerned before Annual Meeting, and no Station report shall be heard till such dockets are presented."

Committee on Proper Spelling of Names of Places for the Minutes and Reports :—A verbal report was made by this committee, suggesting the same spelling as that used by the Government. By consent of the Mission this Committee with the Secretary was made a Committee on authoritative Spelling of names and places for this year's reports.

Resolutions on Death of Mr. Sawtell :—The following resolutions on the death of Mr. Sawtell were adopted by a rising vote :

Chase Cranford Sawtell was born in Tekamah, Nebraska, November, 1880. He graduated from Bellevue College in 1904 and from the Omaha Theological Seminary in 1907. Knowing the neglected state of missions in South America he volunteered for that field though preferring personally to work in the more encouraging field of Korea.

In October, 1907, he arrived with his wife and took up his work in Korea. A man of remarkably strong physique he gave every promise of a long life of service. Gifted with a rare knowledge of practical things, he was from the first able to do much in carrying on the work of the Station.

In the fall of 1909, when the question of opening a new Station in Andong came before Taiku Station, soldierlike he volunteered for the service. His last work was a long trip to this territory to the opening of which he looked forward so expectantly. On this trip he contracted typhoid fever from which he died unexpectedly Nov. 16, 1910. Scarcely more than two years from the time of his arrival in Korea, in the very beignning of a life of active usefulness he has been called out from the ranks, leaving a widow and infant daughter who have since returned to America. We can but look to his Captain and ours to help us close up the ranks and go forward.

Resolved :—That we, the members of the Mission in Annual Meeting assembled do hereby express (our sense of loss personally, and to the work, in our fellow worker's death.

That we express to his father, to Mrs. Sawtell and Mary Elizabeth our sympathy in their affliction and assure them of our prayers that the presence of God the Father and the comfort of the Holy Spirit may be with them.

That the above be spread upon the Minutes of this Annual Meeting.

Resolutions on the Death of Mrs. Adams :—The committee appointed presented the following resolutions on the death of Mrs. Adams :

The last day of last October, God brought Taiku Station face to face with Himself, in taking away their well-beloved. Mrs. James E. Adams left us early on a beautiful Sabbath morning, to go only a step closer to the Master, in whose presence she ever lived. For her, 'to live was Christ, and to die was gain,' for us, her life and death meant a clearer vision of the Master.

Nellie Dick Adams was born Sept. 15, 1866, in Hamilton, Ohio, and her girlhood was spent in Topeka, Kansas. There she was active in church work, and assistant secretary of the Y. W. C. A. She spent one snmmer, under the auspices of the Y. M. C. A. and Y. W. C. A., but without salary, and without even expenses gnaranteed, in going from city to city, in Michigan, and trying to inspire the churches with missionary zeal. She was naturally so retiring, so distrustful of her own powers; that public service for the Master was at first a great trial to her; it was therefore wonderful to those who knew her in her girlhood years, to see oue of her natural timidity led on step by step to varions forms of christian uscfulness.

It was at a Sninmer Bible School taught by Dr. H. Grattan Guinness, that the idea of becoming a missionary was first brought to her attention. Not long after, a very dear sister went as a missionary to Africa; and from that time, her determination to follow her example in some part of the mission field never wavered. It was a very nataral culmination of the years that had gone before. In preparation for it, she spent one year at Dr. Dawkonnt's Medical Missionary Institute, in New York.

On Dec. 27, 1893, she married Rev. James E. Adams, and in 1894 came with him and their baby boy to Korca, as a missionary. They were sent first to Fusan, and then after two years came 280 *li* inland to Taiku, to face pioneer conditions:—a scanty larder, a doing without accustomed things, a restricted social life further hampered by the necessity of conforming to Korean enston. But she never complained of any thing at any time. She was doing the work she loved, and she was serene and happy as well, under circumstances which most women would consider a cross. And here, often with a child on her knee, she studied Korean, not intermittently, but steadily, persistently, till she could make the women understand the story she had come to tell; and it was because she was early able to make herself understood that she was able to begin and establish the work among the Taiku women, which, as some one has said, is her greatest monument.

A little later, when a nucleus of believers had been gathered out from the darkness, with the joy of one who is realizing her highest hopes, she entered into the work of instructing and transforming, under the guidance of the Holy Spirit, the lives of the Korean women whom the Lord was adding to the church.

From that time on she continued the centre and inspiration of the woman's work in the city and the surrounding country. And, notwithstanding the fact that much of her time was taken up with the teaching of her children who were of school age, she gave regular instruction also in the Academy.

Yet it was in her home that Mrs. Adams was made perfect. No one could see her there without being impressed by the pervading spirit of true hospitality, the mutual helpfulness and sweet companionship between mother and children. The same spirit which made her home life beautiful, made her a power among the Korean women.

To missionaries old and new, her home always meant cheer and sweet companionship and wise counsel. A mind at peace with itself ever meant peace for others. "She rested me," was our united verdict.

Of her charms of person-her lovely face and smile; of the strength of her character-her lave and courage and persistence; and of her, Christ filled life-all who knew her bear loving witness. Korean and American must ever know God better because He lived among us in the heart of Mrs. Adams.

Resolved :—That we, the members of the Mission, in Annual Meeting assembled, do hereby express our own sense of loss upon her death.

That we convey to Mr. Adams and the motherless family as well as the friends in America, our heart-felt prayers that they may be comforted of God.

Sec. 12. We recommend that E.H. Miller be transferred to Pyeng Yang for one year. The motion to adopt was lost. (Recorded by request.)

It was then moved and carried that the matter of filling Pyeng Yang vacancy be again referred to the Apportionment Committee.

Time for adjournment, having arrived, discussion was suspended.

After intermission Mr. Roberts led the devotional half hour, his subject being "Giving Him the pre-eminence."

Dr. W.W. White's Conference on Bible Study:— A communication from the pastor of the Seoul foreign Community was stated in regard to Dr. White's arrival. We were urged to attend the conference.

Resolutions on the Death of Mrs. M. Willis Greenfield :—The Committee appointed to present resolutions on the death of Mrs. M. Willis Greenfield reported as follows :

Our all-wise Father has, during the past year, seeu fit to call home to Himself Mrs. Greenfield. We cannot understand the Providence which thus took from our midst so capable and so needed a worker one who was just entering so enthusiastically and with such promise upon her work. But we know that our God doeth all things well, and that His ways are past finding out.

Even in our sorrow and keen sense of loss to ourselves and the work, we can but rejoice in the memory we cherish of her beautiful character and in the influence and inspiration that remain to all that knew her.

All who came within the sphere of this influence felt that she was preeminently a daughter of the King, loyal to her Master, devoted to her duty, entirely unselfish in her consideration for all about her, always cheery and

sunny, always seeing the best characteristics in her fellow workers and over looking their faults, a free dispenser of hospitality in her home. Surely as we contemplate her life, our own must be the nobler and truer, and as we contemplate her death, our faith in God, and a future life of reunion and activity and joy in His presence must be strengthened and purified.

To the husband and father in his deep sorrow we extend our sympathy with a prayer for blessing on the little son left motherless.

Sec. 30. Having heard Rev. W. E. Blackstone present the work of the "Distribution Fund" for the circulation of the Scriptures in China, we, the missionaries of the Korea Mission of the Presbyterian Church, U. S. A., assembled in Annual Meeting at Seoul, September 12th, 1910, wish hereby to express our approval of the plan and especially commend the Picture Portions with a brief statement of how to be saved, to be issued by this Fund. And it is unanimously resolved that we hereby request Mr. Milton Stewart, the founder of the Fund, to kindly furnish us one million copies of the Picture Portions for distribution in Korea, and we pledge ourselves to end-eavor to secure as wide a distribution as possible, especially among the unreached multitudes of the Korean people.

We recommend that this matter be referred to the Publishing Fund Committee with authority to proceed alone or to arrange with the General Council for such publication and distribution. Approved.

Sec. 13. Whereas in seems unjust to the Koreans and the missionaries concerned to put off a decision on the Weju question until next annual meeting we recommend :-

a. That we do not approve the opening of a separate station at Weju as yet. Laid on the table.

b. That the question of whether we shall ask Mr. Whittemore and others to make their residence in Weju, the continuing to be members of Syen Chyun station be referred to the Executive Committee who shall in conference with Mr. Whittemore make a recommendation to the Mission as promptly as possible giving in full the reasons for and against the same and if the question be decided ad interim, it shall require a 2/3 vote of the Mission to pass. Passed.

Sec. 29. That Mr. Ross be allowed to use Yen 300.00 for a rest house in Nong Chun county. Approved.

Sec. 30. Having heard Rev. W. E. Blackstone present the work of the "Distribution Fund" for the circulation of the Scriptures in China, we the missionaries of the Korea Mission of the Presbyterian Church U. S. A. assembled in Annual Meeting at Seoul, September 10th, 1910, wish hereby to express our approval of the plan and especially commend the Picture Portion with a brief statement of how to be saved, to be issued by the Fund. And it is unanimously resolved that we hereby request Mr. Milton Stewart the founder of the Fund, to kindly furnish us one million copies of the Picture Portion for distribution in Korea and we pledge ourselves to endeavor to secure as wide a distribution as possible, especially among the unreached multitudes of the Korean people.

That this matter be referred to the Publishing Committee with authority to proceed alone or to arrange with the General Council for such publication and distribution.

MEDICAL COMMITTEE.

Sec. 1. We recommend that we reiterate the request of previous years for a doctor whose duty it shall be to take charge of medical work in stations whose doctors are absent on furlonghs, and that we request the Board to carefully explain to the candidate the nature of his work. We further urge that this doctor be secured if possible before the beginning of Dr. Whiting's furlough falling due on July next.
