### 6105 Counseling

#### Purpose

 To give formal notice to a Marine on adverse behavior or event which may limit future military service.

#### Required prior to Separation

- Parenthood
- Condition not a Disability
- Personality Disorder
- Unsatisfactory Performance
- Misconduct = MDI and POM
- Weight control
