OPR: J-33 OCR: AF/ILSP

Status: DLA retention policy provided to AF/ILGP 11 Feb 02 and responded to OO-ALC request for retention of all A-10 Class IX items thru 2028. DLA agreed to block all disposal actions on active A-10 items in our WSSP through 31 Jan 06. Will review in 2006 to determine if freeze is still required.

AF/DLA 01-6: AF/ILG briefed DLA-D and AF/IL on A-10 IPT updates by the end of February.

OPR: AF/ILG OCR: J-34XAF/ILSP

Status: AF/ILGP continues to coordinate actions with DSCR and J-34. IPT convened at DSCR in conjunction with Aviation Conference in Oct 02. Follow-on meeting planned for Apr 03.

AF/DLA 01-7: DLA compare Aviation Investment items with AF Readiness/AWP drivers list on the A-10 and provide feedback to AF/ILG.

OPR: DSCR-R OCR: ILGP

Status: DSCR completed the analysis. Analysis was sent to AF/ILGP on 5/30/02. For each of the NSNs in the A-10 and TF34 matching the AIS item Population, the total sum of safety level for AIS Target Years 00-02 was \$31.4M, total sum of obligations \$27.9M, and total sum of receipts \$15.6M.
