MEMORANDUM FOR SUPPLY PROCESS REVIEW COMMITTEE (PRC) MEMBERS

SUBJECT: Approved Defense Logistics Management Standards (DLMS) Change (ADC) 1111, Revise Procedures for Intransit Control of Materiel Turned In To DLA Disposition Services and Establish use of the DLMS 527R for a New Disposition Services Turn-In Receipt Acknowledgement (TRA) Transaction (Supply/MILSTRIP)

The attached change to Defense Logistics Manual (DLM) 4000.25, Defense Logistics Management System, DLM 4000.25-1, Military Standard Requisitioning and Issue Procedures (MILSTRIP), and DLM 4000.25-2, Military Standard Transaction Reporting and Accountability Procedures (MILSTRAP), is approved for implementation on a staggered basis by the DOD Components. **DLA Disposition Services (Distribution Standard System) will implement this change immediately**. The **Supply PRC representatives for the Services and DLA Enterprise Business System, must actively monitor for implementation of this change and advise the Defense Logistics Management Standards Office (DLMSO) of implementation dates when known**. The goal is full implementation by all DOD Components within 3 years of the date of this memorandum. The updated DLMS implementation convention will be posted to DLMSO Web site at <u>www.dla.mil/j-6/dlmso/elibrary/TransFormats/formats.asp</u> within 10 days from the above date.

- New automated DLA-DS Turn-In Receipt Acknowledgement (TRA) transaction.
- TRA transaction is systemically triggered by processing DLA-DS Field Office when processing disposal turn-in documents (DTID) receipts into DSS.
- The new DLMS 527R TRA is confirmation that DLA Disposition Services field offices processed a receipt for the materiel turned in by DTID into the DSS.
- DOD Component customers would use the new DLMS 527R TRA transaction to document that DLA Disposition Services processed a Receipt transaction for the materiel to DLA Disposition Services ownership to close out the DOD Component customer's intransit property records.
- **NOTE:** TRA does not apply to materiel turned in to DLA Disposition Services via the Recycling Control Point (RCP)




