Green Momentum - What is it?

Electronic Stewardship (E-Stewardship)

Affirmative Procurement Program (APP)



- Greening the Government Executive Orders
- EO 13101, Greening the Government Through Leadership in Waste Prevention, Recycling, and Federal Acquisition
- Purpose of APP: Increase Federal Procurement of Products Made With Recovered Materials to Conserve Energy and Natural Resources
- Goals of Electronic Stewardship: Reduce overall environmental and energy impacts of the use and disposal of electronics across the government
- "Finite" natural resources...long term economic, environmental, and societal benefits

- We're doing some good things...
 - Environmental attributes in FLIS
 - Established Affirmative Procurement Programs
 - Built E013101 requirements into DoD 5000.2 (R)
- ...but we're not where we need to be
 - RCRA 6002 compliance:
 - Maximum purchase of items with recovered materials
 - Verification procedures for recovered material certifications
 - Annual review/monitoring of APP effectiveness
 - EO13101 compliance:
 - Delineation of responsibilities: Env & procurement personnel
 - 100% of purchases meet EPA guidelines, unless justified
 - Report progress to the FEE/President (biennial report)
 - Electronic Stewardship: No legal/EO driver
 - Building Federal plan
 - Teaming with WH Task Force, industry, procurement officials



Federal Challenges: Electronic Stewardship

Goals:

- Develop government-wide strategy to help reduce the life cycle environmental and energy impacts of the use and disposal of electronics assets across the government
- Promote growth of the infrastructure for the reuse, demanufacturing, and recycling of obsolete electronic assets, nationwide

Key Short-term Steps:

- Build a team environmental, electronics, and acquisition experts from government and industry
- Define E-stewardship attributes
- Issue acquisition guide for "critical" attributes

Longer-term Steps:

- Change A11 (IT capital planning and investment)
- Develop E-stewardship FAR clause
- Possible new EO...or logical part of EO13101?



DoD Challenges: Affirmative Procurement

Givens:

- RCRA 6002 isn't going away
- No apparent effort to amend or rescind EO13101
- Misperception that APP and Electronic Stewardship are "environmental" programs
- Misplaced or poorly defined accountability
- Establishment of solid, consistent APPs
- Executable process for APP measuring and reporting
 - Issues: Report format and content; external leadership expectations versus internal management needs
- Most importantly... Meet all these challenges without over-burdening our people in the field

So....how do we plan to meet these challenges?



- Engage leadership and establish vision: DoD will build the most effective APP in the Federal government
- Make effective use of tools new and old
 - Policy/Strategy
 - People: Procurement, environmental, spec-writers
 - Programs: APP, awareness training
 - Unique capabilities of sources of supply (DLA, GSA)
- Information management systems: DD350 and Federal Procurement Data System (Draft metrics)
 - Audits: Contract and environmental compliance audits
 - Management structure: DoD In Progress Reviews, EO and RCRA annual reporting requirements
- Leverage other initiatives: Environmental management systems



Proposed Application of Systematic Management to

Develop DoD APP strategy Plans Establish agency-level APP goals and objectives Clearly define responsibilities for all key personnel: procurement, environmental, spec-writers Link to RCRA and EO13101 requirements Do Develop and implement "performance" measurement and reporting process" DD350/FPDS + Item-specific reporting using DLA/GSA capabilities Awareness and government credit card training programs Emphasize "local" leadership involvement and management Check Beef-up environmental/contract audit programs to address APP "system" Incorporate APP in DoD "EQ" In-Progress Reviews and equivalent "DP" reviews - ensure feedback



- Next 90 days: Issue USD(AT&L)DP and ADUSD(E) guidance on use of DD 350/FPDS for APP data tracking
- Next 180 days: Develop and issue DoD strategy document
 - Goals, objectives
 - Structure, Responsibility, Accountability
 - Performance measurement
 - Reporting
 - Auditing
 - Management review
- Coming year(s): Institutionalize in DoD policy and training/education programs (including DAU)





Electronic stewardship makes sense...and aligns logically with APP and EPP objectives

Possible add to FLIS "environmental attributes?"

- APP is here to stay...we're building a "smart" approach to compliance and continual improvement
- New measurement and reporting process evolving
 - DoD advocating systematic approach with item-specific data limited by DLA and GSA capabilities
 - Other agencies and leadership expectations vary
- Success with APP depends on effective system emphasizing accountability, training, *local* performance measurement, oversight, and feedback




