The privatization contracts include: Chemical, Petroleum, Oils and Lubricants (SAIC), Gases/Cylinders (HGI), Gases/Cylinders Europe (IG&S), Gases/Cylinders Centcom (ISS), and Closed Loop Re-Refined Motor Oil (Safety-Kleen). This IST is responsible for related administrative and post-award functions.

All administrative, pre- and post-award functions for kitting commercial procurements are also a part of this IST. These procurements consist of made-to-stock kits. Kits contain multiple components which may be part numbered or NSN components and are both DLA- and non DLA-managed items. Kits are tailored to meet customers need and may contain sub-kits.

IST members perform a variety of functions such as procurement, technical/quality assurance, and chemical review.

- Cylinder Details: dimensions, service pressure, capacity (i.e. 244 cf) and valve if any exception applies (i.e. 9"X 51" DOT3AA2015 recommended for better service (DLA standard cylinder)
- Monthly Demand in Cylinders (i.e. 5 Cylinders/Month)

Industrial Gas Challenges vs. DLA Solution

- Cost of Industrial Gas on local market
 - DLA Aviation price is significantly lower than local market pricing
 - DLA Aviation charges the customer for the gas only
 - Transportation cost, cylinder cost, and refurbishment costs are paid for by DLA Aviation
- Challenge of storing local (contractor owned) empty bottles
 - DLA Aviation has a contractor in Belgium who coordinates pick up of DLA owned empty bottles from customer sites
 - Call (877)352-2255 or Tel (+32) 3 860 95 60 to coordinate pick up of empty cylinders
- Challenge of refilling local (contractor owned) empty bottles
 - DLA Aviation offers a cylinder exchange program where the customer turns in empty cylinders and receives a full one in exchange
