- Supplies the Nation’s military services and civilian agencies with critical resources needed to accomplish their worldwide missions.
- Provides wide-ranging logistical support for peacetime and wartime operations, as well as for humanitarian missions and emergency preparedness.
- Headquartered in Fort Belvoir, Virginia is supported by network of field activities, business units and service activities.
  - DLA manages 5.2 million items in eight supply chains
  - \$36 Billion annual sales/services
  - Ranked number 58 in the Fortune 500 (above Sprint Nextel)

**DLA’s Strategic plan includes a goal to “Increase revenues by 25% on environmental products and services by 2011.”**

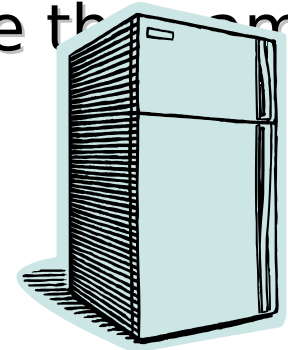

## What is buying Green?

**Green Procurement** – making the right decision to purchase cost-effective, mission-enabling and environmentally preferable items.

**Environmentally Preferable** – “Products or services that have a lesser or reduced effect on human health and the environment when compared with competing products or services that serve the same

## Why buy **green**?

- Comply with Executive Orders and DOD directives
  - Federal laws, regulations, Presidential Executive Orders and recent DOD Green Procurement policy call for increased procurement of “green” products
- Promote environmental stewardship
  - Conserve natural resources
- Reduced operating and maintenance costs
  - Hazardous material handling
  - Reduced disposal costs
- Reduce the hazardous waste stream
  - Eliminate part of the 2.6 billion pounds of toxic chemicals released each year in the US.

## Get the green...

- Products that meet DLA's Approved Environmental Attributes are highlighted in the DLA Federal Catalog system by the ENAC
- Customers can purchase "green" products through the DLA Federal Catalog System or DOD EMALL
- Products meeting one, or more, of the approved environmental criteria, or attributes, will be highlighted by a "green" tree symbol.
- Signifies that a product meets strict, definable environmental standards and criteria from an approved certifying organization
- Currently applied to roughly 7000 items managed by DLA and GSA

## Re-refined Lubricating Oil

### – Basic Re-refined Oil Program

- API certified oil in your choice of 5W-30, 10W-30, 15W-40, 30 and 40.
- No minimum orders.
- Packaged in Quarts, 5 Gallon Containers, and 55 Gallon Drums.
- World-wide delivery from Vendor to Customers

### – Closed Loop Re-refined Oil Program

- API certified oil in your choice of 30, 40, 10W-30 and 15W-40
- Small minimum orders.
- Includes pick up of your used oil for re-refining.
- CONUS delivery of packaged and bulk products, available in Quarts, 5 Gallon Containers, 55 Gallon Drums, and bulk deliveries.

## Reclaimed Engine Coolant

- Conforms with EPA guidelines
- May be purer since recycling process reduces chlorines from hard water
- Army – use recycled only, DLA to do automatic substitution

## Remanufactured Toner Cartridges

- Used in laser printers, photocopiers, fax machines, and microphotographic printers
- When the toner is replaced, the cartridges can be returned to the manufacturer to be refilled, refurbished, and cleaned for resale.

## Battery Consignment Program

- Contract awarded December 2004 services all 50 states - current contractor is Exide
- Direct Vendor Delivery for sites **using 120 or fewer** per year - order on as needed basis through MILSTRIP
- Consignment of 30 day supply for sites using **120 or more** per year - over 200 sites - requires application
- Advantages - no inventory investment, no servicing risks, spent batteries picked up at no charge for recycling, diversion from base waste stream

## **Heavy Equipment Procurement Program (HEPP)**

- Supports the acquisition of over 2,400 “commercial type” heavy equipment products
- Equipment for environmental functions:
  - Balers
  - Crushers
  - Compactors
  - Shredders
  - Recycling equipment
  - Hazardous storage facilities

## Energy-Efficient Lighting

- Online energy efficient lighting catalog
  - Over 5,000 lighting items
    - compact fluorescent
    - high-pressure sodium
    - metal halide
    - low mercury fluorescent
  - From 200+ suppliers/manufacturers

## Bio-based Fuels

- Biofuel use reduces regulated exhaust emissions, decreases petroleum imports
- Biodiesel, mono-alkyl esters of long chain fatty acids derived from vegetable oils or animal fats IAW ASTM D 6751, for use in diesel engines.
  - **Most Popular: B20**, a blend: 20% biodiesel & 80% low sulfur diesel fuel
- **E85**, a blend of 85% ethanol and 15% gasoline
- Driven by the **Energy Policy Act (EPACT) of 1992** and **EO 13149: Greening the Government Through Federal Fleet and Transportation Efficiency.**

- Assists Federal Government personnel who handle, store, transport, use, or dispose of hazardous materials – EPA, OSHA, DOT
- Online web or CD-ROM
- Includes value-added info by Service-agency focal points: HAZCOM warning label & transportation info
