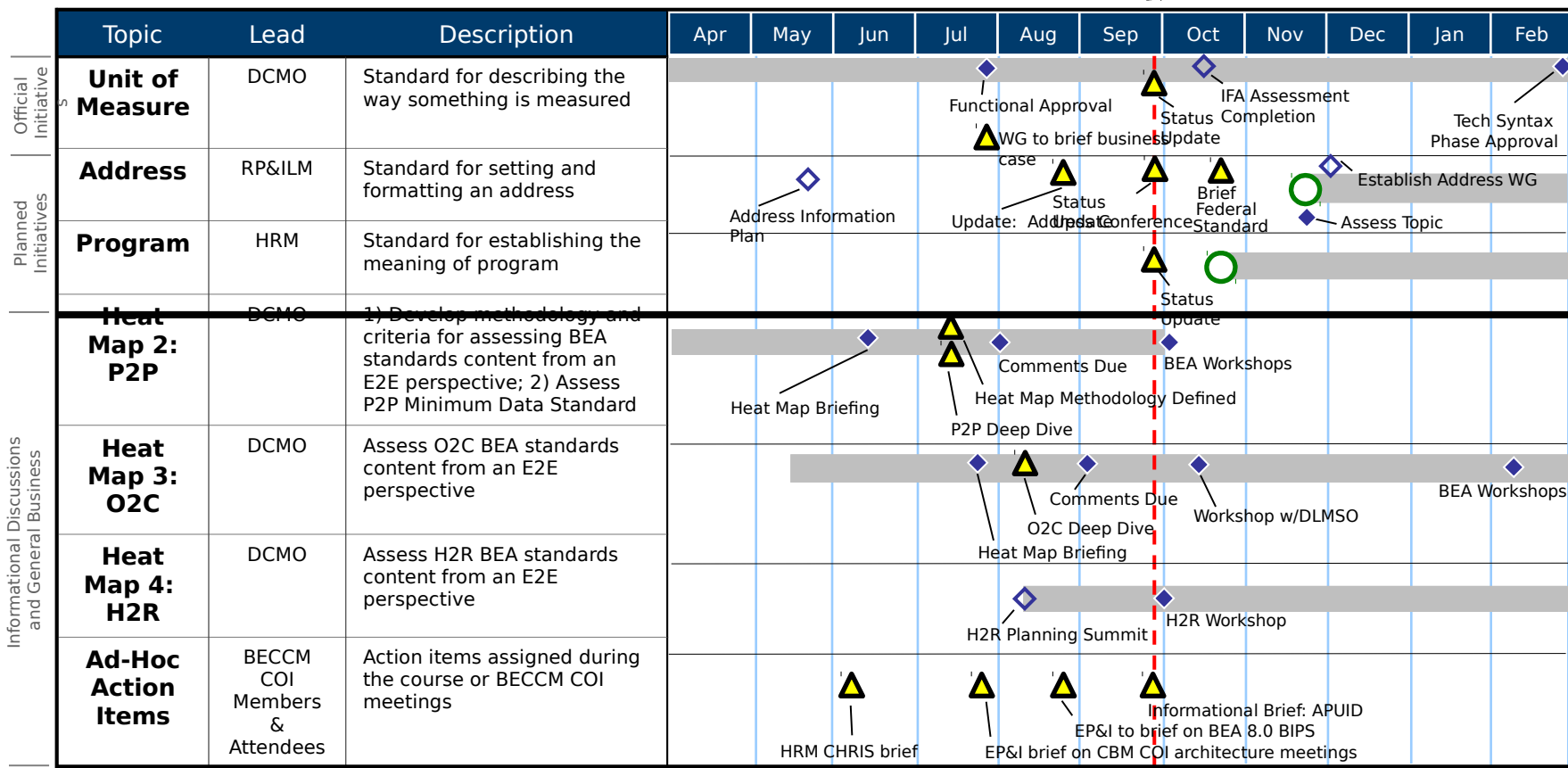

# Current Status

- **Numerous applications have been identified that use various address related attributes**
  - **Purpose is to identify all DoD Communities of Interest (COIs) with a major stake in address standards**
- **Holding introductory discussions with those COIs identified as having a major stake in address standards**
  - **e.g., Military Postal Service Agency, Distribution Data COI, Emergency Services COI, etc.**





# Next Steps

- **Schedule the leader of the draft FGDC standard workgroup to brief the BECCM COI in October**
- **Continue preparation to formally present topic to the BECCM COI in November**
  - **BECCM COI to decide whether to establish a working group or not**
  - **Initial drafts of the following will be presented for comment and review**

    - **Problem statement**
    - **Proposed objectives**
