WHAT IS TD2?

<u>Products-based approach to costing; linked to standard</u> <u>work effort</u>

- Identifies what product is required, what must be done, and the work standard to be applied.

 HQDA, G3
 Sponsored
 Model
- Prices relevant, credible, and mission relationsts.

Comprehensive and integrated system of system

- Combines training and doctrine dever interface requirements into one model to ITRM
- Links funding to TD/DD product management.
- Spans the PPBES timeline.



HQDA validates and programs funding





Purpose

SCHOOL:

- Identifies products to be worked (FMs, MTPs, etc.).
- Assigns manpower against products.
- Identifies cutoff where workload exceeds available resources.
- Identifies products which cannot be completed by priority.

TRADOC:

- Identifies total TD workload by FY.
- Justifies to DA what can and cannot be accomplished with current resources.
- Justifies requirement for additional TD funding.

DA

Can defend validation/funding additional requirements.

Training and Doctrine Development Management System (TD2)

Training and Doctrine Development Management System (TD2) is the interface system that allows users to identify training and doctrine development products, establish corresponding workload effort, develop a work plan, and assign personnel assets to specified work. The system calculates the work effort in accordance with established, certified labor rates per type of product over each year of the POM cycle. TD2 generates the workload requirements for HQDA, G3 and the corresponding input files for costing in the Institutional Training Resource Model (ITRM).

Access is controlled by HQ TRADOC in the form of user IDs and passwords. Please login below or request a User ID and Password from HQ TRADO

- Contracting Officer Representative (COR) justification required for release of data.
- COR must e-mail justification to TD2 functional proponent, Roland Thompson (roland.thompson@monroe.army.mil).

Sample Report

- Generates a variety of reports to determine workload requirements.
- Shows total number of products by type (FM, STP, MTP, etc.) by FY.
- Shows total man-years required by FY.
- Shows what can/cannot be accomplished with available resources by priority.

QA Impact

- Ensure school is inputting workload.
- QA tool for QA managers.
- Identifies total TD workload.
- Identifies how TD manpower is being used.
- Identifies shortfalls and impact to the Army.
