# Proponent Initiatives Affecting TASS

- 91W10, Health Care Specialist Course (reclassification)
  - Approximately 18 months long
  - 4 Phases
  - Phase 1 and 4 POIs and equipment lists submitted to USARC for review (Feb 02)
  - Phase 2 and 3 POIs under development with projected submission to USARC for review in May 02
  - RC projected implementation in 3<sup>rd</sup> or 4<sup>th</sup> Qtr FY 03



# Proponent Initiatives Affecting TASS

- 91D10, Operating Room Specialist Course
  - Current course POI closure on 31 Dec 02
  - Revised course under development with projected implementation of 1 Oct 02 (FY 03)
    - CAD at USARC for review (Feb 02)
    - Two 2 Week ATs increased to two 3 Week ATs



# Proponent Initiatives Affecting TASS

- 91WM6, Licensed Practical Nurse Course
- Current POI through FY 04
- Task Selection Board held Sep 01
- Increased emphasis on critical care
- CMP and LP revision conducted 13-15 Mar 02 with the RC





# Installation Support to TASS

- Last priority for AT dates, location, billets, transportation, and equipment
- Only Region F conducts AT at proponent installation
