MEMORANDUM FOR: THE RECCD

SUBJECT : Addendum to Subprojects 9, 26 and 28

1. The purpose of this addendum is to set forth the mutual administrative responsibilities of the contractor and sponsor.

C 2. The above subprojects represent the research program of [REDACTED] financed under MKULTRA, covering the period of 9 June 1953 through 30 June 1955.

B 3. [REDACTED] has requested the Universities to submit to them a summary accounting of monies received from B [REDACTED]. Also, they requested the return of any unexpended B funds received under a grant from [REDACTED]

4. Title to any permanent equipment purchased by funds granted the University shall be retained by the Universities in lieu of higher overhead rates.

5. It was mutually agreed that documentation and accounting for travel expenses which are reimbursable by the University shall conform with the accepted practices of that Institution.

6. It was agreed that technical reports reflecting the progress of the research program shall be submitted at mutually acceptable intervals.

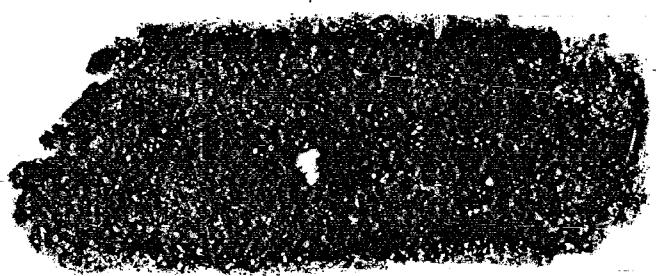

MEMORANDUM FOR THE RECORD

SUBJECT: Project MKULTRA, Subproject 26

A 1. The scope of Project MKULTRA, Subproject 9 has been enlarged to include the research work engaged in by TSS/CD staff-member [REDACTED] recently transferred to the [REDACTED] area.

B 2. The purpose of Subproject 26 is to provide funds for this increase in scope of Subproject 9 for the 6 months period beginning 18 February 1954 as indicated in the attached proposal from [REDACTED] C Chief Investigator of Subproject 9.

C 3. The funds involved will be made available to [REDACTED] through [REDACTED] acting as cut-out. The cost of this service will amount to 4% of the total proposed budget, or \$183.92. The total cost of Subproject 26 for the 6 months period beginning 18 February 1954 will not exceed \$4781.92.

During the past few months the emphasis of studies on drugs has shifted from sternutatory drugs to drugs which may aid in the treatment of the schizophrenic patient either by altering metabolism or producing sedation.

A [REDACTED] has been with us since December 1, and has tried many of these drugs in human volunteers. In order to expedite the research he has offered these subjects \$5.00 to \$10.00 per trial for each drug. This, plus other elaborations of our research program will cause us to incur a deficit if we continue spending at our present rate.

We, therefore, wish to request additional funds at the half year mark, namely: February 18, 1954. These needs can be itemized as follows:

Stipends for volunteers. 200/mo. x 6 = 1200.00

C Travel of Doctors  
[REDACTED] 30/mo. x 6 = 180.00

C Assistance of [REDACTED]  
(Neurosurgeon) 400/mo x 7 = 2800.00
