MEMORANDUM FOR: THE RECORD

SUBJECT : Addendum to Subprojects 5, 25, 29 and 49.

1. The purpose of this addendum is to set forth the mutual administrative responsibilities of the contractor and sponsor.

2. The above subprojects represent the research program of [redacted] financed under MKULTRA, covering the period of 1 September 1953 through 30 June 1956.

3. It was agreed that [redacted] the principal investigator, would submit annual informal summary accountings covering the entire period of the program. It is understood that upon completion of the research program any unexpended or surplus funds advanced [redacted] would be returned to the sponsor. Also, the [redacted] has requested the [redacted] to submit to them a summary accounting of monies received from the [redacted]. They also requested the return of any unexpended funds received under [redacted].

4. [redacted] has established a special bank account for all funds advanced by the [redacted] and a signed Declaration of Trust on this account has been obtained and is on file in TSS/CD.

5. Title to any permanent equipment purchased by funds granted the [redacted] shall be retained by the [redacted] in lieu of higher overhead rates.

6. Title to any permanent equipment purchased by funds granted to [redacted] shall be retained by the Agency and an annual inventory of such equipment shall be submitted to TSS/CD. Upon completion of the research program all permanent equipment will be returned to TSS/CD or disposal made at the direction of and with the approval of Chief, TSS.

7. It was mutually agreed that [redacted] will document all travel expenses (transportation stubs, hotel bill, etc.) that are debited against funds advanced to his personal grant. Documentation and accounting for travel expenses which are reimbursable by the [redacted] shall conform with accepted [redacted] practices.

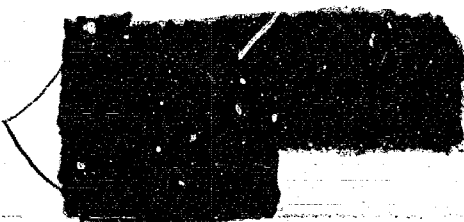

SUBJECT: Project MKULTRA, Subproject 29

1. Subproject 29 of Project MKULTRA is being instituted as a means by which [redacted] work on hypnosis will be continued at the [redacted] for the period 1 June 1954 to 31 May 1955.
