I. SITUATION OVERVIEW

01 November 2020

At 11:00 AM, Tropical Storm "SIONY" slightly intensified and is now inside the Philippine Area of Responsibility (PAR). It entered PAR at 8:00 AM. It is forecast to move generally northwestward until Monday evening, then slowly west-southwestward by Tuesday.

02 November 2020

At 11:00 AM, "SIONY" maintains its strength as it accelerates west-northwestward over the Philippine Sea. The center of Tropical Storm "SIONY" is forecast to continue moving west-northwestward or northwestward today before it slows down significantly and becomes almost stationary tomorrow morning through Wednesday morning.

03 November 2020

At 11:00 AM, "SIONY" slightly intensifies as it moves slowly over the Philippine Sea east of Extreme Northern Luzon. The center of Tropical Storm "SIONY" was estimated based on all available data at 565 km East of Basco, Batanes.

04 November 2020

At 5:00 AM, "SIONY" continues to move slowly over the Philippine Sea east of Extreme Northern Luzon. "SIONY" is forecast to intensify into severe tropical storm in the next 24 hours and reach its peak intensity of 100-110 km/h tomorrow prior to its landfall or close approach over Extreme Northern Luzon.

At 5:00 PM, it intensified into a Severe Tropical Storm (STS) while moving slowly over the Philippine Sea east of Extreme Northern Luzon. the center of Severe Tropical Storm "SIONY" was estimated based on all available data at 735 km East of Basco, Batanes.

Tropical Cyclone Wind Signal (TCWS) No. 1 is in effect over Batanes, the northeastern portion of mainland Cagayan (Santa Ana, Gonzaga), and the eastern portion of

Babuyan Islands (Balintang Isl., Babuyan Isl., Didicas Isl., and Camiguin Isl. including their adjoining islets).

05 November 2020

At 8:00 PM, STS "SIONY" maintains its strength as it continues to move closer towards Batanes. "SIONY" is forecast to reach typhoon category in the next 24 hours with a peak intensity of 120 km/h.

TCWS No. 2 is in effect over Batanes and Babuyan Islands, while **TCWS No. 1** is in effect over the northern portion of mainland Cagayan (Santa Ana, Gonzaga, Lal-Lo, Allacapan, Santa Teresita, Buguey, Camalaniugan, Aparri, Ballesteros, Abulug, Pamplona, Sanchez-Mira, Claveria, Santa Praxedes), the northern portion of Apayao (Santa Marcela, Luna, Calanasan), and the northern portion of Ilocos Norte (Adams, Pagudpud, Bangui, Dumalneg, Burgos, Vintar, Pasuquin, Bacarra).

06 November 2020

At 2:00 AM, STS "SIONY" is about to pass very close or over Batanes. "SIONY" is forecast to make landfall or close approach in the vicinity of Batanes within the next 3 hours as it continues to move west-northwestward. It is forecast to exit the PAR this afternoon or evening.

TCWS No. 2 is hoisted over Batanes and Babuyan Islands while **TCWS No. 1** is in effect the northern portion of mainland Cagayan (Santa Ana, Gonzaga, Lal-Lo, Allacapan, Santa Teresita, Buguey, Camalaniugan, Aparri, Ballesteros, Abulug, Pamplona, Sanchez-Mira, Claveria, Santa Praxedes), the northern portion of Apayao (Santa Marcela, Luna, Calanasan), and the northern portion of Ilocos Norte (Adams, Pagudpud, Bangui, Dumalneg, Burgos, Vintar, Pasuquin, Bacarra)

At 7:50 AM, the center of **STS "SIONY" has crossed Misanga Island in Itbayat, Batanes.** It has maximum sustained winds of 95km/h and gustiness of up to 115km/h, moving westward at 20 km/h.

At 10:00 AM, STS "SIONY" maintains its strength while moving over Bashi Channel. **TCWS No. 2** is hoisted over Batanes while **TCWS No. 1** is hoisted in Babuyan Island. TCWS over the northern portion of Cagayan, Apayao, and Ilocos Norte is lifted.

At 5:00 PM, STS "SIONY" continues to move west-northwestward over the Bashi Channel South of Taiwan. **TCWS No. 1** is hoisted in Batanes. TCWS over Babuyan Island is lifted.

At 11:00 PM, STS "SIONY" is now off the southwestern coast of Taiwan and is about to exit the Philippine Area of Responsibility. TCWS over Batanes is lifted.

II. DISASTER PREPAREDNESS

DSWD- Disaster Response Management Bureau (DRMB)

4. Department of Agriculture (DA)

B. REGIONAL DRRM COUNCILS (RDRRMC)

RDRRMCs I, II and CAR are continuously monitoring its areas of responsibility. Further, said RDRRMCs are in coordination with their respective member agencies to ensure the widest dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories through SMS, facsimile, and official social media websites.

Office of Civil Defense (OCD) I

- a. Continuous monitoring of AOR and close coordination with RDRRMC1 Member Agencies and Provincial DRRM Councils.

Likewise, Provincial Operations Offices (POOs) are in close coordination with the different Provincial/City/Municipal Disaster Risk Reduction and Management Councils (P/C/MDRRMCs) and Provincial/City/Municipal Social Welfare and Development Offices (P/C/MSWDOs) to monitor the adverse effects that might be brought by the weather disturbance.
- d. DSWD-FO I Incident Management Team (IMT) is still on duty while other DSWD staff are on standby for possible augmentation. Likewise, the Field Office ensures availability and readiness of resources.

- e. DSWD-FO I repacked a total of 3,298 Family Food Packs (FFPs) in DSWD FO 1 Regional Warehouse. Out of 3,298 FFPs, 64 FFPs were released as Food for Work (FFW) to the volunteers for the repacking activity.
- f. Disseminated RDRRMC Memorandum relative to the "Reactivation of Response Cluster."
- g. Prepositioned a total of 5,811 FFPs amounting to ₱2,675,067.34 and a total of 15,144 non-food items amounting to ₱24,329,013.25 in the different strategic locations within the AOR.
- h. Continuous conduct of FFPs repacking with the help of regional volunteers at the Regional Warehouse in Biday, City of San Fernando, La Union.
- i. Ensured the availability of quick response funds amounting to ₱7,802,055.20 for disaster operations use.

- e. Advise Barangay Officials and farmers/livestock raisers to ready animal shelters in safe and secure areas and for fishermen not to venture out to sea when there is a gale warning/big waves, strong winds, thunderstorms or adverse sea weather conditions.
- f. Conduct inspection of Evacuation Centers and ensure their functionality. • Ready equipment - dump trucks, rubber boats, evacuation centers, ambulances, food packs, relief goods, medicines, SAR Teams, personnel and other resources and constantly monitor flood, landslide and storm surge risk areas.
- g. Implement Pre-emptive and or force evacuation of residents in highly vulnerable areas to flooding, storm surges and landslides.
- h. Constantly monitor weather conditions and Conduct PDRA Meeting and activate your Emergency Operations Center, if necessary.
