Meat Tainted by Toxic Gas

Dear Duncan: For a couple of years now, a friend of mine has been complaining that "they are doing something to the meat" that is ruining it. His main evidence has been that he can't even get it to rot enough to use for "stink bait" to catch catfish.

So when an article briefly appeared on one of those sign-in web pages, it really caught my attention. The article, "FDA Urged to Ban Carbon-Monoxide-Treated Meat" (http://www. washingtonpost.com), discusses If they could orchestrate this, the treatment of meat with carbon

monoxide to fix the red colour. It briefly talks about the binding of carbon monoxide (CO) to myoglobin. Carbon monoxide is, of course, a very toxic substance and may be indicated as a cause of Parkinson's and other diseases if inhaled (or death, in the most severe case).

Maybe one of your contributors could enlighten us about what changes might occur in our food when treated with CO. I would think that some of the most useful nutrients might be destroyed or radically altered with such a process (carnosine, one of those essential amino acids which we get from meat in our diet, might be altered, for example).

I also wonder, since CO affects the brain itself on direct exposure, if maybe there might be some remote link to treated meat with some of the unexplained cases of "mad cow disease" which are showing up in places like southern Idaho.

Fowl Play in Bird Flu Crisis?

Dear Duncan: I've not seen you post on a very important article that was published at Grain.org, which has had very little media coverage (which itself is very interesting). It's called "Fowl Play: the poultry industry's central role in the bird flu crisis" (Grain, 1 February 2006).

Backyard or free-range poultry are not fuelling the current wave of bird flu outbreaks stalking large parts of the world. The deadly H5N1 strain of bird flu is essentially a problem of industrial poultry practices. Its epicentre is the factory farms of China and Southeast Asia and-while wild birds can carry the disease, at least for short distances—its main vector is the highly self-regulated transnational poultry industry, which sends the products and waste of its farms around the world through a multitude of channels.

Yet small poultry farmers and the poultry biodiversity and local food security that they sustain are suffering badly from the fallout. To make matters worse, governments and international agencies, following mistaken assumptions about how the disease spreads and amplifies, are pursuing measures to force poultry indoors and further industrialise the poultry sector. In practice, this means the end of the small-scale poultry farming that provides food and livelihoods to hundreds of millions of families across the world.

Failure of Vaccinations

Dear Duncan: Two letters and an article by Jon Rappoport in the recent issue (vol. 13, no. 2) highlight the extreme dangers of vaccination. For decades, there has been no question that the cult of vaccination has been a worldwide disaster and the only reason it is still being promoted is because of the silence of the medical lambs!

England introduced compulsory smallpox vaccination in 1852. From 1857 to 1859, it led to a smallpox epidemic that killed 14,244 people. From 1863 to 1865, a second epidemic claimed 20,059 lives. In 1872, the vaccine killed 44,840 people.

In Germany, the most vaccinated country in the world at that time, there were more deaths in proportion to the population, than in the UK. Over one million people got smallpox, of which 120,000 died. From all over the world there were reports of huge numbers of people dying from smallpox following vaccination.

Jenner's smallpox vaccine was included during WWI, when vac-

cination was made compulsory for all German, French, British and American troops. As respective army hospital records reveal, the consequences were so disastrous that it led to the saying, "More soldiers died from vaccine shots than from enemy shots". Near the close of the war, a new paratyphoid jab killed so many soldiers from a strange new disease: it was called Spanish flu!

After the war was over, newspapers around the world alleged that the returning soldiers were riddled with disease and that everybody, men, women and children, must avail themselves of the "life-saving" vaccinations immediately—which was precisely what hysterical populations did, with the result that up to 100 million people died.

Edward Jenner's discovery was not a medical breakthrough at all. He simply enabled Britain and the USA to acquire their first weapon of mass destruction: vaccination.

Tetracyclines and Calcification

Dear Sir: I have read with interest over the past nine years the studies using tetracyclines to assist in the reversal or reduction of calcification in many parts of the human and animal body.

I have been taking doxycycline for the past seven years. I received copies of my first echocardiograph at age 22, and my last just recently to take to a new cardiologist. I've found out I've been suffering recurrent episodes of rheumatic fever, and this is the first time I've seen any of my reports. Rheumatic fever originally gave me the valve damage at age seven. My health for the past 11 years had been misdiagnosed as arthritis until recent heart failure and clinical evidence of chorea.

What struck me as extremely interesting is the difference—in a positive way—in the two reports I've received, especially considering I've suffered six attacks of rheumatic fever in the past 10 years and the last one I'm still

recovering from.

Is there was anyone who I may be able to discuss this with who may be studying more implicitly the changes to heart valves with the use of tetracyclines? Thanks very much for your time.

Hubble Telescope Trouble

Sir: I recently watched a National Geographic television show, featuring conspiracy theories about the NASA Moon landings, which mentioned your magazine. I thought you may be interested in learning some of the facts behind the Hubble Space Telescope (HST) fraud and the fraudulent "investigation" and settlement which followed.

I worked on the HST development project in 1984-1985 wherein I was tasked with testing the FGS, or fine (optical) guidance systems which track the telescope's attitude in relation to the positions of known stars. I was also tasked with testing a quadrant of the telescope's primary mirror (the big one). It was during this testing that I discovered the now infamous "spherical anomaly" which caused images to be produced blurry, necessitating the repair flight to install the COSTAR unit. I reported the flaw to my unit supervisor (Lou Montagnino) who told me, "Keep this under your hat". He also promised they'd fix it prior to shipping it out to Lockheed.

A few months later, while serving with my state's military reserve unit (Air National Guard, Air Force), the completed components were being shipped out through the airfield on our base. I recognised some of the people and asked if they'd fixed the mirror flaw. This question was met with a gruff answer, "There's nothing wrong with that mirror!" Assuming they merely wished to avoid embarrassment, I didn't pursue the matter further.

Only upon watching the results on television after its launch did I realise that they'd knowingly committed a fraud and I began my own investigation.

To make a long story short: NASA and US Justice Department personnel knowingly gave false testimony (under oath) to the US Congress (as documented in the Congressional Record of November 16th, 1993) and cut a deal with the contractor of record (Hughes Division of GM), allowing Hughes to avoid a fine of nearly three-quarters of a billion US dollars.

I contacted both of my state's senators (through their staff) and sent them details of the initial fraud (as it occurred prior to shipping) and to (then) presidentelect Bill Clinton. This letter was sent via registered mail through the US Postal Service and thus its delivery was officially documented in USPS records. I included other issues in that letter to Mr Clintonending with an admonition that the USA was rapidly falling to the same fate as the Roman Empire. In his 1994 State of the Union address (before both houses of Congress), Clinton referred to that passage denying its veracity.

In 1996 I sent a lengthy legal brief to the US Justice Department's Criminal Investigations division, documenting the initial fraud perpetrated by the contractor and the subsequent fraudulent investigation perpetrated by NASA.

Subsequent phone conversations with staff of members of Congress sitting on the committee hearing NASA's testimony revealed they didn't wish to pursue any further investigation into the fraud(s) (due to "contributions" from the leading contractors Lockheed and Hughes?), claiming "Don't cry over spilt milk"
