RE: FLUORIDE REGISTER Dear Duncan,

The National Health & Medical Research Council (NH&MRC) has dismissed claims that certain individuals are allergic to sodium fluoride. Some react from drinking artificially fluoridated water (or products containing such) tablets, gel treatments or fluoride toothpaste. Because water-based products and dried products such as infant formula do not have the presence of NaF declared on the labels, some people may be aware of an allergic reaction but may not be sure of the source. This situation is in contradiction to laws requiring ingredients and food additives to be declared. Certain people have ceased using products with NaF and found their symptoms to quickly disappear; thus proving the source of the allergy. Others were diagnosed as being allergic to NaF by a doctor, or naturopath. Because these cases have been recorded in a rather ad hoc way, or not recorded at all, we feel the need for each state in Australia to compile a central register of victims.

We will record NSW cases on our computer. The address is 182 Lake Road, Port Macquarie, NSW 2444. Professionals honouring patients confidentiality could merely give initials, town and details of problem.
