ADL/Zionist Persecution

Dear Duncan: Thank the Lord for people like Professor Noam Chomsky, who I believe is Jewish, for lifting the lid on the arrogant and vicious activities of the ADL [Anti-Defamation League]. [See Global News, NEXUS 4/03.]

The ADL may present itself as a Civil Rights organisation but it is in fact a political movement, the sole interest of which is the defence of Israel's policies regardless of how they impact on other people, and the parent body is the international Zionist movement.

His right to free speech and the imparting of information to the public was not supported either by his employer or by the Australian Government. And the Zionist officials scream about oppression and victimisation!?

Profits vs Patients' Rights

Dear Duncan: I write concerning my experiences as a result of my approaches to the bureaucracy, the legal fraternity and a multitude of politicians after experiencing a highly avoidable medical mistake. I believe it gives grist to the mill of a global conspiracy to defraud, exploit and kill off those who pay for these services, thereby making rich those who provide them.

My education into how my exploitation had been managed left me awed by my own naïvety. I accepted my surgeon's word that hysterectomy was necessary. I believed that, when someone is paid for performing and delivering a service, the client's or patient's welfare was paramount.

I was given (by my surgeon) a brochure on "Patients' Rights" and a brochure on "Hysterectomy". Both were NSW Department of Health publications. I went into hospital feeling informed and secure for my well-being.

Post-surgically, everything that could go wrong, did. HRT was pushed on me with promises that these nasties would cure my ills. No information was given in regard to adverse reactions or debilitation associated with this procedure and these medications. The positives of both the surgery and the subsequent HRT treatment were emphasised. No mention was made of risks and dangers...

It took me a long time to come to terms with the information that taxpayer-funded Department of Health brochures not only presented very biased misinformation but those "Rights" as presented did not actually exist.

I communicated with all the relevant bureaucratic and political authorities... Without exception the replies I have received negated me and my experiences...they obfuscated the issues I raised and belittled me...

I learnt of the *Rogers v. Whitaker* High Court decision (1992) in which the Court delivered a virtual blueprint for patients' rights—which, five years later, have still not been enacted in legislation...

Too many media outlets and journalists have been contacted in an endeavour to have these issues aired. Too many have declined, but always with wishy-washy excuses. Everyone is too fearful to take on vested interests whilst, at the same time, suppressing information the public has an inalienable right to know. Talk about censorship!

Real choice and informed consent in conventional health care is a myth. Since *Rogers v. Whitaker*, the *Medical Journal of Australia* has stated that doctors will need to decide *what* they tell patients...

The absence of infrastructure to redress violations of patients' rights epitomises the total disregard for the duty of care...

In the pursuit of profits and corporate power, the pharmaceutical industry is clearly not interested in patient care or public health. In collusion with others whose interests coincide (national medical associations, insurance, WHO, etc.) there is a concerted and fraudulent effort to exploit medical patients relentlessly.

I believe that the vast quantity of mostly nonsensical replies from politicians and bureaucrats I have received in the past six years amply prove all of the above.
