Colloidal Silver and the Moon

Dear Duncan: I couldn't help but notice the number of ads relating to colloidal silver in your mag. I thought your readers might be interested in the experiments of Georges Lakhovsky, an engineer, described in 1932.

He found it was possible to sterilise water and other liquids through direct contact with metal conductors. In the case of silver. he found that the effect was different according to the phases of the Moon. During the full moon it could take between 26 to 40 hours to sterilise the water; but four days before the full moon, silver produced the opposite effect: bacterial growth was enhanced. During the waning moon the water was sterilised in from six to seven hours. These experiments have been carried out in two different laboratories, in the Salpêtrière and the Pasteur institutes.

It also interesting that the ancients knew of the connection between silver and the moon. (See Kolisko, *Silver and the Moon.*)

Princess Diana Conspiracy?

I am the web master of the conspiracy theory discussion board which is dedicated solely to the pursuit of the truth of what really happened in the Pont de l'Alma tunnel on 31 August 1997.

This web site was the first to dedicate itself to this topic (launched within three hours of the announcement of Princess Diana's death) and is also the most heavily trafficked. We have had to move our web site several times because of Internet sabotage; however, the combined counters show that we have had close to 450,000 hits in just eight weeks.

I am not a fringe radical. I have never previously involved myself with matters of conspiracy. I am, in fact, a well-educated professional and a writer, and would say that I am considered a person of reason by my friends and associates.

The same is true of the regular posters to this discussion board. Included among them are doctors, lawyers, architects, engineers, nurses, university professors, business executives and journalists. And, almost to a person, they post or tell me in e-mail that they have not previously involved themselves with conspiracy theories of any sort. Those who post here are not "fringe lunatics" as the Press attempts to portray about conspiracy theorists in general. You will not find people here who hold to the theory that Elvis lives and that man's lunar journeys took place in a Hollywood sound stage.

What you have here is a microcosm of global society, students and housewives among them, who believe that we are not being told the truth about what happened in the tunnel that night.

On the night that Diana died, there was speculation here that she and Dodi al-Fayed had gotten engaged that night. Yet the scoffers scoffed and the scorners scorned. Two or three weeks later it was disclosed that Dodi had given Diana an engagement ring that very night.

For weeks we questioned the involvement of another car, and the scoffers scoffed and the scorners scorned. Finally, the same French investigators who had assured the public that no other vehicle had been involved in the crash, asserted their belief that in fact a Fiat Uno had been involved.

Item after item that has been questioned and analysed here, has eventually come into play in the official investigation.

The Press and the governments of Great Britain and France have underestimated who bears the sentiments found on our discussion board. From the e-mail I receive, and discussions with ordinary people everywhere I go, I find almost no one who is satisfied with what the public has been told about the cause behind the crash and how the passengers of the Mercedes died. Diana, from all accounts and photographs, was completely accessible through the rear doors of an amazingly unscathed rear cabin (pre-"jaws of life"), yet this experienced trauma physician didn't feel it important to check her pupils and to ensure that her mouth and throat were clear of blood and vomit before administering oxygen and leaving the scene. And with a crowd of paparazzi around, and Romuald Rat at the car even before the doctor, he (the doctor) never knew whom he was treating? Perhaps it is all true, but people of reason demand then to know the truth behind such seemingly irresponsible treatment.

And there are other things... We have seen *Dateline*'s exclusive photos of the car before the "jaws

of life" cut into it. The back cabin, the entire rear compartment, looked as intact as a car that had just been driven off a dealer's lot. The trunk, roof and rear doors looked unscathed (not like a car that had rolled, as has been reported). Moreover, they were clearly unscathed enough for either rear door to be opened normally, which paparazzo Romuald Rat did. Why then did it take more than two hours to remove Diana from the car? Clearly, she did not have to be cut out, as may have been the case with Trevor Rees-Jones.

And why did it take more than 40 minutes to drive to a hospital six miles away with the ambulance incredibly losing its police escort during that drive? Yes, we have heard the unsatisfactory explanation of the ambulance pulling over to administer adrenaline to Diana's heart. It is just that the doctors who participate in this web site tell us that it was these delays that cost Diana any chance she had of surviving.

There are hundreds of inconsistencies that have been discussed, debated and analysed here. Many may be readily explainable. But there are too many of them, way too many when coupled with contradictions—from "there was no other car involved" to "there was a black/blue/red/white/yellow Fiat Uno involved".

Stop and ask yourself, if these types of questions and inconsistencies loomed over an investigation into the death of your own child or spouse, would you be satisfied? I think not.

Once upon time, in the modern age in which we live, a charismatic leader convinced an adoring public of his noble purposes. He was above question and the rumour-mongers were simply "fringe lunatics"—that is until his infamous *Krystallnacht*, the night that Hitler's goons awoke a sleeping Germany with the "breaking of glass".
