PARTY. HE IS A SLENDER MAN, AROUND FIVE FT. TEN TO SIX FT. HE  
HAS DARK HAIR THAT APPEARS TO BE A CREW CUT COMING OUT AS IT IS  
NOT EVEN ON HIS HEAD. HE HAS A SIDE BRIM OR TRIM ON THE LEFT SIDE  
OF HIS MOUTH, PULLS HIS MOUTH BACK LIKE A SMILE. WHEN HE PULLS HIS  
MOUTH BACK TO SIDE, SPACE IS NOTICEABLE BETWEEN UPPER TEETH. THIS

[REDACTED] IS REPORTED TO HAVE A RESIDENCE IN PANAMA CITY, FLA., AND HIS FATHER IS SUPPOSED TO OPERATE A TRAWLER BOAT OUT OF DESTIN, FLA.

THE LEAD MATERIAL FOUND IN A REVIEW OF THE FOREIGN TEXT IS FULLY AND PROMPTLY EXPLORED IN MEMPHIS DIVISION. WE KNOW OF NO "WALLACE FOR PRESIDENT" ORGANIZATION IN TENN. WE ARE MAKING FURTHER CHECKS CONCERNING THIS INTEREST EXHIBITED BY SAULT.
