If health problems had not prevented it I'd have written you as soon as you and your mother came out for a trial for James Barl Ray. I write now, in violation of doctords orders, in the belief I can inform you and to encourage you not to expect too much, exhaps not to expect the impossible, should Ray be granted a trial. Aside from what I learned in writing my book Frame-Un: the Martin Luther Kins/James Earl Bay Cage and what thereafter I learned as Pay's invostigator, I filed FOIA lawsuits against the government and got about 80,000 pages of that had been secret records. You and your center are welcome, by the way, to copies of any of this and nothing with the asked in return.

Nost of my work has been on the JFK assassination. I wrote the first book and I think eight or nine published since then and do not have a single letter or phone call from any of those of whom I wrote so critically complaining of unfairness or Anaccuracy by any one of them. There was so many similarities that after your father was assassinated by a week FOIA to obtain information about that wime and I add its official investigation.

I conducted the investigation for the habeas corpus, in which we succeeded and then for the two weeks of chilentiary hearing in first the phony liberal judge found in contradiction to all the evidence and edenied the trial. He did use the words "guilt or innocence" were "immaterial" to what was before him, whether May had been coerced into his plea and whether he had had the "effective massistance of counsel." I have those transcripts and it you'd like you can copy them. I think you should want them. They are the addressing of the alleged official evidence under outh in a federal court.

As best I can now recall after all those years the SCIC was persuaded by the Department of Justice, possibly by Assistant Attarney Cenral Vinson, that they had a solid case against Ray and that he would be electrocuted unless he

copped a plea. In fact they had no case at all against May, which is still true, and they could prevent the disaster of taking a case to court only by getting May to agee to a plea. There was chance at all in year days of his being electrocuted.

When my book was out " tried to interest the SCLC and got nowhere. Ditto for the Black Caucus in Congress, other than Canyers, who was fine. I sent copies of the book to Atlanta and others also did. No reaction. The chief leavyer wroteer spoke to you mother for me. We were referred to Mr. Wachtel in New York. I went up and got no farther thank the reception desk. Later he had a law student phone me. He never spoke to me or saw me at all or look ed at any evidence.

- I know nothing about this alleged new test but as of several decades ago it was N ot necessary.
- I have no doubt in there was the person "ay refers to as "Qual" and he refused absolutely to give me may leads on it. I therefore do not believe that he will come up with any now, not any real ones. Or, baseno hopes on that or on anything like it.
 - I doubt he had any real identification anyway.

There seems to be some black assumption of Ray's guilt. I am convinced he was not part of any conspiracy to kill your father of which he knew. Curtisf in the McPillan book made it all up and much is ridicultous. Byers did get leniency for a major crime. I've forgotten the details but he lied. As so many did hoping for consideration in return.

I ask nothing of you. You are welcome to all of this if you went any of it. It is, I fear, as close to the truth a will be possible because the crime itself was never investigated. It will all be a public archive at local Hood College and if you want any information about he I suggest you ask the history professor there who will be in charge of that archive, Dr. Cerald "Characte. Ris office phone is 301/696-3720. His home phone is 301/473-5639.

I did not continue with this work and returned to my work on the IFK assassination because - could not develop any interest on the part of any black person. Other than John Convers.

If you are a lawtger or would corre to have one look at it I staggest you ask Justice for the file of what it gave Jondon to got "ay extradigled. It is public although when I saw it was marked secret. No case at all. They even pretended that the assassination was not a folitical crime. It was disclosed to me in CA 718-70. I do not have the copies I used in the book but they are Vequired to give that file to you if you ask for it under FOIS because it is disclosed, is now public information.
