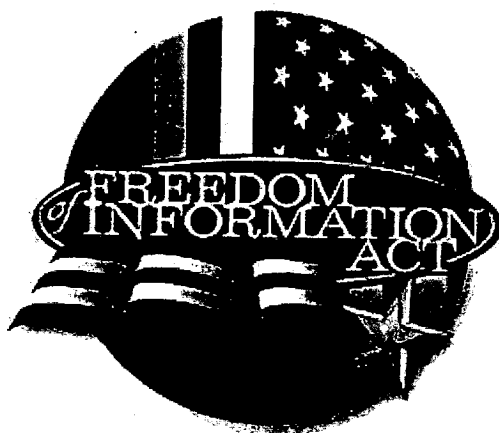

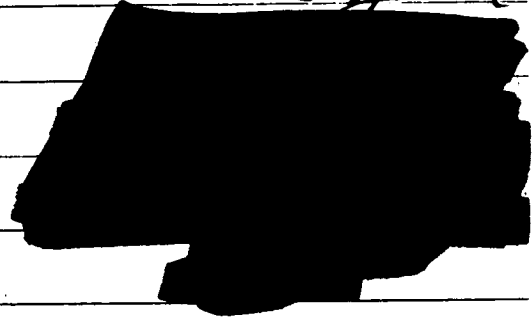

STATEMENT OF J. EDGAR HOOVER, DIRECTOR, FEDERAL BUREAU OF INVESTIGATION, BEFORE THE COMMITTEE ON UN-AMERICAN ACTIVITIES, HOUSE OF REPRESENTATIVES, 3:45 P.M., MARCH 26, 1947, WASHINGTON, D. C.

The aims and responsibilities of the House Committee on Un-American Activities and the Federal Bureau of Investigation are the same—the protection of the internal security of this Nation. The methods whereby this goal may be accomplished differ, however.

I have always felt that the greatest contribution this Committee could make is the public disclosure of the forces that menace America—Communist and Fascist. That is why the venom of the American Communist and the now defunct German-American Bund has been directed at this Committee as it has also been directed at the Federal Bureau of Investigation. This Committee renders a distinct service when it publicly reveals the diabolic machinations of sinister figures engaged in un-American activities.

The Role of the FBI

The FBI has great responsibilities to the Nation. In addition to being charged "with the duty of investigating violations of the laws of the United States, collecting evidence in cases in which the United States is or may be a party in interest and performing other duties imposed...by law," the FBI has been charged by Presidential Directive dated September 6, 1939, "to take charge of investigative work in matters relating to espionage, sabotage..." In implementing this charge the President called upon all law enforcement officers to promptly "turn over to the nearest representative of the Federal Bureau of Investigation any information obtained by them relating to espionage, counterespionage, sabotage, subversive activities..."

The FBI is essentially an investigative agency. It is our duty to get the facts. We do not establish policies—that is the responsibility of higher authority. We do not make decisions as to prosecutions—that is the responsibility of the Attorney General, his assistants and the various United States Attorneys.

To the end that our responsibilities may be discharged it is necessary not to lose sight of the fact that our chief responsibility is the duty to obtain information and to protect confidence. Thus, when a citizen furnishes information on a confidential basis his confidence must be respected. In any intelligence operation, security of information is of primary concern. I recall in the pre-war years that the FBI was criticized on the ill-founded premise that nothing was being done to meet the Nazi-Fascist-Japanism threat to our internal security. The real facts are now a matter of record. What was being done, and done successfully, could not then be discussed and publicized. When the time came to



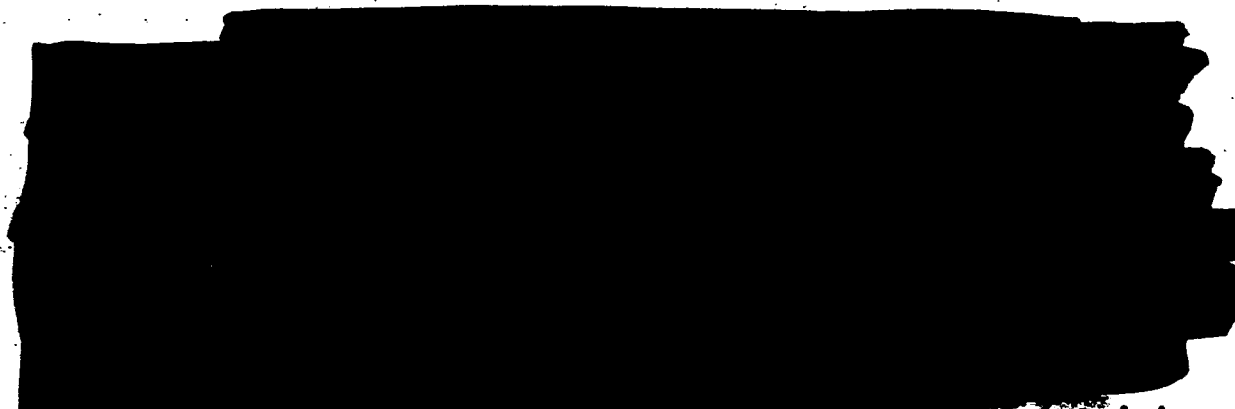

We are indeed interested in the situation you outline in your letter of October 16; press of other matters has made it impossible to write sooner.

As it is set up at present, we do not feel that National Council of Churches is a suitable organization to sponsor the founding of Christian churches. It is controlled by apostates who are apologists for Communism and openly preach socialism under the pretense that it is the doctrine of "the Kingdom of God."

Presbyterian Church USA is in the same position; it must bear a major portion of the responsibility for what goes on in the National Council. Samuel McCrea Cavert, a Presbyterian, was the principal executive officer of the old Federal Council, and has the same position with the National Council. Two of the four divisional vice presidents of NCC and the chairman of the new General Department of United Church Men are among the many Presbyterians in positions of policy-making.

It is a hard thing to say, and of course huge vials of wrath have been poured upon my head for saying such things, but to my mind, a "church" under such sponsorship as is proposed for the Riverside Church is something worse than no church at all.

What, no Sunday School for children? Some will exclaim like this. But I ask, is it any better to have children taught apostate doctrines than to get no religious training? I think not.

If a group of you are of this mind, and are willing to stand on your own feet, not accepting "home mission funds" in aid of the project, you can go ahead and organize an independent church, or accept the help (which probably would not include financial aid) from fundamentalist organizations such as Independent Fundamental Churches of America or General Association of Regular Baptists.

We could put you in touch with either or both of these organizations, but think it would be best if at least an informal group should be formed to consider and make themselves really certain about the undesirability of acting along the proposed lines.

For your immediate information and guidance I send you herewith a pamphlet prepared by an Oklahoma layman which describes the kind of teaching which both adults and children would receive in a Presbyterian Church.

Proceeding with the formalities natural to such an occasion, representatives of the merging agencies were called upon to place in the hands of the chairman documents officially approving the move. Then the denominational delegations gave verbal assent to the merger, and one by one, a representative of each denomination moved to a desk just in front of a tall white cross on the stage. There each signed the official documents. At the signing, the denominational banners, brought into the Arena by the marching groups, were assigned places on the stage.

Now the formal pronouncement could be made—the National Council had come into being. Again the trumpets blared and the organ pealed; the joyful assemblage broke into song, "God of Grace and God of Glory."

This colorful event took place on Wednesday morning, Nov. 29. The following morning, principal business was adoption of the Constitution and By-Laws, and Friday morning, Dec. 1, last day of the Convention, officers were elected.

It had "leaked out" on the first day of the convention that the chosen nominee for the president, sure to be elected, was Rt. Rev. Henry Knox Sherrill of Greenwich, Conn., presiding bishop of the Protestant Episcopal Church. And so it was. Every committee nominee for every office—and there were scores and scores of nominations—either was elected outright by the convention, or in the case of the "smaller fry," recommended to the General Board for later election or appointment by that board.

The Council Framework

The General Board will consist of representatives of the constituent denominations specifically designated for the position by the respective denominations. An appointing agency (denomination or affiliated Council) may name one-seventh of its representatives to the General Board, which will have the powers of an executive committee. All the representatives of the denominations (or other affiliates) will make up the General Assembly, the governing body of the Council.

Never had there been any speculation as to who would be selected to be general secretary, and in effect, general manager of the National Council. Nobody doubted for a minute that "Generalissimo" Samuel McCrea Cavert, general secretary of the Federal Council, would get that "plum" without opposition of any kind from any source. He has been on the Federal Council staff since 1919, served for nearly a decade as one of two general secretaries, and since 1930 has been the Council's chief executive officer.

Dr. Roy G. Ross, for fifteen years general secretary of the international Council of Religious Education, was elected associate general secretary. Another secretary of equal ranking, a woman, is to be selected later by the general board.

Administrative secretaries named are Rev. Earl F. Adams, chairman of the field department of the Federal Council; Rev. Philip C. Landers, associate general secretary of ICRE; Rev. J.

Quinter Al... associate general secretary of... Federal Council, and Wilbur P. Parry, Chicago. Aenid A. Sanborn, editorial secretary of the Federal Council, was named assistant to the general secretary.

Four general vice presidents were elected. They are Mrs. Douglas Horton, former president of Wellesley College and former commander of the WAVES, Congregational; Mrs. Abbie Clement Jackson, Louisville, Ky., executive secretary of the Women's Home and Foreign Missionary Society of African Methodist Episcopal Zion Church; Dr. M. E. Sadler, Fort Worth, Texas, president of Texas Christian University and former president of the International Convention of Disciples of Christ, and Harold E. Stassen, Philadelphia, president of the University of Pennsylvania, American Baptist.

Federal Council Echoes

Four vice presidents to represent and serve as chairmen of the four principal divisions were elected by the divisions.

They are Dr. Paul Calvin Payne, Philadelphia, general secretary of the Board of Christian Education of the Presbyterian Church, USA, Division of Christian Education; Dr. Herman N. Norse, New York City, general secretary of the Board of Home Missions of the Presbyterian Church, USA, Division of Home Missions; Dr. C. C. Adams, Philadelphia, corresponding secretary of the Board of Foreign Missions of the National Baptist Convention of America, Inc., Division of Foreign Missions, and Dr. Arthur S. Fleming, Delaware, O., president of Ohio Wesleyan University, Division of Christian Life and Work.

It is the Division of Christian Life and Work which will carry on the work done by the Federal Council in the social-economic field through its Department of the Church and Economic Life; Dr. Fleming has been serving as chairman of this department in the FCC.

And meet other familiar Federal Council figures—Roswell P. Barnes, who had been associate general secretary of the FCC, will manage the Division of Christian Life and Work as executive secretary. The following executive secretaries of FCC departments now become executive directors of Division departments of the same name: Walter W. Van Kirk and Richard M. Fagely (co-secretaries), Department of International Justice and Goodwill; Cameron P. Hall, Department of the Church and Economic Life; Thomas C. Allen, and J. Oscar Lee (co-secretaries), Department of Race Relations; Dean Edwards, Commission on worship. Elma Greenwood, who had been associate executive secretary becomes assistant executive director of the Division, and Beverly M. Boyd, who had been executive secretary of the Department of Christian Social Relations becomes executive director of the Department of Social Welfare.

Apparently the choice of Roswell P. Barnes as executive secretary of the Division of Christian Life and Work assures that leftist thinking (and acting) in the Division will not be discouraged. Barnes, an ordained Presbyterian minister, has nine listings of

affiliations with un-American organizations in *How Red Is Federal Council of Churches?*, a publication of American Council of Christian Laymen, Madison 1, Wis., and the Laymen's Council has additional listings for him which bring his total to an even dozen.

For treasurer the convention named Charles E. Wilson, New York City, president of General Electric Company, and for associate, James L. Kraft, chairman of the board of the Kraft-Phoenix Cheese Company. Rev. Reuben H. Mueller, Dayton, Ohio, will be recording secretary.

Rubber-Stamp Action

As it was with election of officers, so it was with adoption of the Constitution and By-Laws. Although the Planning Committee had rather freely amended the original drafts after they had been approved by the constituent bodies, the revised drafts were adopted with only minor changes suggested by the committee, and none more important than the correction of typographical errors.

Voting delegates, consultants, and even the alternates, were seated at tables at this convention, perhaps to give it the appearance of a deliberative assemblage, but it never was this in any sense; rather it was a "rubber stamp" convention from start to finish.

There was some apparently independent discussion of the matter of location of headquarters for the National Council, but in the end the matter was left with the General Board without specific recommendation.

And when all was said and done, that which had been accomplished was no more than this: a name was changed. All the inter-church policies of the old Federal Council of Churches of Christ in America were retained and approved. The old leadership of the Federal Council remains in complete control of the "machinery" for making leftist pronouncements and guiding the policies of the entire organization in the direction of liberalism and national Socialism. In the opinion of many, the grip of the Federal Council leaders has been tightened by the reins of inter-church authority.

Nobody can know, and probably it never can be discovered, how much of the "drive" for completing the long-planned merger at this time arose from a desire to discard the name "Federal Council of Churches," so greatly in disrepute, but most certainly this was an impelling factor.

The Federal Council, and probably others of the merging agencies, will not surrender their charters or articles of incorporation, in fact, could not do so as they have assets to conserve and obligations to meet.

What it amounts to is: the Federal Council has "gone underground." This is by no means the first time that the Council has used the Communist technique.

"On the record," as it is written by the Federal Council, the FCC wound up its affairs at a two-day meeting which almost overlapped the Constituting Convention. The FCC meeting, scheduled for Nov. 27 and 28, continued through an afternoon ses-

sion on the second day, and the first convention session was held in the evening of this same day.

Critics Get Lashing

Significant or not, the Federal Council retired from the scene (under this name) and the National Council began its Constituting Convention in notes of recrimination and "alibis."

Speakers at the closing session of the Federal Council "wind-up" and the opening session of the Constituting Convention lashed out vigorously at critics of the Federal Council and its policies. They made the usual general denials of pro-Communist activities and pronouncements and of "unsavory" affiliations of FCC leaders.

Surely it is significant that the principal speaker at the first convention session was Dr. Ralph W. Sockman, minister of Christ Church (Methodist) of New York City. Dr. Sockman ("named names" in his address (designated as a "sermon" in the program), getting a bit mixed up on some of them. But the real significance of his selection to make the "kick off" address lies in the fact that he is a "liberal of the liberals" in matters of theology, and politically he is aligned with the extremely leftist Methodist Federation of Social Action, of which he is (an elected) member-at-large, No. 43 on the official list of nominees.

Methodist Bishop G. Bromley Oxnam, another "liberal of the liberals" both in theology and politics, whose activities in the Federal Council did not slacken at the conclusion of his term as president, was active in arranging the "birth" of the "new" Council. He presided at the Thursday morning session when the Constitution and By-Laws were adopted.

Choice of other speakers for the Constituting Convention was equally significant in showing the true aims and purposes—almost completely political—of the Planning Committee.

Political Figures Speak

Scheduled for the Thursday evening session was Sir Oliver S. Franks, Great Britain's Ambassador to the United States; Thursday afternoon the message was from the other side of the globe—the speaker was Toyohiko Kagawa of Japan. Friday morning the Convention heard a political address by Harold E. Stassen, best known for his continuing presidential "itch"; earlier he had been elected a vice president of the National Council. Thursday evening the principal speaker was Francis B. Sayre, delegate of the U.S. to the Trusteeship Council of the United Nations. Messages of mutual admiration were exchanged by the National Council and Trygve Lie, secretary general of the United Nations.

President Truman was the Planning Committee's first choice as "top bill-

LAYMEN AND THE NCC

EXACT status of the General Department of United Church Men of the National Council of Churches of Christ in the USA (UEA, January 1) is not too clear, even to persons who were on the scene when it was organized.

This much is clear: the Planning Committee setting up the organization for the "new" National Council conceived the idea of a department of laymen to correspond to the United Council of Church Women, an inter-denominational agency which was one of the units merged with the Federal Council of Churches.

Mr. J. Howard Pew, Philadelphia industrialist, chairman of the board of the Sun Oil Company, organized a lay committee of 100 prominent persons, with men greatly in the majority. From Mr. Pew's remarks to the convention, it appeared that he thought that the committee he had organized was to be the nucleus of the proposed new department. But *The National Council News*, a four-page news sheet issued three times during the Constituting Convention, announced in the first issue, available when the delegates arrived, that this lay committee was set up to "sponsor" the convention.

Mr. Pew was scheduled to address the afternoon group meeting at which the new department was organized, but was unable to appear. He addressed the plenary session the following morning. His place on the afternoon program was filled by Mr. Lem. T. Jones, who was shortly to be elected chairman of the department. Other speakers on this program were Mr. Chilton G. Bennett, Chicago, executive secretary of the Methodist Board of Lay Activities, and Dr. Luther Wesley Smith, Philadelphia, executive secretary of the Baptist Board of Education and Publication. Harold E. Stassen, president of the University of Pennsylvania, former governor of Minnesota, presided.

ing" and when he declined to appear, the committee invited Dean Acheson, Secretary of State, who accepted. Messages of mutual admiration were exchanged by the Convention and President Truman.

Whatever we may think of President Truman and Dean Acheson, we must agree that they are two of the most controversial figures in national and world politics today. Introducing Secretary of State Acheson to the Convention, Dr. Edward H. Pruden, Washington, president of the American Baptist Convention said:

"Though separated by many miles, it is a genuine privilege to present to this audience a distinguished statesman and an unselfish public servant who is a son of the parsonage. Occupying one of the most difficult positions in the world at one of the most critical hours in history, the speaker of the evening is performing his duties with marked

When it came time to elect officers, it was easy to find, among the membership of the "Pew committee" and "reserves" standing by, plenty of candidates well-schooled in denominational and inter-church activities under the tutelage of the old Federal Council of Churches. The "slate" elected was as follows:

Lem. T. Jones, Kansas City, Mo., president of the National Council of Presbyterian Men in the USA, chairman of the new department. The five vice chairmen: Ray H. Nichols, Vernon, Texas, president of the Methodist Board of Lay Activities; Charles H. Thompson, Washington, D.C., dean of Howard University graduate school; Gilbert B. Brink, Los Angeles, California, president of the National Council of American Baptist Men; Nat K. Reiney, Lewisburg, Tenn., president of the Presbyterian Assembly Men's Council, Presbyterian Church in the USA, and John Merrifield, Portland, Oregon, member of the Presiding Bishops' Committee on Laymen's Work for the Protestant Episcopal Church. L. J. Fletcher, Peoria, Illinois, was named secretary of the department, and Charles E. Wilson, New York City, was named treasurer.

Mr. Pew's address to the Constituting Convention was a masterful presentation of the basic principles of Protestantism, showing how these principles are basic in the American concept of the free, important and dignified individual. It was the only address to the convention, so far as this observer could learn, which made any attempt to state the principles of Protestantism or to outline a program of Christian work in support of these principles.

In his address Mr. Pew declared that the Planning Committee had made representations to the effect that in the National Council the laity would play important roles in both operation and policy making. Members of the lay committee are to have half the places on the Council's Committee on Busi-

ness and Finance, and generous representation on the boards of directors of both divisions and departments. Laymen also are to have a share in preparation of pronouncements and statements of policy, Mr. Pew declared.

intelligence, great patience and complete integrity." As indicated by Dr. Pruden in his remarks, the Secretary of State was not present in person. He spoke from Washington by telephone. The public relations and radio departments had arranged to have one broadcasting system (Mutual) put the talk on the air waves. When it developed that the address would be a "fireside talk" to the nation, all the four principal broadcasting systems arranged to "air" the address.

Hence the address was not directed to a convention of churches and

ness and Finance, and generous representation on the boards of directors of both divisions and departments. Laymen also are to have a share in preparation of pronouncements and statements of policy, Mr. Pew declared.

That Mr. Pew acted and spoke in good faith cannot be questioned. He, and presumably other Christian men who accepted his invitation to serve in the lay committee, assumed that the promises and pledges of the Planning Committee were bona fide. It is, of course, quite possible that the National Council will follow a more moderate course than did the Federal Council. But nothing in the actions of the Planning Committee points in that direction.

The nominating committees set up by the Planning Committee placed in control all the old, discredited leadership of the Federal Council, which has continued its sniping at free enterprise and the American system of government since the convention, and has announced no change in its plans for using the \$100,000 grant of the Rockefeller Foundation for further sniping at the besmirching of our basic American ideals.

If laymen are to alter the policies of the past in any way whatever they must rally in great numbers and, rolling up their sleeves, pitch in to do a gigantic job of house cleaning.

Congregational Laymen Protest Social Program

MINNEAPOLIS, Minn.—The Council of Social Action of the Congregational Christian Church is under fire by a well-organized group of Minnesota laymen with headquarters here.

The Congregational Lay Group of Minnesota, as the group is called, has called upon their denomination to cease supporting the CSA out of missionary funds; to discontinue its political lobby in Washington; and to include in its official framework a proper representation of business men, manufacturers, and professional men.

The CLGM charge that the CSA has been "pro-labor" and "pro-union" in

churchmen, but to the nation; nevertheless it was accepted by Council leaders as their own. The Secretary was highly complimented for his restraint in not "calling us, a church group, to take part in a 'holy war.'"

Stress Social Action

A book could be written about other indications that the chief attention of the "new" National Council, like that of its predecessor-parent, the Federal Council, will be given to matters social-economic and political rather than to religion.

Convincing evidence of this fact is to be found in the National Council's own publications. One of these is a pamphlet, *Christian Faith in Action*. Here are many fine phrases about "the role the churches should be playing

Pro-Communist Letter Brings Baptist Action

NEW YORK—(RNS)—Officials of the American Baptist Foreign Mission Society have recalled Dr. Dryden L. Phelps, a missionary in China since 1921, because of a letter published under his name in the November issue of the magazine *Soviet Russia Today* (UEA, December 15).

In the purported letter Dr. Phelps, who is stationed at West China Union University, Chengtu, paid high praise to the present Chinese Communist regime. He called it "the most comprehensive renaissance the human spirit has ever experienced," and "the most dynamic change in human history."

The letter also characterized the "reorganization of Chinese society" as the "most profoundly religious experience I have ever been through". It asserted that "God is working alongside of these Communists."

Discussing the situation in Korea, the letter charged that the South Korean government "first attacked" North Korea and that "95 per cent of press reports appearing in the USA on the Far Eastern crisis are absolutely false."

It said that Dr. Phelps and a Chinese colleague had translated into Chinese an article by Rev. William Howard Melish called "Religion in the U.S.S.R." Mr. Melish is the former assistant rector of Holy Trinity Protestant Episcopal church in Brooklyn, N.Y. His father, Dr. John Howard Melish, was removed as pastor of the church for supporting his son's "radical" activities.

The decision to recall Dr. Phelps so that he might be given an opportunity to explain the letter was made by unanimous action of the officers' council of the American Baptist Foreign Mission Society. An announcement issued by the Society said:

"This letter, if it is from Dr. Phelps, reveals that he has taken a position which is not in accord with the policies laid down by the Board of Managers of the American Baptist Foreign Mission Society governing the attitude and work of its missionaries.

"Accordingly, immediate and unanimous action was taken by the officers' council, asking Dr. and Mrs. Phelps to come home immediately for a conference with a board committee."

in this great drama of human destiny," and the need for "larger strategy." The slogan is "Cooperative Christianity." In nineteen numbered paragraphs the planning Committee tells how "The National Council Will Help You and Your Church." The first paragraph—surely the most important—reads:

"By providing an authentic expression of the Christian conscience in matters of religious liberty, human rights family life, social welfare, world peace emergency relief needs, and great moral issues."

A great many Christians will prefer to allow their own consciences to guide them. They will not wish to depend upon the "one voice" of the super-liberals of a Protestantism which protests nothing more strongly than protests the eternal verities of Christianity. But such is the "new" National Council of the Churches of Christ in the USA.

Unfinished Business

Important among items of unfinished business of the supposedly defunct Federal Council of Churches is the matter of the "three-year study of the ethical side of economic activity in modern society" for which the Council accepted a grant of \$100,000 from the Rockefeller Foundation.

Announcement of the grant was made at the National Study Conference sponsored by the Federal Council at Detroit in February, 1950. And of course there is no thought of abandoning the study and turning back the unspent portion of the \$100,000 grant. The study will proceed as planned, under sponsorship and supervision as announced, with some slight change in the titles of supervising persons and departments.

First announcement of plans for the study appeared in Federal Council Bulletin for April. Director and principal consultant of the study, the Bulletin announced, are to be A. Dudley Ward and Dean Howard Rothmann Bowen, dean of the College of Commerce, University of Illinois.

Director Ward is not identified in the story. Readers presumably are expected to know that Mr. Ward is director of studies for the Federal Council's Department of the Church and Economic Life.

Partly Obscured Background

Dean Bowen's background, as described in the Bulletin, is as follows: he is a graduate of the State College of Washington and received his doctorate at the University of Iowa, where he taught economics for seven years. He renewed his studies of economics in England in 1937-38 and was in government service during World War II, serving as chief economist of the Joint Congressional Committee on Internal Revenue Taxation. Subsequently he spent two years as an economist in employ of the Irving Trust Company of New York. In 1947 he assumed his present post.

With customary candor, the Bulletin neglects to inform the readers that Dr. Bowen's English studies were in the London School of Economics, whose best-known professor was the late Harold J. Laski, for many years leader of the British Labor party and world renowned propagandist for a leftist brand of Socialism based in Marxism.

Late in 1950, Dean Bowen was relieved of his administrative responsibilities by action of the Board of Regents of the University. The stated reason was his adherence to the theories of deficit financing, principal exponent of which is Lord Keynes.

The study will be carried on by economists and theologians. The need for including both economists and theologians in a study such as the one contemplated was explained in the Bulletin as follows:

"A theologian may argue for justice in the distribution of income, yet without the technical equipment to measure the effects on production and progress.

"On the other hand, economists report that they feel handicapped by their lack of professional competence in the field of ethics and by inadequacy of their techniques for measuring results of alternative actions and policies."

Just why economists should believe that theologians are better equipped than they to foretell the results of economic changes which economists recommend is not explained.

Nor is explained why it never has occurred to the Department of the Church and Economic Life, setting up and preparing to supervise the study, that a few practical business men who really know what makes the wheels of the national economy turn, might be of value to the group of economists and theologians, if only as consultants.

Director Ward outlines more detailed plans for carrying on the three-year study in a signed article in the October issue of the Bulletin. Quoting:

"The study will relate Christian ethics to five major areas of economic life:

- "1. The goals of economic life.
- "2. The value criteria which people use and the problems of conscience which they face in economic decision making.
- "3. The social responsibilities of individuals in economic activity.
- "4. The place of organized economic groups in modern life.
- "5. The standard of living and the content of consumption in modern society."

Preserved for Posterity

The conclusions of the scholars and theologians will be preserved for posterity in six volumes, one devoted to each of the above five general subjects, and a sixth volume will evaluate the total study, the director wrote. Quoting again:

"To determine the goals of economic life the approach of a variety of disciplines and ways of thinking will be sought. The responsibility for the projects rests with a panel of competent scholars. Each one will prepare a statement. These statements will be integrated, interpreted and evaluated by a theologian in cooperation with a philosopher and an economist. Those participating and their fields of interest are:

"1. The Historical Perspective — Clarence H. Danhof, Professor, Woodrow Wilson School of Public and International Affairs, Princeton University.

"2. The Concept of Economic Progress — Kenneth E. Boulding, professor of economics, University of Michigan.

"3. Theology — John C. Bennett, professor of Christian theology and ethics, Union Theological Seminary.

"4. Philosophy — Theodore M. Greene, professor of philosophy and Master of Silliman College, Yale University.

"5. Psychology — Donald Snygg, professor of psychology, Oswego State Teachers College.

Bible Society Adopts Record Budget in 1951

NEW YORK—A budget of \$2,161,500 to cover the regular work of the American Bible Society in 1951 was approved by the Advisory Council of the Society, at its annual meeting here.

"6. Cultural Anthropology — Ralph Linton, professor of anthropology, Yale.

"7. Biology — Alfred E. Emerson, professor of zoology, University of Chicago.

"8. Jurisprudence — Walton Hamilton, member of the law firm, Arnold, Fortas and Porter, Washington, D. C.

"9. Political Science and Sociology — Robert M. Mac Iver, professor of political philosophy and sociology, Columbia University.

"10. Economics — John M. Clark, professor of economics, Columbia University; Frank H. Knight, professor of economics, University of Chicago; Joseph J. Spengler, professor of economics, Duke University; William Vickrey, professor of economics, Columbia University.

"11. Introduction, interpretation and integration — Reinhold Niebuhr, professor of applied Christianity, Union Theological Seminary."

Who's Who, and Why

Some "personal notes" on persons named above, with numeral reference for convenience of the reader, are as follows:

3. Dr. John C. Bennett ranks among the half-dozen most radical theologians of the day. He long has been an apologist for Communism; his most recent books, including "Christianity and Communism," Association Press (YMCA) 1948, attempt to correlate the ethics of the Christian faith with Marxian Communism.

6. Ralph Linton is listed in "Red-ucators at Yale" published by National Council for American Education, as having four radical affiliations, and three such listings appear in Appendix IX of the House Committee on Un-American Activities.

9. Robert M. MacIver has five listings in "Red-ucators at Columbia," published by the National Council for American Education, and four such listings appear in Appendix IX.

11. Reinhold Niebuhr, long an advocate of the "social gospel" and who retained his belief in Socialism even after he had "discovered sin" about a decade ago, was a co-founder of the Fellowship of Socialist Christians.

From its own authorized description of the aims and methods of procedure of the "three-year study," it is perfectly clear that the cards have been stacked to assure the same kind of findings.

With the personnel selected by the managers of the enterprise, no other result can be expected.

SPEECH OF RABBI EMANUEL RABINOVICH

as reported by Eustice Mullins, May 14, 1952

The following is a speech of Rabbi Emanuel Rabinovich before a special meeting of the Emergency Council of European Rabbis in Budapest, Hungary, January 12, 1952.

Greetings, my children! You have been called here to recapitulate the principal steps of our new progress. As you know, we had hoped to have twenty years between wars to consolidate the great gains which we made from World War Two, but our increasing numbers in certain vital areas is arousing opposition to us, and we must now work with every means to precipitate World War Three within five years.

The goal for which we have striven so concertedly for three thousand years is at last within our reach, and because of its fulfillment now apparent, it behooves us to increase our efforts and our caution tenfold. I can safely promise you that before ten years have passed, our race will take its rightful place in the world, with every Jew a King and every Gentile a slave! (applause from the gathering). You remember the success of our propaganda campaign during the 1930s', which aroused anti-American passions in Germany and at the same time we aroused anti-German passions in America, a campaign which culminated in the second world war. A similar propaganda campaign is now being waged intensively throughout the world. A war fever is being worked up in Russia by an incessant anti-American barrage, while a nation-wide anti-Communist scare is sweeping America. This campaign is forcing all of the smaller nations to choose between the partnership of Russia or an alliance with the United States.

Our next pressing problem at the moment is to inflame the lagging militaristic spirit of the Americans. The failure of the Universal Military Training Act was a great setback to our plans, but we are assured that a suitable measure will be rushed through Congress immediately after the 1952 elections. The Russian, as well as the Asiatic peoples, are well under control, and offer no objections to war, but we must wait to secure the Americans. This we hope to do with the issue of Anti-Semitism, which worked so well in uniting the Americans against Germany. We are counting heavily on reports of anti-Semitic outrages in Russia to whip up indignation in the United States and produce a front of solidarity against the Soviet power. Simultaneously, to concentrate to Americans the reality of outspokenly Anti-Semitic elements in America to increase their effectiveness, and we shall stage anti-Semitic outbreaks in several of their largest cities. This will serve the double purpose of exposing reactionary sectors of America, which then can be turned into a devoted Anti-Russian unit.

Within five years this progress will achieve its objectives, the Third World War, which will surpass in destruction all previous contests. Israel, of course, will remain neutral, and when both sides are devastated and exhausted, we will arbitrate, sending our control Commissions into all of the wrecked countries. This war will end for all time our struggles against the Gentiles. We will openly reveal our identity with the races of Asia and Africa. I can state with assurance that the last generation of white children is now being born. Our Control Commissions will, in the interests of peace and wiping out inter-racial tensions, forbid the whites to mate with whites. The white women must cohabit with members of the dark races, and the white men with dark women. Thus the white race will disappear, for mixing the dark with the white means the end of the white man, and our most dangerous enemy will become only a memory. We shall embark upon an era of ten thousand years of peace and plenty. The Pax Judaica,* and our race will rule undisputed over the earth. Our superior intelligence will enable us to retain mastery over a world of dark peoples.

* (meaning friendly, cooperative symbology as between Judaists)

Questions from gathering: Among them the question, what about the various religions after the third world war,)

There will be no more religions. Not only would the existence of a priest class remain a constant danger to our rule, but belief in an after-life would give spiritual strength to irreconcilable elements in many countries, and enable them to resist us. We still, however, retain the rituals and customs of Judaism as the work of our hereditary ruling caste, strengthening our racial laws so that no Jew will be allowed to marry outside our race, nor will any stranger be accepted by us.

We may have to repeat the grim days of World War Two, when we were forced to let the Hitlerite bandits sacrifice some of our people, in order that we may have adequate documentation and witnesses to legally justify our trial and execution of the leaders of America and Russia as war criminals, after we have dictated the peace. I am sure you will need little preparation for such a duty, for sacrifice has always been the watchword of our people, and the death of a few thousand Jews in exchange for world leadership is indeed a small price to pay.

To convince you of the certainty of that leadership, let me point out to you how we have turned all of the inventions of the white man into weapons against him. His printing presses and radios are the mouth pieces of our desires, and his heavy industry manufactures the instrument which he sends out to Asia and Africa against him. Our interests in Washington are greatly extending the Point Four program for developing industry in backward areas of the world so that after the industrial plants and cities of Europe and America are destroyed by atomic warfare, the whites can offer no resistance against the larger menace of the dark races, who will maintain an unchallenged technological superiority.

And so, with the vision of world victory before you, go back to your countries and intensify your good work, until that approaching day when Israel will reveal herself in all her glorious destiny as the Light of the World. . . .

Are you aiding this plan by contributing to a Church that is a member of the National Council of the Churches of Christ in America?

Many of these Churches are advocating the mixing of the races!!

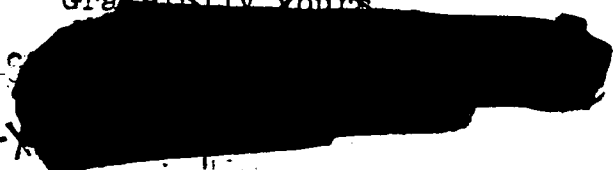

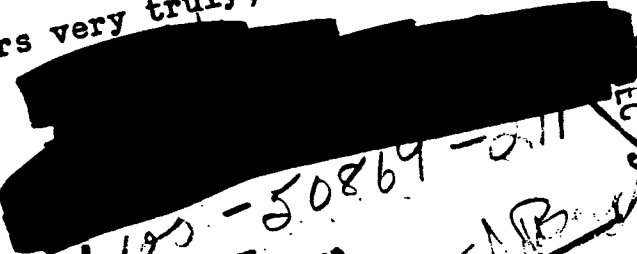

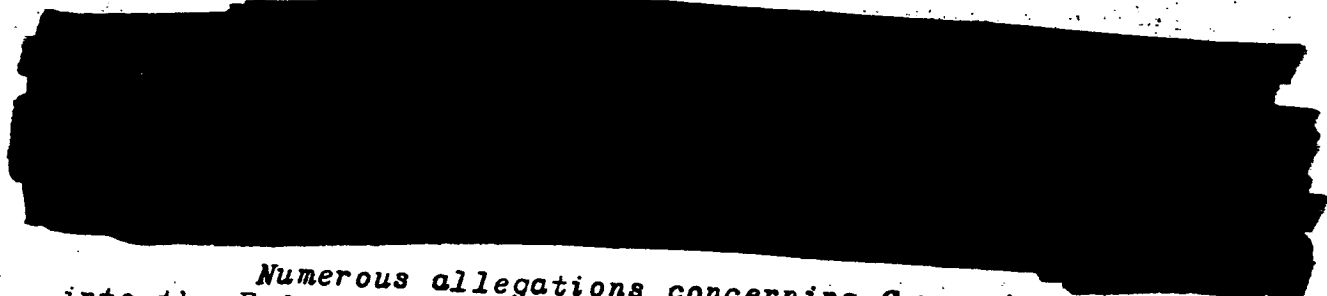

Ike Ignores Politics in Picking Cabinet

WASHINGTON — Orderly minds and efficient operating men can give President-elect Eisenhower a great cabinet. Already the announcement of the three posts of secretary of state, secretary of defense and secretary of the interior reveal that Eisenhower is determined to make efficiency and ability rather than politics the rule.

For John Foster Dulles, as pointed out in these dispatches earlier, is recognized the world over as an American statesman with exactly the right qualifications for secretary of state. And Charles E. Wilson, president of General Motors, is the very type of man long needed to head up the greatly-expanded department of defense.

Parallels Roosevelt's Move.
Just as the late President Roosevelt turned to the president of General Motors, William S. Knudsen, in 1941, to head up the office of defense production, so Eisenhower also turned for a somewhat similar post to the chief executive of the largest business in the world today.

Wilson, of course, like Knudsen, will permanently sever all connections with his company and devote himself entirely to his government position. The president-elect has let it be known on several occasions that he wanted a man of wide business and production experience for the secretaryship of defense. He sees that vital job as not so much a military one, because the tasks of military strategy are vested in the joint chiefs of staff.

He sees the office as involving contract negotiations and appropriations of billions of dollars.

The opinions expressed by David Lawrence in this column are not to be construed necessarily, nor even probably as those of The Press. They are only those of an experienced and responsible commentator.

Businessmen have complained that millions of dollars are wasted because government officials do not understand the production operations of American industry.

Fits Needs of Position.

So, in selecting Wilson, the president-elect has made a ten-strike. Wilson is an engineer. He thinks in straight lines. He is primarily a civilian and will not become immersed in the rivalries of the armed services. Fortunately, he himself, has not been identified with any of them before. He will give the defense department the business management it needs and this will make unnecessary such extra agencies as an office of defense production if a war emergency develops.

Wilson knows full well what can be done by mobilizing small businesses and he knows, also, what the irregular flow of contracts can mean, both from the defense standpoint and the national economy. Small business will get a better break than ever before. If ever there was a time to have a businessman in charge of defense spending it is today when the military appropriations alone run around 50 billion dollars a year.

As for the department of state, the announcement that Dulles will take charge means that worthwhile policies and procedures will

be retained and useless or unwise policies will be discontinued by a man who has been inside the department and knows the score.

Most significant is the manner in which Dulles intends to approach his new duties. He wants to see all the administrative bureaus put in charge of competent men so he can devote himself entirely to policymaking. His appointment was favorably received in Washington by many elements, including church circles. Dulles was for years president of the big Protestant organization then known as the Federal Council of Churches of Christ and he has a son studying to be a Catholic priest.

Abroad there is a mixed reaction to the Dulles appointment. In left-wing Britain and in Russia he has been pictured as a kind of "war monger." But the British people have been so much misled in recent months concerning American affairs by inaccurate if not deliberately distorted impressions about Republican leaders that it may take a little while for them to awaken to the truth, which is that Dulles probably will be found much more direct and forthright and hence more constructive than the vacillating type of diplomat who arouses hopes abroad only to find them dashed to the ground by a realistic reversal by congress back in Washington.

Congress Pleased.

Congress likes Dulles — both Republicans and Democrats say of him that he is an American in every sense and he has not fallen victim to the sloppy thinking which is so often ready to yield American sovereignty at the slightest pressure from the "world government" school of thought.

Dulles is an international co-operationist who never forgets that American interests are most vital to America, and that collective security doesn't mean American boys must do all the fighting in the world while American dollars flow abroad to bolster the budgets of foreign governments. He is a realist about both Europe and Asia, and that's the kind of secretary of state the American people really wanted Eisenhower to pick. And he did.

McKay "Right Man."

The selection of Gov. McKay of Oregon to be secretary of the interior — a man familiar with the vital interests of the west in reclamation and power projects — is also an application of the principle that Eisenhower is trying to follow in fitting the right man to the right job.

Now if the president-elect will select Herbert Brownell as attorney general — and this seems likely soon — the second issue of the campaign, namely how to conduct an efficient, orderly cleanup of Communist influence inside our government, also will be taken care of in accordance with the wishes of the majority of the American electorate.

New York, Nov. 20—President Elect Eisenhower this afternoon made his first three cabinet selections. They are:

1. Secretary of state—John Foster Dulles, Wall street lawyer and special foreign policy adviser to Gov. Dewey of New York.
2. Secretary of defense—Charles Erwin Wilson of Detroit, president of General Motors.
3. Secretary of the interior—Gov. Douglas McKay of Oregon. Dulles and Wilson immediately announced their acceptances. McKay's acceptance followed shortly.

Announced by Hagerly

The announcement was made by James Hagerly, press chief in the Eisenhower organization. He called in reporters shortly after noon and read from a brief statement. The general, he said, "would send the nominations to the senate for confirmation as members of his cabinet" following his inauguration Jan. 20.

Dulles, a well known internationalist, lay church leader and Republican "voice" in several Roosevelt-Truman administration diplomatic ventures around the world, obtained the top cabinet post that was turned down by Gov. Dewey, according to sources close to the inner councils of the new President's entourage.

The New York governor, twice defeated as the G. O. P. Presidential standard bearer, has stated his intention to serve out the remaining two years of his term in the state capital at Albany. Then, his closest friends say, he plans to go into the Dulles firm which has done many profitable legal chores for foreign governments. The governor is not well-to-do.

Might Improve Position

By staying out of the cabinet and dodging brickbats heaved at the new administration, Dewey would be in a position to make another try for the Republican nomination four years hence if in the interim Eisenhower has become unpopular, these sources say.

Dulles would without doubt have been named secretary of state had Dewey reached the White House. Today's announcement culminated the lawyer's long drive toward filling the same post as his grandfather, John Watson Foster, who served in President Benjamin Harrison's cabinet. An aunt of Dulles married Robert Lansing, secretary of state under President Wilson.

"Gen. Eisenhower is a great and purposeful leader," said Dulles in a brief acceptance statement. "His desire for our nation to be just and durable peace is most gladly served in that cause to the best of my ability."

Dulles, 64, the son of a Presbyterian minister, has suffered some embarrassment as the result of important associations with Alger Hiss, the former top ranking state department official convicted of perjury in a case involving the peddling of war time secrets to a soviet spy ring.

The late President Roosevelt appointed Dulles as special adviser to the American delegation at the 1945 San Francisco conference when the United Nations charter was born. Hiss was secretary general of the conference. Subsequently, Hiss was picked for president of the Carnegie Founda-

Wilson, 62, has headed the General Motors organization since 1942, guiding it thru the lean post-war years of reduced production and dislocations of post-war economy.

The proposed defense chief started his industrial career as an electrical engineer in 1909. He served as General Motors vice president from 1929 to 1939, and as executive vice president in 1939 and 1940.

Gov. McKay, 59, named for his prior secretary, was a complete dark horse in the running. According to dispatches, Eisenhower telephoned him this morning and asked him if he would accept. He replied in the affirmative. The Oregon governor refused to discuss any policies he had in mind.

See Eden, Stassen
Eisenhower had another day crammed full of conferences pointing toward the make-up of his new administration. His luncheon guests were British Foreign Secretary Anthony Eden and Harold Stassen, University of Pennsylvania president and former governor of Minnesota. Eden spent an hour and 55 minutes with the general and was smiling and noncommittal at the end of it.

"The general and I talked about international security," said Eden. "For details you will have to speak to Mr. Eisenhower."

Stassen declined to say whether he was angling for a cabinet job. He has been mentioned as a possible secretary of labor. Stassen pronounced Eisenhower's first three appointments as "excellent."

Meets Head of KLM

Before the luncheon, the President Elect was closeted two hours with Dulles. He also saw Dr. Albert Pleman, president of KLM, Royal Dutch Air lines, an acquaintance of Eisenhower's from his days of service in Europe.

"I have some ideas of the world to come which I hope to discuss with the general," Pleman said.

He declined to divulge the ideas. In reply to a question, he said "world federation" was a plan for 150 years in the future. He believed the first step was the North Atlantic treaty organization.

SUPREME COURT UPSETS RAPE CONVICTION OF 2

The Illinois Supreme court yesterday overruled the conviction of Albert Tocco, 24, and Thomas Christofanelli, 22, both of Chicago Heights, on charges of raping an 18 year old Riverdale girl on April 7, 1951. The Supreme court said there was no evidence of forcible attack. In a Cook county Criminal court trial in August, 1951, the defendants were sentenced to prison terms of 25 years each. They were accused of luring the victim into their car and attacking her as they drove thru south suburban communities.

Dear Mr. Hoover:

A story is going around Pittsburgh that the F.B.I. has investigated the National Council of Churches of Christ in America, with headquarters at 297 Fourth Avenue, New York 10, N.Y., and that the F.B.I. would take action because of subversive activities if it were not for the fact that you do not want to be involved in a religious matter. One of the men circulating this story says that he has been told personally by the F.B.I. that this is true.

It so happens that I am connected with several different angles of the National Council and have known some of its top staff members since I entered the ministry more than twenty years ago. I am as interested in the safety and soundness of my country as anyone else and I would like to know, if I am not asking something unreasonable of you, if there is any semblance of truth in this story.

As you perhaps know, the National Council represents the co-operative work of some thirty million Protestants and, of course, in that huge number there must be some of all shades of opinion, but I want to know if the leadership of the National Council has ever been under suspicion or if the Federal Bureau of Investigation has ever said anywhere that these men are subversive.

It is a matter of some concern to some of us as local Protestants that these stories persist. I think you, and you alone, can clarify the situation for us.

On December 15, 1952, [REDACTED] was contacted by Special Agents [REDACTED] and [REDACTED] and personally furnished the copy of the Director's letter to him. [REDACTED] expressed his appreciation of the Director's interest in this matter and stated that he fully understood the Bureau's position.

By way of background, [REDACTED] briefly reviewed the content of his letter to the Director dated November 29, 1952. 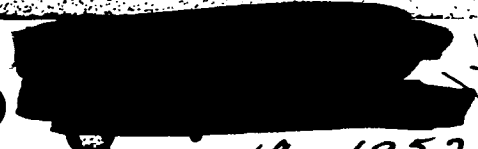

It is noted that during the conversation with [REDACTED] he referred to many individuals as "pinkos" and when asked specifically what he meant by "pinko" [REDACTED] stated that he believed these people were Communist Party sympathizers. With reference to the general allegations concerning the persons considered as "pinkos" by [REDACTED] it is noted that he was not able to furnish any specific information and again stated that it was his opinion.

A review of the Pittsburgh indices at the time the allegations concerning [REDACTED] were received failed to disclose any reference concerning [REDACTED]. No other information concerning [REDACTED] pertinent to this inquiry is reflected in the Pittsburgh Office files.

Since the inquiry in this matter has disclosed what appears to be an interfunctional disagreement within the [REDACTED] and further since [REDACTED] has specifically requested that this office not contact [REDACTED] for reasons stated above, no further action is being taken in this matter at this time.

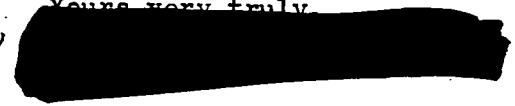

In a meeting this week, a statement was made to the effect that the Bureau had investigated the Federal Council of Churches as a subversive organization. I wonder if it would be possible for you to let me know whether or not such an investigation was made and also something as to the nature of the findings?

As you know, the Federal Council no longer exists since it's work has been included in the work of the present National Council of Churches of Christ in the U. S. A. together with other interdenominational organizations.

Dear Mr Hoover:

Our community of some 50,000 people has been PAI
disturbed by accusations being made by Mr Robert Wells that
the National Council of Churches is communistic and subversive.

Through the public press he has said, "Proof that
it is a SUBVERSIVE organization, cited as such by the U.S. Naval
intelligence". J. EDGAR HOOVER SAYS: "I confess to real appre-
hension, so long as the communists are able to secure ministers
of the Gospel to promote their evil work".

We in America do believe in the freedom of the
press, but we also want the truth. If the National Council
of Churches is subversive, the people ought to know it. If
the F.B.I. has not listed it as such, then we ought to know
that too. Personally, I do not believe such a group to be
subversive. Was not John Foster Dulles active in this group?
It is unthinkable that such a one would be associated with
a subversive group, for he is a fine Christian person.

Would it be possible for me to receive an answer
to the following questions?

Has the F.B.I. ever labeled the National Council
of Churches as a subversive organization?

In your public addresses have you ever accused
the Council of being communistic?

Are the findings of your investigations into
subversive groups, made public?

This may seem trivial in this day of such momentous

Our church wants to support worthwhile movements but we do not want to help any movement that is socialistic and promotes unAmerican practices.

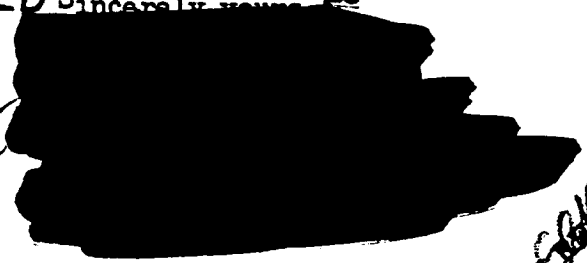

Dear Sir:

I have just read the article by Herbert A. Philbrick, who served as secret agent for the FBI, in the April "Christian Herald," entitled "The Communists are After Your Church!" I am glad for what this article reveals about the tactics of Communists, and I think that churches should guard against communist infiltration.

I would like more information as to what organizations are Communistic. Just what organizations are being used by Communists to trick ministers into supporting Communism without being aware of what they are really doing?

I received a booklet which makes some charges along this line which I have been wondering about. This booklet is entitled "Revised Standard per-Version" and is written by a Rev. Don Brown, pastor of the Fundamental Baptist Church of Buffalo, Missouri. It is supposed to be a printing of a "sermon" which he delivered in above mentioned church. Its main thesis is that the Revised Standard Version is not the Bible. Most of his reasons for saying this seem to me to show lack of real scholarship, but he goes to some length in an attempt to prove that the National Council of Churches in the U. S. A. is communistic and that some of the revisers are communistic--that they belong to many communist organizations. He presents a number of quotations from reports of Un-American Activities Committees of our national and state governments in an attempt to prove that Luther A. Weigle, and W. Russell Bowie are communistic. He also quotes from Attorney Generals Tom Clark and Francis Biddle.

Is there any real grounds for such claims? Could these two revisers have been tricked into some things without realizing what was happening? Are all the organizations listed by Don Brown really communistic? (I imagine you could get a copy of this booklet by writing him--P. O Box 306, Buffalo, Missouri) Is the "Fellowship of Reconciliation" communistic? Do you consider the National Council of Churches to be communistic?

I will appreciate an honest, detailed answer to this letter.

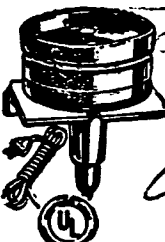

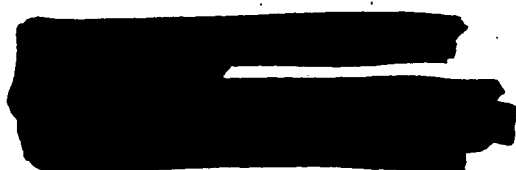

With respect to your letter of June 10, 1953, with enclosures, concerning the subversive lists, I am sending you twelve copies of the "Federal Register" for May 12, 1953, which contains the Attorney General's current subversive listing on page 2741. I see no objection to allowing your friend from General Motors or other associates of yours to go ahead and run off extra copies from this source.

Now with reference to the other group of organizations proposed by the Attorney General for designation within the purview of Executive Orders Number 9835 and Number 10450, a copy of which you enclosed, I think it is perhaps best not to release this data to your contacts until these organizations have been officially designated. I am sure you will agree that this is the safest course of action and would safeguard against any possibilities of embarrassment or criticism in the future. Obviously, you have stirred up a lot of thought-provoking interest in the right places as a result of your distribution.

As to your other letter also dated the 16th with reference to the clergy, I agree that it is definitely a very touchy matter to handle. Fortunately, there can be no question concerning the loyalty of the great majority of the country's clergy, and even among the questionable ones, there is a large percentage who are, in my mind, composed of individuals who regard themselves as enlightened liberals and sincere reformers. Some way or other, [REDACTED] has received the impression that inasmuch as the distribution of these lists is an "official matter," it is necessary to have the Buffalo Office proofread them, if reproduced, for accuracy. [REDACTED] He is being sent copies of the "Federal Register

Regarding [REDACTED] second letter also dated the 16th re the clergy, it is felt desirable to caution him against making any affirmative statements re Communist influence in the churches.

The last paragraph of this communication is in response to SAC Boswell's suggestion that [REDACTED] be thanked for arranging introductory luncheons for him in the Buffalo Division area.

SUBJECT: DIRECTOR'S STATEMENT TO HOUSE COMMITTEE ON UN-AMERICAN ACTIVITIES, 3/26/47

It will be recalled that captioned statement, in the third full paragraph on page 12, contained the following sentence:

"I confess to a real apprehension so long as Communists are able to secure ministers of the gospel to promote their evil work and espouse a cause that is alien to the religion of Christ and Judiasm."

It will also be recalled that in 1949 the American Council of Christian Laymen published the pamphlet entitled "How Red Is The Federal (National) Council of Churches?", a copy of which [redacted] encloses with his attached letter of 7/10/51.

This pamphlet attacks the Federal (National) Council of Churches, and between two paragraphs referring to the Council was inserted the above-quoted sentence from the Director's statement. It thus appears that the Director was referring here to the Council. As a result, numerous inquiries concerning the character of the Council were subsequently received. Depending upon the nature of the inquiries, some were given "files confidential" replies and some were given explanations concerning the origin of the Director's statement.

In this latter category was a letter dated 1/20/51 from Mr. E. L. Repass, a Presbyterian Elder from Danoke, Virginia. The Bureau's reply to Mr. Repass, dated 2/3/51, is correctly reproduced on page 11 of "Plain Facts," a copy of which [redacted] also encloses.

From his letter, it appears that [redacted] desires the Director to take sides in this controversy against the Federal (National) Council of Churches. (100-50869).

The attached letter has been prepared to set [redacted] straight.

RECOMMENDATION:

It is recommended that the attached letter be sent to [redacted] giving him the background of the quotation and a "files confidential" reply on his other inquiries.

On pages ten and eleven of the enclosed pamphlet entitled "Plain Facts about the National Council of the Churches of Christ in the U.S.A." your statement regarding communists being able to secure ministers of the Gospel to promote their evil work is said to be repudiated by you as a reference to the National Council of Churches.

Does your letter to Mr. Repass of February 3, 1951 in any way affect your statement of March 26, 1947 concerning communists being able to secure ministers of the Gospel to promote their evil work? I cannot see that it does in which case the argument set forth by the National Council of Churches is a non sequitor. How does the fact that you have never made any "statements criticizing the Federal Council of Churches or the National Council of Churches" in any way affect the fact that you stated that "communists are able to secure ministers of the Gospel to promote their evil work"?

Whereas your statement of March 26, 1947 was not said concerning the National Council of Churches, your letter of February 3, 1951 to Mr. Repass does not say you "had no such thought in mind" and that such a use of your statement was "unjustified".

It is my opinion that your statement of March 26, 1947 as quoted in the brochure (also enclosed) printed by the American Council of Christian Laymen is entirely justified and I would like to know if you feel otherwise. If the "shoe pinches" that is not your fault.

He resigned when it became clear to him that conditions in the world required preparedness for defense, and has not been a member at any time within the last twenty-five years.

No. 37 is the *North American Committee to Aid Spanish Democracy*.

What are the facts?

Dr. Cavert never was a member of the North American Committee to Aid Spanish Democracy. He made critical statements in 1936 about the way in which Franco overthrew the Spanish Republic, but joined no organization dealing with this issue.

No. 40 is "*The Protestant*."

What are the facts?

Dr. Cavert never was affiliated with this magazine, never served on either its editorial board or its advisory committee, never contributed to its columns. He did sign an appeal against anti-Semitism entitled "Protestantism Answers Hate," which was published by "*The Protestant*," at the time when Nazi propaganda against the Jews was at its height. To infer that this meant any connection with the magazine is untrue.

No. 46 is the *War Resisters League*.

What are the facts?

Dr. Cavert never belonged to the War Resisters League at any time.

▲ ▲ ▲

An especially flagrant case of deception in this pamphlet is the way it uses a remark by J. Edgar Hoover, head of the Federal Bureau of Investigation. Mr. Hoover is quoted as saying, "I confess to real apprehension so long as communists are able to secure ministers of the Gospel to promote their evil work." This statement of Mr. Hoover's is inserted between two sections of the pamphlet, both of which refer to the Council of Churches, and the reader is thereby led to believe that Mr. Hoover was referring to it. Yet Mr. Hoover asserts without qualification that he had no such thought in mind, and that such a use of his statement was unjustified.

given the deceptive title "The Kingdom of God Society," Sunday School literatures are doing the same. David Lawrence, editor of The United States News, writing on the theme, "Saiping at Profit-and-Loss System" said:

"A drive to abolish private ownership and substitute some form of State Socialism appears now and then in democratic countries. But first confidence in the profit system has to be undermined, and the latest example of the subtle efforts to discredit private ownership comes in a bulletin distributed by the Federal Council of the Churches of Christ. Much of the space in the Bulletin (meaning the Federal Council's 'Information Service' bulletins) is devoted to praise of 'Consumer Co-operatives' and of systems of public ownership here and abroad. It would have been a much more persuasive document if it had conceded its thesis to be the advocacy of State Socialism as a desirable objective." (See Issue Dec. 27, 1946).

Must Freedom perish? Those who aid and abet Socialism and Communism in the NCC are numerous . . . and official acts of the NCC often do so.

THE BIBLE

Many of the men whom the Federal Council has delighted for many years to elevate to its principal offices are deniers of the Bible as God's inerrant Word: DR. GEORGE A. BUTTRICK, President of the Federal Council (1940-1942), in his book "The Christian Fact and Modern Doubt" writes:

"Literal infallibility of Scripture is a fortress impossible to defend . . . Probably few people who claim to 'believe every word of the Bible' really mean it. That avowal held to its last logic would risk a trip to the insane asylum." Then, Dr. Buttrick exhorts men to "set out on the long hard quest for truth." (p. 162)

DR. HARRY EMERSON FOSDICK, for many years the Federal Council's most distinguished radio preacher, in his book, "The Modern Use of the Bible" writes:

"Biblical miracles will more and more become surreal ghosts lost in antiquity and, gradually becoming dimmer, will disappear in utter incredulity." (p. 157)

BISHOP G. BROMLEY OXNAM, President of the Federal Council (1944-46) and President of the World Council of Churches, (1948 -), in his book "Preaching in a Revolutionary Age," p. 79, says:

"God, for us, cannot be thought of as an angry, awful, avenging Being who because of Adam's sin must have his Shylockian pound of flesh. No wonder the honest boy in justifiable repugnance could say, 'Dirty bully.'"

The New Revised Standard Version of the Bible is "authorized" by the NCC. It is the product of men who reject the Christian faith — a Bible corrupted by modernism, a perversion.

AMERICAN COUNCIL

The American Council denies the allegation of the National Council that the profit motive is sinful. Honorable profits are endorsed by the Bible as indicated by the parables of the talents and of the pounds. (Matt. 25:14-30; Luke 19:12-26).

The American Council freely concedes the right of collective bargaining for just and righteous ends. It repudiates as contrary to the Bible the trespassing on the part of labor czars into the fields of collective management and control and of collective ownership of such institutions as they in no sense own.

The following is from a resolution adopted by the American Council of Christian Churches on May 1, 1952, through such coercion as threatens no jobs for non-union workers:

"We maintain that joining a union should be entirely voluntary. We have no objection to men joining labor organizations if they so desire in order to safeguard their rights and secure fair treatment. Workers, however, who for reasons of conscience and religious convictions refuse to join a union should not be deprived of their right to work. This Council of Churches is of the opinion that the closed shop is inherently totalitarian, and results in the enslavement of the worker; and for the government to demand a closed shop, or for industry to comply is discriminatory, violates the principle of freedom, and makes the unwilling joiner a victim of forces over which he has little control and no redress."

The American Council believes that the present terrific conflict in the industrial field to preserve free enterprise is but one phase of the larger campaign of the enemy which ultimately would destroy not only economic freedom, but political and religious freedom as well.

At all cost must all outposts of freedom be held impregnable against its powerful foes who are assailing it both from without and from within our land.

Must Freedom perish? Actions of the American Council of Christian Churches never aid Socialism or Communism, Communist-front organization.

THE BIBLE

The Preamble of the Constitution of the American Council, to which all members must subscribe before admission, reads as follows:

"Whereas, it is the duty of Christian believers to make common testimony to their glorious faith, especially in darkening days of apostasy, the bodies forming this Council do now establish it as an agency unreservedly dedicated without compromise or evasion as a witness to the glory of God and the historic faith of the Church universal, including adherence to these truths among others equally precious: the full trustfulness, infallibility, and authority of the Bible, which is the Word of God; the holiness and love of the one sovereign God, Father, Son, and Holy Spirit; the true deity and sinless humanity of Jesus Christ; His virgin birth, His bodily death, His coming again; salvation by grace through faith alone; the precious blood; and the maintenance by His own power of purity of life and doctrine."

The American Council gives evidence to prove the evil character of the Revised Standard Version, and pleads with God's people not to accept this corrupted copy of the Word of God.

A LIFE OR DEATH QUESTION

Christian business men of America today are becoming increasingly aware of the fact that the spread advocacy of plans and ideologies which deny to the Christian the right to life, liberty and ultimately all freedom, it becomes a life or death question when these things are being trumpeted on every hand. Leading churchmen throughout the land are now speaking on behalf of The National Council of the Churches of Christ in the U.S.A. (prior to 1928 known as the Federal Council of the Churches of Christ in America), openly opposing the concept of a controlled-economy, and a cooperative system which they, without any justification whatsoever, describe by the scriptural term of "The Kingdom of God on earth."

Dr. E. Stanley Jones, popular National Council speaker, in his column, "Christ's Alternative to Communism" writes, "When the Western world was floundering in an unjust and competitive order, and the church was bound up with it and was part of that order, God reached out and put his hand on the Russian Communists to produce a juster order and to show a recumbent church what it has missed in its own gospel." (p. 224) Again, on p. 167, Dr. Jones writes, "I am persuaded that Christianity cannot fit into a competitive order." Dr. Samuel McCrea Cavert, General Secretary of the National Council of Churches, in a Council publication is quoted as follows, "The principle of competition seems to be nothing more than a partly conventionalized embodiment of primeval selfishness."

Such foes to freedom as the NCC and its leaders must be exposed. Support for their program must cease — that is, unless American businessmen wish to finance the construction of the guillotine for their own economic necks! The National Council program is obviously at dagger points with our nation's historic position on pacifism and free enterprise, and is contrary to the teaching of the Bible. It is a program which would reject the free economy of our nation as a Republic and replace it with a controlled-economy and accompanying regimentation in a socialist order. Yet leaders of the National Council claim that the weight of American Protestantism endorses their program because it is claimed that over 33 million Protestants are members of the denominations comprising the NCC. "How Red is the National [Federal] Council?" by the American Council of Christian Laymen lists 48 leaders and prominent members of the NCC and shows with which of 46 communist-front organizations they have been identified.

This is what businessmen would like to know: "Are there any Protestant churches which, in the name and authority of the Church of Christ, are opposing the radical innovations and foreign ideologies of these NCC prophets? If so, what are they doing?"

THE ANSWER

The answer is that there are Protestant churches in America which are strenuously opposing the perilous program of the National Council of Churches. Many of them are banded together beneath the banner of the American Council of Christian Churches, principal office of which is at 15 Park Row, New York 38, N. Y. On May 8, 1953, the American Council sponsored a CHRISTIAN CRUSADE AGAINST COMMUNISM, at Constitution Hall, Washington, D. C. At this great Mass Meeting the President, Congress, and the House Committee on Un-American Activities were strongly petitioned to expose and deal effectively with communism in religious organizations. The American Council's straightforward stand for the historic Christian faith and freedom is clearly seen in its pronouncements on these subjects: PACIFISM, FREE ENTERPRISE and THE BIBLE — in contrast to the National Council's dictum on the same issues.

Must Freedom perish? Not if men think straight and act consistently and courageously concerning Pacifism, Free Enterprise and the Bible.

NATIONAL COUNCIL

(From 1908-50, known as the "Federal Council")

PACIFISM

The United States Navy, through its Intelligence Department, made the following declaration in 1935:

"The Federal Council of Christ in America: This is a large, radical, pacifist organization. It probably represents 20,000,000 Protestants in the United States. However, its leadership consists of a small radical group which dictates its policies. It is always extremely active in any matter against national defense" (Congressional Record, Vol. 79, Part 12, p. 13503.)

In 1928 the Federal Council lobbied vigorously in Washington against the Navy's program with a high degree of success. The Federal Council boasted of its triumph in cutting the one billion dollar program to two hundred and seventy-four million—from seventy-one proposed new ships to seventeen! At that time, the Executive Committee of the Federal Council went on record as protesting rearmament generally. More than any other religious organization in the U. S. A. the Federal Council is guilty of contributing to our nation's unpreparedness for World War II, and has a measure of guilt for heavy loss of life by our boys in the earliest days of the conflict.

The Federal Council bitterly repudiated saturation bombings by the U. S. A. and her allies, but there was no word of protest against the most atrocious deeds perpetrated by Germany or Japan.

FREE ENTERPRISE

Plan No. 2 of the "Social Creed" of the Federal Council (now the National Council) advocates the following:

"Social planning and control of the credit and monetary systems and the economic processes for the common good."

The National Council has openly advocated repeatedly through her most responsible spokesmen the abolition of the private ownership of property, and has declared as un-Christian the profit motive in business. It is the usual thing for the National Council to advocate any legislation which radical labor leaders endorse, and their socialist and communist fellow-travelers support. J. Edgar Hoover, Director of the FBI, in his statement before the House Committee on Un-American Activities, on March 24, 1947, remarked:

"The Communists are able to secure ministers of the Gospel to promote their evil work and expose a cause that is alien to the religion of Christ and Judaism."

The Federal Council officially issued a lengthy statement on what should be the Soviet relations of the U. S. A., which was clearly pro-Soviet.

Largely through the influence of the National Council's conferences on "The Church and Economic Life" students in summaries are being prejudiced against free enterprise and made enthusiasts for Socialism, or a controlled economy, to which is

PACIFISM

At its annual meeting in October, 1945, the American Council unanimously adopted the following statement:

"ON MILITARY SERVICE"

"The Christian owes the duty of service and protection to the state as an institution ordained of God and responsible to Him. That duty includes the necessity of bearing arms upon necessary and just occasions. We, therefore, approve the principle of universal peacetime military training. We believe that the sending of untrained boys into combat is cruelly unjust to them and little short of willful murder. In the event of another conflict we may not be given a providential period of time for improvisation as was given us in both World Wars I and II. The Pacifism being spread by the Federal Council of Churches and other agencies will not prevent future conflict, but it might result in the destruction of the United States of America.

"We further urge that in any such program adequate measures be taken to protect the moral and spiritual interest and welfare of the men while in training."

The American Council continues to believe that some form of universal military training is absolutely indispensable to the security not only of the U. S. A., but of freedom wherever it is found in the world. Nothing will be more of a deterrent to another world conflict than a strong America. Her military weakness would constitute the strongest encouragement to aggression on the part of a highly militarized hostile power. During the course of World War II, this further resolution was adopted by the American Council:

"(1) The American Council of Christian Churches pledges its undying opposition to all forms of totalitarianism, whether they be Nazi, Fascist or Communist, and reaffirms its allegiance to the principles of democratic representative government as expressed in the constitution of the United States.

"(2) The American Council of Christian Churches repudiates the Federal Council's militant pacifism, holding it to be anti-Biblical, un-Christian and disloyal to the United States in this time of crisis. We charge the Federal Council of Churches of Christ in America with being a fourth-hand of pacifism for many years, and solemnly declare it must answer at the bar of history for the part it has done in our nation."

FREE ENTERPRISE

The American Council believes that the Eighth Commandment "Thou shalt not steal" is God's sanction for private ownership. No exception is made whereby the state may become a thief. The American Council believes there can be no compromise between freedom and the slavery of totalitarian systems.

I have received your letter of July 13, 1953, with enclosures.

In connection with your inquiry, I would like to point out that at the end of your second paragraph you quote part of a sentence which appeared in my statement before the House of Representatives Committee on Un-American Activities on March 26, 1947. By referring to the complete sentence, and especially to the entire context in which it originally appears, I am sure that you will see that the connotation becomes quite different. I am, therefore, enclosing a reprint of the original text, in which the sentence appears in the third full paragraph on page twelve.

With regard to your question as to how my letter of February 3, 1951, to Mr. E. L. Repass affects this statement, I believe it is obvious that the letter indicates that the statement was not meant to imply anything critical concerning either the Federal Council of Churches, the National Council of Churches, or any other organization. This is entirely in accordance with a policy of long standing which precludes my drawing any conclusions or making any evaluations as to the character of any organization or individual. This policy is based upon the fact that such activities are not within the prescribed functions of the FBI, which is strictly a fact-finding agency.

Obviously, this same policy must apply with respect to the article on Naval Intelligence to which you refer.

SUBJECT: The Communist - Clergy Matter

Dear Edgar:

The nation-wide controversy re the above subject has naturally hit Buffalo, and every so often it boils up.

Eddie Butler of the Buffalo Evening News had Fred Turner, who is one of his special write-up men and who particularly takes care of, shall we say, left wing matters, write up an article which appears in the June 10, 1953, issue of the Buffalo Evening News, copy of clipping enclosed.

I had several calls from friends who have been interested in the activities of the Council of Churches of Buffalo and Erie County. Their questions, in substance, were "How authentic do you think Turner's article is?" My answer was that, if the item reported by Turner were properly and accurately reported, the article must be authentic, inasmuch as Turner brought out the fact that Philbrick had been an FBI under-cover man for years.

Certain, shall we say, of the 700 odd clergymen who make up the Council of Churches of Buffalo and Erie County, I would call "pinkish."

Several years ago you put out a release, and in connection with its distribution to the Executive List, you mentioned that you thought it would be well for the clergy to receive it. I, therefore, took the matter of distribution up with the Reverend Harland M. Frost, Executive Secretary of the Council of Churches, he having received a copy of the release when it was distributed to my Executive List. I could see he was not enthusiastic and, to make a long story short, this is what happened.

- (1) They had no funds to cover the postage.
- (2) Would they run off envelopes from their addressograph machine? Answer - yes.
- (3) Told them I would pay for their envelopes.
- (4) Said he would not want to send them out in their envelopes.

Philbrick Testified That Reds Infiltrated the Religious Field

'7 or 8 Hardened, Disciplined Members Posed As Ministers of Gospel' in Boston Area

By FRED TURNER

To many who are inclined to view with alarm the announced intention of a congressional committee to inquire into the extent of Communist infiltration of the clergy and church bodies, the testimony of Herbert A. Philbrick of Boston, who became an FBI counterspy in the Communist Party, is of interest.

The detailed testimony given in April before a subcommittee of the Judiciary Committee of the U. S. Senate, was published last Wednesday by the U. S. Government Printing Office.

Mr. Philbrick described for the committee the make-up of the "pro" group of Communists to which he belonged in the late '40s in Boston. He listed five or six doctors; about six teachers; 20 to 30 college or university professors; 12 to 15 businessmen; four or five government workers and, "in the religious field, seven or eight." They were all "deeply underground," whose identities were not even known to rank and file Communists.

Questioned by Chief Counsel Robert Morris, the queries and answers were as follows:

MR. MORRIS—You say in the religious field. What do you mean by that?

MR. PHILBRICK — By underground pro group Communist Party members in the religious field I mean those individuals—and this, again, was to me, a Christian, a matter of terrific shock when I discovered this fact in Boston, a very dismal fact, that actually the Communist Party had in its pro group section between seven and eight individuals, hardened, disciplined, steeled party members posing as ministers of the gospel.

SENATOR HERMAN WELKER

(Idaho)—In connection with the ministers you have mentioned in the Pro-4 group, in your experience . . . were they ministers first and then Communists, or Communists first and then ministers?

MR. PHILBRICK—So far as I could determine, these individuals were all Communists prior to their becoming ministers. In fact in the latter part of 1948 and early 1949, I actually sat in at a cell meeting at the home of Otis Hood, one of the heads of the Communist Party . . . and a member of our cell at that time was a young Communist who was being assigned by the Communist Party to that field of activity, and was in fact . . . about to be planted or was already planted in a seminary to study to be a minister . . .

SENATOR WELKER—Then these few ministers that were planted were dedicated to the Communist cause and not to the cause of their religion.

MR. PHILBRICK—That is absolutely true, sir.

SENATOR WILLIAM E. JENN-ER (Indiana)—To your knowledge did the Communists try to influence the ministers in the Boston area?

MR. PHILBRICK—Senator, that was one of the main projects which we had. All through the years, way back, starting with the youth activities, we were constantly instructed by Communist Party bosses to work upon the church groups, church youth activities, church youth organizations and upon both ministers and laymen.

When Mr. Philbrick moved to Wakefield, Mass., the first instruction he got from the Communist Party was to join the church of his denomination.

Dozens of suspected Communists called before the congressional committees have been permitted to place in the record formal statements denouncing the investigating committees in scathing terms.

Mr. Philbrick supplied the answer for this pattern.

The testimony continues:

SENATOR WELKER—What was the attitude of the Communists toward congressional investigations such as this?

MR. PHILBRICK—Not only a congressional committee, but even a court of law, a United States court of law—it was taught to us and described to be simply a tool of the capitalists . . . an organization designed to oppress the working class . . . We were taught to hold this committee and any legally, duly constituted committee or legal organization of the U. S. Government in complete contempt.

The next witness was Howard Selsam, a former teacher at Columbia University and Brooklyn College. He was unfriendly.

"I come before this committee only under compulsion," read his prepared statement. "I testify under protest. This is nothing but an evil inquisition into the heresies of which educators may be suspected. . . . Such a proceeding as this deserves nothing but contempt from any teacher, scholar or citizens of a democracy."

The Selsam statement differed but faintly from dozens of other statements filed by unfriendly witnesses.

Council of Churches Asks Full Hearing For Bishop Oxnam

The Council of Churches of Buffalo & Erie County has recommended a complete House Un-American Activities Committee hearing for Bishop G. Bromley Oxnam of the Washington Area Methodist Church "so that he and the National Council of Churches can defend themselves against the smear campaign that is being waged against them."

The council's support of the outspoken and widely-criticized Methodist leader came in an overwhelmingly-supported resolution at its annual mid-year planning conference Thursday afternoon and evening on the Council House lawn at 1272 Delaware Ave. Some 150 clergy and laymen attended.

Offered by the Rev. J. Ralph Davie, minister of South Park Baptist Church and temporary chairman of the council's Public Affairs Department, the resolution was presented "in view of recent criticism directed at Bishop Oxnam by Republican Representative Harold H. Velde of Illinois, the Investigating Committee's chairman."

Drive 3% Past Goal

In another resolution, the council urged continued financial support of the United Nations International Children's Emergency Fund "because of its humanitarian effects." Copies of both proposals, Mr. Davie noted, will be sent to the nation's Capital.

Harvey W. Busch, finance-campaign chairman, reported that contributions totaling \$62,744.40 pushed the January-February drive 3% over its \$60,835 goal.

Expressing gratitude to everyone "for their wonderful support," Mr. Busch announced that the council's 1954 budget will total some \$79,600.

Mrs. Mildred H. Taylor, director of the council's Displaced Persons Department, noted that 455 families or 1941 persons have received aid since the department was formed in January 1949.

8 Groups Report Needs

The department closes June 30, she reported, because the flow of persons needing help has dwindled to the point where it would be more economical to turn cases over to the International Institute. The department will reopen if the need ever arises, she said.

Eight simultaneous discussion groups which considered the present work of the council reported that there is still a need for:

1—A "stronger" public relations program.

2—Arousing individuals to take action on public issues.

3—Sharing the insights and various special emphasis of various denominations.

4—Strengthening the chaplain program in hospitals, colleges.

5—Exploration of the special ministeries.

6—Aiding churches in the older sections of the city.

7—Reaching more lay people in the Council's work.

Dr. Ralph W. Loew, pastor of Holy Trinity United Lutheran Church, quizmaster, emphasized that all participants praised the cooperation of the press, the radio stations and WBEN-TV "for their willingness in transmitting church news."

DANGER AHEAD.
"THE GROWING SUPER-CHURCH"

- A Critique of the National Council of Churches of Christ
 BY JAMES DeFOREST MURCH

In November 1950 in Cleveland, Ohio, in the midst of a scene rivaling papal pageantry, the National Council of Churches of Christ was organized, superseding the Federal Council of Churches of Christ. A true appraisal of its aims, purposes, methods, and beliefs brand it as the organized apostasy of today. We might be persuaded to blithely let this organization go its way and to deceive ourselves that it can make no impact upon the thoroughly evangelical forces of our nation. But this is far from true, for as this incipient super-church develops its program, the true church will find itself not only opposed by, but in positive conflict with this super-body. Its program is materialistic, socialistic (if not communistic), Christ-denying, and opposed to the true gospel.

There are several areas in which the carefully planned and organized activities of N.C.C.C. have already affected, and can further affect, the true Christian testimony.

1. *In the establishing of churches and erection of church buildings.* Let us quote from Dr. Murch's analysis of the situation:

"In many cities, territories have been assigned certain denominations to the exclusion of all others. In one large midwestern city a home missionary organization made a canvass of a suburban area to determine where a new church might be established. Forty families of the community were discovered in one suburb who were being forced to travel many miles to attend the church of their choice, because the Council of Churches insisted that no church but a Presbyterian church could operate in this territory. The home missions body proceeded to buy a lot without permission of the Council, and to organize a church. When the Council secretary heard of it, he immediately engineered protests to the City Planning Commission who blocked the establishment of the new church on zoning technicalities. At the edge of the same city a new government housing project barred the same home missions organization from establishing a new church there, despite the fact that it was able to prove that a large percentage of the citizens were of its faith. The Council of Churches was then asked to establish an Ecumenical Church which it did under the leadership of a rank 'liberal' minister. Thus it will be seen that an unholy alliance between super-church and state is already in existence in some sections of the nation, to prevent strictly evangelical churches from being established. In these areas one who labors under the belief that this is a free country, and the law-abiding citizens may build a church where they can worship according to the dictates of their conscience, has to reckon with a new un-American factor in the nature of a super-church. If this is the case today, what will conditions be a few years from now when

the Ecumenical Church machinery is geared to power politics and greased for precision operation?"

2. *In its opposition to true evangelism.* The local Councils of the NCCC in Los Angeles, Boston, and Portland opposed the Billy Graham meetings. In Portland five downtown pastors in a well-advertised panel discussion one Sunday night literally "took Dr. Graham apart" and stated that the campaign had "set the cause of Christ in Portland back fifty years."

3. *In the field of foreign missions.* NCCC has absorbed the former Foreign Missions Conference of North America and will now control missionary personnel, mission policies, and occupation of fields. It will decide what missionary, charitable or educational institutions may or may not be established or supported. Evangelical missionaries under church boards in the NCCC have already felt the iron hand of restriction in these directions, and one missionary wrote, "It is worse than being under a bishop."

Worse than this, through political flinching with foreign governments, of which the former Federal Council was quite capable, NCCC may and possibly can in future bar true evangelical testimony from certain areas.

4. *In the field of radio broadcasting.*

"The Council early recognized the importance of this means of disseminating religion. At a conference in Atlantic City, Dr. Charles C. MacFarland, then FCCC secretary, made this widely-publicized statement: 'The ultimate plan to be worked out will probably be for the local federations of churches to endorse and local stations to present national programs provided on Sunday by the Federal Council, whereby all will have their choice of hearing . . . a few selected preachers who have received the full endorsement of the Federal Council.' Dr. MacFarland continued, 'The Federal Council is now surveying the entire field throughout the country and is signing up all available stations to carry its programs.' Frank R. Goodman, later head of the FCCC Department of National Religious Radio, made this survey and signed up fifty or more stations with iron-clad contracts obliging them to use the Federal Council religious programs and none other."

"At the Atlantic City conference a reporter asked, 'Did you mean, Dr. MacFarland, that it is the expectation of the Federal Council to control all religious broadcasting, making it impossible for denominational conventions to get on the air and for pastors to broadcast sermons without Federal Council sanction?' Dr. MacFarland replied, 'Precisely. The Council feels this to be a wise policy.' Thus was laid down the policy which in principle at least has been perpetuated until the present."

Only the grace of God and the loyalty of millions of Bible-believing, Christ-honoring radio listeners in a still-free America make possible such evangelical broadcasts as "Revivaltime," "The Lutheran Hour," "The Hour of Decision," and "The Old Fashioned Revival Hour." "Nevertheless these programs must pay commercial rates and are under constant shrewd undercover attack designed to eliminate them from the air."

All of our preachers, as well as our constituency at large, should read and be warned to alertness by Dr. Murch's able analysis of this modern apostate Colossus.

Dear Mr. Hoover:

This year Christian Education Week, as sponsored by the National Council's Division of Christian Education, has been set for September 27 - October 4. The theme of the observance will be: For All Children, Faith in God.

The Central Department of Public Relations is endeavoring to assist in every way it can to bring full notice of the Week to the attention of the whole American public, with special emphasis on the press media. One very effective way to obtain press cooperation in helping promote the Week is to furnish the newspapers (and radio stations) with a group of thoughtful statements on the place of spiritual and religious values in the lives of children. There would be seven statements in all, one from each of seven prominent church and lay leaders, for use on each day of Christian Education Week.

I earnestly hope that we may call on you to compose one of these statements, of a length not exceeding 250 words. It would have to be in our hands September 8th at the latest, to give leeway for general press release.

Here are some suggestions that may stimulate thought along the lines mentioned:

The importance of spiritual and religious values in the lives of children to the welfare of the nation.

The importance of these values in the child's own life.

The contribution of these values instilled in the young to family stability.

The ways spiritual and religious values help keep boys and girls out of difficulties and provide them with happy experience in life rather than those that lead too often to prisons.

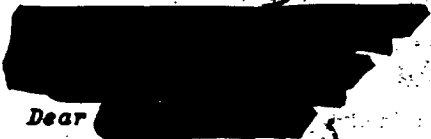

plete analysis of his charges against one of the 48 listed churchmen is presented. Dr. Samuel McCrea Cavert, respected General Secretary of the National Council of Churches, has been dedicating his time, talent and experience for the past 35 years to the development of Christian cooperation in this country and throughout the world. Because of his key position in the Council, we present a detailed examination of the attacks on him.

Dr. Cavert is charged with having "aided and abetted God-hating un-American organizations" — namely, Nos. 24, 37, 40, and 46 in Mr. Kaub's hodge-podge compilation.

No. 24 in his list is *The Fellowship of Reconciliation*.

What are the facts?

Dr. Cavert did belong to the Fellowship of Reconciliation for a year or two at the time when our government was convening an international conference for reduction of armaments and pressing for the Kellogg Pact for the Outlawing of War. He resigned when it became clear to him that conditions in the world required preparedness for defense, and has not been a member at any time within the last twenty-five years.

No. 37 is the *North American Committee to Aid Spanish Democracy*.

What are the facts?

Dr. Cavert never was a member of the North American Committee to Aid Spanish Democracy. He made critical statements in 1936 about the way in which Franco overthrew the Spanish Republic, but joined no organization dealing with this issue.

No. 40 is "*The Protestant*."

What are the facts?

Dr. Cavert never was affiliated with this magazine, never served on either its editorial board or its advisory committee, never contributed to its columns. He did sign an appeal against anti-Semitism entitled "Protestantism Answers Hate," which was published by "*The Protestant*," at the time when Nazi propaganda against the Jews was at its height. To infer that this meant any connection with the magazine is untrue.

No. 46 is the *War Resisters League*.

What are the facts?

Dr. Cavert never belonged to the War Resisters League at any time.

An especially flagrant case of deception in this pamphlet is the way it uses a remark by J. Edgar Hoover, head of the Federal Bureau of Investigation. Mr. Hoover is quoted as saying, "I confess to real apprehension so long as communists are able to secure ministers of the Gospel to promote their evil work." This statement of Mr. Hoover's is inserted between two sections of the pamphlet, both of which refer to the Council of Churches, and the reader is thereby led to believe that Mr. Hoover was referring to it. Yet Mr. Hoover asserts without qualification that he had no such thought in mind, and that such a use of his statement was unjustified.
