— PROCEEDINGS —

The Eighty-Eighth session of the Louisiana Conference of the Methodist Protestant Church convened with the Methodist Protestant Church at Grayson, La., Oct. 26th, 1934.

The Conference was called to order by the President, Rev. F. Lyman Shows, who also conducted the devotionals by scripture reading and prayer.

Mr. John Wesley McKeithen, one of our loyal, consecrated laymen and member of the entertaining church, delivered the welcome address, which carried with it inspiration and confidence.

This address was fittingly responded to by Rev. G. J. L. Brown, one of our faithful pastors.

The Conference Roll was called and upon motion the name of Rev. James Albert Holt was transferred to the Roll of our Honored Dead.

Upon motion the Conference Bar was fixed to include the first five pews from the altar.

At this time the Secretary called the Roll of our Sainted Dead.

Upon motion O. A. Anderson was seated delegate from Bear Creek church.

Dr. John C. Broomfield, President of the General Conference, arrived and was introduced to the Conference.

Upon motion the time was fixed for Dr. Broomfield to address the Conference immediately after the Conference re-assembled for the afternoon session.

The President called Rev. G. J. L. Brown to the chair, after which he read his annual report which was adopted.

PRESIDENT'S REPORT

To the Eighty-Eighth Session of the Louisiana Annual Conference Methodist Protestant Church, Grayson, La.

Dear Fathers and Brethren:

I come to you in the name of Christ our Lord. It is with a heart of gratitude that I am before you to make my annual report. Considering the many things we have had to contend with and the continued depression, this has been a great year in many respects. God has blessed us with many revivals of the "Old-Time Wesleyan type." Souls have been led to Christ and quite a few have been added to the churches

We have only lost one of our ministers this year, and that in the person of Rev. J. A. Holt. Brother Holt was a dear, good man

and we are sure that he is now enjoying the reward of the faithful. Three of our ministers have lost their companions this year. Early after the last session of our Conference, God called and Sister Patten was exalted from the task of sharing in the sacrifices of her faithful husband, Rev. I. A. Patton, to a home with God; as was Sister Lee, the wife of Rev. J. W. Lee who was called some months after Sister Patten's going; also the wife of Rev. E. O. Hearn, who this year passed away.

We feel that our people have been gradually climbing. The different interests of the church have been taken care of in a better way than they were last year. The work among our women has been very gratifying, showing a steady, upward trend, with half of the apportionment paid at the end of the first six months of the fiscal year.

The Leadership Training School is proving a great factor in our Conference in giving us trained leadership in our Sunday Schools, Christian Endeavor and other phases of church work. We had one hundred and fifty registered for work in our school this year. One unit of the buildings was completed on the beautiful camp site at Chatam where we met this summer. Each student was asked to pay \$1.75 to take care of registration and meals, this with a few small donations of groceries, covered the expense of feedings, with about \$22.00 left over to start with next year. The building completed is the kitchen and dining hall, size 24x120 feet. The credit for this work is due largely to the untiring efforts of the Chatam people, and especially the menu committee. We hope not only to be able to feed ourselves next year but to have our sleeping quarters ready also.

Official Acts

A short time after the last session of our Conference I was asked to appoint a commission of twelve of our ministers and laymen to meet with a like commission from the Arkansas Conference to try to reach a basis of union between the Southern part of the Arkansas Conference and the Louisiana Conference, which I did. Early in December I appointed Rev. R. H. Hearne, pastor of Arcadia Circuit. In the early part of the year I gave letters of standing to Mrs. Bessie Kindricks and Rev. J. A. D. Williams. About the first of September, I released the following brethren that they might enter school: Rev. J. E. Garlington from Jena; Rev. T. E. Strickland from Campbell Church and Rev. L. A. Bodie from Pollock. These churches have been taken care of by different ministers since the release of these brethren. I attended the Missionary Convention in Washington, D. C., in May; also the Southwest Group Conference at Haynesville, La., in June. I have held fifty-three quarterly conferences, two revival meetings, preached about three times a week, traveling about twenty thousand miles in my car during the year.

Recommendations

I would like to refer to the recommendation I made last year in regard to the four special days: If our pastors would see to it, that each church observed these days, the amount raised for general conference interest would be much larger. There should be a missionary society in each church; the pastors can assist our Loui-

siana branch president in bringing this about by telling their churches the advantage of having such an organization.

Our annual conference claim has come up almost blank for a number of years so early in the conference year I suggested a plan for raising this fund and the most of our churches adopted it. The plan is, that each member of the church pay one penny for each year of their age. I would like for this conference to adopt this plan, unless someone has a better one.

And last, I want to suggest again, as I did last year, that there is plenty of room for the extension of the Methodist Protestant Church in this state, and we should be getting into new fields. We did not join the church or conference to obtain a place or position but our work is to extend God's kingdom through the Methodist Protestant Church.

Afternoon Session, First Day

Devotionals by Rev. F. L. Hearn, after which Dr. John C. Broomfield addressed the Conference on "World Conditions and the General Interest of the Denominational Program." This splendid address was enjoyed by all present.

The hour for the election of officers having arrived, the President appointed J. C. Blackburn, P. C. Thomas and L. J. Overstreet as tellers.

Rev. F. Lyman Shows was re-elected President on the first ballot and upon motion the vote was made unanimous.

By motion the President was ordered to cast the Conference ballot for the re-election of Rev. Mary Ellon Perdue as Secretary.

By motion the President was ordered to cast the Conference ballot for the re-election of Rev. Ira L. Yeager as Treasurer.

Rev. Edwin H. Grant was elected Statistician.

Upon motion the same standing district committee was elected.

Upon motion the Board of Church Extension remains the same with one exception. Because of the resignation of Rev. E. O. Hearn, Rev. Lula Wardlow was elected to take his place on said Board.

Committee on Periodicals submitted report which was adopted.

PERIODICALS

We your committee submit the following report:

Whereas there is a tendency among our people to permit our church paper to be supplanted by secular and independent religious papers which have no claim on us and our people and do not advocate our church benevolence nor instruct in the teachings and history and achievements of our beloved Methodist Protestant Church nor inspire loyalty to same;

Therefore, we recommend that each probationary member of this conference be required to subscribe for and read the Methodist Protestant Recorder to pass their course of study and that each member of this conference subscribe for same and do all they can to put the paper in the homes of each member of the church, and where possible that churches take advantage of the "block subscription plan" and that we use our own Sunday School literature.

Rev. Morris Lee's report was read and adopted.

Motion prevailed to adjourn.

Dr. John C. Broomfield filled the pulpit in a most masterful way at the evening hour.

Morning Session, Second Day

The Conference was called together promptly at 8:30 a. m., by Rev. Edwin H. Grant.

Devotionals were conducted by Rev. C. A. Calhoun.

The roll was called and the minutes of Friday's session read and adopted.

Dr. Frank W. Stephenson, Secretary of the Board of Christian Education; Dr. Sutton, President of Westminister College, Tehacanna, Texas; Dr. J. A. Wade, pastor of the Methodist Protestant Church, Magnolia, Ark.; Rev. C. A. Calhoun, pastor, Methodist Protestant Church, Haynesville, La., were introduced and invited to honorary seats.

Because of the limited time Dr. Stephenson and Dr. Sutton could be present it was moved and carried that they be permitted to address the Conference immediately in the interest of their special work.

At the close of their addresses a resolution was offered by Rev. Edwin H. Grant pledging anew our loyalty to the program of our General Conference and to the support of Westminster College.

RESOLUTION OFFERED BY REV. EDWIN H. GRANT
AND ADOPTED

In view of the messages brought to us by the President of the General Conference, Dr. J. C. Broomfield; and the Secretary of the Board of Christian Education, Dr. Frank W. Stephenson, be it resolved: That we, the members of the Louisiana Conference, pledge anew our loyalty to the program of our General Conference, and our cooperation with the Board of Christian Education, and our support of Westminster College at Tehuacana, Texas.

Upon motion time was granted Rev. J. A. Wade, pastor of the Magnolia Church, Magnolia, Ark., to address the Conference and also to bring fraternal greetings from the Arkansas Conference.

The Conference adjourned and the eleven o'clock hour was under the auspices of the Womans Missionary Auxiliaries of the District; Rev. J. Lawrence Grant and family, returned missionaries from China, having charge of the program which was deeply spiritual. At the close an offering was taken for Missions.

A bountiful dinner was served on the church lawn by the ladies of the church.

Roll call omitted. Minutes read and adopted.

Rev. Ola Ramsey's report read and adopted.

Upon motion and by his request, Rev. John Strozier was transferred to local ranks.

Upon motion and by his request Rev. H. H. Cantley was left without appointment.

Upon motion Rev. A. Deville was transferred to the local ranks.

Rev. J. B. Blackburn, W. W. Waller, Richard M. Walker, Jack Wiggins and J. F. Reid submitted verbal reports which were accepted.

Committee on Finance submitted report which was rejected.

Committee on By-Laws and Rules of Order submitted report which was adopted.

Committee on Itinerancy and Orders submitted report which was adopted.

1st: We recommend that Paul B. Durbin having satisfactorily passed the prescribed course of study, be elected to Elders Orders.

2nd: That Ezell Garlington and Jack Wiggins be passed to the Third Year's Course of Study.

3rd: That Charles Moore and T. E. Strickland be passed to the Second Year's Course of Study.

4th: That Jas. W. Patton, J. T. Garrett and Miss Lizzie Lewis coming properly recommended by their respective quarterly conferences be granted probationary relationship to this conference, and be placed in the First Year's Course of Study.

EDUCATION

We your Committee on Education submit this, our report:

Whereas the demand for educated people to fill all walks of life is continually increasing and high schools and institutions of various kinds to meet these demands are accessible to almost every youth of the land, making it possible for the poorest to have, at least a high school education; and,

Whereas, these opportunities are being taken advantage of, it becomes us as a church to take a definite stand against an illiterate ministry; and,

Whereas, many of the so-called Theological Seminaries are sending out young men and women filled with the poison of false doctrines to institute in the churches modern methods of kingdom service, we therefore, recommend:

That we get our eyes opened to these appalling facts and see to it that the young ministers of our churches receive their training, if possible, from our own fundamental schools and go into the fields that are now white unto harvest, God-called and Spirit-filled to preach the doctrines of the Bible uncompromisingly and to earnestly contend for the faith once delivered unto the Saints.

We further recommend that all of our ministers having a limited education avail themselves of every opportunity of learning by diligently reading and studying such books, papers and maga-

zines as would be profitable along fundamental lines that they may show themselves "approved unto God, workmen that needeth not to be ashamed, rightly dividing the word of truth."

Ten per cent of this is to be used for local or state expenses. The remaining 90 per cent is to be used for general conference interest of which each pastor will receive credits for their part. All funds sent to branch treasurer will be promptly receipted. Our branch is asked for one hundred dollars (\$100.00) from thank offering, \$50.00 in November and \$50.00 in February.

BY-LAWS

Section 1. No delegates shall be entitled to a seat in the annual conference without proper credentials or other satisfactory evidence of his election; and in case of alternate, the certificate shall so express it.

Section 2. Delegates to the annual conference shall be elected from the members in good standing and in full membership, over the age of fifteen years. In circuits, stations, and missions, it shall be the duty of the Steward to designate the time and place and give notice of election. The election shall be held under the directions of the Stewards; and they shall act as judges of the election and cause the same to be returned to the Fourth Quarterly Conference, there to be compiled and consolidated. The person or persons receiving a plurality vote shall be declared duly elected delegate or delegates, and receive certificates accordingly; provided that in the case of a tie, members of Quarterly Conference, by a majority vote shall decide; and provided further that in case the delegates and alternate elected from any work are providentially hindered from attending the annual conference to which they were elected, then the pastor in charge shall have the right to appoint a suitable person to represent the work in the conference. That no one, especially the men shall be allowed to vote for delegate who does not contribute regularly for the support of the pastor and the claims of the general and annual conference.

Section 3. No person shall be elected to orders, except they be persons of exceptional moral character, genuine piety, respectable attainment and sound in the belief of the fundamental doctrine of christianity and faithful in the discharge of gospel duties.

Section 4. No minister in good health shall be left without ministerial work for more than two years at the end of which time he shall resume his itinerate labors, or be transferred to the unstationed list, and if so transferred shall receive a certificate of his standing. This rule shall apply to any minister so transferred provided he, at his own request, may locate by vote of the conference.

Section 5. No minister or preacher appointed to a circuit, station or mission, shall cease from labors assigned him by the stationing authority until his term of service shall have expired, except by consent of the president, for reason by him deemed expedient.

Section 6. The Secretary shall furnish each pastor with a condensed blank Pastors report at least ten days prior to the opening of each session of the annual conference that each pastor during the morning of the second day of conference hand their reports to the committee on pastors reports and that as soon as passed upon by committee and conference, said report shall be delivered to conference steward for his action, then to the statistical secretary for final disposition. Should any pastor fail to comply with this rule for the first offense he shall be reprimanded by the president and for the second offense shall be located by a majority vote of the conference. That the evangelists and conference missionaries read their reports to the conference. We recommend that when the president visits a pastoral charge, that he first converse freely with the pastor as to the spiritual and financial condition of the charge and that he insist on a strict obedience to the vows made when uniting with the church.

Section 7. The Board of Stewards of each Charge shall soon after the adjournment of the annual conference meet and in connection with the pastor proportion the assessment made by the Fourth Quarterly Conference for the support of the pastor. The proportion to be made to each class according to ability and willingness to pay and that the Stewards see that the same is paid promptly and in connection with Section 7, we recommend that each Steward keep a non-effective roll, noting those that are able and do not contribute to the support of the pastor, the president and to the general interest of the church and that the Stewards notify the pastor of the number of members that do not help support the church.

Section 8. On all subjects involving the financial interest of the church no one shall be entitled to vote except those who are eighteen years of age and are contributing members in full membership.

Section 9. Any member twenty-one years of age and in good standing and in full membership for one year is eligible to any office in the church and as a delegate to the annual conference; provided that where a church, circuit, station or mission has no member of said age, they may place in office in the church or elect as delegate to the annual conference such as are not twenty-one years of age and such as have not been members one year.

Section 10. Due notice shall be given previous to any action to be taken that involves the financial interest of the church.

Section 11. The term of office of Conference Steward shall be one year.

Section 12. The Conference Steward shall be required to receive and hold all moneys collected for various benevolent purposes from the different Charges, also Conference collections.

Section 13. It shall be the duty of the conference steward to settle all incidental expenses of the conference out of the conference collections during the session and present the remainder to the conference for disbursement.

Section 14. He shall pay over to the different boards or persons authorized to receive same all money received for the various benevolent purposes taking receipt and at which any other business in his hands shall make proper exhibit to the conference during the session at which he was appointed also at the expiration of his term of office.

Section 15. At the first quarterly conference of each conference year the pastor shall call attention to the amount of the assessment made by the fourth quarterly conference for his support during the year. Immediately after each quarterly conference the pastor shall call attention of each class to the amount of his salary that is unpaid and in case the pastor neglects to do this, the Steward will not be held responsible if the full amount is not paid.

Section 16. There shall be appointed at each session of the annual conference a minister or preacher to preach an opening sermon at the sitting of the next annual session.

Section 17. The proceedings of the annual conference shall be recorded by the secretary and properly arranged for printing in the annual minutes for which she shall receive reasonable compensation and the minutes shall be signed by the President and the Secretary.

Section 18. The secretary shall take charge of all books and journals, records and proceedings of the conference and transmit the same to the conference at its next session.

Section 19. The President shall be stationing authority of the conference, calling to his aid as council one layman from each work represented.

Section 20. In stationing the ministers and preachers,

there shall not be given to any one appointment who in the opinion of a majority of the members is incompetent for the duties thereof, or who they believe will neglect the appointments and such ministers and preachers may be transferred by conference to the unstationed list; provided that no minister or preacher who in the judgment of the conference is entitled to a superannuated relationship shall be transferred.

Section 21. It will be the duty of the President to see that deeds be taken to all the church property belonging to the Methodist Protestant Church in the Louisiana District and have same recorded.

Section 22. That the President, Secretary, Conference Steward and Standing District Committee shall be elected at 3:00 o'clock p. m., on the first day of each annual session of the Louisiana Annual Conference of the Methodist Protestant Church.

Section 23. These By-Laws can only be changed, altered or amended by giving one day's notice in open Conference of such change, alteration or amendment and it will require a two-thirds vote of the members belonging to that session of the conference.

RULES OF ORDER

Section 1. The conference shall be opened promptly on the day and time appointed, the president conducting the devotional services. The roll shall then be called, after which the president shall read the annual report.

Section 2. During the morning of the second day of conference all ministers and preachers under appointment of this conference shall hand their reports to the committee on Pastor's Report.

Section 3. On assigning the floor to any member of the conference he shall distinctly announce the member to whom it is assigned.

Section 4. All motions and resolutions shall be written if the President and Secretary request.

Section 5. When a motion is seconded or a resolution introduced and seconded, or a report presented and is read by the Secretary, or is stated by the President it shall be deemed in the possession of the Conference any time before the amendment or decision.

Section 6. All motions to postpone or lay on the table shall be taken without debate.

Section 7. No new motion or resolution shall be entertained until the one under consideration has been disposed of which may be done by adopting or rejecting, unless one of the following motions shall intervene, which are placed namely: First, indefinite postponement; second, laying on the table; third, referred to a committee; fourth, postponement to a given time; fifth, substitute; sixth, amendment. A substitute may be amended.

Section 8. When any member is about to speak in debate or deliver any matter to the Conference, he shall arise and respectfully address the President but shall not proceed until recognized by him.

Section 9. No member shall be interrupted while speaking except by the President to call him to order when he departs from the question or uses personalities or disrespectful language; but any member may call the attention of the president to the subjects when he deems a speaker out of order and any member may explain when he thinks himself misrepresented.

Section 10. When a member wishes to speak on a question of privilege he shall briefly state the question, but it shall not be in order for him to proceed until the President shall decide it a privileged question.

Section 11. No person shall speak more than twice on the same question nor more than five minutes at one time, without leave of the conference; nor shall any member speak more than once until every member choosing to speak has spoken; provided, however, that the mover of a resolution or a committee making a report shall in all cases be entitled to five minutes to close the debate.

Section 12. When a motion or resolution shall have been voted upon by the conference it shall be in order for any member who voted with the prevailing side to move a reconsideration but a motion to reconsider is a non-debatable motion, and must be decided without debate.

Section 13. No person shall absent himself from the conference without leave, unless he is sick or unable to attend.

Section 14. No member shall be allowed to vote on any question who is not within the Bar when such question is put by the President except by leave of the Conference when he shall be necessarily absent.

Section 15. Every member who is in the bar at the time the question is put shall give his vote, unless the conference for special reason excuse him.

Section 16. It shall be in order for any member to call for the ayes and nays on any question before the conference and if the call be sustained by one-third of the members present, the vote shall be taken by the ayes and nays.

Section 17. It shall be in order to move the question be taken without further debate on any measure pending before the conference except in cases where character is involved.

Section 18. A motion to adjourn shall always be in order and shall be decided without debate.

Section 19. The president shall appoint the chairman of committees on subjects of general interest and notify each chairman of his appointment at least ten days before each session of the conference.

Section 20. The committee on examination shall be appointed one year in advance and meet at next annual conference one day prior to convening of that body and that the under-graduates meet such committee for the purpose of being examined in their studies. Failure on the part of the under-graduates with this requirement (unless providentially hindered) forfeits their opportunity to meet the committee during that session of conference.

Section 21. No minister or preacher who are members of this conference shall intrude themselves on any station, circuit or mission without first receiving an invitation or permission from the pastor in charge.
