FIRST DAY

Thursday, October 22, 1908

The Twelfth Annual Session of the Atlantic Mission Conference of the Methodist Episcopal Church convened in Pearl Street church, Elizabeth City, N. C., October 22, 1908. Bishop Earl Cranston, D. D., presiding.

After singing "Nearer, My God, to Thee!" and prayer, the Bishop read the fifty third chapter of Isaiah. He made very touching and interesting remarks relative to "losing and finding Jesus," especially in connection with the Sacrament of our Lord's Supper.

Assisted by T. S. Davis, the Bishop administered the Holy Communion to the conference and congregation present.

The Conference was called to order by the Bishop and the Roll called by the former Secretary.

The following Members responded: W. Q. A. Graham, T. S. Davis, M. L. Chappell, W. H. Luther, J. J. Lewis, D. D. Bailey.

The following Probationers were present: W. C. Baines, W. R. Woodell, W. J. Pint, L. N. Booth, W. F. Graham.

On motion of D. D. Bailey, W. J. Plint was elected Secretary and named W. F. Graham as his Assistant.

On motion of W. H. Luther, W. Q. A. Graham was elected Statistical Secretary and named L. N. Booth as Assistant.

On motion of T, S. Davis, W. H. Luther was elected Conference Treasurer and named D. D. Bailey as his Assistant.

On motion of the Superintendent, the following Committees were appointed:

On motion of T. S. Davis, D. D. Bailey was given charge of the accounts of the Book Concerns.

Question 15 was taken up and the Superintendent was called, his character passed and report of the work under his care given as follows:

SUPERINTENDENT'S REPORT

"Dear Brethren:

To the close of another Conference Year God has brought us on our way, and in presenting this, our second annual report of the work of the Atlantic Mission Conference, we desire to express our gratitude to Almighty God for health and strength and a disposition to do His will.

Although the year with its work has not been as satisfactory as we have wished, and although the financial stringency of the country has been felt no-where in the south more severely than within our bounds, we can, nevertheless, cry with the Psalmist "Bless the Lord, Oh! my soul, and all that is within me bless his holy name."

During the year Bishop Wilson has seen fit to make the following transfers: A. B. FitzGerald, to the Newark Conference, A. Hudson to the Wilmington Conferences. These removals have had a depressing influence upon the preachers and people, and occurring as they did, in the middle of the Conference year made it impossible for me to find Supplies in time to avert a considerable decrease in the benevolent collections.

We find nothing more discouraging in our field of labor than we have found in the past. There are immortal souls to save, young people to educate, and evil to oppose.

"The field is white unto the harves but the laborers are few". There are more doors open to us than we have men or means to enter.

AVON.

Edward Johnson was appointed to this work last year. It was his second year on this charge and when he took the work soon after Conference adjourned we had great hope that he would do efficient service during the year. but rumor soon had it that he was about to join our sister Church. I immediately wrote to him and he denied having any such intention but claimed that the work was prospering in his hands. He left the work without fiving me any notice. I found it practically impossible to supply this charge until sometime in June, when Brother Reindale, a salvation army man, took charge of the work. This circuit will not have a pastor'd report this year but it has not been an idle year with them. Repairs have been made on the churches at Hatteras and at the Cape. The benevolences have been looked after, and substantial promises have been made relative to the support of a pastor next year.

BLADEN AND THESSALONICA.

W.C. Bains was appointed here last year and while he will not be able to report much success as the result of his labor he has not been idle; he has done a faithful year's work.

ELIZABETH CTTY.

J.A. Hudson was appointed to this church but was thransferred in May and W.J. Plint was shifted here for the remainder of the year. He will make his own report.

HAMLET.

W.R. Woodell has been the pastor of this

charge ever since its organization. He has done excellect work this year. He has received fifty new members, and has organized a new society in two new places. This section affords our church an apportunity of vast dimensions.

HARKERS ISLAND .

W.J. Plint was sent to this church by the Bishop and was making considerable advance when he was removed to Elizabeth City in June. Dr. Graham has been preaching here since that time and will report for the charge.

MARSHALLBERG.

A.B. FitzGerald was sent as pastor of this church. He only preached once when he announced his transfer. I found it necessary to move L.N. Booth here. He has proven very acceptable to the people and under the conditions brings up a fair report.

MOREHE .. D CITY.

For the second time D.T. Baily was sent to Morehead City. His report will speak for itself.

OCRACOKE.

Altho! this charge is situated on an island and the tide has often washed under the parsonage and around the church, we do not hesitate to pronounce this work one of the best charges in our Conference. Amgrose Burgess was sent here last year but he was transferred in April and we once more found it necessary to make a change. I placed W.F. Graham in command and he has done excellect work.

PARMELE.

M.L. Chappell has just closed his second

year as the acceptable pastor of this charge. While we would like to pause here he will make his own report.

PATES.

This is one of our Indian charges. W.F. Graham was sent there last year but since April the work has been in the hands of W.L. Moore and W.R. Woodell. This field is white unto the harvest and more workers are needed.

PINNERS.

W.H. Luther has just closed his second year at this point. He is an able worker and will make his own report.

POWELTON.

J.H. Garris has been the acceptable pastor of this charge for three years.

ROWLANDS.

This charge has been supplied by G.W. Stancill.

WHALEYVILLE.

L.N. Booth was sent at last Conference but since he was removed to Marshallberg, the work has been surplied by Joseph Bundy in a very acceptable manner.

WILDWOOD.

This work will be represented by J.J.Lewis.

WINFALL.

This circuit was supplied at our last Conference by George F. Sever. In June, he was taken ill and was forced to quit. Since then

they have had preaching occasionally by Bundy and Plint.

This closes our list except the work of Dr. Graham as President of the G.C.I. He has done good work and will report."

The Doxology was sung and Benediction pronounced by the Bishop.

SECONI DAY.

Friday, October 23, 1908.

Conference convened at 9 a.m. Bishop Cranston in the chair. After devotional services, the journal of Thursday was read, corrected and approved.

Question 10 was taken up, D.D. Bailey called, his character passed, report given and on motion of T.S. Davis, he was elected to Elder's Orders.

L.N. Booth was called, his character passed, report given, the Examiners made report and on motion of the Superintendent he was continued on Trial and advanced to the studies of the Second year.

W.F. Graham was called, his character passed, report given, the Examiners made report and on motion of the Superintendent he was continued on trial and advanced to the studies of the Second year.

J.H. Garris was called, his character passed, report given and on motion he was continued on trial in Studies of the Third Year.

The Eand question was taken up and J.B. Bridgers was called. After remarks by the Superintendent, the Secretary was requested to write him concerning his location asking for his reploy by wire. He was continued in the Supernumerary Relation.

Question 4. was then called and upon recommendation of Elizabeth City quarterly Conference, on motion of the Superintendent, James A. Morris was recieved on Trial in the Studies of the First Year.

The Elst question was then asked and on the recommendation of Elizabeth City quarterly Conference, and the motion of the Superintendent, James A. Morris coming from the Free-will Baptist Church was recognized as a Peacon.

Question 14. The Bishop announced the transfer of A.B. FitzGerald to the Newark Conference, C.M. Levister and A. Burgess to the Baltimore and J.A. Hudson to the Wilmington Conference.

On motion of W.H. Luther under the 6th question, Edward Johnson was discontinued and referred to the Superintendent for trial.

Question 50. was asked and invitations were recieved from Marshallberg, Ocracoke and Parmele. Marshallberg was withdrawn in favor of Parmele which was selected as the place for holding our next session.

Notices were given, the Doxology was sung, and Conference adjourned with Benediction by the Bishop.

THIRD DAY.

Saturday, October 24, 1908.


Conference convened at 9 a.m. Bisnop Cranston in the chair. The journal of Friday as read, corrected and approved.

On motion of T.S. Davis, the Conference Committees were continued for next year.

Dr. Graham read his report as President of the Graham Collegiate Institute.

On motion of Dr. Graham the amount of \$56. for the Freedman's Aid Society and \$37. for the Episcopal Fund was ordered apportioned among the various charges.

On motion of W.J. Plint, all cash held by

the Conference Tressurer for Local Educational Interests was ordered paid to our Conference School.

On motion of W.H. Luther, Conference adjourned until 4 p.m. the Doxology was sung and Benediction pronounced by Rev. B.F. Watson of the Methodist Episcopal Church, South.

Afternoon Session.

After devotional services, the Bishop called the Conference to order at 4 ρ .m.

The journal of the morning was read, corrected and approved.

On motion of M.H. Luther, the Secretary was authorized to write to J.B. Bridgers requesting him to Locate at our next Conference Session.

The Statistical Secretary read his report. (See reports.) On motion of J.J. Lewis, the report was received and ordered princed.


The Treasurer read his report. (See reports) Upon vote the report was received and ordered printed.

On motion of T.S. Davis, W.C.A. Graham was a warded the contract to print the Conference Minutes after the Secretary has edited them and every pastor assessed two dollars for the cost of the same.

The Bishop introduced Dr. Baketel who addressed the Conference on the subject of Sunday Schools.

After the address, the Superintendent, W.J. Plint and M.L. Pilard were elected a Conference Board of Sunday Schools.

Nominations for trustees of the Graham Collegiate Institute were presented and D.D. Bailey and M.L. Pilard were elected as trustees, terms to expire in 1911.

Lr. Race was introducted to the Conference and spoke a few words.

On motion of Dr. Gruham, the Board of Trustees of the Graham Collegiate Institute were ordered to send at least two names for each nomination to be presented for election by the Conference.

On motion of T.S. Davis, it was ordered that the vote upon such names be taken by ballot.

On motion of the Superintendent, the pastor at Pinners was accorded the privilege to go without the limits of the Conference to collect funds for the pay-of the debt upon the charge.

ir. Race presented each pastor with a year's subscription to the Methodist Advocate Journal and the Conference voted its thanks.

The minutes were read, corrected and approved.

On mation of D.D. Bailey, after the reading of the Appointments and Missionary Appropriations at the close of the Ordination Service Sunday, Conference adjourned 'sine die.'

In submitting this report of my year's work in our school, I am happy to say that some promises and predictions that I made in my report to this body a year ago are being fulfilled and realized. You will remember that I said; "When I took charge of our school it's resurrection seemed almost as difficult as the effort to evolve the protoplastic germ from the primordial coze, but last year we regained one fourth of our loss, this year one half, and I expect nect year to regain all." I am very happy to be able to claim victory in sight. We now have twice as many in the Boarding Hall, and fully twice as many enrolled as we have had on this date before for a number of years.

Our finances have, of course been affected by the recent, and present, hard times, but the following figures which are as correct as possible, will show that we are slowly nearing the safe side of the ledger, and, with the twenty years of splendid history which we have back of us, we can face the future confident of success.

the dissolution of the consolidated societies known as 'The Board of Education, Freedman's Aid and Sunday Schools,' and provided for the Board of Education. To this Board was committed the maintenance and administration of the schools for the white race in the South, also the work of assisting and maintaining institutions of Christian learning and of promoting the cause of Christian education in the Methodist Episcopal Church.

The new trust committed to this Board in the form of the schools white people in the South entitles it to increased attention on the part of this Conference. The special collection asked for this purpose should be taken at the earliest possible moment and forwarded to the Secretary in New York. It is the purpose of the Board to sypply this need, in part at least, from the proceeds of the collection taken in the churches on Children's Day. The collection taken in the church congregation on that day is for the aid of our Southern schools.
