Dear Mr. Graves:

The attached FOIA request from Mr. Jeremy Singer-Vine is being referred to your organization as a matter under your cognizance, and for response to the requester.

We are providing two data CDs to honor a recent discussion between OPM and Brandon Gaylord at DOD. The first CD is DOD data with all redactions applied, which is what we previously agreed to. The second, CLEAN version, is the same data set without the agreed upon DOD redactions; instead, it only contains redactions that OPM universally applies to data it releases under FOIA. DOD should evaluate whether or not to release the redacted CD, while the clean version is for internal DOD purposes to learn more about the data being redacted, and if DOD chooses, they can include some of this data to be released in-lieu of the redacted fields. DOD personnel would need to create a new CD in such cases.
