



THE PEDIGREE OF THE LATE HENRY HAWARDEN-GILLIBRAND-FAZAKERLEY AND THE DESCENT TO HIM OF FAZAKERLEY HALL, GILLIBRAND HALL AND LOWER HOUSE IN WIDNES.

I. FAZAKERLEY OF FAZAKERLEY.

It is not an easy matter to write this family history in war time. I made several extracts from the family papers in 1892 which were then in the possession of the late Mrs. Everard Evered, who was the only surviving daughter of Henry Hawarden-Gillibrand-Fazakerley. They are now the property of her son, Captain Robert Evered, and are stored away in the bank during his absence at the Front. I have marked all the extracts from these papers with an asterisk. I am deeply indebted to the Editor of the Victoria History of Lancashire for his very able summary of the family history which I have consulted down to 1500, and have also made many extracts from the publications of the Chetham Society, and of the Lancashire and Cheshire Record Society. The Catholic Record Society has also been of very great help for the post-Reformation period when the Fazakerleys, Gillibrands and Hawardens adhered to that old Faith which they had inherited from their forefathers. The earlier generations have certainly existed, but their connection in this pedigree is tentative. The early history of the Manor is obscure, but the pedigree which is in Captain Evered's possession gives as the first known ancestor.

- I. RICHARD FAZAKERLEY, Lord of Fazakerley,* Co. Lancaster, in the days of Henry III, c. A.D. 1240, who had issue:—
- II. HENRY DE FAZAKERLEY, his son and heir, who in 1276 recovered possession of half a messuage and 15 acres of land in Walton. He had issue:—
- III. RICHARD DE FAZAKERLEY, was one of the tenants of Richard de Walton in 1292.² He and his son Henry were witnesses to a grant by Richard Lord of Walton to Robert Cawdran of land in Fazakerley with free entry to moor and wood and other easements.³ He had issue:—

1. Henry Fazakerley (IV), who follows.

 Richard Fazakerley, to whom his brother Henry granted lands adjoining the field of Fazakerley with housebote and heybote and quittance of passage in the wood of Walton.⁴

- 3. Robert Fazakerley, to whom his brother Henry granted lands in Fazakerley in the Little Ley from the lane to the ditch of the Bancroft with easements in Walton.⁵ He made a grant in the vill of Walton with various easements to which his brother Richard was witness.⁶
- IV. HENRY DE FAZAKERLEY, of Fazakerley.* He was living 1 Ed. II (1307), and had issue:—

1. Robert (V), who follows.

 Richard de Fazakerley, mentioned in deeds of 1323 and 1329 as son of Henry.⁷

3. Henry de Fazakerley.8

V. ROBERT DE FAZAKERLEY, of Fazakerley, gave a portion of a meadow to Richard son of John, son of Margery de Fazakerley in 1315.9 Lord of Fazakerley 2 Ed. III.*

Robert, son of Henry de Fazakerley, was a plaintiff concerning land in Walton in 1352, Simon de Walton being the defendant. He had issue:—

1. Hugh de Fazakerley (V), who follows.

HUGH DE FAZAKERLEY, Lord of Fazakerley, living 49 Ed. III VI. (1375).* In 1356 Hugh son of Robert, son of Henry de Fazakerley, brought a suit against Robert son William de Walton. 11 He accompanied the Duke Lancaster to Britanny from about 1356 to 1359.12 He married Isabel, who in 1379, as widow of Hugh de Fazakerley, gave a release of actions to John de Taylor and Henry de Fazakerley, the executors. (Townley MSS. G.C. n. 2491.) She was perhaps the Isabel, widow of John de Toxteth, who in 1419 was bound to Robert and John de Fazakerley (ibid., 2831.) The whole of this period is extremely confusing as there were several collateral branches of the family besides the main stem dwelling in Fazakerley, and they are all quoted side by side in volume iii of the Victoria History of Lancashire. Thus Richard son of Henry, son of Robert de Fazakerley was plaintiff in a case about 1352 (Duchy of Lancaster Assize Rolls, 2 m. iij). Three years later Robert de Fazakerley was plaintiff in a case in which Richard son of John de Fazakerley was one of the defendants (Duchy of Lancaster Assize Rolls, R. 4, m. 20). Henry, son of Robert, took action against the same defendant

in the following year (ibid., R. 5, m. 1), and at the same time another Henry, the son of Richard, was plaintiff against John son of Richard, son of John (R. 5 m., 14 d). In these circumstances one may be forgiven for assuming that the family pedigree was based upon some evidence which we do not possess and that its conclusion that Roger Fazakerley, the next most prominent member of the family, was the son of Hugh is probably correct.

- VII. ROGER FAZAKERLEY, Lord of Fazakerley, is stated to have lived 18 Richard II (1394).* In any case, according to an inquisition taken 8 Richard II (6 March 1385) on the death of Thomas de Lathom, 13 he married Joan, his second wife and widow, said to have been the second daughter of Hugh Venables, of Kinderton.14 Letters of protection were granted to both of them by the Duke of Lancaster in 1382.15 In the same year the Bishop of Lichfield allowed him to have divine service in every oratory within his manors in the diocese. 16 Roger de Fazakerley and Jean his wife received a third part of the manor of Hayton 20 Aug. 1384,17 His widow Joan married thirdly, Sir Nicholas Haryngton, of Tarleton, and by fine 1397 remitted to Margaret de Lathom and her heirs the moiety of the manor of Huvton.18 His son :-
- VIII. ROBERT DE FAZAKERLEY, of Fazakerley, married Ellen. daughter of Robert de Walton, who claimed her father's estate from John, Robert's bastard son, and obtained a third part by virtue of a settlement made about 1380 by her father before John's birth.19 In August 1412, Robert, with a hundred others, came in warlike array to the Manor of Walton and dispossessed John, taking away all his goods and chattels. The dispute was not settled until 1426-7, when a third part was awarded Robert de Fazakerley and Ellen his wife in lieu of her marriage portion.²⁰ They had issue :-
 - IX. ROGER FAZAKERLEY DE FAZAKERLEY, is described in 1593 as son and heir of Ellen, daughter of Robert de Walton.²¹ He was living 7 Hen. VI,* and had issue:-
 - Χ. THOMAS FAZAKERLEY, of Fazakerley and Walton, who in 1476 is described as son and heir of the late Roger Fazakerley of West Derby, released to William, son of John Lightwood

of Tattenhall, all his rights to the lands of John Cropper, within the lordship of Fazakerley.22 He had issue :-

- XI. ROGER FAZAKERLEY,* of Fazakerley, married Elizabeth daughter of Henry Blundell, of Crosby, and had issue :-
- NICHOLAS FAZAKERLEY,* of Fazakerley, Lord of Fazakerley, XII. and Walton, married Elizabeth, daughter of John Urmston, of West Leigh, and had issue :-
- ROGER FAZAKERLEY,* living 1523 (15 Hen. VIII), married 23 XIII. Elizabeth, daughter and coheir of George Pemberton, of Pemberton, near Wigan,* and had issue:-
- ROBERT FAZAKERLEY,* of Fazakerley, married Margaret, XIV. daughter of Thomas Eccleston, of Eccleston, 23 by Katherine, daughter of Sir Henry Halsall, of Halsall,24 and held the manor of Walton and Fazakerley in 1591.25 They had issue :--
 - XV. NICHOLAS FAZAKERLEY, of Spellowe House, 26 Fazakerley, and Walton,24 was reckoned among the gentry of the Hundred in 1612; buried at Welton, 19 Warch 1611-12, married Mary, daughter of John Moore, of Bank Hall, co. Lancaster, by Anne, daughter and heiress of Thomas Hawarden, of Chester,27 and had issue:-
- ROBERT FAZAKERLEY, of Fazakerley, living 1613, married XVI. Anne, daughter of Edmund Molyneux, of Ye Wood in Melling.23 (She was living 8 April 1652, and claimed as her dower a third part of her third part of her then late husband's sequestered estate.28) He died 5 April 1643, at West Chester, leaving issue :-

1. Nicholas (XVII), who follows.

2. Robert,* died young. 3. Edmund,* died young. 4. Richard,* died young.

5. Thomas, three years old in 1613,23 alias Ashton. Five years a student at the English College, at St. Omer; was admitted to the English College at Rome, at the age of eighteen, on 20 Oct. 1629; was ordained a priest 25 March 1635; went on the Mission to Lancashire and died Chaplain to Lord Molyneux at Croxteth Hall, 22 March 1665; he was buried at Halkirk in 1665 (Foley, Record of Society of Jesus, vi, 302, 320).

6. John,* died s.p., young.

7. John Fazakerley.*

8. William Fazakerley,* born 1614, married Winifred ..., who were both Catholic Recusants.²⁹ He was living 26 Oct. 1654, when he gave evidence on behalf of his nephew, Nicholas Fazakerley.³⁰

9. Richard Fazakerley,* died in Ireland.,31 1642.

10. Robert, died in the Indies about 1647.32

Margery, married as his second wife, Robert Breres,³³
of Walton, son of Lawrence Breres, of Walton, by
his marriage with Elizabeth, daughter of Richard

XVII. NICHOLAS FAZAKERLEY, of Fazakerley, b. 1600³⁴; was at the English College at Rome, 1623-6. On 15 April 1626 he left the College for England, where he married Catherine daughter of John Peacocke, of Chichester, and died, as Captain in the Royal Cause, at Liverpool in October 1613,35 leaving issue:—

1. Robert, died young.

 Nicholas Fazakerley, of Spellow House in Walton, aged 28 Visit. of Lancashire, 23 Sept. 1664,³³ who as an infant claimed through William Whitfield, of Riby, co. Lancaster, his guardian, the estates of his father and grandfather, 24 Oct. 1654,³⁶ married Winifred, daughter of Edward Tarleton, of Aigburth, and died January 1691,³⁷ leaving issue:—

(1). Robert, died 1664.*

- (1). Ellen, born 1657,* living 1 Oct. 1730 when she was mentioned by Robert Fazakerley, of Fazakerley, in the entail of the family estates.
- (2). Catherine, for three years a Novice at the Augustinians in Paris, entered the Abbey ³⁸ of Our Lady of Consolation, at Cambrai, 29 Oct. 1681; was professed, 1683, and died 20 Sept. 1726.³⁹

- XVIII. THOMAS FAZAKERLEY, of Fazakerley, aged fourteen in 1654.40

 - XIX. ROBERT FAZAKERLEY, of Fazakerley, married firstly, Mary, daughter of Thomas Walsh, of Walsh Hall, 40 within Aughton, who died 12 Jan. 1721 (Blundell's Diary, p. 173); secondly, Sarah, daughter of, who was living 8 April 1731. He died 1725-6 and was buried at Walton 17 Feb. leaving issue:—

1. Robert (XX), who follows.

Mary, bapt. 14 Jan. 1704 (Blundell's Diary, (p. 19), married firstly, Bryan Hawarden, of Lower House, in Widnes, who died before 1 Oct. 1727, and was the younger son of John Hawarden, of Lower House in Widnes by his marriage with Catherine, daughter of Bryan Lea, of Sutton; secondly, 8 April 1731, Edward Barrett, of Dublin; thirdly, Thomas Mostyn, a younger brother of Sir Piers Mostyn, of Talacre, and had issue by her first husband:—

(1) John Hawarden Fazakerley, of Fazakerley, married at Ormskirk, 21 Sept. 1748, Anne, only child of Samuel Parr, of Ormskirk, who died 10 Sept. 1779, aet. 83. M.I. at Ormskirk. Took name of Fazakerley, and was buried at Ormskirk 10 Feb. 1781,

leaving issue :--

i. Samuel Hawarden Fazakerley, of Fazakerley, born 1753; a Lieut.-Colonel in His Majesty's Service; died 20 and buried at Ormskirk 25 June 1813. By his will, dated 27 June 1804, he bequeathed his family estates to his cousin, Henry Hawarden Gillibrand, who assumed the name of Fazakerley.

 Robert, buried at Ormskirk, 1 June 1757, aged three weeks (Piccope, iii, 354).

 Anna, died an infant, 10, and buried at Ormskirk 13 Oct. 1767, aged 13.

XX. ROBERT FAZAKERLEY, of Fazakerley, died unmarried in 1731. By his will, dated 1 Oct. 1730, proved at Chester 21 Oct. 1731, he bequeathed his estates in the first instance to his nephew, John Hawarden, of the Lower House in Widnes, who assumed the name of Fazakerley.

II. GILLIBRAND OF CHORLEY.

The Gillibrand family has been settled in Lancashire since the Conquest, if we are to believe an old Latin document quoted in St. George's Visitation of Lancashire:—"Copia extractus veteris Rentalli dat' est 13 die Julii Ao regni Will'i Conquest' quinto, quod propter antiquitatem vix legi potest, in nulla re differens nec aliena ab illo dicto vetere rentali nisi quod possessores et tenta transmutantur Nicholaio Gilibrond de Astleigh in Comit' Lancast' gentleman (sic in MS.) suorumque heredum." The Visitation of 1613 gives the arms of the family as:—Argent, two swords in their scabbards in saltire Sable,

hilts Gules, quards Or.

Three principal branches of the family settled in different parts of Lancashire. The ancestors of the Gillibrands of Peel Hall were tenants of Peel under the Abbey of Cockersand as far back as 1286, when John Gillibrand and Margery his wife demanded against Richard, son of Alexander de Astley, the third part of the messuage here as the wife's dower. In 1292 John, son of John Gillibrand held the estate under the Abbey of Cockersand by the free rent of 2s. yearly. The pedigree of this family is given on p. 447 of the third volume of the Victoria History of Lancashire down to 1665, when Ralph Gillibrand of Peel Hall entered his pedigree back to his great-great-grandfather, Nicholas Gillibrand.

Notes on the Gillibrands of Ramsgrove will be found in Abram's *History of Blackburn*, pp. 629-630; their pedigree was entered in the Visitation of 1665 by Jonathan Gillibrand, Vicar of Leigh, back to his

grandfather Thomas Gillibrand of Ramsgrove in 1610.

The earliest mention of the Gillibrands of Chorley occurs about 1430, when Humphrey Gillibrand was holding a small portion of the Hospitallers' land by the rent of 4d. He married Elizabeth . . . and died about 1441, leaving issue, a son, John. In this year Eaveshey was divided between Humphrey Gillibrand, Richard Crosse and William Woodward, John the son and heir of Humphrey Gillibrand assenting. An additional agreement was made in 1441 between Richard Crosse

on the one side and Elizabeth, widow of Humphrey Gillibrand, and John her son on the other, by which the former took the north part of this land and the latter the south. 45

- I. John Gillibrand, who was probably the grandson of John Gillibrand, the son of Humphrey, is described as of Chorley Hall, aged 55, 28 April, 30 Hen. VIII (Lancashire and Cheshire Record Society, vol. xxxv, p. 94).⁴⁶ He was the holder of a third of Eveshey, together with Henry Breres, 4d., Alexander Street, 4d., and James Crosse, 4d.⁴⁷ His son:—
- II. THOMAS GILLIBRAND, of Chorley Hall, 46 married Agnes, daughter of William Fleetwood, of Heskin, by Helen, daughter of Gilbert Standish, and had issue:—46

1. John (III), who follows.

- Elizabeth, who married Laurence Breres, of Walton Hall, son of Roger Breres, of Walton-juxta-Liverpool, by Blanch, daughter and coheir of Richard Crosse, of Liverpool and Crosse Hall, by Elizabeth, daughter and coheir of Roger Walton, Lord of Walton. (J.G.)
- III. JOHN GILLIBRAND, of Chorley, married Jane, daughter of Richard Urmston, of Westleigh, co. Lancaster. 46 48 His widow was paying her fines for recusancy, 20 Jac. I (1621-2 and 1628), (J.G.) They had issue:—

1. Thomas (IV), who follows.

2. Richard, of Chorley, a recusant in 1622.

 Agnes, married Thomas Worthington, 46 of Crashaw. (J.G.)

2. Margaret, married Edward Durning, of Bispham in

the parish of Eccles.46

 Elizabeth, married William Tootell, of Lower Healey Hall, 46 son of Hugh Tootell, of Lower Healey Hall, by Alice, daughter of Thomas Anderton, of Horwich. 49

IV. Thomas Gillibrand, of Chorley Hall, aged 31 in 1613,46 married Anne, daughter of William Blundell, of Crosby Hall, by Emilia, daughter of Edward Norreys, of Speke Hall. Both he and his wife were convicted Recusants,50 and he was one of the more considerable landowners in 1628. In 1631 he was called upon to pay £10 for having refused knighthood.51 Some interesting details are afforded by the narrative of two of his daughters who became nuns at Louvain in 1643. "Their mother, Anne Blundell, of Crosby, was brought up a good Catholic, but her husband was not. When he sued her for

marriage she told him plainly that he would never have to look to her unless he would become a Catholic. He then, God's grace concurring, being perhaps well minded before, became a Catholic, and as they were married by a priest he continued ever afterwards a most good and constant Catholic. At the Convent, on his daughters' profession, he promised to give £400 apiece, but had difficulty in doing so, for after this it happened that their parents were extremely plundered, as others of that same miserable time of war in England, and were fain to leave their house which was taken from them, as also they lost their estate and Mr. Gillibrand was forced to fly into Wales. There he lived in poverty, yet content to suffer for God. Their mother went and lived with her daughter who was then newly married. also in poverty, but with content to suffer for her conscience, being a Catholic." 52 Their estates were sequestrated and ultimately forfeited during the Commonwealth period. 53 His will was dated 10th April, proved at Leyland 15 Aug. 1007.51 They had issue:-

1. John (V), who follows.

2. William, died unmarried.

3. Thomas, died in infancy. (J.G.)

 Anne, married firstly, William Hesketh, of North Meols Hall; secondly, Richard Girlington, of Great Worth, a convicted Recusant in 1667,⁵⁵ who died at Withnell and was buried at Brindle, 23 March 1698, son of John Girlington, younger son of John Girlington, of Girlington and Thurland Castle,⁵⁶

. Elizabeth, O.S.A., professed 10 Feb. 1643 at St.

Monica's, Louvain. (J.G.)

 Margaret, O.S.A., professed at St. Monica's, 10 Feb. 1643, died 1678, aged 52. (J.G.)

V. John Gillibrand, of Chorley Hall, aged 48 in 1664, married firstly, Elizabeth, daughter of Richard Chorley, of Chorley, by Elizabeth, daughter of John Ditchfield, of Ditton Hall ⁵⁷ (marriage articles dated 14 Aug. 1652). ⁵⁴ She was baptized 20 Dec. 1621. and was buried at Chorley 18 Oct. 1661. ⁵⁴ He married secondly, Anne, widow of William Hawkeshead ⁵⁴ (a recusant), who executed a release to John Gillibrand, son and heir of John Gillibrand, deceased, 10 July 1680.

John Gillibrand died 23 June 1679. Will dated 16 June 1679, proved at Chester 20 Sept. following. By his first wife he had issue :-

Thomas, bapt. at Chorley 7 Oct. 1655.54 Renounced his inheritance to enter the Society of Jesus, but died-at Liège at the close of the Novitiate, 1678.58

2. John (VI), who follows.

- Richard.54 3.
- William, S.J. Born 1 Oct., bapt. at Chorley 12 Oct. 4. 1661 54; came to the Mission from St. Omer's College, 1694, and soon after became Chaplain to Mr. Blundell, of Crosby. Left 2 Dec. 1707 to undertake the Mission at St. Mary's, Liverpool, but in two years he went to fill the family chaplaincy at Chorley, where he died I April and was buried 2 April 1722.59 Was a Jesuit when he died (Blundell's Diary).

- IX. WILLIAM GILLIBRAND, of Chorley, born 11 and bapt. 13 Dec. 1715 at Chorley, 54 entered the Society of Jesus, 1735, and in due course came to the Mission in Lancashire. In 1749 he was appointed to Slate Delph in Wheelton, 64 whence he appears to have come to Southworth Hall. In 1762 or 1763 he went to Exeter, was Superior of that district in 1765, and after five years removed to Tusmore, co. Oxon., where he was in 1773. became known as Gillibrand Hall. It is a spacious and elegant mansion, standing in a richly-wooded park, about a mile to the south-west of Chorley. The principal front consists of a centre and two wings, with a balcony supported by columns, the entrance being at the right through a handsome portico. (J.C.)

III. THE FAMILY OF HAWARDEN OF WIDNES.

The Lancashire family of Hawarden was represented in the seventeenth century by two main branches. The Hawardens of Woolston were, according to Flower, a branch of the Hawardens of Hawarden, co. Flint, but Mr. Gillow, in his historical introduction to the Catholic registers commenced in the hall at Woolston (C.R.S., vol. xvii, 479-507), points out that it is almost certain from the armorial quarterings that the family derived from the de Ardernes of Harden or Hawarden Hall, co. Chester, a baronial and picturesque erection now in ruins. In 1401 Hugh de Wolston was in possession of the Manor of Woolston.65 Through the marriage of his daughter Annabel (or Elizabeth) to John de Arderne, son of John de Arderne, of Hawarden, co. Chester, by his marriage with Amery, daughter and heiress of John Legh, of High Legh, 66 the manor of Woolston passed to the Hawardens. In 1432, John Hawarden & Elizabeth his wife were freeholders in Poulton and Woolston.⁶⁷ This family is extinct since the death of Adam Hawarden, of Woolston, 6 Feb. 1596-7, his only son having predeceased him.68 Elizabeth, his daughter, married (settlement dated August 20 1574) Alexander, son and heir of Edward Standish, of Standish, by Helen, daughter of Sir William Radcliffe, of Ordsall.⁶⁹ The manor subsequently descended with Standish until March 1870, when the Hall was sold to the present owner, Mr. John Bennett, by the Standish trustees, with the consent of the late Charles Henry Lionel Widdrington Standish.70 The Hawardens of Widnes are said to be a branch of the Hawardens of Woolston.⁷¹ It should, however, be noted that a William de Hawarden was settled at Widnes as early as 1332.⁷²



HENRY HAWARDEN GILLIBRAND FAZAKERLEY, of Gillibrand Hall and Fazakerley, born at Gillibrand Hall 6 May 1809, assumed by royal licence 6 May 1814, in compliance with the will of his cousin Samuel Hawarden Fazakerley, the right to take and use the surname of Fazakerley only and to bear the Arms of Fazakerley quarterly with those of Gillibrand. He married Harriett, daughter of Richard Kenrick, of Nantclwyd, by Ermine, daughter of Sir Thomas Kyffin, of Maenan Abbey, and died leaving issue:—
