## GRADUATE ADVISORY COMMITTEE.

---

### ARTICLE I.

*Sec. I.* This body shall be called the Graduate Advisory Committee of Princeton College.

*Sec. II.* The object of the Committee shall be to promote the athletic interests of the College.

### ARTICLE II.

*Sec. I.* Any Alumnus of the College or any one who has taken a four years' course in College, shall be eligible to membership on the Committee, at least one of whom shall have graduated within three years of the time of election.

*Sec. II.* In the election of the Committee special reference shall be paid to the abilities and qualifications of proposed membership, as advisors in foot ball, base ball, and track athletics. It is, moreover, desirable that at least one member of the Committee be a resident in or near Princeton..

### ARTICLE III.

*Sec. I.* The Committee shall consist of three members, all of whom shall be elected by the

Executive Committee, subject to the ratification of the College, at the regular annual foot ball meeting, to be held on the first Wednesday in March, and shall hold office as follows : During the first year one shall be elected for three years, one for two years and one for one year. After the first year's office one shall be elected each year on the Committee to take the place of the one whose term of office has expired, the term of holding office on the Committee being for three years.

#### ARTICLE IV.

*Sec. I.* The officers of the Committee shall consist of a Chairman, a Secretary and Treasurer.

#### ARTICLE V.

*Sec. I.* It shall be the duty of the Chairman to call meetings of the Committee, to preside at the same, and to cast the deciding vote in case of a tie.

*Sec. II.* It shall be the duty of the Secretary and Treasurer to keep a record of the proceedings of the meetings and to preside in the absence of the Chairman. He shall, moreover, take charge of all moneys collected by the Committee from the alumni for the benefit of athletics in



College, and pay out the same according to the directions of the Committee.

*Sec. III.* The Secretary and Treasurers shall also inspect the accounts of the Treasurers of the various athletic associations in College, as presented by the University Treasurer, at least two weeks before the end of each College term.

#### ARTICLE VI.

*Sec. I.* All officers of the Committee shall be elected by a majority vote of the Committee.

*Sec. II.* The Chairman shall be elected for a term of one year.

#### ARTICLE VII.

*Sec. I.* There shall be at least three meetings of the Committee a year, one within the first two weeks of each college term, at such exact time and place as the Chairman may decide.

#### ARTICLE VIII.

*Sec. I.* The Advisory Committee shall be consulted in regard to all matters of importance, which pertain to the athletic welfare of the College, such as business of conventions, schedules of games, trainers, &c.

*Sec. II.* If satisfactory evidence shall be produced to show that an officer of any athletic asso-

ciation of the College is guilty of maladministration, either through ignorance, inefficiency or incompetence, the Committee shall be empowered to demand the resignation of said officer and order the election of a successor, by the body accustomed to elect such officer.

*Sec. III,* In regard to any changes contemplated by the officers of any athletic association, which shall involve additions to or alterations in the athletic grounds or buildings of the College, of such a nature as to permanently affect the interests of any or all the various athletic organizations, the Advisory Committee must first be consulted and shall have the power of veto.

## EXECUTIVE COMMITTEE.

---

### ARTICLE I.

*Sec. I.* This body shall be called the Executive Athletic Committee of Princeton College.

### ARTICLE II.

*Sec. I.* The object of the Committee shall be to promote the general interests of undergraduate athletics.

### ARTICLE III.

*Sec. I.* The Committee shall consist of the Senior and Junior officers of the Foot Ball Association, Base Ball Association, Track Athletic Association, Lacrosse Association and the University Treasurer.

*Sec. II.* The officers of the Committee shall consist of a Chairman, a Secretary and Treasurer.

*Sec. III.* The Chairman shall be elected by a majority vote of the committee, at the first meeting in first term.

*Sec. IV.* The University Treasurer shall be the Secretary and Treasurer of the Executive Committee.

## ARTICLE IV.

*Sec. I.* It shall be the duty of the Chairman to call meetings of the Committee at the request of the Foot Ball, Base Ball, Track Athletic or Lacrosse Associations, or of the University Treasurer. The Chairman shall preside at all meetings and vote in case of a tie.

*Sec. II.* It shall be the duty of the Secretary and Treasurer to keep a record of the proceedings of the meetings held by the Committee.

## ARTICLE V.

*Sec. I.* There shall be a regular meeting of the Committee, on the second Saturday of each College term, time and place to be fixed by the Chairman.

*Sec. II.* Seven members of the Committee shall constitute a quorum, and each Association must be represented in the quorum.

*Sec. III.* Every member of the Committee shall have a vote. The Chairman shall vote only in case of a tie.

## ARTICLE VI.

*Sec. I.* There shall be a University Treasurer elected by a majority vote of the undergraduates

from the Junior Class, at the regular Annual Base Ball Meeting held the last Thursday in May.

*Sec II.* It shall be the duties of the University Treasurer to audit the accounts of the Treasurers of the various Athletic Associations represented in the Executive Committee and submit a report of the same to the Graduate Advisory Committee, at least two weeks before the end of each College term.

*Sec. III.* It shall be the duty of the University Treasurer to collect from the Treasurers of the various Associations, the money set apart for the payment of the trainer's salary and hand over the same to the trainer.

*Sec. IV.* The University Treasurer shall collect the money from the Treasurers of the various Associations for the payment of the rent due annually on the Athletic Grounds, and pay over the same to the proper authorities. The University Treasurer should have his orders countersigned by the Chairman of the Executive Committee. He shall also report the condition of the Athletic Grounds to the College authorities and make applications for all necessary repairs or improvements.

*Sec. V.* The University Treasurer shall see that such settlements are made between the various Athletic Associations, as the Executive Committee shall order.

*Sec VI.* The University Treasurer shall transact according to the directions of the Executive Committee all business, financial or otherwise, connected with the general athletic welfare of the various associations, not pertaining strictly to or falling under the jurisdiction of any one organization.

*Sec. VII.* The University Treasurer shall present the Treasurers of the athletic organizations with order books. He shall also take charge of and be responsible for money, resulting from any entertainment that is to be given for the benefit of the combined Athletic Associations or for any single athletic organization.

## ARTICLE VII.

SEC. I. It shall be the duty of the Executive Committee, to decide all questions pertaining to the use of the Athletic Grounds on any particular date.

SEC. II. The Executive Committee shall, after consultation with the Graduate Advisory Com-



mittee, decide upon all questions pertaining to the appointment and payment of a trainer.

SEC. III. The Executive Committee shall decide the amount to be contributed by each Association towards the salary of the Trainer and direct the payment of the same by the University Treasurer.

SEC. IV. The Executive Committee shall decide all questions, financial or otherwise, which arise between the various Associations.

SEC. V. The Executive Committee shall settle all questions, pertaining to any or all the athletic organizations represented, which are not provided for in the constitutions of those organizations.

SEC. VI. It shall be the duty of the Executive Committee to consult the Graduate Advisory Committee on all questions of importance, pertaining to the general welfare of the College athletics.

SEC. VII. It shall be the duty of the Executive Committee to elect the members of the Graduate Advisory Committee subject to the ratification of the College at the Annual Foot Ball Meeting the first Wednesday in March.





## FOOT BALL ASSOCIATION.

---

### ARTICLE I.

The Association shall be known by the name of the Princeton University Foot Ball Association.

### ARTICLE II.

Every undergraduate of the College shall be considered a member of the Association.

### ARTICLE III.

SEC. I. The Directors of the Association shall consist of the Captain, President and Treasurer. The President to be chosen from the Senior class. The Treasurer from the Junior class.

SEC. II. The President and Treasurer shall be elected by a majority vote of those present at the annual mass meeting of the Foot Ball Association.

### ARTICLE IV.

SEC. I. This election shall take place on the first Wednesday in March and shall be announced in the previous issue of the PRINCETONIAN and in the Class Rooms.

SEC. II. The officers thus selected shall go into office at beginning of third term.

SEC. III. No member of team or substitute shall hold the office of President or Treasurer.

#### ARTICLE V.

The Captain shall be elected at the close of the foot ball season by the members of the team who played in any of the championship games.

#### ARTICLE VI.

SEC I. It shall take a majority of all those who are entitled to a vote to elect a Captain.

SEC. II. In case of a tie the President shall cast the deciding vote after those ballots have been taken.

SEC. III. Any person entitled to a vote for Captain, who is not able to be present, shall have the right to send his vote in writing. Unless said vote be written and signed by the voter, it shall not count.

SEC. IV. In case the Captain resigns or does not return to College, a Captain shall be elected at the earliest possible date by the members of the team of the previous year—non-resident members voting by proxy.

## ARTICLE VII.

SEC. I. The duties of the Directors as a whole shall be to carry on the business of the Association, arrange games, &c.

SEC. II. It shall be the duty of the Directors to consult the Graduate Advisory Committee on matters of importance which pertain to the Athletic welfare of the College, such as business of conventions, schedules of games, trainer, &c., and to represent the Association in the Executive Committee.

## ARTICLE VIII.

The duties of the President shall be to preside at all meetings of the Association and the team. He shall carry on all correspondence of the Association, shall keep one copy of all letters written for the Association and shall also keep on file all letters received.

## ARTICLE IX.

The duties of the Treasurer shall be to take charge of all moneys, keep a strict account of all expenditures and receipts by the use of an order book and make at the end of each football season, a report of the same to be published in THE PRINCETONIAN. He shall make

a report within the last two weeks of each term to the University Treasurer concerning the affairs of the Association. He shall also take charge of all suits and foot balls belonging to the Association.

#### ARTICLE X.

The duties of the Captain shall be to choose the team. He shall have absolute power in management of the team on the field. He shall be a delegate to all Inter-Collegiate Foot Ball Conventions.

#### ARTICLE XI.

It shall take a two-thirds vote of members of the College assembled in mass meeting to make void any action of the Executive Committee.

#### ARTICLE XII.

At the request of thirty men, ten from any three classes, a meeting shall be called by the President of the Association.

#### ARTICLE XIII.

It shall require a majority vote of all the members of the Association to alter or amend in any way their constitution.

## BASE BALL ASSOCIATION.

---

### ARTICLE I.

The Association shall be known by the name of the "Princeton University Base Ball Association."

### ARTICLE II.

Every undergraduate of the College shall be considered a member of the Association.

### ARTICLE III.

The Executive Committee of the Association shall consist of the Captain, President and Treasurer. The President to be chosen from the Senior Class, the Treasurer from the Junior Class.

### ARTICLE IV,

The Captain shall be elected at the close of the base ball season by the members of the team who played in any of the championship games.

### ARTICLE V.

SEC. I. It shall take a majority of all those who are entitled to vote to elect a Captain.

SEC. II. In case of a tie the President shall cast the deciding vote after those ballots have been taken.

SEC. III. Any person entitled to a vote for Captain who is not able to be present shall have the right to send his vote in writing. Unless said vote be written and signed by the voter, it shall not count.

SEC. IV. In case the Captain resigns or does not return to College, a Captain shall be elected at the earliest possible date by the members of the team of the previous year; non-resident members voting by proxy.

## ARTICLE VI.

SEC. I. The President and Treasurer shall be chosen by the College at a mass meeting for that purpose.

SEC. II. The election shall take place on the last Thursday in May.

SEC. III. The officers thus elected shall go into office at the beginning of first term.

SEC. IV. No members of team or substitute shall hold the office of President or Treasurer.



## ARTICLE VII.

SEC. I. The duties of the Executive Committee as a whole shall be to carry on the business of the Association, arrange games, etc.

SEC. II. It shall be the duty of the Executive Committee to consult the Graduate Advisory Committee on all matters of importance which pertain to the welfare of the Association, such as conventions, schedules of games, trainer, etc.

## ARTICLE VIII.

The duties of the President shall be to preside at all meetings of the Association and of the club. He shall carry on all correspondence of the Association, shall keep copies of all letters written for the Association and shall keep on file all letters received. He shall be a delegate to all Inter-Collegiate Base Ball Conventions.

## ARTICLE IX.

The duties of the Treasurer shall be to take charge of all moneys, keep a strict account of all expenditures and receipts by the use of an order book and make at the end of each base ball season, a report of the same to be published in "THE PRINCETONIAN." He shall make

a report within the last two weeks of each term to the University Treasurer concerning the affairs of the Association. He shall also take charge of all suits, bats, balls, etc., belonging to the Association.

#### ARTICLE X.

The duties of the Captain shall be to choose the team. He shall have absolute power in management of the team on the field. He shall be a delegate to all Inter-Collegiate Base Ball Conventions.

#### ARTICLE XI.

It shall take a two-thirds vote of members of the College assembled in mass meeting to make void any action of the Executive Committee.

#### ARTICLE XII.

At the request of thirty men, ten from any three classes, a meeting shall be called by the President of the Association.

#### ARTICLE XIII.

It shall require a majority vote of all the members of the Association to alter or amend in any way their constitution.



## TRACK ATHLETIC ASSOCIATION.

---

### ARTICLE I.

SEC. I. The name of this Association shall be "The Princeton College Athletic Association."

SEC. II. The object of the Association shall be to encourage athletic sports in the College.

### ARTICLE II.

SEC. I. Any member of the College shall become a member of the Athletic Association on the payment of \$5.00 annual dues.

SEC. II. Every member of the Athletic Association shall be furnished with a card of membership which shall entitle him to the use of the Association's grounds, track and dressing rooms, and the services of the trainer, and admission to all games given by the Association.

### ARTICLE III.

SEC. I. The officers of this Association shall be a President chosen from the Senior Class; a Secretary chosen from the Junior Class; a Treasurer, chosen from the Sophomore Class; and a

Freshman Director. These shall constitute the Executive Committee of the Association and shall hold office for a period of one year.

SEC. II. The Director chosen from the incoming Freshman Class shall be chosen by the officers of the Association at any time before Thanksgiving.

#### ARTICLE IV.

The Captain shall be elected by the members of the team who contested in the Inter-Collegiate games.

#### ARTICLE V.

It shall take a plurality of the members present to elect any officer of this Association.

#### ARTICLE VI.

The President, Secretary and Treasurer shall be chosen by the members of the Association, at a meeting held the Wednesday following the Inter-collegiate games.

#### ARTICLE VII.

SEC. I. The duties of the Executive Committee shall be to carry on all business of the Association.

SEC. II. It shall be the duty of the Executive Committee to consult the Graduate Advisory Com-

mittee on matters of importance which pertain to the welfare of the Association, such as business of conventions, trainer, etc.

### ARTICLE VIII.

SEC. I. The duties of the President shall be to preside at all meetings of the Association, and to have general control over matters pertaining to the interests of the Association.

SEC. II. The duties of the Secretary shall be to keep the minutes of the proceedings of the Association, preserve the records of all field meetings given by the Association, issue all necessary notices, and conduct the correspondence of the Association.

SEC. III. The duties of the Treasurer shall be to take charge of all moneys, keep a strict account of all expenditures and receipts by the use of an order book and at the end of each term make a report to the University Treasurer.

### ARTICLE IX.

The duties of the Captain shall be to exercise control over the athletic team which shall be chosen by the officers.

## ARTICLE X.

SEC. I There shall be four regular field meetings of the Association during the year, namely, 1st, Fall Handicap games, some time before Nov. 1st; 2nd. Winters Sports, in the Gymnasium on Washington's Birthday; 3rd. Preliminary I. C. games, at least two weeks before the I. C. field meeting, and 4th, Class Championship games, for the "Peace Cup" some time during Commencement Week.

SEC. II. The rules governing all meetings shall be those of the Inter-Collegiate Athletic Association.

## ARTICLE XI.

The delegates to the Inter-Collegiate Convention shall be the President and Secretary.

## ARTICLE XII.

It shall take a two-thirds vote of all members of the Association to make void any action of the Executive Committee.

## ARTICLE XIII.

It shall require a majority vote of all the members of the Association to alter or amend this constitution.

## LACROSSE ASSOCIATION.

---

### ARTICLE I.

The Association shall be called the Princeton University Lacrosse Association.

### ARTICLE II.

Every undergraduate of the College shall be considered a member of the Association.

### ARTICLE III.

The Executive Committee of the Association shall consist of the Captain, President and Treasurer. The President to be chosen from the Senior Class, the Treasurer from the Junior Class.

### ARTICLE IV.

The Captain shall be elected by the members of the team who played in any championship game of the season.

### ARTICLE V.

SEC. I. It shall take a plurality of all those who are entitled to a vote to elect any officer of this Association.

SEC. II. Any person entitled to a vote for Captain, who is not able to be present, shall have the right to send his vote in writing. Unless said vote be written and signed by the voter, it shall not count.

SEC. IV. In case the Captain resigns or does not return to College, a Captain shall be elected at the earliest possible date by the members of the team of the previous year—non-resident members voting by proxy.

#### ARTICLE VI.

SEC. I. The President and Treasurer shall be chosen by the College, by a Mass Meeting for that purpose.

SEC. II. The election shall be held on the second Wednesday in June.

SEC. III. The officers thus elected shall go into office at the beginning of first term.

#### ARTICLE VII.

SEC. I. The duties of the Executive Committee as a whole shall be to carry on the business of the Association, arrange games, etc.

SEC. II. It shall be the duty of the Executive Committee to consult the Graduate Advisory Committee on matters of importance which per-

tain to the Athletic welfare of the College, such as business of conventions, schedules of games, trainer, &c.

#### ARTICLE VIII.

The duties of the President shall be to preside at all meetings of the Association and to have general control over matters pertaining to the interests of the Association.

#### ARTICLE IX.

The duties of the Treasurer shall be to take charge of all moneys, keep a strict account of all expenditures and all receipts by the use of an order book and make at the end of each Lacrosse season, a report of the same to be published in THE PRINCETONIAN. He shall also at any time when requested submit a report to the University Treasurer. He shall carry on all correspondence of the Association, shall keep one copy of all letters written for the Association and shall also keep on file all letters received.

#### ARTICLE X.

The duties of the Captain shall be to choose the team. He shall have absolute power in management of the team on the field. He shall be a delegate to all Inter-Collegiate Lacrosse Conventions.



## ARTICLE XI.

It shall take a two-thirds vote of members of the College assembled in Mass Meeting to make void any action of the Executive Committee.

## ARTICLE XII.

It shall require a majority vote of all the members of the Association to alter or amend in any way their constitution.
