## **PROCEEDINGS**

Atkinson, N. C., August 3, 1922.

The committee on Missions made her report. (See report). The report

was received and adopted. Dr. W. H. Moore being present responded to the report and urged that Zion ever keep the spirit alive within them, The committee on Education made her report. (See report). Same was adopted. The committee on Temperance made her report. (See report).

Same was received and adopted.

The corresponding delegate reported. Same was received. At this point Sister Francis A. Murray travelling in the interest of Home and Foreign Missions was introduced to the Auxiliary. She came forward and stated her work as a co-worker with Zion. She highly commended the work of Zion. She further told of the need of more women workers for Christ and His cause. Some must see the home needs. It takes prayer and work, said she, to accomplish the work before us. She made a strong appeal for the missionaries in Africa. And when she had concluded, a collection was lifted which amounted to \$4.05. Before accepting this gift Dr. Moore was asked to offer prayer, that God would accept this offering.

#### FRIDAY NIGHT SESSION.

Met pursuant to adjournment. Bro. Silas Carr opened divine praise by lining hymn No. 420, "How Sweet the Name of Jesus Sounds," etc. Bro. Leslie Carr read a portion of the 14th chapter of St. John, then offered prayer. Second hymn, "God moves in Mysterious Ways," etc.

The Counsellor then presented the speaker for the hour, in the person of Rev. Will Boykin. He arose and sang a spiritual anthem, then announced his text, Isaiah 6:8. Words used, "Also, I heard the voice of the Lord saying, whom shall I send, and who will go? Then said I, Here am I, send me." The speaker portrayed the call and life of Isaiah working in the service of the Lord. Isaiah said, send me. The Lord wants you to be like Isaiah. Answer Here am I Send me. Sister Murray read the 47th division of Psalms. Then Sister Sarah Lee led in fervent prayer. Second hymn No. 490, "I am not ashamed to own my Lord," etc. Then prayer was offered by the president. Then a spiritual anthem was chanted. The president made a few brief remarks, then announced the Bible Lesson taught by Sister S. F. Sellers, who had the lesson read in concert. Sister Sellers brought out some clear points from the lesson. Then Sister Hollingsworth followed Sister Sellers, showing how weights hindered one in running a narrow way.

The president then came forward and began to name some of the many weights that causes the preacher to stop running. Some that cause separation between wife and husband. Some that cause the home to become a

Being pressed for time was compelled to close the discussion. The president announced the house in order for business. The minutes of the previous session were read and adopted. The committee on place reported. Their report was not received and the committee was asked to go out and reconsider their report. They did so.

The committee on Petitionary Letters came forward and made a second report. (See report). Same was adopted. The applicants came forward and

received the right hand of fellowship.

This done, business was suspended to hear the Missionary sermon by Rev. M. R. Robinson. A spiritual anthem was chanted, then divine service opened by singing No.490 "I'm Not Ashamed to own My Lord," etc. Rev. Robinson read a portion of .. St. Matt. Rev. Tom Cowan led in fervent prayer. Second hymn No. 55. "A Charge to Keep I Have," etc., was sung with the spirit. The Counselor then presented the speaker for the hour in the person of Rev. M. R. #### CONSTITUTION.

1. This organization shall be known as the Women's Missionary Baptist Daughters of Zion Auxiliary.

2. The object of this auxiliary shall be to spread information among the organizations and for the discussion for the best means for the promotion of Christ's kingdom and our mutual encouragement.

3. This auxiliary shall consist of delegates and life members chosen

from the different organizations being entitled to three delegates.

4. Any person may become a member of this auxiliary by the payment of fifty cents, who has been properly organized in a subordinate organization and are in good and regular standing at home.

5. The delegates shall bear letters communicating information relative

to the work being done in each organization.

6. This auxiliary shall choose annually a President, Vice-President, Recording Secretary, Corresponding Secretary, a Treasurer and a Counsellor, who shall continue in office until their successors are elected.

7. The Counsellor shall instruct them in the best ways to be pursued.

The said Counsellor shall be a Missionary Baptist ordained minister

8. It shall be the duty of the President to preside over all meetings, and see that proper decorum is kept. In case of her absence the Vice-President shall act.

9. This auxiliary shall elect missionaries whose duty it shall be to visit each organization and see that they are properly organized, and instruct them in ways to be pursued in the transaction of their business.

10. This auxiliary shall have an Executive Board consisting of seven members chosen from this body annually who shall be subject to the call of the President, and suggest plans for the promotion of the work.

- 11. The following committees shall be appointed at each annual session of the auxiliary: First, Committee on Hours of Meeting; second, Committee on Finance and Account; third, Committee on Time and Place of the next session.
- 12. Other committees may be appointed whenever it shall be deemed prudent.
- 13. Every officer of this auxiliary shall pay annually the sum of twenty-five cents,

This Constitution shall be amended by a two-third vote of the members present at any annual session; provided, the proposed amendment is offered in the previous year and printed in the minutes.

#### BY-LAWS.

1. Auxiliary shall be opened by singing and prayer by the President or one appointed by her.

2. The minutes of the previous session shall be read, corrected and

adopted.

3. Persons invited to seats in the bar shall have the privilege or speaking on any question, but shall not vote.

4. Each person when arising to speak shall call the attention of the

President to the point in question.

5. No speaker shall be interrupted when speaking unless their remarks are foreign to the question under discussion; any member then should arise to a point of order, or the President may call her to the proposition under debate.

6. When two members arise at the same time and claim the floor, the

President shall give preference to the one farthest off.

7. Members shall not speak more than once upon the same question without permission.

8. A motion seconded shall be definitely stated by the President before discussion.

9. No motion shall be withdrawn after discussion.

10. When a question is under debate no motion or proposition shall be received except to adjourn or lay on the table, to amend, to commit, to postpone to an indefinite time, which several notices shall have precedence to order in which they are stated.

11. No member shall absent herself from the auxiliary without the permission from the Auxiliary, and if any shall do so, their absence shall

be noted in the minutes.

12. All questions except as to the Constitution, shall be decided by a

majority of votes.

13. The Auxiliary shall have a right to decide what subjects shall be admitted for consideration.

14. A motion may be divided into sections or amended, or withdrawn

by the mover.

15. These By-Laws may be altered or amended at any session of the Auxiliary by a majority of votes.
